

CM Wilkerson moved to approve the minutes of the May 2, 2022, meeting; the motion was seconded by CM Zappone. The minutes were approved by a vote of 6-0.

- 1. Police Department Update
 - Assistant Chief Lundgren briefed the Committee on SPD's response to the threat of an active shooter in light of the recent school shooting in Uvalde, Texas. Chief Lundgren explained that the goal of the department is to save lives and secure the scene. SPD would then assess medical treatment needs and evacuation of injured individuals while rescuing all those affected in the area.
 - <u>Action taken</u> Presentation and discussion only, no action was taken.

2. Fire Department Update

• Tom Williams briefed the Committee on SFD's budget process. He indicated this process has been made better by using Questica. He further discussed the wildland fire season and has staff working on fires in New Mexico.

Nationally, the threat level is two for fire danger. Additionally, the department is preparing for large scale community events like Hoopfest. Fire will be graduating 17 individuals from the academy in June.

- <u>Action taken</u> Presentation and discussion only, no action was taken.
- 3. Fire Settlement Costs
 - Mike Ormsby briefed this matter relating to two separate lawsuits in which budget authority has already been met. Seeking amendment of two contracts to add additional funds from Risk Management for litigating an appeal and also seeking a motion to dismiss.

- 4. SMC Parking Discussion
 - Jesten Ray shared proposed changes to the SMC relating to parking permit municipal codes. Changes being
 made at a section level 10 sections total. Amends 4 sections of code, Repeals 3 sections of code, Adds two
 sections of code and sets an effective date. Changes combine permit types with the same business rules and
 makes the permit definition clearer for Commercial Loading Zones.

- 5. Fire/EMS Academy SBO
 - Rex Strickland briefed the committee on the ask from SFD to facilitate a 24 person recruit school in August including wages and benefits for instructors and additional funds for equipment, uniforms and PPE.

- 6. Public Defender Salary Savings
 - Paul Ingiosi and Nick Antush briefed the Committee on hiring positions and salary savings in the department that could be used for hiring additional help in the office.

 - Assistant Chief Lundgren presented on a proposed SBO that would bring two new civilian positions into the department for the purpose of creating an abandoned vehicles unit.

- 8. Lease Agreement for Trent Shelter Site
 - City Administrator Johnnie Perkins and Eric Finch presented on the Mayor's Homeless Plan 2.0 and how the plan aligns with siting of a new shelter which has been identified as the Trent Ave Shelter. The overarching strategy is to build trust with the unhoused community to individualize services and opportunities for individuals to exit homelessness by way of accessing services through this shelter.

 - Eric Finch discussed the operator selection for the Trent Ave Shelter. The Guardians Foundation application scored the highest based on the scoring rubric. Next steps involve identifying a service provider for wrap around services.

CP Beggs moved to approve the minutes of the March 7, 2022, meeting; the motion was seconded by CM Bingle. The minutes were approved by a vote of 7-0.

Agenda Items

Discussion items

- 1. Police Department Update
 - Chief Meidl briefed the Committee on crime trends and data since police reforms were enacted statewide in July 2021. A powerpoint presentation with relevant data was shared with the Committee.
 - <u>Action taken</u> Presentation and discussion only, no action was taken.
- 2. Fire Department Update
 - Chief Schaeffer briefed the Committee on EMS Levy Renewal Ordinance and Resolution
 - City has 5 different levies. This is a levy for EMS which renews every 6 years and began in 1993. Requires a majority vote and not a super-majority. Rate is usually renewed at \$0.50. SFD runs at approximately 46 million annually and this will total about 13.1 million. Ballot day is April 26.
 - <u>Action taken</u> Presentation and discussion only, no action was taken.
- 3. Asset Forfeiture Update
 - Major McNab and Matt Folsom briefed the Committee on how law enforcement agencies incur great expense in the investigation, prosecution, adjudication and incarceration of drig related offenders. Asset forfeiture funds provide a significant deterrent by removing profit incentive and provide a revenue source to help defray costs of law enforcement. Folsom further briefed the Committee on the fund uses based on RCWs. SPD presented a request for use of specific federal and state funds.
 - <u>Action taken</u> Presentation and discussion only, no action was taken.
- 4. Mobile Speed Feedback Trailers
 - Carly Cortright presented to the Committee on Mobile Speed Radar Trailers which are deployed by the City to the neighborhoods since 2011. The trailers have a data collection mechanism and are solar powered. Movement of the trailers have been an issue with different departments moving the trailers and facilitating the data collection. The new proposal would allow for a partnership with Spokane COPS who will deploy the trailers within the neighborhoods on a routine schedule. Cortright proposed support for funding tow hitches for COPS.
 - <u>Action taken</u> Presentation and discussion only, no action was taken.
- 5. Police Fleet Purchasing for 2022
 - SPD is in desperate need of replacement cars and this information is based on a tailored 10 year replacement schedule. The life span of a police vehicle is considered 5 years/100k miles. Acquisition timeframe for vehicles is currently one year and beyond. Major McNabb shared a fleet breakdown and described how 57 percent of the SPD fleet is in need of replacement. SPD is requesting 64 K8 hybrids and will consider future hybrid purchases when a comparable model is available in response to the issues officers are experiencing with the Tesla fleet.

 - a. Ratepayers will be assessed by the City of Spokane annually, beginning with the base year of the authorization (2016). Beginning in July 2016 for the initial year, the assessment will be as follows:
 - i. For properties in Zone 1, the assessment will be 2.5¢ per Lot Square Foot (LSF) plus 60¢ per \$1,000 Total Assessed Value (TAV) based on the 2015 Spokane County records, with a minimum of ((\$200)) <u>\$250</u> per property parcel and a maximum of ((\$1,000)) <u>\$1,200</u> per property parcel.
 - ii. For properties within Zone 2, the assessment will be 1.3¢ per LSF plus 30¢ per \$1,000 of TAV based on the 2015 Spokane County records, with a minimum of ((\$100)) <u>\$125</u> per property parcel and a maximum of ((\$500)) <u>\$600</u> per property parcel.
 - iii. For properties within Zone 3, the assessment will be 0.6¢ per LSF plus 15¢ per \$1,000 TAV based on the 2015 Spokane County records, with a minimum of ((\$50)) \$65 per property parcel and a maximum of ((\$250)) \$300 per property parcel.
 - b. Adjustment to the minimum and maximum assessment rates set forth in SMC 04.31C.040(B) shall be made on an annual basis in the same percentage and manner as determined by the CPI Factor as set forth in SMC 04.31C.040(C).

If an ordinance is vetoed by the Mayor, the Mayoral veto will be published in a subsequent issue of the *Official Gazette*.

ORDINANCE NO. C36239

An ordinance determining the process and criteria for siting basic City facilities; amending section 12.05.005; and enacting new sections 12.05.062 and 12.05.063 of the Spokane Municipal Code; and declaring an emergency.

WHEREAS, public input, collaboration, and cooperation are all critical to the successful process of locating basic City facilities, to ensure that neighborhoods obtain all the benefits of basic city facilities while mitigating the detrimental impacts of those facilities; and

WHEREAS, members of our community, regardless of where they live, their race, ethnicity, socio-economic status, or any other characteristic, deserve to have the benefit of open, collaborative and transparent interactions with their local government, particularly when it comes to decisions to locate or relocate basic city facilities in their neighborhoods; and

WHEREAS, actions by city officials that ignore the voices of our community members in taking unilateral steps to locate or relocate basic city facilities erodes the public trust, degrades the effectiveness of local government, engenders suspicion, and demands an immediate response; and

WHEREAS, the City Council determines that because this ordinance concerns the process and criteria for the siting of basic City facilities, this ordinance is needed for the immediate preservation of the public peace and safety, and for the immediate support of City government and its existing public institutions, and that because of such need, this ordinance shall be effective immediately, under Section 19 of the City Charter, upon the affirmative vote of one more than a majority of the City Council.

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That section 12.05.005 of the Spokane Municipal Code is amended to read as follows:

Section 12.05.005 Definitions

- A. "Agent" means any person acting within the scope of employment by or acting on behalf of the City of Spokane including City-facility property managers.
- B. "Baby changing facility" means a table or other device suitable for changing the diaper of a child.
- C. "Employee" means any person holding a regularly compensated position of employment with the City of Spokane including elected officers.
- D. <u>"Basic City Facility" or "Basic City Facilities" means public safety facilities, including fire and police stations, City-owned water reservoirs, and other utility facilities, city-owned homeless shelters, and community centers. Provided that, utility facilities shall not include privately constructed utility facilities, stormwater facilities and conveyance systems, or water and wastewater utility transmission and distribution systems and related appurtenances, to include without limitation, pipe replacements and relocations; well upgrades; pump stations; lift stations, etc.</u>
- ((D.))<u>E.</u> "Federal civil immigration enforcement operations" means an operation than has one of its objectives the identification or apprehension of a person or persons in order to investigate them for a violation of the immigration law and subject them to one or more of the following:
 - 1. Civil immigration detention;
 - 2. Removal proceedings; and
 - 3. Removal from the United States
- ((E-))<u>F.</u> "LEED" is a green building rating and certification system developed by the U.S. Green Building Council to evaluate environmental performance from a whole building perspective, including sites, water efficiency, energy &

atmosphere, materials & resources, indoor environmental quality, locations & linkages, awareness & education, innovation in design, and regional priority.

- ((F.))<u>G.</u> "Nonpublic" means any area of a city facility or property that is not generally open and accessible to the general public, but instead requires prior to entry express permission, such as a valid ticket for a bona fide passenger, or permission by a city employee or an employee of a tenant in a city facility on an individual basis. Areas posted as "Restricted" in City facilities shall be considered to be non-public areas.
- ((G.))<u>H.</u> "United States Citizenship and Immigration Services" means the agency of the United States Department of Homeland Security and any successor agency charged with overseeing United States immigration laws.
- ((H.))<u>I.</u> "United States Customs and Border Protection" means the agency of the United States Department of Homeland Security and shall include any successor federal agency charged with border enforcement.
- ((+))J. "United States Immigration and Customs Enforcement" means the agency of the United States Department of Homeland Security including Enforcement and Removal Operations and Homeland Security Investigations and shall include any successor federal agency charged with the enforcement of immigration laws.
- ((J-))<u>K.</u> "U.S. Green Building Council" is an organization serving as the nation's foremost leaders from across the building industry working to promote buildings that are environmentally responsible, profitable, and healthy places to work and live.

Section 2. That there is enacted a new section 12.05.062 of the Spokane Municipal Code to read as follows:

Section 12.05.062 Siting of Basic City Facilities - Process

- A. Prior to locating a Basic City Facility, the city shall undertake the following public process.
 - 1. Convene at least one public community meeting and solicit written comment from members of the affected neighborhood council area(s) concerning the need(s) for the facility and the service(s) desired or required by the community, as well as identified service gap(s) to be addressed by the facility.
 - Publish any alternative locations considered for the proposed new or relocated Basic City Facility, to enable the residents of the affected neighborhood(s) of the relative merits and compliance with SMC 12.05.063 of each proposed alternative location and solicit comment on the proposed alternative locations in at least one open public meeting held in the affected neighborhood(s).
- B. The Spokane City Council's Equity Subcommittee shall review all responsive proposals and make a recommendation to the City Council based on at least the following criteria, to be given equal weight:
 - 1. effective demonstrably needed service to impacted neighborhood residents;
 - 2. responsiveness of the location to the demonstrated needs of the residents of an impacted neighborhood; and
 - 3. financial sustainability of the location.
- C. City services shall not be provided at the location unless the City Council has approved the location or relocation of a Basic City Facility.
- ((D. Nothing in City law prevents a Spokane resident, with standing, who believes that the City has not fully complied with this section prior to the City providing services at a Basic City Facility from seeking injunctive relief in Superior Court under the authority of this ordinance to stop delivery of services and/or funding until compliance with this section has been achieved. Provided, this section shall not apply to Basic City Facilities that provided services prior to June 25, 2022.))

Section 3. That there is enacted a new section 12.05.063 of the Spokane Municipal Code to read as follows:

Section 12.05.063 Basic City Facilities – Criteria

- A. The following criteria shall be met before any decision to place a new or relocated Basic City Facility can be made:
 - 1. For police precincts, the chosen location shall:
 - a. be visible to the public in a frequently-traveled location;
 - b. provide access for the public to onsite services and for officers responding to reports of crime;
 - c. be located within high visibility of patrol cars, foot and bicycle community policing patrols; and

- d. provide adequate space and facilities for co-deployed services and reception provided through mutual agreement with Spokane C.O.P.S.
- 2. For utility facilities:
 - a. the location must be designed to minimize conflicts with traffic to the extent consistent with efficient operations.
 - b. the location must be designed and operated to minimize noise, odor, dust, or other negative impacts due to the operation of the facility to the extent consistent with efficient operations.
- 3. For city-owned homeless shelters:
 - a. the location shall not be located within three blocks of schools;
 - b. the location must be accessible by public transportation; and
 - c. a good neighbor agreement must be in place between the shelter provider and the surrounding businesses and the applicable neighborhood council.

Section 4. That this ordinance applies to all basic city facilities which are located or relocated after June 25, 2022.

Section 5. That the City Council declares that an urgency and emergency exists such that this ordinance is needed for the immediate preservation of the public peace, health, or safety, and/or for the immediate support of City government and its existing public institutions, and that because of such need, this ordinance shall be effective immediately, under Section 19 of the City Charter, upon the affirmative vote of one more than a majority of the City Council.

- 1) Increase appropriation by \$160,000, funded from the city's direct allocation of the State and Local Fiscal Recovery Fund of the American Rescue Plan Act. This ARP fund appropriation qualifies as part of the General Government Services program category.
- (A) \$160,000 of the appropriation is provided solely for the replacement of playground equipment to be purchased through the Parks department.

Section 2. It is, therefore, by the City Council declared that an urgency and emergency exists for making the changes set forth herein, such urgency and emergency arising from the need to provide appropriation for Parks Playground Equipment and because of such need, an urgency and emergency exists for the passage of this ordinance, and also, because the same makes an appropriation, it shall take effect and be in force immediately upon its passage.
