Monday, September 19, 2022

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington.

Roll Call

On roll call, Council President Beggs and Council Members Bingle (appearing virtually), Cathcart, Kinnear, Stratton, and Zappone were present. Council Member Wilkerson arrived at 4:12 p.m. (during Executive Session).

City Administrator Johnnie Perkins; Hannahlee Allers, Director-City Council Office; Assistant City Attorney Lauren Beattie, and City Clerk Terri Pfister were also present for the meeting.

Advance Agenda Review

Council Members and staff provided an overview of the September 26, 2022, Advance Agenda items.

Action to Approve September 26, 2022, Advance Agenda

Following reports and Council inquiry and discussion regarding the September 26, 2022, Advance Agenda items, the City Council took the following action (pursuant to Council Rule 2.1.B):

Motion by Council Member Zappone, seconded by Council Member Kinnear, **to approve** the September 26, 2022, Advance Agenda; **carried 6-0.**

Suspension of Council Rules

Motion by Council Member Zappone, seconded by Council Member Stratton, **to suspend** Council Rules (for purposes of modifying tonight's Agenda); **carried 6-0.**

<u>Emergency Ordinance C36281 (Council Sponsors: Council President Beggs and Council Member Zappone)</u> **Motion** by Council Member Zappone, seconded by Council Member Stratton, **to add** Emergency Ordinance C36281—improving the standards for the City's efforts to help unhoused and vulnerable people—**carried 6-0**.

Motion by Council Member Zappone, seconded by Council Member Stratton, **to amend** Emergency Ordinance C36281 by increasing the air quality index from 150 to 201; **carried 6-0.**

Council Recess/Executive Session

The City Council recessed at 4:00 p.m. and immediately adjourned into Executive Session to discuss litigation and potential litigation for 20 minutes. Council Member Wilkerson arrived during Executive Session at 4:12 p.m. Interim City Attorney Lynden Smithson and Assistant City Attorneys Mary Muramatsu, Margaret Harrington, and Lauren Beattie were present during the Executive Session. At 4:20 p.m., the Executive Session was extended an additional five minutes. The Executive Session ended at 4:25 p.m., at which time the City Council reconvened into the Briefing Session.

Current Agenda Review (continued)

Final Reading Ordinance C36272 Relating to the Protection of Public Lands and Properties The following actions were taken on Final Reading Ordinance C36272:

Motion by Council Member Cathcart, seconded by Council Member Bingle, **to amend** Ordinance C36272, as follows:

Add Section - Unlawful Camping - Where Camping Prohibited and Enforced At All Times - Notwithstanding the availability of shelter space or beds, it is unlawful to camp or store personal property, including camp facilities and camp paraphernalia, or to have unauthorized encampments, at any time in the following locations: Within 2500 feet from any congregate shelter location.

Motion rejected 2-5.

Motion by Council Member Cathcart, seconded by Council Member Bingle, **to amend** Ordinance C36272, as follows:

Section 12.02.1002 – Definitions - The following definitions are applicable in this chapter unless the context otherwise requires:

A. "Camp" means to pitch, erect or occupy camp facilities, or to use camp paraphernalia or both, <u>or to otherwise occupy public property, such as sidewalks, with one's belongings</u>, for the purpose of, or in such a way as will facilitate, outdoor sheltering for living accommodation purposes or for remaining outdoors overnight, or using a camper, recreation vehicle, trailer, or other vehicle for living accommodation purposes or for the purpose of remaining overnight.

Motion rejected 2-5.

Motion by Council Member Cathcart, seconded by Council Member Bingle, **to amend** Ordinance C36272, as follows:

Section 12.02.1010 – Unauthorized Camping on Public Property – Violation – A. Prohibition

3. Underneath and within 50 <u>300</u> feet of any railroad viaduct located within the <u>City of</u> Spokane Police Department 's Downtown Precinct Boundary.

Motion rejected 2-5.

Motion by Council Member Bingle, seconded by Council Member Cathcart, **to amend** Ordinance C36272, as follows:

Add Section – Unlawful Camping - Where Camping Prohibited and Enforced At All Times - Notwithstanding the availability of shelter space or beds, it is unlawful to camp or store personal property, including camp facilities and camp paraphernalia, or to have unauthorized encampments, at any time in the following locations: Within 1000 feet of any licensed/authorized children-centric facility, to include but not limited to public parks, daycare, children sports center, education facility, campus, dormitory, community center or after-school center.

Motion rejected 2-5.

Upon 7-0 Roll Call Vote, the City Council **approved**, **subject to conditions** (in the Street Vacation Report dated July 26, 2022), the vacation of the alley between Everett Avenue and vacated Sanson Avenue, from the east line of Julia Street to the west line of Myrtle Street, as requested by Camtex, Inc.

An ordinance amending Ordinance No. C-36161, passed by the City Council December 13, 2021, and entitled, "An ordinance adopting the Annual Budget of the City of Spokane for 2022, making appropriations to the various funds of the City of Spokane government for the fiscal year ending December 31, 2022, and providing it shall take effect immediately upon passage," and declaring an emergency.

WHEREAS, subsequent to the adoption of the 2022 budget Ordinance No. C-36161, as above entitled, and which passed the City Council December 13, 2021, it is necessary to make changes in the appropriations of the Public Safety & Judicial Grant fund, which changes could not have been anticipated or known at the time of making such budget ordinance; and

WHEREAS, this ordinance has been on file in the City Clerk's Office for five days; - Now, Therefore,

The City of Spokane does ordain:

Section 1. That in the budget of the Public Safety & Judicial Grant Fund, and the budget annexed thereto with reference to the Fund, the following changes be made:

- 1) Increase the appropriation by \$153,000.
- A. Of the increased appropriation, \$150,000 is provided solely for upgrading and installing a new target turning system at the firing range.

ORDINANCE NO. C36271

An ordinance relating to the permitted use of forfeiture funds; amending sections 08.19030-040 of the Spokane Municipal Code.

WHEREAS, the long and well-established laws of the State of Washington provide for law enforcement agencies to seize and subsequently, through legal process, cause the forfeiture of assets used in, or gained from, illegal activity to be disposed of; and

WHEREAS, in 2014, the Spokane Police Department implemented comprehensive polices and ethical standards in regards to seizing property; and

WHEREAS, the Spokane Police Department undergoes annual audits by the Washington State Auditor's Office regarding the receipt and use of proceeds of those seizures; and

WHEREAS, since 2014 the Spokane Police Department's normal practice of using drug forfeiture funds to buy drugs and then pursue drug dealers has been unsuccessful in preventing a huge rise in the sale of fentanyl and drug overdoses in the City of Spokane, so new additional interventions are required to reduce drug abuse and drug crimes; and

WHEREAS, police youth programs are proven methods of expanding and improving law enforcement activity to reduce the crimes targeted by the above forfeiture statutes, particularly youth drug diversion, prevention, and mitigation strategies; and

WHEREAS, the Spokane police department has endorsed youth programs and requested that forfeiture funds be used to implement these programs; and

WHEREAS, the Spokane City Council intends to ensure that the proceeds legally obtained by the Police Department are used for the "expansion and improvement" of law enforcement within the City of Spokane that is proven to reduce crime and recidivism; and

WHEREAS, under Washington State law and Spokane City ordinance the City Council has final authority over the City of Spokane's budget, including approval of the spending of forfeiture dollars, and the Chief of Police and City Council must work together to determine the best use of these funds; and

WHEREAS, the Spokane City Council has not previously turned down any special budget ordinances requested by the Spokane Police Department for use of forfeiture funds in recent history but intends to support the Department's use of funds to reduce drug crime in Spokane by the most effective means available; and

WHEREAS, the collection of state authorized forfeiture funds has continued to reach historical highs despite the Washington Supreme Court's ruling in *Blake*; and

WHEREAS, the regulations regarding the use of state forfeiture funds differ from those regarding the use of federal forfeiture funds.

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That sections 08.19.030-040 of the Spokane Municipal Code are amended to read as follows:

Section 08.19.030 Permitted Use of Funds

- A. No asset forfeiture funds may be expended beyond the purposes allowed under applicable state and federal law and may not supplant existing funding. <u>Limitations on the spending of federally derived forfeiture assets</u> shall not apply to the spending of state derived forfeiture assets.
- B. Asset forfeiture funds under the control of the Police Department may only be spent by appropriation and approval of the Spokane City Council under its applicable policies for approving budgets and expenditures.
- C. The City Council will not approve <u>any special budget ordinance</u> spending ((of any)) asset forfeiture funds <u>for</u> <u>any purpose</u> absent a <u>current or past</u> request by the Chief of Police <u>for spending for that purpose</u>. ((The Chief of Police may request expenditure of asset forfeiture funds as part of the preparation and submission of the annual budget to City Council or by requesting approval of an special budget ordinance.))
- D. <u>The Chief of Police may request expenditure of asset forfeiture funds as part of the preparation and</u> submission of the annual budget to City Council or by requesting approval of a special budget ordinance.
- E. <u>The City Council may include expenditure of forfeiture funds in the annual budget for any purpose that the Chief of Police has previously requested funding regardless of whether the Chief is currently requesting funding for that purpose.</u>
- F. <u>The City's top priorities for spending state authorized forfeiture funds in 2022 and 2023 are as follows. The City will annually fund these two priorities equally from state funds and will not expend additional state forfeiture funds if it would reduce the reserve of state forfeiture funds below \$250,000.</u>
 - a. Payments to confidential informants and for controlled drug purchases; and,
 - b. <u>At-risk youth drug prevention programming and services based on peer support and leadership by</u> individuals who have successfully exited criminal justice involvement.
- <u>G. In 2024, the City Council shall evaluate all evidence of drug forfeiture expenditures in 2023 along with available forfeiture funds and trends and determine in collaboration with the Chief of Police whether the allocation set out in Section F shall continue or be modified to best support police efforts to reduce drug crime in the City of Spokane.</u>

Section 08.19.040 Reporting on Use of Funds

The Police Department shall provide to the Spokane City Council Public Safety Committee quarterly and yearly reporting of the receipt of proceeds from all civil forfeiture funds, the specific source of all forfeiture funds and all expenditures of forfeiture funds including the amount paid from the proceeds to the Washington State Treasurer. The reports shall also provide information related to and certification that all seized funds were spent consistent with any limitations imposed by federal or state law. No forfeiture funds are permitted to be spent in any annual quarter until a written report of the same quarter from the previous year has been submitted to City Council at a standing Public Safety and Community Health Committee meeting.
