Monday, September 30, 2024

BRIEFING SESSION

The Briefing Session of the Spokane City Council held on the above date was called to order at 3:30 p.m. in the Council Chambers in the Lower Level of the Municipal Building, 808 West Spokane Falls Boulevard, Spokane, Washington. Legislative Process: Initial Plan Commission Workshops were held on August 28, 2024, September 11, 2024, October 9th, 2024, and one is scheduled for October 23rd, 2024 to introduce the Commission to proposed amendments. A Plan Commission Public Hearing is tentatively scheduled for November 13, 2024. City Council action is expected to occur in Winter 2024.

An ordinance creating the Climate Resilience and Sustainability Board (CRSB); repealing Chapter 04.36 of Title 04 the Spokane Municipal Code; creating a new Chapter 04.41 to Title 04 of the Spokane Municipal Code.

WHEREAS, the City of Spokane produced its first Sustainability Action Plan in 2009; and

WHEREAS, the Spokane City Council officially adopted the City's first Sustainability Action Plan by an ordinance (No. C35519; SMC 15.05.030 B.) in 2017, which included a recommitment to the City's Greenhouse Gas Reduction Goals; and

WHEREAS, a 2018 ordinance (No. C35668; SMC 04.36) created the Sustainability Action Committee; and

WHEREAS, the Sustainability Action Committee was not empaneled by the Condon or Woodward administrations; and

WHEREAS, in 2018 the City Council created the Sustainability Action Subcommittee, reporting to the Council's Public Infrastructure, Environment and Sustainability Committee, to help move the City forward on sustainability and climate action (Resolution No. 2018-0110); and

WHEREAS, in 2021 the Spokane City Council adopted an updated Sustainability Action Plan that was developed by the City Council's Sustainability Initiatives Manager and the Sustainability Action Subcommittee in a multi-year process that engaged a large number and wide variety of community members and included six months of community engagement in reviewing the plan, and

WHEREAS, the 2021 Sustainability Action Plan established Goal 4, TL8, "Update the comprehensive plan to incorporate climate action and updated sustainability goals", and

WHEREAS, in 2021 the City Council codified in SMC 15.05.060 various reporting requirements concerning the status and progress of the City's efforts to implement the City's Sustainability Action Plan, and

WHEREAS, Mayor Brown's Transition Team committee focused on *Building a Resilient Future* recommended the creation of a Community Resiliency and Sustainability Board and further recommended the Sustainability Action Plan be integrated into the City's Comprehensive Plan; and

WHEREAS, the City is embarking on an update to the Comprehensive Plan to include a "Climate Element" with resilience and greenhouse gas emissions mitigation sub-elements as required by an update to the Growth Management Act that was adopted by the State Legislature in 2023; and

WHEREAS, the legislation anticipates robust public engagement, and guidance provided by the Washington State Department of Commerce recommends the establishment of a "Climate Policy Advisory Committee" of community volunteers and other stakeholders to help shape the new Climate Element; and

WHEREAS, the City of Spokane seeks to bring people together to identify the co-benefits of sustainable actions and to move our community towards resilience in the face of climate change; and

NOW, THEREFORE, the City of Spokane does ordain:

- **Section 1.** Chapter 04.36 entitled "Sustainability Action Committee" of Title 04 of the Spokane Municipal Code is repealed:
- **Section 2.** There is enacted a new chapter 04.41 to Title 04 of the Spokane Municipal Code to read as follows:

Chapter 04.41 Climate Resilience and Sustainability Board 04.41.010 Purpose

- 04.41.020 Membership 04.41.030 Appointment and Term 04.41.040 Officers 04.41.050 Ancillary Powers
- 04.41.060 Duties and Responsibilities 04.41.070 Environmental Justice Considerations
- 04.41.080 Removal of Board Members

04.41.010 Purpose

The purpose of the Climate Resilience and Sustainability Board is to provide advice and recommendations to the Mayor, City Council, and community on the actions necessary to achieve the community's sustainability and climate goals consistent with the City's Comprehensive Plan, Sustainability Action Plan, environmental stewardship policies of the City as adopted by the City Council, and within the requirements and parameters set forth in state law.

04.41.020 Membership

- A. The Climate Resilience and Sustainability Board shall consist of up to fifteen (15) voting members committed to achieving the goals of SMC Chapter 15.05 and implementing the policies and recommendations of the Sustainability Action Plan and the Climate Component of the Comprehensive Plan.
- B. The Climate Resilience and Sustainability Board membership will consist of diverse and broad representation including but not limited to:
 - 1) members of impacted communities facing disproportionate environmental and health disparities;
 - 2) individuals with expertise in public health, emergency management, climate planning, or sustainability and resiliency initiatives;
 - 3) business leaders and entrepreneurs with experience implementing sustainability and resiliency initiatives; and
 - 4) students of secondary and postsecondary education institutions within the city of Spokane.
- C. Climate Resilience and Sustainability Board members shall be at least sixteen years of age.
- D. The City Council may appoint a city council member to serve as a liaison to the Board.

04.41.030 Appointment and Term

A. Term

- 1. Board members are nominated by the Mayor and appointed by the City Council.
- 2. The term of office shall be two years.
- 3. The terms of eight of the Board members shall expire in odd-numbered years.
- 4. The terms of seven of the Board members shall expire in even-numbered years.
- 5. Initial and subsequent Board members may be appointed to such shorter and/or longer terms as are necessary to achieve this term cycle.
- 6. No Board member shall serve more than four consecutive full terms.

B. Vacancy

- 1. Any vacancy may be filled for an unexpired term in the same manner as for an original appointment under this section as amended.
- 2. Appointment to fill the balance of an unexpired term where more than half of the unexpired term remains shall be considered a full term.
- C. To achieve broad representation, city residency shall not be required to serve on the Climate Resilience and Sustainability Board; provided, however, a majority of the Board members shall consist of residents of the city, students of secondary or post-secondary institutions located within the city of Spokane, or business owners or nonprofit employees located within the city limits of Spokane.

04.41.040 Officers

- A. The Climate Resilience and Sustainability Board shall select a Chair and Vice Chair of the Board from voting members appointed through the process outlined in SMC 04.41.030 for a term of two years. No person shall serve as chair for more than two consecutive two-year terms. The chair shall preside over meetings and the vice chair shall preside over meetings in the absence of the chair.
- B. The Climate Resilience and Sustainability Board may appoint other officers as it deems necessary.

04.41.050 Ancillary Powers

The Climate Resilience and Sustainability Board shall have the power to:

- A. Adopt internal rules of procedure to accomplish its duties;
- B. Use administrative support and staff as well as technical support from appropriate City departments and offices as necessary to assist the Board in the performance of its functions, maintenance of its records, and preparation of official correspondence;
- C. Organize itself, establish workgroups, committees, or subcommittees, establish annual work programs in consultation with the appropriate City staff, and delegate duties to such subordinate groups for the performance of its work.
- D. Access all relevant City of Spokane data and develop productive analytics and metrics;
- E. Host joint meetings with the City Council, Plan Commission, Transportation Commission and other relevant boards and commissions; and
- F. Host public events that encourage and support community engagement.

04.41.060 Duties and Responsibilities

The Climate Resilience and Sustainability Board shall provide advice and recommendations to the Mayor, City Council, and community on the actions necessary to achieve the community's sustainability and climate goals consistent with the City's Comprehensive Plan, Sustainability Action Plan, environmental stewardship policies of the City as adopted by the City Council, and within the requirements and parameters set forth in state law. Specifically, the Board shall have the following duties and responsibilities:

- A. Serve as the Climate Policy Advisory Team for the state-required Climate Element addition to the Comprehensive Plan, reviewing climate information gathered through engagement processes and providing recommendations on areas of focus and ensuring that climate goals and strategies are addressed in the housing, land use, transportation, public facilities, and other Comprehensive Plan elements;
- B. Consult with all City divisions and departments and relevant boards, committees, and commissions to recommend to the Mayor and Council funding opportunities and policy changes that advance resiliency, sustainability, and the policies that make up the Climate Element of the Comprehensive Plan;
- C. Identify opportunities for the City to collaborate with tribal, regional and statewide partners to advance the goals, principles, and strategies of the Sustainability Action Plan and Climate Element of the Comprehensive Plan;
- D. Provide recommendations and guidance for incorporating environmental and climate justice into City operations to limit the impacts of climate change in vulnerable and overburdened communities and reduce the cost-burden to low-income citizens as a result of implementing the Climate Element of the Comprehensive Plan;
- E. Consider research and best practices to make recommendations on climate and sustainability policies, programs, and projects as determined by the Board's annual work plan and upon request by City Council, City staff, and community members; and
- F. Establish an annual work plan in consultation with the appropriate City staff designated by the Mayor which shall be adopted by the City Council.

4.41.070 Environmental Justice Considerations

A. In making and approving appointments to the Climate Resilience and Sustainability Board, the Mayor and City Council shall seek adequate representation from impacted community members and from historically underrepresented geographic areas or marginalized communities, including communities of color and areas of the city of Spokane that are subject to disproportionate environmental and health disparities. B. In performing its duties under SMC 4.41.070, the Climate Resilience and Sustainability Board shall consider the effect of its policy and recommendations on impacted community members and shall consider the effect on historically underrepresented geographic areas or marginalized communities, including low-income and communities of color and areas of the city of Spokane that have been subject to disproportionate environmental and health disparities.

4.41.080 Removal of Board Members

Climate Resilience and Sustainability Board members shall not be removed from office by the City Council before the expiration of their terms except for cause based upon a determination of incapacity, incompetence, the presence of irreconcilable conflicts of interest, neglect of duty, or malfeasance, and upon the affirmative vote of five (5) Council members. No Board member shall be removed without written notice of the intent to remove and an opportunity to provide a written response to the notice.

Section 3. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

Upon approval by the city attorney, the city clerk is authorized to make necessary corrections to this ordinance, including scrivener's errors or clerical mistakes; references to other local, state, or federal laws, rules, or regulations; or numbering or referencing of ordinances or their sections and subsections.

ORDINANCE NO C36558

An ordinance repealing inactive funds; amending Sections 07.08.100, 07.08.119, and 07.08.159; repealing Sections 07.08.105, 07.08.111, 07.08.118, 07.08.120, 07.08.126, 07.08.128, 07.08.142, 07.08.144, 07.08.200, 07.08.308, 07.08.309, and 07.08.410 of the Spokane Municipal Code.

WHEREAS, the administration seeks to update the municipal code to remove previously codified funds that are no longer active; and

WHEREAS, the repeal and amendment of these inactive funds has no fiscal impact;

NOW, THEREFORE, the City of Spokane does ordain:

Section 1. That Section 07.08.100 of the Spokane Municipal Code is amended to read as follows:

Section 07.08.100 ((City Street)) Street Maintenance Fund

There is created a fund to be known as the "((city street)) street maintenance fund" from which all expenditures shall be made for proper street purposes.

- **Section 2.** That Section 07.08.105 of the Spokane Municipal Code is repealed.
- Section 3. That Section 07.08.111 of the Spokane Municipal Code is repealed.
- Section 4. That Section 07.08.118 of the Spokane Municipal Code is repealed.
- Section 5. That Section 07.08.119 of the Spokane Municipal Code is amended to read as follows:

Section 07.08.119 ((Cable TV)) Channel Five Equipment Reserve Fund

- A. There is established a special revenue fund to be known as the "((eable TV)) channel five equipment reserve fund". ((into which will be deposited those various grants from Cox Cable Communications Company (TCl Cablevision of Washington by transfer of franchise (Resolution 1996-142, December 23, 1996)) as specified in Attachment 1 to the cable television franchise Ordinance C29733, passed July 2, 1990.))
- B. This fund will be used to purchase various items of equipment to be used for a number of City cable programs ((as indicated in said Ordinance C29733 Attachment 1)) including, but not limited to:
 - 1. Terminal and portable governmental equipment.
 - 2. Educational equipment.
 - 3. Video arraignment equipment; and
 - 4. Fixed and field government production equipment.

Section 07.08.159 Cannabis Special Revenue Fund

- A. Effective January 1, 2024, there is established a special revenue fund entitled the "Cannabis Special Revenue Fund" into which shall be paid all funds received by the City pursuant to RCW 69.50.540.
- B. As provided in the annual budget, the "Cannabis Special Revenue Fund" is appropriated as follows:
 - a. No less than \$500,000 shall be appropriated on an annual basis to the general fund for support of the Spokane Police Department; and

ORDINANCE NO. C36559

An ordinance relating to the membership of the Spokane Employees' Retirement System Board; amending SMC section 4.14.040.

WHEREAS, Spokane Employees' Retirement System (SERS) Board administers the retirement system and retirement fund for City of Spokane employees and elected officials except police and fire department employees; and

WHEREAS, SERS Board has the power to direct investments of the retirement fund, change the rates of contribution, and adopt mortality and service tables to determine retirement benefit calculations; and

WHEREAS, SERS Board membership is governed by SMC 04.14.040 and currently consists of seven members with equal employee and Council appointees and one member selected by the other six members; and

WHEREAS, as part of the comprehensive budget review process, the Mayor seeks to add additional financial expertise to the administration of the retirement system and Employees' Retirement Fund with the goal of improving overall retirement system health and performance.

NOW, THEREFORE, the City of Spokane does ordain:

Section 1. That SMC section 4.14.040 is amended to read as follows:

4.14.040 Membership - Selection

- A. The board consists of ((seven (7))) nine (9) members.
 - 1. Three (3) board members are appointed by the city council. <u>One of the board member appointments is a council member.</u>
 - 2. ((Three (3))) four (4) board members are elected from employees eligible for the retirement system by such eligible employees; ((and))
 - 3. One (1) board member, the Mayor or the Mayor's designee.
 - $((\frac{3}{2}))$ <u>4</u>. One (1) board member, who may not be an elected official or employee of the City, is appointed by the other $((\frac{\sin x}{6})))$ <u>eight</u> (8) board members.
- B. Terms.
 - 1. The board members appointed by the city council serve at the pleasure of the city council.
 - 2. The elected employee board members serve staggered ((three)) four-year terms commencing on the first Monday in July.
 - 3. The Mayor or designee serves at the discretion of the Mayor during the Mayor's term of office.
 - ((3)) 4. The ((seventh)) ninth board member serves a four-year term.
 - 4. A vacancy is filled and a replacement is made in the same manner as original selections, except that a vacancy in one of the elected employee positions is filled by appointment by the other((two)) three (or a minimum of two) elected employee board members, which appointment is until the next annual election.

ORDINANCE NO. C36580

AN ORDINANCE relating to Noise Control; amending SMC section 10.70.120 to chapter 10.70 of the Spokane Municipal Code; and setting an effective date.

WHEREAS, Eastern Washington and Spokane have a limited construction season due to weather conditions – traditionally April through October; and

WHEREAS, Washington State has enacted regulations which govern workers who work outside and require work start earlier to avoid extreme heat conditions; and

WHEREAS, extreme heat can occasionally occur anytime May through October when temperatures exceed the normal; and

WHEREAS, for the safety of workers and the safety of the public, it is important to schedule construction related activities during times which have lower traffic activity and avoid peak travel hours on roadways or arterials.

The City of Spokane does ordain:

Section 1: That SMC section 10.70.120 is amended to read as follows:

10.70.120 Noise Variance

- A. A person may request a variance from compliance with this chapter by making an application with the director of public works and utilities at least ((thirty)) seven (7) days before the time period for the variance is to take effect. The variance is limited to ((ene-time)) activities that do not include concerts or permitted special events and entertainment facilities. The variance may not be used for private activities (weddings, parties etc). The applicant shall explain the:
 - 1. nature of the noise,
 - 2. source of the noise,
 - 3. duration for which the noise shall be created,
 - 4. time period for which the variance will be required,
 - 5. ((reason why the noise violation cannot be avoided)) public benefit of a noise ordinance variance (e.g., high heat avoidance, significant reduction in traffic impacts, etc.), and
 - 6. mitigating conditions the applicant will implement to minimize the noise level violations.
- B. The application must be submitted at least ((thirty)) seven (7) days before the time period the permit is to take effect. ((The director, after informing the affected City departments, may issue an excess noise permit if the director determines that the noise level violations:
 - 1. cannot be avoided,
 - 2. will exist for a specific period of time,
 - 3. will not endanger public health, safety or welfare. And
 - 4. have been mitigated to the greatest extent reasonably possible.))
- C. The director, after informing the affected City departments, may issue a variance from this chapter if the director determines that ((the noise level violations cannot be avoided)) there is a public benefit to a noise ordinance variance, will exist for a specific period of time, and have been mitigated to the greatest extent reasonably possible. The director shall issue a written decision indicating the time period and location restrictions for the variance.
- D. The person obtaining such written variance must have the written variance posted in a viewable area or on their person when such variance takes place.
- E. A decision of the director of public works and utilities regarding a request for a variance may be appealed to the hearing examiner within ten days of the director's written decision.

ORDINANCE NO. C36581

An ordinance relating to the use of composted materials in City of Spokane projects; adopting a new section 7.06.221 to Chapter 07.06 of the Spokane Municipal Code.

WHEREAS, in 2022 the legislature adopted an organics management law to reduce the emissions of methane created in organic materials such as food and yard waste; and

WHEREAS, the organics management law encourages cities and counties to "procure more of the compost and finished products created from their organic materials waste in order to support the economic viability of processes to turn organic materials into finished products and increasing the likelihood that composting and other responsible organic material management options are economically viable; and

WHEREAS, Washington state law requires the City of Spokane to adopt a compost procurement ordinance to implement the state organics management law.

NOW, THEREFORE, the City of Spokane does ordain:

Section 1. That there is enacted a new Section 7.06.221 to Chapter 07.06 SMC to read as follows:

Section 07.06.221 Use of Composted Materials in City Projects

- A. Before issuance of a solicitation for bids or proposals, the City shall consider whether the use of composted material is practicable and feasible in the project. At minimum, the City shall consider whether the use of composted material, as defined by RCW 70A.205.015(3), may be utilized in the following:
 - 1. Landscaping projects and City-maintained areas;
 - 2. Construction and post-construction soil amendments;
 - 3. Applications to prevent erosion, filter stormwater runoff, promote vegetation growth, or improve the stability and longevity of roadways; and
 - 4. Low-impact development and green infrastructure to filter pollutants and keep water on-site, or both.
- B. The City shall prioritize purchasing compost products from companies that satisfy the following:
 - 1. Produce compost products locally;
 - 2. Are certified by a nationally recognized organization such as the US Composting Council;
 - Produce compost products that are derived from municipal solid waste compost programs; and
 - Meet quality standards adopted by the Washington State Department of Transportation or adopted by rule by the Washington State Department of Ecology.
- C. The City is not required to use composted products if:
 - 1. Compost products are not available within a reasonable period of time or distance from the project;
 - 2. Compost products that are available do not comply with existing purchasing standards;
 - 3. Compost products that are available do not comply with federal or state health, quality, and safety standards; or
 - 4. Compost purchase prices are not reasonable or are not competitive.
- D. The City shall develop and implement strategies to inform residents about the value of compost and how the City uses compost in its operations.
- E. Pursuant to RCW 43.19A.150, the City shall report to the Department of Ecology the City's previous year's compost procurement activities.

ORDINANCE NO. C36582

An ordinance relating to commercial truck traffic on Nebraska Avenue and amending Section 12.08.010 of the of the Spokane Municipal Code.

WHEREAS, the residents of West Nebraska Avenue have been experiencing consistent use of their residential street by commercial truck traffic, despite repeated entreaties to local businesses to route their commercial vehicles outside of the residential area; and

WHEREAS, Section 12.08.010 of the Spokane Municipal Code currently bars trucks from many Spokane Streets; and

WHEREAS, the City wishes to add West Nebraska Avenue to the list of streets where all non-local truck traffic is barred,

NOW THEREFORE, the City of Spokane does ordain:

Section 1. That Section 12.08.010 Spokane Municipal Code be amended to read as follows:

Section 12.08.010 Streets Closed to Trucks

- A. Hereafter the following streets and avenues in the city shall be permanently closed to all truck travel except for the purpose of making deliveries or providing service to points upon such streets or avenues:
 - 1. Buckeye Avenue from Rebecca Street to Havana Street.
 - 2. Cannon Street from Fourth Avenue to Riverside Avenue.
 - 3. Carlisle Avenue from Ralph Street to Havana Street.
 - 4. Chestnut Street from Fifth Avenue to First Avenue.
 - 5. Cleveland Avenue from Greene Street to Havana Street.
 - 6. Coeur d'Alene Street from Sixth Avenue to Pacific Avenue.
 - 7. Cuba Street from Upriver Drive to Frederick Avenue.
 - 8. Elm Street from Third Avenue to Riverside Avenue.
 - 9. Ermina Avenue from Sycamore Street to Havana Street.
 - 10. Fairview Avenue from Greene Street to Havana Avenue.
 - 11. Ferrall Street from Montgomery Avenue to Euclid Avenue.
 - 12. Fifth Avenue from Chestnut Street to Coeur d'Alene Street.
 - 13. First Avenue from Maple to Poplar Street.
 - 14. Fourth Avenue from Cannon Street to Spruce Street.
 - 15. Frederick Avenue from Freya Street to Havana Street.
 - 16. Freya Street from Upriver Drive to Frederick Avenue.
 - 17. Grace Avenue from Greene Street to Havana Street.
 - 18. Greene Street from Grace Avenue to Euclid Avenue.
 - 19. Havana Street from Upriver Drive to Frederick Avenue.
 - 20. Hemlock Street from Sixth Avenue to Riverside Avenue.
 - 21. Jackson Avenue from Greene Street to Havana Street.
 - 22. Julia Street from Grace Avenue to Frederick Avenue, and from Upriver Court to Marietta Avenue.
 - 23. Marietta Avenue from Greene Street to Havana Street.
 - 24. Montgomery Avenue from Ralph Street to Havana Street.
 - 25. Myrtle Street from Carlisle Avenue to Frederick Avenue.
 - 26. Oak Street from Third Avenue to Riverside Avenue.
 - 27. Pacific Avenue from Maple Street to Coeur d'Alene Street.
 - 28. Poplar Street from Third Avenue to First Avenue.
 - 29. Ralph Street from Carlisle Avenue to Euclid Avenue.
 - 30. Rebecca Street from Upriver Drive to Frederick Avenue.
 - 31. Second Avenue from Havana Street to Freya Street; and from Maple Street to Coeur dAlene Street.
 - 32. Spruce Street from Fourth Avenue to Pacific Avenue.
 - 33. Sycamore Street from Ermina Avenue to Frederick Avenue.
 - 34. Third Avenue from Elm Street to Coeur d'Alene Street.
 - 35. Thor Street from Montgomery Avenue to Euclid Avenue.
 - 36. Upriver Court.
 - 37. Upriver Drive from Ralph Street to Havana Street, and from the City limits at Buckeye Avenue to the east City limits.
 - 38. West Nebraska Avenue from North Ash Street to North Monroe Street.
- B. Any person, firm, or corporation operating a truck upon the streets or avenues enumerated in subsection (A) of this section, except for the purpose of making deliveries or providing service to points upon such streets or avenues, shall be guilty of a traffic infraction.

Section 2. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

Section 3. <u>Clerical Errors</u>. Upon approval by the city attorney, the city clerk is authorized to make necessary corrections to this ordinance, including scrivener's errors or clerical mistakes; references to other local, state, or federal laws, rules, or regulations; or numbering or referencing of ordinances or their sections and subsections.

ORDINANCE NO C36591

An ordinance establishing the Community Safety Fund and setting the expiration date of the additional sales and use tax authorized by RCW 82.14.450; adopting section 07.08.160 to chapter 07.08 of the Spokane Municipal Code, and declaring an emergency.

WHEREAS, the City of Spokane has the authority pursuant to RCW 82.14.450 to enact a 1/10 of 1% sales tax to be approved by the electorate of the City of Spokane, subject to limitations as required by law; and

WHEREAS, necessities such as food and prescription drugs are exempted from sales and use tax per Washington state law; and

WHEREAS, the Spokane City Council adopted Resolution 2024-0067 placing a Community Safety Sales tax proposition on the November 5, 2024, ballot to provide ongoing funding for enhanced community safety, criminal justice, and law enforcement such as funding for the Spokane Fire Department, Spokane Police Department, Spokane Municipal Court, and the Office of Police Ombuds; and

WHEREAS, if approved by the electorate, collection of the additional sales and use tax will begin to be collected pursuant to state beginning approximately April 1, 2025; and

WHEREAS, the Brown Administration and Spokane City Council seek to establish a dedicated Community Safety Fund, if approved by voters, to increase transparency and segregate the use of the funds exclusively for improving community safety; and

WHEREAS, the Brown Administration and Spokane City Council seek to provide additional accountability for the use of funds generated upon voter approval of the Community Safety sales tax proposition by establishing a date in which the community safety sales tax will expire on December 31, 2035, unless the expiration date is extended by the City of Spokane electorate in a primary or general election extending the expiration date; and

WHEREAS, to ensure the voting public is fully informed about the sunset date for the proposed sales tax proposition well before the election date of November 5, 2024, it is essential that the City Council establish the community safety fund and a codified sunset date before the election; and,

WHEREAS, the joint decision by the Brown Administration and the City Council to establish a sunset date is sudden, unexpected, and requires immediate action to prevent or mitigate the threat of misunderstanding to the voting public about Proposition No. 1 before the election; and

WHEREAS, the normal course of legislative procedures of the City Council cannot result in a timely adoption of this ordinance before November 5, 2024; and

WHEREAS, this ordinance is necessary for the immediate preservation of the public peace, health or safety or for the immediate support of City government and its existing public institutions,

NOW, THEREFORE, the City of Spokane does ordain:

Section 1. There is enacted a new section 07.08.160 to Chapter 07.08 of the Spokane Municipal Code to read as follows:

Section 07.08.160 Community Safety Fund

- A. There is created a special revenue fund known as the "Community Safety Fund" into which shall be deposited all funds received from the increase in the sales and use tax approved by the City of Spokane electorate and provided by RCW 82.14.450 for the enhancement of community safety functions and operations pursuant to Resolution 2024-0067.
- B. The retail purchase of food, prescription drugs, motor vehicles, and all other sales and use tax exemptions adopted in state law shall also be exempted from the community safety sales and use tax provided by RCW 82.14.450.
- C. The collection of the additional sales and use tax authorized by the City of Spokane electorate pursuant to Resolution 2024-0067 shall expire no later than December 31, 2035, unless the expiration date is extended by the City of Spokane electorate in a primary or general election.
- D. Should the increase in the sales and use tax provided by RCW 82.14.450 not be approved by the City of Spokane electorate, then this section is automatically repealed.

Section 2. Severability. If any section, subsection, sentence, clause, phrase or word of this ordinance should be held to be invalid or unconstitutional by a court of competent jurisdiction, such invalidity or unconstitutionality thereof shall not affect the validity or constitutionality of any other section, subsection, sentence, clause, phrase or word of this ordinance.

Section 3. Clerical Errors. Upon approval by the city attorney, the city clerk is authorized to make necessary corrections to this ordinance, including scrivener's errors or clerical mistakes; references to other local, state, or federal laws, rules, or regulations; or numbering or referencing of ordinances or their sections and subsections.

Section 4. Emergency Findings. Pursuant to Section 01.01.080 Spokane Municipal Code, the City Council declares that an urgency and emergency exists such that this ordinance is needed for the immediate preservation of the public peace, health, or safety, and/or for the immediate support of City government and its existing public institutions, and that because of such need, this ordinance shall be effective immediately under Section 19 of the City Charter, upon the affirmative vote of five members of the City Council.
