NOTICE OF CITY COUNCIL PUBLIC HEARING INTERIM ZONING ORDINANCE CONCERNING BUILDING HEIGHTS (Ordinance C36646)

The Spokane City Council will hold a public hearing in a hybrid format on **Monday, March 24, 2025, at 6:00 p.m.** in Council Chambers, Lower Level of Spokane City Hall, 808 W. Spokane Falls Blvd., and virtually, to receive public testimony related to Interim Zoning Ordinance C36646 concerning building heights and adopting a new Chapter 17C.425 SMC. Information about the City Council agenda and how to join the meeting and testify is available on the City's website at: https://my.spokanecity.org/citycouncil/meetings/. Oral testimony and written comments submitted during the hearing will be made part of the public record.

<u>Subject:</u> A proposed interim zoning ordinance to exempt areas with Downtown zoning from maximum height limits except in the Special Height Overlay Districts of SMC 17C.170; also to modify height limits in Office and Office-Retail zones to have a height limit of 40 feet, consistent with the height limit in residential zones; lastly, to specify that areas with a designated height of 35 feet will have a height limit of 40 feet consistent with the height limit in residential zones.

<u>Location:</u> The removal of height limits in areas with Downtown zoning would apply to areas in and around downtown Spokane with zoning map designations of DTC, DTG, DTS, and DTU. The remainder of the proposal would apply citywide.

<u>SEPA:</u> A SEPA Checklist for this non-project action has been submitted. A Determination of Non-Significance (DNS) was issued on February 28, 2025, under WAC 197-11-340(2); the lead agency will not act on this proposal for at least a 21-day comment period which ends March 21, 2025.
