Cooperative Purchasing Agreement

032 2001-955

In accordance with ORS 279.015 (g), the City of Spokane, Washington and Klamath County agree to a cooperative governmental purchasing agreement for a street sweeper using Klamath County Board's competitively awarded contract.

Klamath County therefore extends the use of its contract to the City of Spokane, Washington to the extent provided by law and upon the following terms:

1. The vendor(s) agree to extend to the City of Spokane, Washington the terms and conditions of Klamath County's contract.
2. The City of Spokane, Washington accepts responsibility for compliance with any additional varying laws and regulations governing its purchases. Any purchase by the City of Spokane, Washington shall be effected by a purchase order from the City of Spokane, Washington and directed to the vendor.
3. Klamath County accepts no responsibility for the performance of any of the purchasing contracts by the vendor.
4. Klamath County accepts no responsibility for payment of the purchase price by the City of Spokane, Washington.

This agreement may be revoked at any time in writing by either party.
