### 5.0 POLICY

5.1 It is the policy of the Park Board to delegate signature and authorization authority to the Director of Parks and Recreation for Riverfront Park film showings as follows:

# 5.1.1 Park Board Approval Required.

- a. Master agreements by film producer.
- b. Initial agreement by individual film if the initial expected expenditure or revenue is greater than the then current minor contract level for City contracts.
- c. Changes in terms and conditions to agreements that are not normal or routine.

## 5.1.2 Park Board Approval NOT Required.

- a. Extensions / renewals of previously authorized existing film lease agreements.
- b. Changes to estimated expenditures and / or revenues due to higher than expected ticket sales.
- c. Changes in terms and conditions to agreements that are normal or routine.

#### 6.0 PROCEDURE

- 6.1 Film lease agreement documents shall continue to be processed in accordance with regular City procedures.
  - 6.1.1 The City Clerk shall attest the signature of the Director and the documents shall be kept on file in the Office of the City Clerk.
  - 6.1.2 Film lease agreement documents shall be approved as to form by an assistant city attorney.
  - 6.1.3 Film lease agreement documents shall be processed in accordance with department budgetary requirements.

### 7.0 RESPONSIBILITIES

The Director of Parks and Recreation shall administer this policy.
