# May Public Safety Committee Report

Reporting Period: May 1, 2013 through May 31, 2013

#### **2013 OVERVIEW**

**Complaints Received:** Since January 1, 2013: <u>53</u> complaints have been received by the Office of Police Ombudsman and forwarded to Internal Affairs. The complaints were for:

- 1 Selective Enforcement
- 1 Unlawful Entry
- 1 Gratuity
- 1 Harassment
- 1 Driving
- 1 False Arrest
- 5 Procedural
- 9 Demeanor
- 5 Excessive Force
- 28 Inadequate Response

**Complaints Referred:** Since January 1, 2013, <u>15</u> complaints have been referred to the following agencies:

- 11 complaints have been referred to the Spokane County Sheriff's Office
- 1 complaint has been referred to the Stevens County Prosecutor's Office
- 1 complaint has been referred to the Washington State patrol for follow up
- 1 complaint has been referred to the Spokane Transit Authority
- 1 complaint has been referred to the Spokane Streets Department

#### **CONTACTS**

Between May 1, 2013 and May 31, 2013 the Office of Police Ombudsman was contacted <u>128</u> times.

Since January 1, 2013 there have been <u>497</u> contacts received by the Office of Police Ombudsman.

#### COMPLAINTS

To assist in identifying where complaints are occurring, the Office of Police Ombudsman has divided the City into four quadrants. The north-south borderline is Sprague Avenue and the east-west borderline is Division Street.

Complaint outcomes are updated regularly and can be viewed at the Office of Police Ombudsman website at <a href="https://www.spdombudsman.org">www.spdombudsman.org</a> under the headings "Documents and Reports" and "2013 Received Complaints."

Between May 1, 2013 and May 31, 2013, 16 complaints were received.

- 1. Thursday, May 30, 2013: A **Harassment** complaint was received by the Office of Police Ombudsman. The Complainant advised that their life was put at risk as a result of an undercover police action. Also, according to the Complainant, they have been harassed by an Officer for the past five years. (N/A), (OPO # 13-53)
- 2. Wednesday, May 29, 2013: A **Demeanor** complaint was received by the Office of Police Ombudsman. The Complainant was not pleased with an Officer's response to a call involving a child with a mental health disorder. (N/W), (OPO # 13-52)
- 3. Tuesday, May 28, 2013: A **Demeanor** complaint was received by the Office of Police Ombudsman by phone. The Complainant advised that their adult grandchild was assaulted in a store parking lot and transported to a local hospital for treatment. An Officer responded to the hospital and made comments about the grandson to the Complainant that the Complainant took offense to and believed were inappropriate (N/E), (OPO # 13-51)
- 4. Tuesday, May 28, 2013: An **Inadequate Response** complaint was received by the Office of Police Ombudsman. The Complainant advised that they took a polygraph test at the request of an Officer. The Officer has since misrepresented the results of the test to CPS which has caused an unnecessary hardship for the Complainant. (N/A), (OPO # 13-50)
- 5. Friday, May 24, 2013: An **Inadequate Response and Demeanor** complaint was received by the Office of Police Ombudsman. The Complainant advised that their child was assaulted and Officers responded inappropriately and in a rude manner. (N/E), (OPO # 13-49)
- 6. Monday, May 20, 2013: An Excessive Force complaint was received by the Office of Police Ombudsman by email. The Complainant witnessed an incident in 2010 that they opted not to file a complaint about until they recently read an article in the newspaper regarding the officer being disciplined. (N/E), (OPO # 13-48)
- 7. Monday, May 20, 2013: A **Driving** complaint was received by the Office of Police Ombudsman through a referral from the Office of the Mayor. The Complainant advised they observed an Officer who appeared to be with the Officer's child at a local youth activity. The Officer was in uniform and driving a marked police car. The Complainant advised that the Officer's child appeared to be 9-10 years old and should be riding in the backseat, however, the Complainant watched as the Officer drove away with the child in the front seat of the police car. (N/E), (OPO # 13-47)

- 8. Friday, May 17, 2013: An **Inadequate Response** complaint was received by the Office of Police Ombudsman. The Complainant was involved in an altercation with their neighbor and during the altercation the neighbor assaulted the Complainant's adult child. The Complainant advised that the responding Officers failed to thoroughly investigate the incident and were rude. **((N/W), (OPO # 13-46)**
- 9. Friday May 17, 2013: A **Procedural** complaint was received by the Office of Police Ombudsman. The Complainant advised that they resell electronic equipment and they were arrested by an Officer for possession of stolen property. According to the Complainant, the property they sold to the Officer actually belonged to the Officer but had not been reported stolen. **(S/E)**, **(OPO # 13-45)**
- 10. Friday, May 17, 2013: A **False Arrest** complaint was received by the Office of Police Ombudsman. The Complainant advised that Officers falsified information to arrest their significant other for domestic violence. The Complainant advised that Officers then provided CPS with inaccurate information that led to the Complainant's infant child being temporarily removed from their custody. **(S/W)**, **(OPO # 13-44)**
- 11. Monday, May 13, 2013: A **Procedural** complaint was received by the Office of Police Ombudsman. The Complainant was arrested by an Officer, handcuffed and placed in the back seat of the police car. The Complainant advised that they struck their head and shoulder several times while being transported to jail. (S/E), (OPO # 13-43)
- 12. Friday, May 10, 2013: A **Demeanor** complaint was received by the Office of Police Ombudsman. The Complainant advised that an Officer at the Public Safety Building was rude and refused to take their complaint. The Complainant demanded to speak with the Officer's supervisor who then took the complaint. (N/W), (OPO # 13-42)
- 13. Thursday, May 09, 2013: A **Procedural** complaint was received by the Office of Police Ombudsman. The Complainant advised that their neighborhood was blocked off by the Police Department but alleges that this was not done in a consistent and fair manner. The Complainant was concerned that vehicles could enter and exit the neighborhood while pedestrians could not, which kept a child living at their residence from getting home. (N/W), (OPO #13-41)
- 14. Wednesday, May 08, 2013: A **Demeanor** complaint was received by the Office of Police Ombudsman through a referral from City Council. The Complainant advised a friend of theirs was arrested by Officers after the friend requested the Officers' names and badge numbers and the Officers refused to provide the information. (S/W), (OPO # 13-40)
- 15. Monday, May 06, 2013: An **Inadequate Response** complaint was received by the Office of Police Ombudsman by email. The Complainant alleges that they were threatened by a stranger. While the assailant was still in view, the Complainant flagged down a Spokane Police Officer but was told that no back-up was available at that time so the Officer could not apprehend the suspect. **(S/W), (OPO # 13-39)**

16. Thursday, May 02, 2013: A **Demeanor** complaint was received by the Office of Police Ombudsman. The Complainant advised that they called police to report that a person who had previously stolen electronic equipment from the Complainant was parked in front of their residence. The Complainant advised that it took Officers an hour to respond and by that time the suspect had left. The Complainant alleges that when they refused to open their door to speak with the Officers, the Officers became angry, threatened to kick in the door and arrest the Complainant. (N/E), (OPO # 13-38)

Between May 1, 2013 and May 31, 2013 4 complaints were referred.

- 1. Wednesday, May 15, 2013: A complaint involving a Parking Enforcement Officer was referred to the City of Spokane Streets Department for follow up.
- 2. Monday, May 13, 2013: A complaint involving the Spokane County Jail was referred to the Spokane County Sheriff's Office for follow up.
- 3. Thursday, May 9, 2013: A complaint involving Spokane Transit Authority security officers was forwarded to the Spokane Transit Ombudsman for follow up.
- 4. Tuesday, May 7, 2013: A complaint involving the Spokane County Sherriff's Office was referred to the Sherriff's Office for follow up.

## **INVESTIGATIONS CERTIFIED**

Between May 1, 2013 and May 31, 2013 **3** completed investigations were certified as timely, thorough and objective:

- 1. Friday, May 24, 2013: An **Inadequate Response** complaint was received by the Office of Police Ombudsman on March 14, 2013. The Complainant has a Protection Order and advised that an Officer arrested an individual for violating the order. After two convictions, subsequent violations are to be charged as a felony but the Officer only charged the violator with a misdemeanor. The Ombudsman confirms that the complaint was investigated through a timely, thorough and objective process. **(SPD IA # 13-021), (OPO # 13-19)**
- 2. Tuesday, May 14, 2013: An **Inadequate Response and Demeanor** complaint was received by the Internal Affairs Unit on March 14, 2013. The Complainant was involved in a dispute with three bicyclists riding bikes on the sidewalk. The Officer advised the Complainant that the Complainant's conduct could be construed as disorderly conduct and they could be arrested in the future for similar behavior. The Complainant was upset by the way the Officer handled the dispute. The Ombudsman confirms that the complaint was investigated through a timely, thorough and objective process. (SPD IA # 13-019)

3. Wednesday, May 8, 2013: An **Inadequate Response** complaint was received by the Internal Affairs Unit on March 5, 2013: The Complainant advised that an Officer failed to properly document and follow up an incident. The Ombudsman confirms that the complaint was investigated through a timely, thorough and objective process. **(SPD IA # 13-015)**


