

Reporting Period: November 1 – 30, 2022


## **Complaints/Referrals/Contacts**



#### **Highlights:**

In October, the Office of the Police Ombudsman (OPO) submitted 3 Commendations to SPD, 3 Complaints to Internal Affairs, 4 Referrals to various agencies and conducted 1 Mediation. Highlights include:


- OPO 22-28: A community member was frustrated at a lack of response from detectives regarding a burglary and physical assault that occurred in their home.
- OPO 22-29: A community member was concerned that an officer driving a marked police vehicle was driving dangerously for the road conditions.
- OPO 22-30: A community member was concerned that their friend was mistreated by officers who served their partner with a protection order.
- OPO 22-31: A community member is frustrated that when they call for service due to issues with their neighbor, they receive no assistance. They believe that this is discrimination.
- OPO 22-32: A community member wanted to thank an officer who took on their case in 2020 and it was solved.






