METER BAG (SPECIAL LOADING ZONE) PERMITS

USAGE: Spokane Municipal Code (SMC 16A.61.5703) provides for the creation of special loading zones within a legal parking space by placing an authorized bag over a regular parking meter and are for expeditious loading and unloading of commodities for a maximum of 30 minutes. When bags are leased or a lease is renewed, rules of use are provided. These rules will be strictly enforced by the City of Spokane Parking Services Team. Any violations of the rules may result in removal of the bag from the meter, cancellation of the permit, forfeiture of the bag deposit, and the issuance of citations. Food trucks, taxis, and mobile vendors are NOT eligible for meter bag permits.

ALL meter bag permits are issued by appointment **ONLY**. Please call (509) 625-6318 to schedule an appointment. Permits require a current City of Spokane Business License and method of payment (check, cash, or money order – NO credit/debit cards) at the time of issuance.

PRICING:

Commercial/Service Vehicles:

Daily Permit: \$15/meter daily (no deposit) 24 hour advance notice required
Monthly Permit: \$125/bag monthly PLUS \$25 security deposit
Quarterly Permit: \$350/bag monthly PLUS \$25 security deposit

News Media:

Yearly Permit: \$1000/year for first bag PLUS \$25 security deposit
Additional Permits: \$500/bag yearly for additional bags PLUS \$25/bag security deposit

Charitable/Non-profit:

Monthly Permit: \$60/bag monthly PLUS \$25 security deposit
Additional Permits: \$60/bag monthly for additional bags PLUS \$25/bag security deposit

COMMERCIAL LOADING ZONE PERMITS

USAGE: Spokane Municipal Code (SMC 16A.61.5703) provides for the use of Commercial Loading Zone (CLZ) Permits in marked Commercial Loading Zones. Use in any other zones or in metered stalls is prohibited. Commercial Loading Zones are for the expeditious loading and unloading of commodities only, for a maximum of 30 minutes. The decal must be displayed in the inside lower left corner of the front windshield on the vehicle for which it was issued. The decal must be permanently affixed to the windshield and those from prior years must be removed. When permits are issued or renewed, the rules of use are provided. These rules will be strictly enforced by the City of Spokane Parking Services Team. Failure to follow the usage guidelines will result in issuance of citations as appropriate. Food trucks, taxis, and mobile vendors are NOT eligible for meter bag permits.

ALL Commercial Loading Zone (CLZ) Permits are issued by appointment **ONLY**. Please call (509) 625-6318 to schedule an appointment. Permits require a current City of Spokane Business License, vehicle information (year, make, and license plate #), and method of payment (check, cash, or money order – NO credit/debit cards) at the time of issuance.

PRICING:

\$100/vehicle annually if purchased prior to June 30th
\$50/vehicle annually if purchased on or after July 1st
\$15/vehicle for qualifying transfer or replacement
\$15/vehicle for corrections to existing decals
No charge for state initiated license plate changes
