



Prior Year Complaint Totals, 2013-2017

- 2013: 204 Complaints (87 were inquiries)
- 2014: 169 Complaints (101 were inquiries)
- 2015: 109 Complaints (72 were inquiries)
- 2016: 78 Complaints (20 were inquiries)
- 2017: 66 Complaints (12 were inquiries)

Complaints have reduced by 68% since 2013.



Use of Force Update

2018 Non-Deadly Reportable Use of Force Incidents

From January 1-April 30, 2018, there were 31 non-deadly use of force incidents, including 6 K9 contacts and 25 other (e.g., TASER, neck restraint).

2018 Deadly Use of Force Incidents

From January 1-April 30, 2018, there was one deadly force incident.

Incident 2018-20045627 (Under SIRR investigation)

Incident 2018-20045627 occurred on March 12, 2018, in the 5300 block of North Regal. The Spokane Investigative Regional Response Team (SIRR) is currently investigating.

2017

Incident 2017-20185893 (pending Administrative Review Panel)

Incident 2017-20185893 took place on 9/18/2017, in the area of Monroe/Sinto. The Spokane Investigative Regional Response Team (SIRR) completed the criminal investigation. The Prosecutor ruled the shooting was justified. The SPD internal investigation is complete. The case is with the Administrative Review Panel.

Downtown Precinct Highlights

- The Downtown Precinct (DTP) hosted coffee with a cop in the River Park Square with coffee provided by Thomas Hammer.
- Downtown Neighborhood Resource Officers (NROs) worked the Bike Swap at the Fairgrounds, which is a charity event that funds Big Brothers/Sisters.
- With the return of good weather, DTP NRO's have resumed daily bike/foot patrols.
- Several DTP personnel, including Sergeant Jason Hartman, recently joined the Enhanced Crisis Intervention Team (ECIT) and attended training in May.
- Frontier Behavioral Health (FBH) recently received a grant to embed mental health professionals (MHPs) with SPD. One of those MHPs will be working full-time at the DTP. The MHP attended ECIT with our officers this month and will likely begin working out of the precinct sometime in June.







Downtown Precinct Significant Arrest -- Prolific Vehicle Prowler

Kyle Hull was identified as one of the Downtown's most significant prowlers in 2018. He was linked to a number of vehicle prowling and subsequent trafficking in stolen property cases along with his girlfriend. Although a primary problem for Downtown, they travel all over in stolen vehicles and have been linked to cases in the Valley and Northside. SPD recently booked Hull for Theft of a Motor Vehicle in the Valley for a car theft that occurred Downtown near the Steam Plant. He was released the next day. SPD arrested him during an enforcement special at the House of Charity where he was in violation of a Domestic Violence order with the same girlfriend and partner in crime. Clearly, when he is in jail, our vehicle prowling problem Downtown diminishes significantly. Hull has remained in jail since April 2, 2018 on an \$11,000 bond and our vehicle prowling numbers have remained low.
