I was assigned to **Officer Joe Dunsmoor.** I joked with him that he must be on probation or something as he drew the short straw and got me! We had a great day together, and I think by the time we were done that he enjoyed having me around. Your team has a an incredibly difficult job, and they handle it with the utmost professionalism. They were great with the people that they stopped with drug concerns. They showed empathy, they showed humor, they remembered the names of those (and their dogs!) that they had dealt with before, and tightened things down when necessary. They also worked really well as a team.

Officer Brett Spring came to my house to inform me of the death of my brother. Officer Spring was compassionate and professional. My brother died unexpectedly. He informed me what steps would be taken and who would be calling. I just want to let you all know that your officers are caring, compassionate and professional.

Deadly Force Incidents (Officer-Involved Shootings)

2023

From January 1- July 31, 2023, there was one deadly force incident.

Incident 2023-20088146 (Pending Criminal Investigation)

Incident 2023-20088146 took place on May 10, 2023, in the area of 5th and Browne. The Spokane Independent Investigative Response (SIIR) is conducting the criminal investigation.

2022

From January 1- December 31, 2022, there were five deadly force incidents.

Incident 2022-20012711 (Pending Deadly Force Review Board)

Incident 2022-20012711 took place on January 24, 2022, in the area of 2400 E. Desmet. The Spokane Independent Investigative Response (SIIR) completed the criminal investigation. The Spokane County Prosecutor's Office completed their review and found the shooting to be justified. The Administrative Investigation is complete and will be scheduled for a Deadly Force Review Board.

Incident 2022-20134271 (Pending Criminal Investigation)

2022-20134271 took place on August 3, 2022, in the area of 2nd and Sheridan. The Spokane Independent Investigative Response (SIIR) is conducting the criminal investigation.

Incident 2022-20156670 (Pending Criminal Investigation)

2022-20156670 took place on September 4, 2022, in the area of 2900 E. Wabash Avenue. The Spokane Independent Investigative Response (SIIR) is conducting the criminal investigation.

Incident 2022-20184192 (Pending Criminal Investigation)

2022-20184192 took place on October 16, 2022, in the area of 100 S Cedar. The Spokane Independent Investigative Response (SIIR) is conducting the criminal investigation.

Incident 2022-20214924 (Pending Prosecutor Review)

2022-20214924 took place on December 4, 2022, in the area of Morton and Illinois. The Spokane Independent Investigative Response (SIIR) completed the criminal investigation. The case is with the Prosecutor's Office.

Hiring and Recruiting

SPD Holds Third Basic Law Enforcement Academy (BLEA)

2023 is the first year to have three BLEA sessions in Spokane. SPD has eight new hires who were sworn in on August 14, 2023. We welcome Jacob Collins, Andrew Willis, Kendall Stonebraker, Alexzander Bishop, Keilah Martin, James Welty, Spencer Clouse, and Drew Helsper to the Spokane Police Department.





Recruiting

- SkillBridge Program: SPD is now participating in the Department of Defense's SkillBridge program. SkillBridge provides SPD with direct access to a highly skilled applicant pool – volunteer/intern applicants who are transitioning from military service to civilian life. These applicants are paid fulltime with entitlements from their military branch, while they are given an opportunity to train/job shadow, apply, and process with SPD for up to six months. SkillBridge will help SPD find qualified applicants for commissioned and non-commissioned positions.
- New Lateral Officer Package: For experienced officers coming from other departments, their total years of law enforcement experience will be used to calculate their vacation and sick time accruals once they join SPD. Laterals will accrue vacation, sick time and longevity pay at the rate of their experience upon joining the ranks of SPD. They will receive a 120-hour sick leave bank upon being hired.
- SPD updated its recruiting materials with the salary increases and incentives for laterals. The website now has more information to recruit potential officers.

2023 Reserve Academy

The 2023 Reserve Academy is midway through the course. There are seven Reserve applicants in the Academy currently. Volunteers from our community complete a rigorous program to become a Reserve Officer. Applicants must pass a background check, physical ability test, a polygraph, oral board, psychological testing, medical screening, and a review by the Chief of Police.

Applicants then attend the 370-plus hour Reserve Officer Academy on evenings and weekends. The program culminates with a certification examination administered by the Washington State Criminal Justice Training Commission prior to graduation. Reserve Officers continue monthly training and volunteering to maintain their status.



Drug Education for the Community



On July 11, SPD Officer Mike Thomas led school administrators, nurses, and resource officers in a Drug Impairment Training for Education Professionals (DITEP) at the Talbott Event Center, organized by Amy Lutz, NEWESD 101's Public Health Program Specialist.

The free workshop equipped attendees with knowledge for recognizing and evaluating students who are impaired by drugs and/or alcohol to aid in regional substance abuse prevention and treatment intervention efforts.

Noteworthy Arrests

SPD seizes multiple guns, thousands of drugs, and more than one hundred thousand dollars in cash, in a major drug distribution investigation

On 8/3/23, The Spokane Police Department's Violent Crimes Task Force and the Special Investigations Unit, with the assistance of SWAT, executed several search warrants at multiple locations in Northwest Spokane, resulting from an ongoing criminal investigation. Investigators seized six handguns including one stolen handgun, a large amount of ammunition, approximately 8 to 10 thousand illicit fentanyl pills, and approximately \$120,000 in cash.



Jonathan Smith (36) was arrested and booked into the Spokane County Jail for Possession of Controlled Substance with Intent to Sell and Possession of a Stolen Firearm. Additional arrests in this case are pending. The Spokane Police Department is committed to combating the fentanyl epidemic and the violence and devastation that accompany drug use and delivery.



Sector Updates

Baker (Northeast) Sector – Coffee and Conversation put on by Cops & Communities



Officers enjoyed connecting with the community in North Spokane at Starbucks at the Cops and Conversation event on August 4, 2023.

Northeast Precinct Captain Steve Wohl served coffee in the drive-through during the event. He said, "Although many were surprised to see an SPD uniform as they came up to the window, I was overwhelmed by the amount of support for SPD that was shared with me as I handed out drinks. I often heard that they knew we were understaffed, but wanted to thank us for the job we do. These quick impromptu meetings resulted in great conversation."

National Night Out Against Crime

National Night Out is an annual community-building campaign that promotes police-community partnerships and neighborhood camaraderie to make our neighborhoods safer, more caring places to live. National Night Out enhances the relationship between neighbors and law enforcement while bringing back a true sense of community. It provides a great opportunity to bring police and neighbors together under positive circumstances. SPD had a great time connecting with community members and talking about safety. SPD Leadership from each sector participated in the festivities. Spokane C.O.P.S. Staff and volunteers, Chief Meidl, Mayor Woodward, SPD officers and volunteers, Councilmember Cathcart, representatives from the U.S. Attorney's Office, and many more had a great time meeting with neighbors. Thank you to Spokane C.O.P.S. for carrying on this tradition.

Police Activities League 2023

The 10th season of the Police Activities League (PAL) program took place at A.M. Cannon Park, Friendship Park, and Grant Park in July and August 2023. The PAL program was created in 2013 to help build trusting relationships between at-risk youth and local law enforcement. PAL offers positive programs such as soccer, football, basketball, lawn games, art activities, and educational activities. Youth enjoyed presentations from various Spokane Police specialty units (K9, SWAT, Drone Unit), Spokane C.O.P.S. Mounted Patrol Unit (horses), and nutrition education and fresh fruit. PAL is made possible by partnerships with many organizations. PAL allows police officers and community leaders the opportunity to mentor youth and provide education (e.g., drug and alcohol education, STEM, safety education).

The PAL program is made possible by the Spokane Police Foundation.





The drug/alcohol/tobacco education the PAL program provides is needed more than ever, as we are experiencing an increase of drug overdoses in our community. The federal Drug Enforcement Administration (DEA) selected Spokane County as one of 11 locations across the nation with enough fentanyl overdose deaths to warrant special attention. The DEA joined PAL as a partner in 2023 and is enhancing the education component. The DEA funded the martial arts portion of PAL. Throughout the season, students focus on five core values: honesty, integrity, leadership, sportsmanship, and respect. Officers and community leaders identify youth modeling the core values, as do their peers, and nominate those youth for recognition at the end of each session.
