Summary:

On 04-11-13 at approximately 1956 hours Ofc. Stone and Ofc. Jones were dispatched to a domestic violence call at 2914 E. Diamond #1 in Spokane, WA. It should be noted that Ofc. Stone had a Spokane Police Explorer, Stephanie P. Scheurer, riding with him on this shift.

The complainant, Ethel Laststar, advised she could hear a male screaming at his wife at the listed location. She described the male suspect as a black male in his 40's, approximately 5'09" tall, with a thin build, wearing a gray sweatshirt and sweatpants. Laststar requested to remain

anonymous in the call.

Ofc. Stone arrived at the listed location and contacted a male in front of the location that matched the suspect description. The male, identified as Terrell O. Dike, was yelling and stated that he was just inside apartment #1. Dike continued to walk towards apartment #1 and did not appear to want to talk to Ofc. Stone. Ofc. Stone told Dike to sit down so he could investigate a domestic violence call. Dike refused to cooperate and kept walking toward the apartment entrance. Ofc. Stone had to grab Dike's arm and order him to sit down on the step to the apartment in order to control his movement. Dike complied with this action.

At this point, Dike's girlfriend, Crystal B. Werner, walked out of the apartment with their infant and sat down on the steps next to Dike. Dike acted very nervous, continued to look back towards the front door, and looked as though he may try to run.

#3a #3a Dike tried to stand up again claiming that he needed to go to the bathroom. Ofc. Stone ordered him to sit down again. Again, he had to grab Dike's hand to get him to sit back down. Based on Dike's actions and Ofc. Stone's observations, Ofc. Stone was concerned that Dike was going to fight or run. Ofc. Stone was concerned enough with Dike's actions that he checked with radio to see how far away Ofc. Jones was from the call.

Ofc. Jones arrived and he could hear Dike repeating to Ofc. Stone that he had to go to the bathroom really bad. Dike's intensity and mannerisms led Ofc. Jones to believe that Dike wanted to leave for another reason.

Ofc. Stone advised Dike that he had several warrants for his arrest and was going to be detained.

At this point both officers knew that Dike had warrants for his arrest and they were on a domestic violence call. Domestic violence calls can be volatile, it was dark out, and the suspect had not been checked for weapons. Officer Stone knew that these warrants were for domestic violence. Due to Dike's statements and actions, both officers perceived that Dike may try to flee the scene. In fact, Ofc. Stone had to use verbal and physical control to get the suspect to comply with him on two prior occasions during this short period of time.

The suspect tried to stand up and move towards his apartment before officers could make physical contact with the suspect. Ofc. Jones told Dike he was under arrest and Dike pulled his arms away to prevent being placed in handcuffs. Dike grabbed a pole on the porch right next to his girlfriend and their infant child. Dike refused to let go of the pole and continued to resist while laying on top of the female and her infant child. The female began screaming as the suspect continued to resist while laying on top of them. Given the totality of the circumstances in this tense, uncertain, and rapidly evolving situation, Ofc. Jones delivered several closed fist technique strikes to the suspect's abdominal area. This technique was applied in an attempt to cause a momentary disruption in the mental process of the suspect in order to facilitate a control technique. This technique appeared to be successful and the suspect let go of the pole. Despite continued resistance, officers were able to take him to the ground. Once on the ground, they were able to gain control of him and handcuff him in the prone handcuffing position. It should be noted a small hammer was located in the suspect's pants pocket during a search incident to arrest. The suspect claimed he carries the hammer for self defense due to the neighborhood he lives in.

I spoke to Explorer Scheurer at jail. She provided a similar description of the incident. See Ofc. Stone's report for her statement.

I spoke to the suspect, Terrell Dike, at jail. He explained that he was arguing with his girlfriend, Crystal Werner, tonight because they were both lying to each other. He confirmed he knew he had warrants for his arrest prior to police contacting him. He admitted reaching out and grabbing the porch railing after the police told him he was under arrest for his warrants. He did not have an explanation for this reaction and he denied using drugs or alcohol tonight.

I asked Dike if he had been arrested before. He told me his first arrest was for being an accessory to a robbery in Detroit, Michigan. He went on to say that he has been arrested approximately 5 to 10 times in his life. I told him that he should know better than to grab a pole

to keep from going to jail at this point in his life. He stated, "I know better."

I asked Dike about the force that was used to take him into custody. He explained that he was punched in the abdomen area several times and taken to the ground. He did not have any visible injuries to his abdomen and did not complain of any abdominal pain. He showed me a small abrasion on his left cheek along with a minor amount of swelling in the same area. He said the injury to his face occurred when he was taken to the ground.

I spoke to Werner at her residence. She informed me she came down to the front porch when Dike called to her through the front door. She also confirmed that they were arguing about lying to each other tonight. Werner sat down next to Dike on the porch with her child in her arms while officers spoke to Dike. When the officers told him he had warrants for his arrest she thought Dike was going to run into the apartment because he moved backwards. Dike grabbed the pole above her with one hand and the police moved in to get control of Dike. She said she could not describe what was going on at that point because there was a "pile", on her until the police officers took him to the ground.

Werner added that she knew Dike did not want to go to jail for his warrants but she was, "Shocked he acted that way." I asked Werner if Dike was using any drugs or alcohol today. She stated that he was smoking marijuana earlier and had part of one beer tonight. Werner said she did not want to back track on her story but she did not want to say anything that would get Dike in trouble because they are still trying to get back together. Werner confirmed that her and her child were not injured during the incident.

I spoke to Laststar by phone. She confirmed she did not see or hear the contact between the police officers and Dike tonight.

Cpl. Prichard photographed the injury to Dike's face and the lack of any other visible injuries. Cpl. Griffin photographed the scene.

The injury to Dike's face is consistent with the statements provided and with being taken to the ground on a rough concrete / dirt surface. Given the totality of the circumstances, the amount and type of force used appears consistent with the reasonable officer standard and department policy. See the attached reports for further details on the call.

Reviewer comment:

Officers were responding to the violent reaction by the suspect. The suspect was resisting and attempting to flee. He was also posing a threat to the female victim and infant as he was having physical contact with both of them while resisting the officers. Additionally, the suspect wanted to get back inside the apartment for the stated reason of wanting to use the bathroom. However, based on his actions and the active arrest

warrants for past DV crimes, officers were understandably suspicious as to the suspect's motives. Their immediate actions were necessary to control the suspect and the situation before any serious injuries could occur to any involved parties.

NARRATIVE					

On 4/11/2013 at approximately 1956 hrs, Explorer Scheurer and I were dispatched to 2914 E Diamond #1 for a DV. Dispatch advised that a neighbor heard a male screaming at his wife in #1. The complainant said the suspect was a black male 5'9" thin, wearing a gray sweatshirt and sweatpants. The female was named Crystal.

I arrived onscene and walked up to the apartment. I did not hear any arguing as I approached. I knocked on #1 and received no answer. Seconds later, I heard a male yelling at someone along the west side of the apartment complex. A black male (later identified as Terrell Dike) emerged from the west side of the building still yelling at someone. The male matched the description as the suspect. I asked Dike where he was coming from. Dike said, "I was just inside #1." Dike was walking towards the entrance to #1. It was obvious that Dike did not want to talk to me.

I told Dike to sit down on the steps so I could investigate the possible DV. Dike kept walking towards the entrance and refused to cooperate. I grabbed onto Dike's arms and made him sit down on the steps. At this point, the female (identified as Crystal Werner) exited #1 with a small infant. Werner sat down next to Dike.

Werner and Dike were on the second step from the top of the stoop (4 steps). The entrance to #1 was directly behind them approximately 3 feet away with the door open. Dike was very nervous. I could tell his body language that he did not want to be sitting there. He kept looking around. One of

his feet were up so he could turn and run quickly if need be. Dike kept looking back towards the door saying, "I have to go to the bathroom really bad. Can I run upstairs and go to the bathroom really quick?" I had to tell Dike multiple times that he could not go to the bathroom and that he just needed to be patient.

Werner and Dike both told me that it was a verbal argue only and nothing physical took place. They had recently got back together and were working things out. Dispatch advised me that Dike have several DV warrants. Dike continued with his nervous behavior - looking around and trying to see if I would let him go to the bathroom. Dike tried to stand up again, but I told him to sit down and had to grab his hands again.

I had a feeling that Dike was going to either fight or run if he knew that he was going to be detained. I was still alone at this point with my backup coming. I got on the radio and asked to see how far off OFC Jones was since Dike was getting more and more agitated and nervous as time went on.

As soon as OFC Jones arrived, Dike became more nervous and kept asking, "Why does there need to be another cop here. For an argument? No need for another cop."

I told Dike that he had several warrants and that he was going to be detained. Seconds after I said that Dike was going to be detained, OFC Jones said that Dike was under arrest. As soon as OFC Jones and I moved in to gain control of Dike's arms, Dike stood up and swung his arms towards his right side to resist and escape being detained. Dike tried to run towards the south. Dike had grabbed onto the metal pole which was right next to Werner and the infant. Dike dove over Werner and the infant in order to try and avoid LE. Dike refused to let go of the pole and was kicking his feet towards OFC Jones and I. Dike continued to resist by kicking his feet and using all of his arm strength to hold onto the pole as he had all of his body weight on Werner and the infant.

I was yelling at Dike to stop resisting. I advised dispatch that OFC Jones and I were fighting with Dike. Dike continued to resist and not cooperate with commands given to relax and stop fighting. Dike finally let go of the pole, but still continued to fight and pull away in an attempt to escape. At this point, the situation was escalating. A crowd was gathering outside from the yelling and Dike had not been frisked for weapons yet due to the rapidly evolving situation. I did not know what Dike's intentions were - trying to escape or continue the fight possibly pulling out a weapon.

OFC Jones and I were able to gain control of Dike's arms and escort him to the ground into a prone handcuffing position. I told Dike again that he was under arrest and needed to stop resisting. Dike continued to struggle and fight. His arms were tensed up and he was using his feet to try and kick away from us. We were finally able to get Dike's hands into handcuffs (DL). Dike continued to mouth off and yell at LE this entire time. Dike was in custody for resisting arrest and his two warrants (3 counts of City Assault DV and 1 count of Interfering with a DV reporting). Dike's behavior and actions drove the response from LE. If Dike would have just cooperated then there

would have been no need for the resisting charge; however, Dike refused to cooperate. Dike put Werner and his infant child in danger by standing over them and refusing to cooperate with LE.

Dike was transported and booked into Spokane County Jail by OFC Jones. See his report for further statements and details.

I contacted Werner again and asked her what Dike's problem was. Werner stated that Dike knew he had warrants and did not want to go to jail. Werner stated that Dike's behavior was out of control, but that she still loved him.

Explorer Scheurer told me the following:

Scheurer noticed immediately that Dike was acting very nervous and did not want to be around LE. Dike was not listening nor following commands very well. Dike kept asking to go inside and had to be grabbed by OFC Stone who had asked him to sit down multiple times. OFC Stone had to escort Dike to sit down. Dike continued to act nervous by looking around.

Scheurer said that something did not feel right the way Dike was acting. OFC Stone told Dike that he was going to be detained on his warrants and then seconds later OFC Jones say that Dike was under arrest. Dike immediately stood up and turned to either run or fight. Dike refused to cooperate with commands and grabbed onto a metal pole. Dike refused to let go of the pole. He was kicking towards LE in an attempt to escape. Officers had to end the situation quickly since a crowd was starting to gather outside.

Officers got Dike off of the pole and escorted him to the ground where he continued to fight and resist. OFC Jones and OFC Stone were finally able to get Dike in custody. The Officers used the appropriate use of force to end the situation quickly and ensure that no one would be hurt. Scheurer did not have anything further to add.

Sgt. Keller was advised of the situation and met us at Jail. There was no PC to arrest Dike or Werner on the original call - yelling. It was a verbal argue only.

On 04/11/2013 at 2000 hours I responded with officer Stone to 2914 E. Diamond Ave #1 on report of a DV.

After arriving on scene I observed that officer Stone had two people detained on the front porch of the address. A male and a female. They were both sitting down on the steps.

As I approached I could hear the male telling officer Stone that he had to go to the bathroom really really bad. The male had already been identified by officer Stone as being Terrell O. Dike. Terrell kept saying that he had to go to the bathroom really bad and he needed to go. Officer Stone told him that he needed to wait. The intensity and manner at which Terrell was trying to leave led me to believe that the male had a completely different reason for wanting to get away from myself and officer Stone. At this time officer Stone advised Terrell that he had some active arrest warrants, which I was unaware of, and that we were detaining him. At the same time both officer Stone and I each went in to grab Terrell's arms in order to place him into handcuffs. Before officer Stone and I could even make physical contact with Terrell he started to stand up, and back up away from us. Terrell also started pulling his arms away from us as we attempted to grab his arms. At this time I yelled at Terrell that he was under arrest and for him to place his hands behind his back. Terrell refused to comply and was tensing up his arms and pulling them away from us to prevent being placed into handcuffs. I was unable to place his arm behind his back due to his continuing resistance. It was at this time that I attempted to pull Terrell off of the steps and away from his fiance who was holding their baby. Terrell reached over both his fiance and his baby and grabbed hold of the metal porch railing and would not let go. He was physically laying up against his fiance and his baby while he refused to comply and resisted arrest. At this time Terrell's fiance started screaming. I kept yelling at Terrell to "let go!" and to place his hands behind his back. Terrell kept resisting and would not comply with our repeated lawful orders. At this time I delivered 2-3 closed fist strikes to Terrell's mid section as a momentary diversion tactic in hopes that he would let go of the railing and comply with our orders to place his hands behind his back. After delivering these strikes, Terrell did finally let go of the railing. After he let go of the railing he kept refusing to place his hands behind his back. At this time both officer Stone and I took Terrell down to the ground where we were finally able to place him into handcuffs. I advised Terrell that he was now also under arrest for Resisting Arrest.

As I was searching Terrell incident to arrest I located a small hammer in his front right pants pocket. I asked him what it was for. He told me that he carried it because of the neighborhood he lived in and it was for self defense.

Sgt. Keller was notified and met us at the jail. Cpl. Prichard responded to the jail for photos. I transported Terrell to the Spokane County Jail where he was booked in on his numerous warrants
