Summary:

On 05-16-13 at approximately 1828 hours Ofc. K. Reese and Ofc. L. Fairbanks were dispatched to a domestic violence call at 1802 W. Gardner Ave. #7 in Spokane, WA. Dispatch advised an anonymous complainant reported a male and female yelling at the listed location. The complainant heard banging and the female say, "Ow." The complainant advised both people live together. The complainant described the male as a black male in his 50's, 5'08", thin, and said he goes by the name of Francis. The complainant described the female as a white female, about 49 years old, 5'05", heavy build, and said she goes by the name of Tina.

Ofc. Reese was close to this call when it came out and quickly arrived at the scene. He knew his backup, Ofc. Fairbanks, was responding from the other side of town. (5400 N Market) Ofc. Reese slowly approached the address in order to gather information without trying to contact the involved parties until he had backup.



A male in front of #7, later identified as the suspect, Francis Harris, looked over the railing and spotted Reese at the apartment complex. The male matched the suspect description and Reese contacted the suspect.

Ofc. Reese explained that he was investigating a possible fight at the listed location and asked the male for his name. The suspect said his name was, "Frank." Harris was wearing loose fitting baggy clothes. Harris immediately put his hands in his pockets and Ofc. Reese quickly told him to remove his hands from his pockets. Harris was scanning, fidgety, looking around, and constantly rubbing his hands together. Harris put his hands back in his pockets again while looking around and moving away as if he was making a plan to escape. Ofc. Reese ordered him to remove his hands again and was trying to buy time until his backup arrived. Harris complied for a moment but put his hands back in his pockets a third time.

Ofc. Reese knew Harris was at the location of the reported domestic violence call and matched the description of the male wanted on a felony warrant. Domestic violence calls can be dangerous and unpredictable. Harris was wanted for a warrant related to 1st degree robbery, a violent crime where force or weapons are used during the commission of the crime. Harris refused numerous commands by Ofc. Reese to keep his hands visible and continued to move his hands into the pockets of his loose fitting pants where a weapon could easily be concealed. Harris also made movements that indicated to Ofc. Reese that Harris was planning his escape.

Ofc. Reese ordered Harris to place his hands on the back of his head so he could check him for weapons. Ofc. Reese moved in to control Harris' wrists and Harris pulled his hands in towards the front of his chest. Ofc. Reese told Harris to put his hands behind his back because he was being detained and has a warrant for his arrest. Harris continued to actively resist Ofc. Reese's attempts to move Harris' arms behind his back. Ofc. Reese continued to give verbal commands for Harris to relax and listen.

Harris tried to pull away and Ofc. Reese placed Harris in a level one neck restraint. Harris tried to escape the neck restraint by pulling away and trying to grab at Ofc. Reese's right arm. Ofc. Reese moved Harris to the ground to further control the suspect's movements. Harris tried to pull Ofc. Reese's arms away and also tried to reach into the cargo pocket of his pants. Ofc. Reese did not want to lose control of the suspect and did not know if the suspect was trying to

access a weapon in his pocket. Ofc. Reese tried to apply a level two neck restraint but he was unable to render the suspect unconscious because he had to reposition himself when the female, Chopot, exited the apartment door and began screaming.

Ofc. Fairbanks arrived and observed Ofc. Reese on top of Harris and Harris was on the ground in the prone position. Harris had his hands on the ground in front of his chest and was pushing up to the point that there was distance between himself and the ground. Ofc. Fairbanks tried to gain control of the suspect's right hand but the suspect pulled away from him. Eventually, Ofc. Fairbanks was able to get the suspect's right hand behind his back and place it into a handcuff. Ofc. Reese gained control of the suspect's left hand and they handcuffed Harris in the prone handcuffing position.

The investigation determined that no domestic violence crime occurred on this date. Harris was arrested for his outstanding felony warrant and obstructing. Although Harris never lost consciousness, he was transported to Deaconess Hospital to be evaluated as a precaution so he could be cleared for jail booking.

Ofc. Fairbanks contacted a witness at the scene, Casey Blaine. Blaine observed Ofc. Reese contact Harris when Harris stepped out of apartment #7. He heard Ofc. Reese ask Harris if he had any weapons. He heard Harris reply that he did not have any weapons. Blaine observed Harris put both of his hands in his pockets. Blaine heard Ofc. Reese tell Harris not to put his hands in his pockets. Blaine observed Ofc. Reese grab the suspects hands and the suspect pull his hands into his chest, away from the officer. Ofc. Reese took the suspect to the ground and the suspect continued to tense up. Blaine heard Ofc. Reese tell the suspect to relax. Blaine stated the suspect was handcuffed when other officers arrived.

I spoke to Chotpot at the scene. She told me she exited her apartment and observed Ofc. Reese struggling with Harris. Ofc. Reese had his arm around Harris' neck and she did not know what was going on. She claimed she did not see what took place prior to this moment and she did not see anything else because she went back in her apartment.

I spoke to the suspect, Harris, at the hospital. Harris claimed he was familiar with the arrest process because he has been arrested more than 20 times and he spent 22 years in prison. Harris admitted he knew he had a warrant for his arrest and he did not want to go to jail today. He admitted resisting Ofc. Reese but denied fighting with him. Harris did not have any visible injuries. He claimed his neck was sore from the neck restraint and his shoulders were sore from being taken to the ground. Cpl. N. Lundgren photographed the lack of any visible injuries.

Based on the totality of the circumstances, the amount of force used by Ofc. Reese and Ofc. Fairbanks was reasonable, appropriate, and within policy.

I responded to a DV at 1802 W Gardner #7 on May 16, 2013 at 1828 hours. An Anonymous caller was reporting hearing a male and a female arguing and yelling at each other. The caller reported that the female was saying ouch and there was banging sounds going on. The caller said that the male and the female live together in the apartment. The male is named Francis and he is a black male around 50 years old about 5'8" tall. The female was named Tina and she was described as 49 years old, 5'5" and heavy.

I was close to this call when it came out so I arrived at the location quickly. Officer Fairbanks was my cover officer and he was responding from 5400 N Market. #3a

I slowly approached the address knowing how far off Officer Fairbanks was. I saw several people outside of their apartments and everything appeared to be calm and normal. I approached a little further and noticed that the door was shut to apartment #7. I could not hear any screaming or fighting coming from that apartment. I asked a few people outside of the apartment if they heard any arguing or fighting and they all said no. I was staying back and a female in apartment #4 opened her door and pointed upstairs to apartment #7. Apartment #4 was on the second level and was directly below apartment #7. Apartment #7 was on the third level. The female in #4 waved for me to come contact her.

I went and contacted the female in apartment #4 and went into her apartment. She said that the male and the female had been arguing and there was banging sounds coming from upstairs. She said that she did not see anything, only heard the fighting. I could hear a male and a female yelling at each other but I could not make out what they were saying. I heard the banging noises. It sounded to me like they were still fighting and arguing. I updated dispatch that they were still fighting and to start a third officer.

I then watched as a black male with a pit bull walked up the stairs to apartment #7. I could then hear the black male and another male, later identified as Francis Harris talking directly outside of #7. The female in #4 wanted to remain anonymous for fear of retaliation and did not want to be named in this report. I stepped out of her apartment so that she could remain anonymous as much as possible. I stayed back against the apartment outer wall and listened to the two males conversation while I waited for other officers.

About a minute or so passed by and then Francis looked over the railing and saw me standing there.

I had to make contact at this point, so I walked up the stairs and made conversation with Francis and the other male. After some small talk, I told the other male that I needed to talk to Francis about a fight at the location. The male left with his dog. I asked Francis what his name was and he said Frank. Francis immediately put his hands in his pockets and I quickly asked him to keep his hands out of his pockets while we talked. Francis was constantly scanning and looking around. His hands were fidgety and he kept rubbing his hands together. Francis told me that there was no one else in the apartment and that he had not been involved in any fight or argument.

Francis then put his hands back in his pockets and I again asked him to take his hands out of his pockets. Francis was slowly moving away from me as he kept changing his stance towards me. He also continued to look away from me. Based on my training and experience, Francis appeared to me to be making a plan to run. He was trying to covertly move away from me while at the same time trying to look around and see what his options were. It was clear to me that he was making a plan to get away from me.

Francis put his hands on the back of his head and stretched as he looked away from me. Francis was wearing cargo style pants that were baggy with pockets on the sides. He was wearing a button up shirt that was also very baggy. At this point, I was trying to buy time until other officers arrived at the location before I went hands on with Francis. I knew that Francis matched the description of Francis Harris who had the felony warrant. Francis also stated his name was Frank and Francis had history with the female at apartment #7. I was contacting Francis, but I still needed to contact Tina to see if there was a DV crime at the location. When I initially contacted Francis, the apartment door of #7 was open and Francis shut it.

Francis took his hands off his head and put them in his pockets again. I asked him if he had any weapons on him and he said no. I told him to put his hands on the back of his head and that I was going to frisk him for weapons. I moved toward Francis and grabbed his right wrist. I tried to assist Francis in putting his hands behind his head and he pulled both of his arms in front of him and in towards his chest. I then told Francis, put your hands behind your back you are being detained. I told him that he had a warrant and I was also detaining him while I investigated the DV call. I never got to do a weapons frisk because he tensed up and pulled his arms in towards his chest.

Francis was still not complying with my commands to put his hands behind his back and he was actively resisting my attempts to pull his arms behind his back. I repeatedly told Francis to relax and not to fight. I told Francis that he had a warrant and to relax. I kept trying to pull on his arms and get his hands behind his back. I was standing directly behind Francis and he was up against the railing looking out away from the building. I had control of both of Francis' wrists. A male was on the third floor a few apartments down. He was yelling at Francis to relax and not to fight me. I also told Francis again to relax and to listen to what the guy was saying and not fight. Francis continued to resist me putting his arms behind his back and then started trying to peel away from me. He was trying to get free from my grip on his wrists and began trying to pull away.

I was by myself and on the third story of an apartment complex. Francis was trying to get away from me and trying to pull away from me. I quickly put Francis in a level one neck restraint and attempted to control him as he tried to get away. After struggling with Francis trying to get away from me, he then started grabbing at my right arm. I did not want to get into a stand up fight with Francis on the third story of this building because of the low railing and potential for falling off the third floor. While maintaining the level one neck restraint, I did a take down on Francis and forced him to the ground. We landed with Francis on his right side and me directly behind him still maintaining the level one neck restraint.

I had not attempted the level two neck restraint at this point and was merely using the level 1 for control of Francis. While on the ground Francis grabbed my left arm with his left arm and pulled my left arm away from my right arm. At the same time Francis grabbed my right arm with his right arm and was trying to pull my arms away from his neck. I then went to a level two neck restraint and applied pressure. Francis started trying harder to pull at my arms and get away. He then reached his right hand down into his right side cargo pocket. I pulled his upper body and his neck to the left to get his right hand away from that pocket since I didn't know if he was reaching for a weapon. I continued to apply pressure.

I applied pressure for about 10 seconds and it appeared that Francis was about to go unconscious when the door to apartment #7 opened. I looked back and saw Tina standing in the door way. She was screaming at me to get off Francis and that he didn't do anything wrong. I yelled at her to get back and she did. As I turned, I must have released the pressure on Francis' neck and he did not go unconscious. He was moving and actively trying to get away from me during this entire incident. I went back to applying pressure to Francis while keeping Tina back away form me. I was also scanning the area looking for other subjects who may try and help Francis in this incident. People heard the commotion and came out of their apartments on the second and third floor to see what was going on.

I then looked and saw Officer Fairbanks coming up the stairs. Once I saw Officer Fairbanks, I stopped applying pressure and just held Francis down. Officer Fairbanks assisted me in handcuffing Francis. Even with Officer Fairbanks' help, Francis was still resisting putting his arms behind his back and he was trying to pull his arms in towards his chest. Francis did not have any visible injuries from the incident.

I contacted Tina who said that her and Francis live at the location together. She said that they were not arguing and that there was no fight. She said that she was not assaulted and nothing was broken. I looked around the apartment and everything was in order and I did not see anything broken. Tina did not have any signs of injury. There was no one else in the apartment. I explained to Tina what was going on and why Francis was going to jail.

Sgt Keller responded to the location and I updated him about the incident. I transported Francis to Deaconess for medical clearance to go to jail. I had a Corporal respond to Deaconess and take photos of Francis and his lack of visible injuries. Francis said that his right should hurt and that his throat was sore like he had strep throat. Francis told me that he had injured his right shoulder in the past. He was treated at the hospital and released to go to jail. I then transported and booked Francis into jail for his outstanding warrants and obstructing.

I was in the uniform of the day displaying a badge. I had rug burns from rolling around with Francis on the ground. The Corporal took photos of my injuries. My right elbow and right shoulder were sore from the incident but did not require medical treatment at this time. See related reports for further.

I could also see a female next to Ofc. Reese standing in the doorway of an apartment, which was apartment #7. This female was within a few feet of Ofc. Reese and I could hear someone telling her to step back. I ran up the two flights of stairs to assist Ofc. Reese in gaining control of the male.

The male was a black male with a shaved head who matched the jail booking photo of Francis Harris. The male was on the ground in the prone position underneath Ofc. Reese and his body was tensed up with his hands planted on the ground in front of his chest creating distance between him and the ground. I attempted to gained control of the male's right hand. He tried to pull his arm away from me and keep it under his chest. He eventually loosened his arms and allowed me to move his hand around to his back and place his hand into a handcuff. Ofc. of the male's left hand and I then was able to get his left hand into handcuffs. The male identified himself as Francis.

I then assisted Francis in standing up. I adjusted the handcuffs to allow proper spacing and double locked the handcuffs. He was then escorted to Ofc. Reese's car.

I then contacted Casey Blaine. He advised that he was outside of the apartments and observed an officer standing on the second level of the apartment complex. He pointed to Ofc. Reese and advised that was the officer he saw. He said that he then came up to the third level and contacted Francis. He said that Francis stepped out of the apartment and Ofc. Reese asked him if he had any weapons. He said that Francis told him no. He said that Francis then reached both of his hands into his pockets. He said that Ofc. Reese told him not to reach into his pockets. He said that Ofc. Reese then grabbed his hands and Francis tried to pull his hands into his chest away from the officer. He said that Ofc. Reese took him to the ground and Francis continued to tense up. He heard Ofc. Reese tell Francis to relax while this was occurring. He said that other officers arrived and Francis was placed into handcuffs.

Ofc. Reese transported Francis to Deaconess Hospital to seek medical clearance for jail. I followed Ofc. Reese to the hospital and stood by with Ofc. Reese and Francis until he was medically cleared.
