#### Summary:

Officer Raleigh responded to the area of Coeur D Alene Park to look for a subject wanted on a theft warrant. He had received information from the subject's roommate of the wanted subject's description including the color hat he was wearing. The subject knew he was wanted and had gone to the park to hide from police. Officer Raleigh checked police records and learned that the suspect, Chris Michael Dugan had a warrant, he was a registered sex offender, and a convicted felon.

Officer Raleigh spotted a subject in the area of the park that matched the description he was given. He drove past the subject and as he returned to make contact the subject took off running. Officer Raleigh advised radio of the situation. He was by himself at the time and he did use his car to pursue the suspect. Officer Raleigh observed that the suspect had something he was holding in both hands. He was concerned that the suspect was armed with a weapon such as a knife or firearm.

Officer Raleigh lost sight of the suspect for a moment and then located him crouched down by a fence next to the address of 317 South Cannon Street. He seemed to be cornered at that location. Officer Raleigh further observed that the suspect was holding his hands together as if he were holding something in both hands. Officer Raleigh was concerned that the subject was armed and that he may be planning some kind of ambush or attack. Officer Raleigh took out his handgun and pointed it directly at the suspect. He gave him verbal commands directing him into prone cuffing position. The suspect complied. As this was occurring he saw that the suspect was not holding a knife or firearm he was holding onto a lighter. At that point Officer Raleigh lowered his weapon to the low ready position. Officer Raleigh was still by himself at this time. He took the subject into custody using a prone cuffing technique. He pat searched the suspect and did not locate any weapons. After confirming his identity as Dugan he conducted a search incident to arrest.

Dugan was taken to the Spokane County Jail and booked on his warrant. Dugan did not sustain any injuries during the arrest.

In reviewing this incident there are several factors to consider. Officer Raleigh knew the description of the wanted suspect, the fact the suspect had a warrant, the fact that the suspect was a convicted felon, and the fact that the suspect knew police were looking for him. These facts alone raise officer safety concern. As the situation unfolded the suspect ran when he saw the police and he had an unknown object in his hand that could have been a weapon. When the suspect was located he was crouched down and appeared to be cornered. Officer Raleigh was concerned that he may be in a position to ambush officers. All of these factors increase officer safety concern. Officer Raleigh pulled his firearm and pointed it at the suspect. He gave him verbal commands and the suspect complied. Once he learned the suspect was not armed he lowered his weapon to the low ready. Eventually he conducted prone cuffing and took the suspect into custody without incident.

In this case I believe Officer Raleigh used force in accordance with department policy. He used his weapon when he believe their was a high officer safety risk, and lowered his weapon (deescalated) when he saw the suspect was not armed. He combined verbal commands and prone cuffing to gain compliance with the suspect.

On 020814 at approximately 1023 hours, Ofc Eriksen and I responded to the West Wynn Motel located at 2701 West Sunset Blvd. in the City/County of Spokane, Washington reference a possible suspicious person call for service.

While in route, Spokane Police Radio advised an anonymous complainant had called Spokane 911 to report the fact an unknown male known only by the first name of "Chris" was staying in room #128 at the West Wynn Motel and the complainant believed the male suspect was currently wanted for the possible criminal violation of "child rape."

Upon arrival at approximately 1040 hours, I contacted the adult male front desk manager, later identified as "Kenneth."

I heard as Kenneth stated he knew of the suspect male staying in room #128 and that the male suspect had contacted him prior to law enforcement arrival and asked for Kenneth to lie to law enforcement officers if they asked about the male's location or identity.

I heard as Kenneth further advised the male suspect was also staying with another adult white male, later identified as Harley M Green (111491). Kenneth further stated Harley was also wanted for an outstanding and valid arrest warrant as well.

I observed as the motel manager showed the registration paperwork for the motel room without any prompting from me or Ofc Eriksen who was also on scene. I observed the paperwork included a photocopy of Harley's Washington State Driver's License. I observed Harley's name was in fact Harley M Green (111491) as listed on his driver's license.

#### #3a

I attempted to locate and contact Harley inside his motel room at the West Wynn Motel located at 2701 West Sunset Blvd. #128, but found no one was in the room at the time of my contact.

While I was still on scene at the West Wynn Motel, I observed as Harley walked onto the property of the West Wynn Motel by himself. I observed Harley was carrying several grocery bags at the time and walked

to the manager's office where he contacted another male just outside.

At this time, Ofc Eriksen and I contacted Harley just outside the manager's office. Ofc Eriksen and I placed Harley under arrest for his outstanding and valid arrest warrant by placing Harley in handcuffs (double locked).

I asked Harley who he was staying with in his room at the West Wynn Motel, at which time Harley stated he was staying with his friend, "Chris Michael Dugan."

Harley stated Chris also had an arrest warrant for his arrest and knew officers were at the West Wynn Motel. Harley stated Chris decided to hide at the Coeur D Alene Park nearby since he knew he had an outstanding arrest warrant and police officers where at his motel room.

I heard as Harley stated he was just with Chris as the two males went grocery shopping at the Grocery Outlet store together. Harley stated Chris was last seen in the area of the Coeur d Alene Park and was last seen wearing a red baseball hat and a red and white sweatshirt top.

At this time, I assisted Ofc Eriksen place Harley in the backseat of his patrol vehicle and transport Harley to the Spokane County Jail where Ofc Eriksen booked Harley into the jail facility for his outstanding and valid arrest warrant.

#3a

I checked the area of the Coeur d Alene Park in the City/County of Spokane, Washington for Christian Dugan who Harley stated was last seen wearing a red baseball cap and red and white sweatshirt.

While searching Coeur d Alene Park for Christian, I located and observed an adult white male wearing a red baseball cap and red and white striped sweatshirt standing on the northeast corner of Sunset Boulevard and Cannon Street.

I observed as I passed the male in my Spokane Police Department patrol vehicle, the male cautiously watched my police vehicle travel passed his location as I attempted to ascertain if the male subject on the corner was that of Christian Dugan.

I traveled around the block to return to the male subject's location to contact the male since he appeared to match Harley's description, at which time I observed as the male suspect immediately began to run eastbound towards the Sunset Grocery Mini mart upon seeing my patrol vehicle return.

At this time, I advised Spokane Police Radio of my location and observations regarding the fleeing male suspect, but heard as they only started to dispatch other officers to the location to assist me. I observed I was by myself as I pursued the male suspect and attempted to contact him and other responding officers were several minutes away in their response.

I briefly lost sight of the male suspect as he fled the location on foot, but was able to re-locate the male suspect as he attempted to flee by running back westbound in the alley just to the north of the Sunset Grocery Mini mart located just north of Sunset Boulevard and east of Cannon Street.

I traveled westbound through the alley to pursue the fleeing male suspect, at which time I observed as the male appeared to be holding something with both hands in front of his person as he exited the alley way. As I as pursuing the male suspect and observed he appeared to be holding something, I immediately believed and thought the male suspect was holding and armed with possibly a weapon of some unknown nature such as a knife or firearm.

I witnessed as the male suspect quickly turn the corner around the residence at 317 South Cannon Street and continue to flee running southbound again on Cannon Street from the alley way, but again disappear out of my view.

As I started to drive southbound on Cannon Street from the alley way in an attempt to locate the male suspect, I found the male suspect was cornered and hiding approximately 40 to 50 feet from my location between the houses at 317 South Cannon Street and 321 South Cannon Street in the City/County of Spokane, Washington in what appeared to be an ambush or attack position.

I observed as the male suspect was squatting on the ground in a crouched position next to the residence at 321 South Cannon Street with his back to a large six foot fence as if to jump up and either attack any pursuing officers or continue to flee the location.

I further observed the male suspect was also crouched on the ground holding his hands together in front of his person on the ground as if he was holding something with both hands. I was unable to observe what the male subject was holding from my vantage point, but feared the male suspect was in possession of some unknown weapon to defend himself such as a firearm or edge weapon and was waiting for officers to contact or approach him and possibly ambush or attack them with the unknown weapon or firearm.

I observed the suspect male was also facing the street with his back against the six foot wood fence as if he was watching for any police officers pursuing him as he squatted on the ground next to the residence

and held his hands together in front of his person.

Due to the fact I was searching the area for a possible wanted subject who I had gathered the name and description of and confirmed did have an outstanding and valid arrest warrant just minutes prior and also learn the wanted male subject had knowledge that law enforcement was in the area and looking for him and was actively hiding in a city park coupled with the fact the male suspect attempted to flee on foot upon initial sight of a law enforcement vehicle and was now hiding next to the residence in possibly an attack or ambush position next to a residence holding what I believe and feared to be a possible edged weapon or firearm of some nature as he waited for pursuing law enforcement officers to contact him; I drew my Spokane Police Department issued handgun and pointed by firearm directly at the male suspect ordering him to show his hand and lay on the ground immediately.

I observed upon contacting the male suspect and directing the male suspect to immediately obey my commands and lay on the ground, the male suspect slowly complied and lay on the ground on the ground in the prone position after several further oral commands. I witnessed as the male suspect extended his legs and arms directly above his head as I had instructed.

At this time, I was able to observe the male suspect was only holding some small unknown yellow object in his hand which turned out to be a small lighter.

I was able to observe the male suspect was not holding any weapons or firearms at the time of my contact.

I lowered my firearm to the low ready once I was able to observe the male suspect was not holding any weapons in his hands such as a knife or firearm and was cooperatively obeying my commands.

At this time, I attempted to gain control of the male suspect by assuming a prone handcuffing technique by handcuffing the male suspect with his hands behind his back as he laid extended on the ground. detained the male suspect from the prone handcuffing technique by placing him in handcuffs, double locked without incident.

I pat frisked the male suspect for any possible weapons on his person, but was unable to locate any.

I confirmed the male suspect was the same male Harley had advised myself and Ofc Eriksen of and described, "Christian Michael Dugan."

I advised Dugan he was under arrest for his outstanding and valid arrest warrant for the criminal violation of "City Theft."

I searched Dugan, search incident to a lawful arrest, but was unable to locate any illegal weapons, contraband or illegal narcotics on his person.

I placed Dugan in the back seat of my Spokane Police Department
