



On 030314 at approximately 1930hrs, Lena Maples called from the Carlyle Apartments at 206 S Post to report that resident **#14** in **#711** threw a chair through a window and was destroying items in his room. She said he may have a pocket knife but it was not in use. Ms. Maples called back at 1941hrs, and said she heard glass breaking. She also informed 911 that Mr. **#14** has a history of suicide attempts. She was afraid to go in the apartment by herself without law enforcement to assist.

Officer McCasland and I responded. I arrived at 1946hrs, and we went inside. We contacted Ms. Maples and she told us Mr. 414 was still breaking things. She told me she was the social worker for the building. Ms. Maples opened the door with her key before I could tell her to wait. I

called inside for Mr. #14 but no one responded. I could see into the apartment and saw the broken window. We were seven stories up and the hole was large enough for an adult to fit through. We opened the door wider but I couldn't see anyone inside. I thought Mr #14 d may have jumped out the window so we went inside the apartment.

Once inside I found Mr. 414 laying on his bed. We tried communicating with him but at first he wouldn't respond. He was barefoot and I could see a cut under one of his feet. There was broken glass all over the floor. Mr. #14 started cursing at us, saving something similar to, "Fuck you, I'm not going anywhere!" Officer McCasland told Mr. #14 to get up but he pushed the officer away. Mr. #14 velled something similar to "I'm going to fuck you up." Mr. #14 was pushing Officer McCasland away. I tried to get control off one of Mr. #14 arms but they were tense and he was keeping them by his waist. Officer McCasland and Mr. 414 fell onto the bed and Mr. #14 put his arms under him. I repeatedly told him to put his arms behind his back but he refused saying, "fuck you."

At that point I had the following information:

1. I was responding to a malicious mischief crime involving Mr. #14 and when contact was made he was being uncooperative.

2. Mr. #14 had not been searched and could have the knife Ms. Maple reported, or other weapons that could injure or kill officers, staff, or other residents. He was keeping his arms by his waistline which is a common area for weapons to be stored.

3. Mr. #14 made the statement that he was going to fuck up Officer McCasland, therefore he led me to believe he was going to assault the officer.

Based on this information I took out my Taser and told Mr. #14 to stop resisting and to put his hands behind his back. He still would not put his hands behind his back. When I tried to hold onto his arm I could feel that he was very tense and was not going to voluntarily put his hands behind his back. I provided Mr. #14 with another warning that I was going to Tase him but he responded by saying something similar to, "Fuck you."

At that point I felt the safest way to resolve the situation with the least amount of force was to attempt a drive-stun on Mr. 414 tense arm. I took the cartridge off and placed the taser contacts on Mr. #14 arm. I pulled the trigger initiating a 5 second burst but Mr. #14 was still moving around violently so I couldn't keep it in contact with him. Mr. #14 pushed forward on his bed and this presented his legs to me. Before the 5 seconds was up I placed it on his right calf. immediately gave up and put his hands behind his back. I estimate the amount of time Mr. #14 the Taser was contacting his calf while it was engaged was about 2 second or less. I couldn't seen any injury from the Taser contact.

I handed Officer McCasland my handcuffs and he handcuffed Mr. #14 We called for medics to

come check out his cuts. Cpl. Bartlett responded for photos of the damage. I advised him of his mandatory court date. I gave him a copy. I provided staff at the hospital with the details of this incident for the mental evaluation.

On 03-03-14, I responded with Officer Widhalm (See his report) to 206 S. Post711. The complainant, Maples had called saying a male, #14 was being disorderly and she could hear glass breaking.

Upon arrival, We contacted the Maples who was the hallway waiting on us to arrive. Maples opened the door to **#14** apartment. I could hear loud Music and feel a cold draft coming in to the room.

I turned the radio off and announced we were Spokane Police. I could see a large double pane window on the west side of the apartment was completely broke out. #14 was lying on his bed with his feet crossed and hands across his chest.

I heard Officer Widhalm saying to #14 we were the Spokane Police. #14 responded with "Fuck you, what you going do". I told #14 we were here to find out what was going on. I asked him why the window was broke out. He said, "Fuck you what you going to do. Why don't you just bring it".

I asked #14 where his shoes and coat were at as we were going to need them. He again told me, "Fuck you, lets do this, I'm going to fuck you up".

I asked #14 to calm down and the only response we got was "Fuck you".

I grabbed **#14** right arm and pulled him toward the end of the bed. He immediately tense up screaming "Fuck you". He curled up in to a ball. I took his arm and put it behind his back. He would not cooperate. He reached back with his left arm. I then attempted to get a lateral neck restraint. I could not get it on from the angle I was at. I pulled back on his arm and Officer Widhalm initiated a touch stun with his taser.

#14 complied with our instructions from the point forward. I told him to roll over and put his arms behind his back. He did this, he was handcuffed D/L, He remained on his stomach laying on the bed.

We gathered his coat and shoes and noticed he had a deep cut on his foot from the glass.

Officer Interview Summary

I contacted officer Widhalm at Sacred Heart on 3/3/14 at approximately 2100. He described the incident as follows: Subject is a patient/resident at the Carlyle Hotel. Subject was damaging property at the facility. When contacted the subject became combative. Widhalm attempted to apply a drive-stun to the male's arm but missed. While the Taser was still going through the standard cycle, he transitioned to the right calf where contact was made for a second or two. The male then complied and was taken into custody. Subject had several cuts on his feet from walking on broken glass. The cuts were made prior to officers contacting the subject.

Witness Interview Summary

I spoke to #14 #14 at Sacred Heart Medical Center on 3/3/14 at approximately 2100. Mr. #14 was being treated for multiple minor lacerations to his feet. I examined #14 right and left calves for any injuries left by the Taser finding none.

#14 was uncooperative stating he did not know why he was at the hospital. He did not remember being contacted by the police or any type physical altercation with officers. #14 asked me to leave him alone.

Physical Evidence

Photographs taken by Corporal Bartlett.

Investigative Summary

Officer Widhalm and McCasland were confronting a mentally ill subject who was possibly armed with a knife, possibly suicidal, and was damaging property. The male made it verbally known that he intended to resist arrest and assault the officers. The subject actively resisted being taken into custody. Officer Widhalm observed Officer McCasland's failed attempt of a lateral neck restraint and decided to deploy his Taser in drive-stun mode. Officer Widhalm had difficulty making contact with the device due to the subject's movements. He made contact to the subject's right calf for a second or two. The drive-stun tactic was effective resulting in the subject's immediate compliance.

I reviewed the attached Taser data. I noted trigger activation at 1949 for five seconds. The attached graph for that activation shows contact was briefly made towards the end of the cycle. The Taser data is consistent with Widhalm's statement and report.

Officer Widhalm's use of force was reasonable given the circumstances he and Officer McCasland were facing. He chose a minimal amount of force to gain compliance which resulted



in no injuries to the suspect or officers. His actions were within department's use of force policy.


