Summary:

9-1-1 received several calls from this apartment complex stating a male appeared high and was making threats. Some also indicated that the suspect was brandishing a handgun.

Officers responded, contacted several witnesses for confirmation and searched the complex. Witnesses all said they saw the suspect holding the handgun and acting in a threatening manner. suspect had also activated a laser sight. Two witnesses expressed extreme fear for themselves and nearby children.

A male matching the suspect's description was found and ordered to get on the ground. Initially uncooperative, he eventually followed commands from Officers E. Bishop, Groom and Geren. Groom drew his weapon and held it at the low ready position. Geren, armed with a rifle, aimed it at the suspect until Groom and Bishop safely detained him in handcuffs and searched him.

Suspect was arrested for Intimidation With a Weapon.

Other officers located the weapon that had been partially hidden behind an electrical panel. It was an air soft pistol with a laser sight.

Neither suspect or officers were injured.

This was an appropriate use of force in a potential life threatening situation.

On 02/26/2014 at about 2017 hours Officer Geren and I were dispatched to 617 E Houston Spokane, WA, reference a person with a weapon. The person was described as a Hispanic male, mid 20's, tattoos on face, red and black outfit and messed up teeth.

We arrived on scene around 2020 hours and began looking around the Lyons Crest Apartments located at 6616 N. Addison, Spokane WA. We did not locate the individual described in the call. We began checking the area to try and locate the individual. Around 2038 hours we returned to the Lyons Crest Apartments located at 6616 N. Addison, Spokane WA, and noticed a male running towards our patrol car. The male was saying that there was a male around the corner that had the gun. I pulled the patrol car onto the sidewalk near the south/west entrance to the apartment complex.

Officer Geren and I exited the patrol car and I noticed an individual matching the description walking west out from the apartment complex. The individual had a backpack and was not wearing a shirt. I drew my weapon (I was indexed and remained at the low ready) and started giving commands to get on the ground with his arms to the side. The individual was later identified as (Tashan C. Highpine) through SPRS.

Tashan eventually responded to the commands and got onto the ground. Officer Bishop and I approached Tashan while Officer Geren provided cover.

Officer Bishop and I (handcuffed/DL) Tashan and frisked him for weapons. No weapon was found on his person. I escorted Tashan to my patrol car and I placed him into the back. Officer Bishop returned to the apartment to talk to the complainant/victim, (see Officer Bishop's report.)

Tashan would not give us his name and Officer Geren advised me of a name he had located (see Officer Geren's report.) Tashan said he was aware of his rights and he refused to talk.

Officer Bishop advised that there was PC for displaying a weapon. Officer Geren and I informed Tashan that he was under arrest for RCW 9.41.270, displaying a weapon.

I transported Tashan to the Spokane County Jail. During the transport Tashan became very hostile and was yelling profanities. Tashan began hitting his head on the cage and kicking the door. Officer Geren advised Tashan that if he hit his head on the cage again we would have to put him in leg restraints for his safety. Tashan hit his head on the cage again around Post and Indiana. I pulled the patrol car over at Post/Sinto. Officer Geren and I pulled Tashan out of the patrol car and placed him into leg restraints. We requested another unit to our location, in order to get a second seat for the back of my patrol car. I got the second seat and placed it into the patrol car so that Tashan would not fall onto the floor board while in restraints. We placed Tashan back into the patrol car and continued the transport.

I booked Tashan into jail and issued citation #4Z0276914 for displaying a weapon.

I conducted no further investigation.

a gun who had possibly broken into apartment B304. In the last hour or so, we had numerous calls in the area about said male but we were not able to find him. (14-61359,14-61403,14-61436,14-61449,14-61452).

I went up and contacted 2 of the complainants, Heather Sasenett who lives in B305 and Ashley Walker who lives in B309. Sasenett stated she heard banging around outside her apt so she went outside and saw a male, later identified as Tashan Highpine, exited apt #B304.

Sasenett stated she knows what the tenant looks like in B304 and Highpine was not the tenant. She stated there is a lot of traffic from B304. She went back into her apt until she heard her neighbor, Walker, yelling in the hall. She came out and saw Walker arguing with Highpine who was threatening to beat her up and kill her.

Walker was telling Highpine to just leave but he was yelling/screaming at everyone. He walked down the stairs w/a backpack and they last saw him walking WB through the complex.

Walker stated she came out of her apt when she heard a commotion in the hall. She saw Highpine exiting out of B304 which has a lot of unusual traffic. She knew Highpine was not the tenant who lives in B304.

Highpine asked Walker if she had a lighter he could borrow. She walked down, handed him hers, and then he turned to walk away. Walker she told him to stop, that she needed her lighter back. He swore at her and threw the lighter at her.

He started threatening to "kick her ass," and Walker told him to just leave, he was full of it. By this time, other tenants had come out into the hall. They were all yelling at him to leave. He did head down the stairs to leave but swore/threatened them on the way down.

Walker and Sasenett both stated they were not intimidated or worried Highpine was going to hurt them. Ofc E Bishop located Highpine and took him into custody for further investigation.

We were not able to locate the tenants who lived in B304. The door had been wide open when we arrived but it did not appear to be forced. The manager arrived and she stated she would secure the apt. She said she was serving the tenant in B304 with an eviction notice in the am. We were getting ready to leave when the tenants on the 3rd floor started yelling for us to return.

Ofc Harvey and I went upstairs to see what was going on. There is an electrical panel in the siding along the hall which was pried back slightly. Ofc Harvey and I could see what appeared to be a handgun jammed inside.

I took a photo and we removed the firearm which was actually a Sig Sauer 1911 airsoft gun. I took

NARRATIVE

On 02/26/2014 at about 2017 hours Officer Groom and I were dispatched to the area of 617 E. Houston, Spokane, WA, reference a person with a gun call. Dispatch advised that the male was described as a Hispanic male in his twenties with abnormal teeth, red and black hat, red and black outfit, and tattoos on his face.

We arrived in the area and another caller from 6616 N. Addison had seen a similar male with a gun. We circulated the area of both calls but did not initially find anything. I observed a male jogging towards us as we approached the Addison address from the south. He was looking over his shoulder and pointing behind him towards the north driveway of the complex.

I observed a dark-skinned male walk west out the driveway. He was not wearing a hat or shirt but was yelling and was very animated. It was apparent that he was the suspect described in the calls.

I was aware that the suspect had displayed what was believed to be a gun to more than one caller. Based on my training and experience, more than one caller tends to substantiate the validity of the threat/call. The male was about thirty yards away and was initially non compliant with my commands. I could only see the left side of his body as he angled away from me. He further was fumbling with a black backpack in his right hand, but it was not clear what he was doing. He had not been searched and his pants would have easily concealed a handgun.

I pointed my patrol rifle at the suspect while I continued to give commands from him to get down on the ground and put his hands out to the side. He initially did not comply but eventually got down on the ground and put his hands out. I observed that he had tattoos on his face as described in the call. I brought my patrol rifle back down to a low-ready as Officer Groom and Officer Bishop detained the male in handcuffs. I assisted in maintaining control of the male as he was yelling loudly and was moving his upper body erratically, making it difficult to search him for weapons.

I assisted in placing the suspect in our patrol vehicle. I retrieved the backpack from the hood of another patrol vehicle where it had been placed. It was unzipped. I observed a prescription bottle inside with the name of Tashan Highpine. #3b

#3b Officer Groom and I remained with Highpine as other officers investigated the matter. Officer Bishop advised that she had probable cause for weapons intimidation.

I opened the rear door of our patrol vehicle after observing Highpine slam his head into the shield of our car. He was screaming at the top of his lungs and challenged me to a fight. I told him that he would be placed in leg restraints if he were to continue to try and hurt his head. He agreed that he would no longer hit his head against the car.

NARRATIVE:

On Wednesday February 26, 2014 at about 2020 hours I responded to 6616 N Addison to investigate a male walking around possibly pointing a gun at people, acting strange, and then later possibly breaking into an apartment. There had been numerous calls on this male, later identified as Tashan Highpine.

I arrived onscene with numerous other officers. We were attempting to locate Highpine in the apartment complex when numerous people came running up and yelled he was "over there" and that he "had a gun." Highpine emerged from the north side of building "B" near the stairwell. He was wearing jeans and no shirt. He was an Hispanic male, 27 years of age, with numerous tattoos on his face and chest. Highpine was detained by the sidewalk on Addison. He appeared very high on drugs and was uncooperative. Ofc Groom and Ofc Geren escorted Highpine back to their patrol vehicle and detained him in there.

I then went and spoke with Heather Walsh. In summary she told me the following:

She had been staying in apartment #B316. She and her friend, Daren Beach, were outside the apartment smoking a cigarette. She heard foot steps coming up the stairwell but did not see anyone. She thought that was odd. Then she observed an hispanic male, about 20-24 years of age, wearing a red/black baseball hat, and tattoos under his eyes walking up the stairwell with something black tucked underneath his left arm pit. He was holding it with his right hand. She thought it looked like a handgun.

The male, later identified as Highpine, walked by her and Daren and began walking down the hallway of all of the apartment front doors to building "B." He walked down the hallway and then turned back around. He began walking back towards her and Daren.

Now Highpine was holding the handgun in his right hand out in front of his chest. There was a "laser" on it, and the red beam of the laser was turned on. As soon as Heather observed the handgun she became very scared. Highpine approached her with the gun in his hand and the laser on and asked her and Daren, "Hey man, will you stash this for me?" Heather was so scared and alarmed by Highpine's actions and now asking her to hide the gun, she told Highpine, "NO!" and immediately began walking back towards her apartment to call the police. Highpine then walked

back down the stairwell and Heather could no longer see him. Heather then called the police. Heather said she was very scared for her safety and for the two children who were also in her apartment.

Heather described the gun as a black handgun (pistol) type gun with a built in laser type addition that emitted a red light.

[End of Heather's Statement]

I then spoke with Daren Beach. In summary he told me the following:

He was outside with Heather smoking when he observed Highpine come walking up the stairwell. Highpine appeared to have a gun tucked under his arm. He walked down the hallway and then turned back around. Highpine was now holding the gun out in front of his chest, although not pointing it directly at anyone. The "laser" portion of the gun was on and there was a red light coming from it. Highpine asked them, "hey man, can you stash this for me?" Heather told him no and then Highpine began walking back down the stairwell.

Daren said Highpine's behavior was very strange and he appeared to be high or mental. He felt threatened by Highpine's display of the gun in that manner with the laser on and what appeared to be ready to shoot at any second. Heather went inside and immediately called the police.

The gun was discovered by other officers in the hallway of apartment building "B." It turned out to be an extremely realistic looking air soft gun. It was collected as evidence and placed on Police Property.

Based on Heather's statement and Daren's statement, the air soft gun, and the other numerous calls by numerous citizens about Highpine's erratic behavior and random displays of the gun, I developed Probable Cause to arrest Highpine for Weapons Apparently Capable of Producing Bodily Harm (Intimidation with a Weapon).

Ofc Groom and Geren transported Highpine to Jail and booked him in on this one new charge.
