





On 030914 at approximately 1107 hours, I responded to the residence located at 2305 West Dean Avenue in the City/County of Spokane, WA along with several other officers of the Spokane Police Department regarding a possible residential burglary in progress call for service.

Spokane Police Radio later advised #14 updated the incident and reported the suspect was now identified as the neighbor from 2307 West Dean Avenue and had forcefully gained entry into the basement of the residence with a hammer to access his own property in the basement.

Upon arrival at approximately 1113 hours, I observed Ofc Atkins, Cpl Ferguson and Sgt Ervin of the Spokane Police Department were already on scene at the residence. I witnessed Ofc Atkins was contacting an adult white male in the front yard of the residence while Sgt Ervin and Cpl Ferguson were clearing the basement of the residence for any possible suspects still inside.

I contacted an adult white female who was standing on the front porch of 2305 West Dean Avenue and began to interview her regarding the incident. I starting asking the female what was occurring at the residence and how the Spokane Police Department could provide any assistance, at which time I heard another female and male hysterically yell at each other just inside the front door of the residence approximately seven to ten feet behind the female witness I was speaking with.

I heard as the unknown male yelled at the other female to get away from him and not to touch him while the female yelled back at the male to leave her alone. I further heard as the male aggressively yelled at the female in a very angry and growling voice and called her several foul names to include "Whore" and "Fuckin Bitch."

As I listened to the irate couple yell at each other, it sounded as if the couple was young and immature teenagers in a lover's dispute and emotionally yell back and forth and threatened one another.

I witnessed as the female I was speaking with on the porch quickly turn and open the front door to the

residence. I watched as the female loudly yell at the arguing couple inside to "stop fighting" and "go to their rooms" as if she was a parent or guardian of the male and female inside.

I heard as the yelling subsided for a couple seconds, but observed as an adult white female stormed out the front door onto the front porch. I watched as the excited female yelled at the female I was speaking with stating the male inside had assaulted by hitting her and threatened her.

I continued to observe as the adult female I was trying to interview yelled at the other female to go to her room and stay away from the male inside since the police were at the residence.

I observed as the upset female stomped her feet and stormed back into the residence. I heard within seconds the male inside the residence began to yell again. I heard as the male screamed at the top of his voice, "She just threatened me with a knife."

At this time, I observed as the adult female I was attempting to interview on the front porch walk into the residence in an attempt to separate the two combatants. Sgt Ervin and I walked to the front door of the residence where I looked inside to residence and observed an adult white male, later ID'd as Tanner W Moore (112881) standing in the front kitchen area of the residence attempting to put a pair of pants on.

I briefly observed the same adult white female who had walked out onto the front porch, later ID'd as #14 (081885) quickly walk out of the kitchen area and disappeared into a back bedroom, but state "I just want to die" as she walked away.

I heard as Moore continued to raise his voice and yell at myself and Sgt Ervin stating #14 just threatened him with a knife and still had the knife with her.

Based on the fact both Moore and #14 were actively involved in some unknown heated and emotional altercation with one another for some unknown reason and #14 had now armed herself with a knife of some unknown size and fashion; I determined to detain Moore by placing him in handcuffs (double locked) for the time being until myself and the other officers at the location were able to gain control of the incident and ensure the safety of the officers on scene as well as the other occupants of the residence.

I observed as Sgt Ervin directed his attention to a bedroom just off the kitchen area where Sgt Ervin advised #14 had retreated to and was now hiding inside. I witnessed there was no door on the bedroom, but the doorway to the bedroom was covered with a pink blanket that was tacked around the door frame.

Upon detaining Moore, I instructed Moore to be seated on the front porch while I assisted Sgt Ervin contact #14 inside the bedroom.

I witnessed Sgt Ervin had contained #14 inside the bedroom for the time being and had established verbal contact with #14. I heard as Sgt Ervin had instructed #14 to put the knife down and come out of the bedroom, but #14 just yelled "No," and stated she wanted to kill herself.

As Sgt Ervin was speaking with #14 I removed the blanket covering the doorway. I observed #14 was sitting on a bed just inside the bedroom approximately five to six feet away from the doorway where I was standing. I observed the bedroom was completely full and cluttered with miscellaneous property, furniture and

clothing and there was only a small short path to walk to the bed located opposite from the doorway. I observed the rest of the floor was completely covered.

I witnessed #14 was holding a sliver metal knife in her right hand with the blade open and extended out the bottom of her hand as she held the knife in a stabbing position.

I watched as #14 raise the knife and begin to cut her left wrist with the blade of the knife. I watched as cut her left wrist in a parallel cutting action to her wrist. I further observed #14 had several cut marks on her left wrist where she had made several cuts to her wrist with the knife and were currently bleeding.

Based on the following facts and circumstances, I determined to take immediately and rapid action to prevent #14 from injuring if not killing herself as well as to protect the safety of #14 and the other officers and occupants inside the house:

- 1. #14 was involved in a very heated and emotional altercation with another male resident inside the residence which prompted each other to counter accuse each other of assault
- 2. #14 had armed herself with a knife of some unknown size and fashion after observing officer s of the Spokane Police Department were on scene and contacting other witnesses on the front porch
- 3. #14 had no regarding to any personal consequences with law enforcement as she allegedly threatened Moore with the knife as officers of the Spokane Police Department stood just outside on the front porch
- 4. #14 had very little if any concern for her or the other occupant's safety inside the residence being that she armed herself with a knife and stated she wanted to die
- 5. Sgt Ervin and I had contacted and contained #14 inside the small and cluttered bedroom of the residence as she was armed with a knife
- 6. I was now standing within five to six feet of #14 who was seated on her bed and attempting to kill herself by actively cutting her wrists with a knife.

At this time, I transitioned from lethal cover of my handgun to my Taser. Being within striking and lunge distance of #14 I immediately deployed my Taser. I activated the Taser probe application and aimed for #14 lower chest/abdomen as she sat leaning forward on the bed. I observed as one Taser probe successfully impacted the center of #14 chest, but I was unable to see where the other Taser probe impacted. I yelled at #14 saying, "Drop the knife" as I deployed my Taser. I observed as #14 released the knife from her right hand and arched backward as she threw herself onto the bed as the Taser was activated. I watched as the knife fell to the floor just at #14 feet as she tensed her body, but was still open and clearly within #14 reach.

I instructed #14 to roll over onto her stomach and yelled at #14 to place her hands behind her back. I observed as Sgt Ervin entered the room and climbed onto #14 bed to gain physical control of #14 Sgt Ervin and I rolled #14 onto her stomach and placed her hands behind her back.

I assisted Sgt Ervin detain #14 by placing her in handcuffs (double locked). I immediately advised

Spokane Police Radio of the Taser deployment and requested the assistance of the Spokane City Fire Department to respond to remove the Taser probes from #14 I observed the second Taser probe impacted #14 left hand and was stuck in the back of her hand between her thumb and index finger.

I stood by with Sgt Ervin and #14 in the bedroom until emergency medical personnel of the fire department were able to arrive and treat #14 I observed the responding medics removed the Taser probes from #14 person without incident and checked #14 vitals.

I collected my spent Taser equipment and requested a Corporal of the Spokane Police Department respond to take photographs of #14 and her injuries as well as the knife #14 had armed herself with.

I requested #14 be transported to Sacred Heart Medical Center for an involuntary psychiatric evaluation based on her suicidal statements and actions of cutting her wrists with the knife.

I further contacted Ofc Zinkgraf of the Spokane Police Department regarding the incident. Ofc Zinkgraf advised she contacted and interviewed Moore and was able to gather his statement regarding the altercation. I heard as Ofc Zinkgraf advised upon investigating the altercation, she was unable to establish any sufficient probable cause or reason to conduct any further law enforcement action regarding the incident.

I followed the American Medical Response ambulance to Sacred Heart Medical Center where I checked into the hospital for a psychiatric evaluation.

I later placed #14 knife and my deployed Taser cartridge on Spokane Police Department Property to be held as evidence and examined at a later date and time. (See also Spokane Police Department Property Report #14-0072837)

I further downloaded my Taser activation information file with Sgt Ervin regarding my Taser deployment. (See also Sgt Ervin's additional incident report)

I completed this informational incident report documenting my response to the incident and subsequent actions and cleared the call.

On 3/9/14 at approximately 11:07 I responded to a burglary in progress at 2305 W. Dean. Several other officers responded as well. When I arrived on scene a female witness pointed to a door that had been pried open on what appeared to be a storage room. Corp. Ferguson and I cleared the room and did not located anyone. I talked briefly with the witness. She advised that Officer Atkins was talking to the suspect. Officer Raleigh arrived on scene and was attempting to get information from this witness. While the witness was attempting to talk to us she kept yelling back inside her apartment at a male and a female. These two people were yelling at each other. The yelling continued and the male later identified as Moore said the female had hit him. I told him to go back in his room and leave her alone and we would contact them once we were done with the burglary. He ignored me and continued to engage the female. She was later identified as #14 Moore stated that the female had just pulled a knife and threatened him. At that time I told more to exit the residence. Officer Raleigh contacted Moore and handcuffed him.

I continued into the residence. The residence was cluttered, there were several rooms in the residence and each entry was covered with a blanket. I heard #14 talking in one room as if she was still talking to Moore. I identified myself as a police officer, told her to put the knife down, and to show me her hands. I had anticipated she would show her hands through the blanket door way. I had my pistol out of its holster and at the low ready. She did not do as she was directed. Officer Raleigh came into the room. He pulled the blanket down so we could see into the room. He had a clearer angle to see into the room and see #14. He advised she still had the knife and was cutting herself. He took his Taser out. I still had my weapon drawn. He fired the Taser at #14 The Taser made connection and #14 dropped the knife. I climbed on the bed and we rolled #14 face down on the mattress. I handcuffed her and sat her up. I explained to her what happened and told her that she had a small Taser probe in her left hand by the web of her thumb. I told her not to pull on it that we would have medics remove it. I told her she had a probe in her chest and to leave it alone and we would have it removed by medics.

Officer Raleigh had requested medics to respond. I stayed with while we waited for medics. At one point forward off the mattress onto the cluttered floor. She acted like she was having a seizure. I advised radio of this information and requested medics to speed up. After a short period of time forward witching and responded almost immediately to my questions. It has been my experience that this is not normal behavior after having a seizure. Usually patients are confused as to what happened. She told me that she has been having seizures but does not use

medication. She also told me she has heart problems. Medics arrived and she pretended to have another seizure. Medics told me that these were not real. I gave medics what medical information she told me. They removed one probe from her hand and discovered the probe in the chest did not make contact. It had contacted her zipper but there was no injury to the chest area. They transported her to Sacred Heart.

It should be noted that the room #14 was in was very small. The bed was a mattress without a frame. The room was cluttered and not easy to move around in. Getting to #14 to handcuff her took a little extra time due to the clutter. #14 did have fresh bleeding cut marks on her wrist.

Later I contacted Officer Raleigh at the station and did a download of his Taser. The data indicated that the probes did make functional contact and that the duration was 10 seconds. I contacted Lt. Olsen and advised him of the situation.

Officers responded to this address reference a burglary in progress. While on scene an argument broke out between a male and female. When the argument got heated and officers discovered a knife was involved and they intervened. Ms. #14 was found to be in a small cluttered room that had a blanket cover being used as a door. Sgt. Ervin ordered her to drop the knife and show her hands. She refused and did not come out. Officer Raleigh removed the blanket and was able to see that she was cutting her wrist with a pocket knife. Officers were about 5 to 6 feet away from her which was easily within lunge distance. Officer Raleigh fired his Taser using probes striking the female in the hand and chest. She dropped the knife, she was rolled over onto her stomach and handcuffed. Medics responded, removed the probes and she was taken to Sacred Heart Hospital for evaluation.

In my opinion the use of force in this case followed policy, was a good choice, and quickly ended the situation. Verbal commands were given to the individual which were ignored. The subject had a knife in her hand and she was cutting her wrist at the time of Taser deployment. The use of the Taser was a good choice which ended the situation quickly and without further harm to Ms.


