



Use of force investigation.

On 5/19/14 at about 0138 hours I responded to 6008 N Ash to assist officers with a person with a weapon call. Prior to my arrival, Officers advised that a Taser had been deployed and they requested a supervisor.

Officers had responded to that address at about 0004 hours on a report that a female had "pulled a knife on the complainant." The female had left the location prior to officers arriving. Officers conducted the initial investigation and then left. This was the second 911 call to this residence and dispatch had advised that 911 could hear a male and female yelling at each other and the female was saying "I'm going to kill myself."

Upon my arrival, I saw the suspect, Sarah Wilson, sitting on the front porch of the residence. She was obviously intoxicated, uncooperative and verbally hostile toward officers. I saw that she had been impacted by Taser probes in her stomach area and in her chest. She did not appear to have any other injuries and she was not complaining about any injuries. Officer Everly later advised that she did have a cut to her neck that was self-inflicted and occurred prior to contact with officers.

Officer Everly advised that he was the officer that deployed the Taser. He explained that he and his recruit, Mohondro, had PC to arrest Sarah for 2nd degree assault from the original 911 call that occurred at 0029 hours. The assault that occurred in the original call involved a knife. Officer Everly explained that they heard statements to believe that Sarah was suicidal. He was concerned that she was armed based on the previous call only moments earlier, and he could hear a struggle between Sarah and a male in the residence when they entered. See his report for further details on the incident.

Officer Mohondro provided lethal cover during the incident. When the Taser was deployed, Officer Mohondro observed the suspect lift her arm to her midsection. She did not immediately fall from the Taser application and he thought he saw a metallic object in her hand. He initially believed the suspect was armed based on the totality of the circumstances and within only a few feet of Officer Everly and himself. He advised that he pointed his firearm at the suspect briefly preparing to use lethal force. The suspect then went to her knees and was taken into custody.

I entered the residence and went back to the kitchen area where the use of force occurred. This kitchen was very small. There was a walkway on the north end of the kitchen and the kitchen was in the shape of an L, extending about 7-10 feet to the south before extending a few feet to the east. I saw that there was a butcher knife and smaller knife lying on the floor just inside the walkway on the north end of the kitchen. When looking to the south, I saw that there were

numerous knives lying on the floor in the southwest corner of the kitchen. In that same corner there was a wooden block/knife holder that was lying on the floor with the knives. It appeared that someone had pulled the holder and knives off of the counter and onto the floor. I also saw that the floor was wet and the room was in disarray as if there was a struggle in that room.

Officer Everly advised that Sarah had been standing in that kitchen, in the southwest corner of the kitchen next to the numerous knives, when he entered the room. He said that Stephen was just east of Sarah and he appeared to be struggling with Sarah. He explained that he deployed the Taser from just inside that north entry to the kitchen while Sarah was standing in the southwest corner of the kitchen. Once the Taser was deployed, it proved effective and allowed Officer Everly and Mohondro to move up and safely taking Sarah into custody without further incident and without further injury. Cpl. Cordis took photographs of the kitchen to include the locations of both Sarah and Officer Everly when the Taser was deployed.

I listened to Officer Fabian and Officer Dollard interview the only citizen witness to the actual Taser deployment, Stephen Bayless. He explained that he was in the kitchen, trying to prevent Sarah from harming herself with a knife. He explained that she had armed herself two different times with knives during the struggle and that he had wrestled the knives away from her each time. He described that during the struggle he had held her down on the ground. Just prior to officers entering the room he had let her up and she was on her feet when officers entered the room and deployed the Taser.

I asked Bayless what he thought would have happened if the officers had not arrived when they did? He said, "I would have had to wrestle another knife away from her." I asked if he thought the officers did anything inappropriate and he simply replied "no." See additional reports for further on his statement.

Cpl. Cordis collected Officer Everly's Taser from him after he arrived at jail and then brought it to the sergeant's office. Sgt. Kannberg conducted the download of Everly's Taser. The download confirmed that there had been one deployment on that date, at 0138 hours, that lasted 4 seconds. See Taser report for further details.

The use of the Taser in this incident was justified and within department policy. Prior to the use of force, officers had developed probable cause to arrest Sarah for 2nd degree assault, involving a knife. This is a violent and serious crime. It was only about an hour after the alleged assault that officers were called back to the same address to deal with this suspect. The 911 information indicated that there was a physical altercation inside the residence with the 2nd degree assault suspect being involved and upon arriving officers heard what sounded like a physical altercation. Officers also heard Sarah make statements that she was intent on killing herself. At the time when officers contacted Sarah they evaluated her level of resistance as assaultive as well as suicidal. When officers entered the house, the situation was tense, uncertain and rapidly evolving. Officers entered into a very small area where there were numerous knives within arm's reach of the suspect. There was also a potential victim within arm's reach of the suspect. Officer Everly was required to make a split-second decision on how to control the situation and protect the potential victim, he and his partner, as well as the suspect. Officer Everly deployed the Taser which was effective and allowed officers to take the suspect into custody without further incident or injury. The use of the Taser also prevented the suspect from re-arming herself and causing harm to any of the involved parties. Had he not taken such swift and effective action this incident could have easily turned into a lethal situation for all involved. Officer

Mohondro's pointing of the firearm at the suspect was reasonable based on the totality of the circumstances. He showed correct restraint in this incident by not deploying deadly force.

On 5/19/2014 at about 0030 hrs Ofc. Everly and I were dispatched to 6008 N. Ash St. on a report of domestic violence. Dispatch advised the complainant's daughter was in the house armed with a knife and had damaged things in the home.

Upon arrival I contacted Debra A. Wilson. Wilson said her daughter Sarah showed up drunk at her home at around 0015 and pulled a knife on her. Wilson told me Sarah came to the house to get her purse and phone which Wilson gave her. Sarah told Wilson she was going to go get high. I asked Wilson where she thought Sarah would go and she said, "I don't know a trap house." She told me a trap house is what drug users call abandoned homes they use to get high in. Wilson told Sarah she needed to go to detox.

After she gathered her things Sarah left through the back door. A short time later, she came back up to the back door of Wilson's house. Sarah told Wilson she wanted something else out of the house. I asked Wilson what else Sarah wanted and she told me Sarah wanted paperwork of some kind that was in the house but wasn't sure what it was for. She also wanted her knife. Wilson went on to tell me Sarah has somewhat of an obsession with knives and owns many.

Wilson blocked the back door to the house as she didn't want Sarah to come back in because of her behavior. Wilson told Sarah she wasn't allowed to come back inside and asked her to leave. Wilson told me Sarah shoved her out of the doorway with both hands and pushed past her into the kitchen. I asked Wilson if the shove knocked her over. She said she didn't fall but lost her balance and stumbled backward. I asked Wilson if she had any injuries from being shoved and she said she didn't. Wilson told me she thought if she just let Sarah get her papers and knife she would leave. She got Sarah's knife out of the kitchen to give back to Sarah so she would leave. Her daughter's ex boyfriend Stephen M. Bayless who lives at the house was arguing with Sarah and telling her to leave and stop acting the way she was.

Sarah went back into the living room and dumped a backpack of hers out onto the couch and rummaged through it's contents. Wilson told Sarah to pick up the mess she made on the couch and she put everything back into the backpack. Wilson told me after Sarah picked up the couch, she stood back up and used her arm to "swipe" almost everything that was on the coffee table off onto

the floor. Wilson yelled at Sarah to "stop wrecking her house" and leave.

After Wilson yelled, Sarah picked up a folding pocket knife about three inches long from the coffee table. Wilson told me Sarah turned and faced her and opened the knife. Wilson was standing in the doorway between the kitchen and living room about three feet away from Sarah. Sarah was holding the knife in her right hand near her waist line with the knife pointed toward Wilson. Sarah took a step toward Wilson and lifted the knife over her head and Wilson thought Sarah was going to stab her.

Wilson told me as soon as Sarah raised the knife over her head, Bayless grabbed Sarah's hand holding the knife. He yelled, "you don't pull a knife on your mom!" as he did so. He tackled Sarah to the floor. Bayless and Sarah wrestled on the ground for a moment over the knife. Bayless was able to get the knife away from her and took control of it. Wilson told me Sarah was kicking and hitting at Bayless as they were on the floor wrestling for the knife. During the struggle, Sarah kicked Wilson in the right shin. When Bayless got control of the knife he stood up and moved away from Sarah and yelled at her to get out. Ofc. Fabian interviewed Bayless and took his statement (see his report).

Sarah sat on the floor for a few seconds yelling at Wilson and Bayless. She stood up and pushed past Wilson into the kitchen. Wilson told me she followed Sarah into the kitchen to lock the door behind her. Sarah reached up into the cabinet and grabbed a full bottle of rum and threw it on the floor. Wilson told me she didn't think Sarah was trying to hit her with the bottle, rather just trying to make a bigger mess. Wilson had since picked up the broken glass and put it in the trash. I looked in the trash can and saw the pieces of a broken bottle. The kitchen floor was soaked and the room smelled of intoxicants. Wilson told me the bottle smashed to the floor a few inches away from her left foot.

I asked Wilson how she felt when Sarah pulled the knife on her. She told me she "felt very threatened" and believed Sarah was going to stab her. She said if Bayless hadn't tackled Sarah she was sure she was going to get hurt. I noticed a camera in Wilson's living room. She said it recorded and she showed me the video of the incident. There was no camera in the kitchen. The camera in the living room showed Sarah standing near the coffee table and her knocking everything off of it. It also showed Bayless contacting Sarah and taking her to the floor. Wilson said she couldn't make a copy of the video for me to use as evidence.

Wilson told me she had custody of Sarah's daughter [REDACTED] #2d [REDACTED] #2d has been living with Wilson for the past 7 years. I asked Wilson if [REDACTED] #2d saw the assault and she told me she was in her room until the police arrived. Wilson told me Sarah had struggled with drug addiction in the past and was court ordered to be in treatment. She told me Sarah didn't go to treatment a single time and "gave her P.O every excuse in the book" to get out of it. Ofc. Fabian spoke with [REDACTED] #2d (see his report).

Wilson also told me Bayless is Sarah's ex girlfriend. They were now broken up and Bayless is also a

recovering drug addict. Wilson allowed Bayless to keep living with her because he was clean now and in treatment doing well. She took him in to help him get back on his feet.

I asked Wilson about the knife she was holding during the assault. She told me it was in her bedroom and went in to get it. I stopped her and told her I would secure it for her. The knife was lying on her bed under her pillow. It was about eight inches long. I asked Wilson how she was holding it when Sarah picked up the folding knife. She used her cigarette and demonstrated for me. She held it in her left hand behind her back. She told me Sarah hadn't seen it when she picked up the folding knife and came after her. I asked Wilson if Sarah ever saw the knife she had. She said when Sarah held the folding knife over her head, she stepped back into the kitchen away from Sarah and held it in front of her. She told Sarah to get away from her. Wilson told me she felt very threatened and was worried she may need to use the knife to defend herself. She told me she never intended to use it against anyone and only had it to give it back to Sarah so she would leave.

Cpl. Cordis responded to the house and took photos of the knives, broken rum bottle, and alcohol soaked floor. Ofc. Everly asked Wilson if we could take the knife that was on her bed as evidence and she said yes. Ofc. Fabian placed the knives on property. Wilson asked me if she could get some type of order to keep Sarah out of her house. I told her she could petition the courts for a protection order. She said she was more worried Sarah would show up at #2d school and wanted to prevent that. I gave Wilson a crime victim card with my name and badge number and the incident number on it. I showed her the phone numbers on the back and explained the resources to her. I told Wilson to call 911 if Sarah came back and she said she would.

Wilson said Sarah was calling her the whole time I was interviewing her. She said there were probably voicemails from Sarah. She showed me a text message Sarah sent her while I was interviewing her. It read, "You don't care about me and give a flying fuck. All I wanted to do was come home and sleep but whatever I see where your loyalties stand. I will die tonight if you can't talk to me tonight." I asked Wilson if Sarah had ever attempted suicide and she said not to her knowledge but had been threatening it. I asked when Sarah threatened to kill herself and Wilson said "oh today, Sunday, Saturday, Friday." I asked if she thought Sarah would try to kill herself and she said she thought she might after this incident.

Sarah came into Wilson's house after she was told to leave several times. Sarah was intoxicated and starting arguments with Bayless and Wilson. Sarah shoved Wilson out of the doorway and pushed past her into Wilson's house after being told she could not come and and to leave. Sarah came into the house and swiped everything off the coffee table, breaking a mirror and scattering things across the floor. Sarah opened a knife and pointed it at Wilson as she was standing about three feet away. Sarah raised the knife over her head and took a step toward Wilson, causing Wilson to fear for her life. Sarah kicked and punched Bayless when he grabbed her arms to defend Wilson. Sarah reached up and out of her way to obtain a bottle of rum and then smashed it against the floor, shattering it. Based on these facts I have probable cause to arrest Wilson for City Assault

(DV) and 2nd Degree Assault (DV) against Wilson.

Ofc. Everly and I left 6008 N. Ash. About three minutes after we left, a 911 call came in from 6008 N. Ash. Dispatch advised that Sarah was back at the house and armed with a knife. She could be heard yelling she was going to kill herself. I turned my patrol car around and went back to the corner of E. Dalke and N. Ash St. and Ofc. Everly I walked up to the house just south of 6008 N. Ash. and held that position. We decided to wait for more officers to arrive before making contact.

From our position, I could hear a female and a male screaming inside the house. I heard a female scream something similiar to 'I'm going to do it'. Ofc. Everly told me to wait, and if Sarah came outside we would contact her. While we were listening, Debra Wilson came out the front screen door. I heard her say, "we need an officer hear now" and then she saw Ofc. Everly and I. When she saw us I heard her say something similiar to 'hurry someone's going to get hurt!' She also said something similiar to "he's holding her down". Ofc. Everly and I ran to the front door of the house.

Believing Bayless had Sarah detained, I decided to go into the house and secure her while the oppurtunity was presenting itself. Sarah had already shown that she was willing to arm herself and use a weapon against someone. I knew based on Wilson's statement that Sarah was likely already armed with a knife. Based on the nature of her activity and the statements about killing herself I heard from inside the house I was worried that if she broke free from Bayless she would re-arm herself with a knife and hurt herself or others.

Ofc. Everly and I went past Wilson into the house to contact Sarah. I drew my Taser as I entered the house and could hear a male and female I believed to be Sarah and Bayless screaming in the kitchen. I heard Bayless scream something like 'help she's going to cut herself.' In the living room I re holstered my Taser and transitioned to my pistol. I was behind Ofc. Everly. When Ofc. Everly got to the entry way to the kitchen I saw Bayless step backward to the south wall of the kitchen. He and Sarah were still screaming. I saw Ofc. Everly had his Taser out and moved up to his left side. I saw Sarah standing about 6 feet away from Ofc. Everly and I and I couldn't see her hands at first. I saw several knives scattered across the kitchen floor and a wooden knife block that was knocked over. Sarah was standing in the kitchen facing us and screaming.

Ofc. Everly tased Sarah while I provided lethal cover. As soon as I heard the Taser discharge I saw Sarah lift her arm toward her midsection. I couldn't immediately recognize what was in Sarah's hand but saw something metallic near her chest and Sarah began to move forward toward Ofc. Everly. The Taser had limited effect and Sarah did not immediately fall. Sarah had already shown her propensity for violence and arming herself with knives on two separate occasions. I feared based on the movement of her hand, seeing something metallic near or in her hand in front of her chest, and her forward movement that Sarah was going to come at Ofc. Everly and stab him. Based on these reasons, I pointed my pistol at Sarah and decided to use deadly force.

Before I did, Sarah went down to her knees. I saw an opportunity to take Sarah into custody. Re-holstering my pistol I moved up to her and slid a knife that was on the floor away from myself and Sarah. She went to her knees and put her back against the kitchen cabinets. I took hold of her by her arm and put my forearm against the back of her neck to keep from turning at me, proning her onto the floor. As I grabbed Sarah, I stepped on a knife with my left foot. I slid the knife away from me with my foot and escorted Sarah to the floor. I felt another knife on the floor and slid it away from me. I handcuffed Sarah and frisked her.

Lt. Hendren responded to 6008 N. Ash (See his report). Cpl. Cordis also responded and took photographs of the scene.

I escorted Sarah outside while Ofc. Everly called for medics. I saw some blood on Sarah's chin. I read Sarah her constitutional rights and asked her if she understood. She said, "I don't have any fucking rights" and said apparently she gets arrested for going into her own house and having someone pull a knife on her. I asked her if she understood her rights again and she shook her head no. I re-read her constitutional rights and asked her if she understood and she shook her head again.

Medics responded and removed the Taser probes from Sarah's body. Ofcs. Fabian and Dollard placed the probes and cartridge on property. I escorted Sarah to my patrol car and searched her incident to arrest. I double locked her handcuffs and placed her in the back of my patrol car. I transported Sarah to the Spokane County Jail and booked her for 2nd Degree Assault (DV). At jail, I noticed a cut on sarah's throat and three parallel cuts on her left arm. Cpl. Cordis responded to jail and photographed her injuries.

On 5/19/14 at about 0032 hours Officer Mohondro and I responded to 6008 N. Ash Street in reference to an assault involving a knife. Prior to arriving on scene radio advised the suspect had left the residence.

Upon our arrival Officer Mohondro contacted Deb Wilson, one of the residents of the house. Officer Fabian interviewed Stephen Bayless another resident of the house. Based on their interviews we developed probable cause to charge Sarah Wilson (Deb Wilson's daughter) for Assault 2nd D.V. against Deb Wilson, and City Assault D.V. against Stephen Bayless.

We cleared the residence at about 0133 hours. At about 0136 hours Radio advised another call came from the above residence and male and female could be heard arguing. Radio stated a female was heard screaming "I'm going to kill myself" and "kill me". Officer Mohondro and I responded back to the residence and arrived at about 0138 hours.

We approached the house on foot from the north. Once we were one house to the north of 6008 N. Ash Officer Mohondro and I held that position waiting for additional officers to arrive. While we were there I could heard screaming coming from inside the residence. I heard a female scream something like "I want to die", and I heard a male's voice say something like "kill yourself but not in this house."

Based on what I was hearing I thought Sarah Wilson had returned home and she was the female screaming she wanted to die. I determined the male's voice to be that of Stephen Bayless. I knew from being there a few minutes prior that Deb Wilson was somewhat disabled, and there was an 11 year old female (Sarah's daughter) also in the house.

Based on that I told Officer Mohondro if Sarah Wilson exited the house we would contact her outside. I decided to wait for additional officers to arrive before we entered the house unless the situation inside deteriorated to the point where others lives were put in jeopardy.

About a minute after hearing Sarah Wilson screaming she wanted to die, I saw Deb Wilson open the front door. She was talking on the phone with radio and I heard her say something to the effect of Sarah was being held down and to get the police there quickly. I decided this was an opportunity to enter the house and safely take Sarah into custody since she was already detained. I feared if we waited she might be able to free herself. If she freed herself I was concerned she may arm herself

with a knife. I based this belief on her past behavior because only minutes before Sarah had shown her propensity to arm herself with a knife. Additionally Sarah's suicidal statements I had just heard solidified my belief if she was able to free herself she would arm herself with a knife or other weapon.

Officer Mohondro and I ran towards the front door and came inside the residence passing Deb Wilson. Once in the residence I heard Stephen yelling something like "help me she is trying to cut her throat." As I went through the livingroom towards the kitchen (that was where I was hearing the Stephen yelling) I drew my Taser. I told Officer Mohondro to provide lethal cover with his pistol. I stopped at the entrance from the livingroom into the kitchen and looked around the corner into the kitchen. I saw Stephen standing up struggling with a female, who I later identified as Sarah Wilson. Sarah was also standing up. They were about 6 feet away from me. I saw a knife on the ground near their feet. I decided to deploy my Taser based on the following factors: Sarah had already committed Assault 2nd Degree D.V. against her mother using a knife, I had just heard Stephen yell Sarah was trying to cut her throat, there was a knife at their feet easily within Sarah's grasp, we were in a kitchen where more knives, and other objects that could be used as a weapon are easily accessible, and I was only about 6 feet away from them.

Sarah turned her body towards me opening up her torso. I discharged my Taser and the probes contacted her in the lower torso area. Sarah slumped down the cabinets to the floor. At this point Officer Mohondro engaged Sarah and pulled her forward onto the kitchen floor. As he was doing this I saw several more knives on the floor. To the left of Sarah I saw a large wooden knife holder that had been knocked on the floor. Both Officer Mohondro and I kicked the various knives that were on the floor out of the way.

Once Officer Mohondro handcuffed Sarah we escorted her outside. She was crying and cursing saying she was trying to come home and her mother pulled a knife on her. I didn't try to talk with Sarah. I requested Fire respond to take the probes out of her. Upon their arrival they took the probes out of Sarah, and Officer Mohondro secured her in our patrol car.

We transported Sarah to the Spokane County Jail where she was booked for Assault 2nd D.V. While at the Jail I saw Sarah had a linear cut mark across the front of her throat. She also had several linear cut marks on her left forearm. Photographs were taken of those injuries.

Officers Fabian and Dollard placed the Taser cartridge and probes on property.

On 5/19/14 at approx. 0230 I was dispatched to a call of a person with a weapon at 6008 N. Ash. Dispatch informed me the caller's daughter was outside the home with a knife that they were able to get away from her but there was an assault.

There were multiple officers already on scene when I arrived and I immediately started speaking with Stephen M. Bayless Jr, the recent ex-boyfriend of the suspect. He told me that his ex, Sara L. Wilson, had come to the house and had been drinking a lot. Once there he said that she entered on her own and without permission. Stephen and Debra were in the bathroom smoking when she came in the house. Debra went out to speak with her and tell her to leave. He said that Debra and Sara started getting in a loud argument which prompted him to come out of the bathroom. As he came out and was heading towards the kitchen through the living room, he said that Debra was standing there with a kitchen knife at waist level and telling Sara she should leave.

It was at this time that Stephen heard a click and saw that Sara had a folder knife now open in her right hand. He assumed she had been holding it the whole time, but can't actually remember seeing it till he heard it open. The moment that he saw the knife, he described the actions of Sara by saying, "I have been around the block and I know when someone is about to attack". He said that Sara also said something along the lines of telling Debra to "come and get some".

Due to Stephen thinking this, he immediately grabbed onto Sara and "popped" the knife out of her

hands and started to try and get control of her. After struggling for a few moments, she broke away from him and ran out of the house. Stephen said that they were wrestling with their hands and in the process Stephen was scratched on the inside of his left elbow/forearm. I saw the scratches and asked Cpl. Cordis to take photos of it. Stephen didn't want any photos taken.

After speaking with Stephen I then spoke with [REDACTED] #2d Sara's 11 year old daughter who was sleeping in the back bedroom. [REDACTED] #2d said that she was awakened by the sounds of people arguing really loudly, but she couldn't understand what anyone was actually saying. She didn't come out of the bedroom during this entire incident until the police arrived. [REDACTED] #2d has been living at the 6008 N. Ash address for the past 7 years with her grandma and during so she says that her mother, Sara, has only been staying there for about the past year. During that time she says that her mother only gets drunk once and awhile, but when she does, "...she really drinks a lot".

After speaking with Ofc. Mohondro who interviewed Debra, he said that her story and Stephen's matched up. He believed that he had probable cause to arrest Sara for Assault 2nd, Burglary 1st and City Malicious Mischief.

I collected up the both of the knives mentioned in the incident to take them to Property. Approx. 15 minutes later while enroute I was dispatched back to the same address with dispatch informing me that Sara had returned and that she was at the house with a knife. Officers Mohondro and Everly were the first ones back on scene and ultimately arrested Sara (see Ofc. Mohondro's report).

After Sara was brought outside and placed in a patrol car, I went in to interview Stephen about what had just happened. He said that Sara had returned back to the house and entered through the back door into the kitchen. Once inside Debra tried to get her back outside with a broom.

Stephen was also in the kitchen and said that Sara didn't make any threats towards them at this point, but did grab onto a kitchen knife and tried to cut her throat with it. Stephen grabbed her and wrestled the knife out of her hands and in doing so said that he was cut on the fingertip. She frantically grabbed another knife and again tried to cut herself with it but Stephen grabbed it from her again and then started trying to gain physical control once again.

It was at this moment that he said two Spokane Police Officers came around the kitchen corner and he saw a red dot move up Sara's legs to her torso. He knew what that was and immediately backed away and then heard the "Clack Clack Clack!" that he knew was a taser and saw Sara go down to the ground where then the police moved in and took control of her.

When asked what Stephen thought Sara would have done if she would have been allowed to grab another knife he said she definitely would have cut herself.

I then collected up the taser cartridge from Ofc. Everly to take to Property along with the two knives

Officer's had investigated an assault call at the location earlier, however, the suspect returned and was armed with a knife.

Upon arrival, I made contact with Debra Wilson and she told me the following: Her daughter, Sarah Wilson, left the location earlier and was the suspect in the assault from earlier.

Debra let her dogs out the back door into the backyard. Shortly after Debra opened the door, Sarah came running toward the back door and tried to push her way into the house. Debra grabbed a broom and held it in front of her to try and keep Sarah from coming in the house but Sarah pushed past her into the kitchen. Debra told Sarah to leave but she ignored her and grabbed a knife and said she was going to kill herself.

Steven who was sitting in the living room heard the yelling in the kitchen and entered the kitchen. Steven saw Sarah with the knife and grabbed her to keep her from hurting herself or hurting Debra with the knife. Steven and Sarah fell to the floor and wrestled on the floor. Debra left the kitchen and called 911.

The undersigned, a law enforcement officer, competent to testify, states as follows: That he/she believes a crime was committed by the above named defendant/defendants in the City and County of Spokane, State of Washington, because:

On 5/19/14 at about 0032 Hours Officer Mohondro and I were working in a two man unit and responded to 6008 N. Ash Street to the report of a female with a knife. Prior to our arrival Radio advised the female with the knife had been disarmed and left the residence.

Upon our arrival Officer Mohondro contacted and interviewed Debra Wilson, one of the residents of 6008 N. Ash Street. She told Officer Mohondro the following. Sarah Wilson is Debra's daughter and is living with her at 6008 N. Ash. She said earlier in the night Sarah told her she was going to go get "high". According to Debra, Sara uses Methamphetamine. Debra said this caused an argument and Sarah left. A few minutes later Sarah returned at the back door telling Debra she wanted her papers and knife. Debra said Sarah then entered the house and pushed her in the chest with both hands knocking her backwards and almost making her fall. Debra said she got Sarah's fixed blade kitchen knife and was holding it in her left hand concealed behind her. She

said she intended to give it to her once Sarah was outside the house. Debra said as Sarah was in the living room she was standing in the doorway connecting the kitchen and living room. She was yelling at Sarah to get out of the house. Debra told Officer Mohondro Sarah produced a knife in her right hand exposing the blade towards Debra. She said Sarah then raised the knife above her head and started to step forward. Debra said she was about 3 feet away from Sarah and feared Sarah was going to stab her. At this point Debra said Stephen Bayless grabbed Sarah's right arm and got the knife away from her. She continued saying Bayless took Sarah to the ground and she saw Sarah hit, slap and kick Bayless. At one point while they were on the ground Debra said Sarah kicked her in the right shin. Once Sarah was let up Debra said she (Sarah) went into the kitchen and took a bottle of rum out of the cabinet and threw it on the ground breaking it. Sarah then left through the backdoor.

Officer Fabian interviewed Stephen Bayless. He told Officer Fabian the following. He was in the bathroom smoking when he heard Debra arguing his with ex-girlfriend Sarah Wilson. He said he went out and saw Sarah holding a knife over her head facing Debra. He said he grabbed Sarah's arm that was holding the knife and took her to the ground. While on the ground Stephen said Sarah was hitting and kicking him. Stephen said something to the effect of he had a feeling Sarah was going to stab Debra.

In the kitchen I noted the floor was wet. Debra said that was a result of Sarah breaking the Rum bottle on the floor. Debra also gave me the fixed bladed knife she had that she was going to give to Sarah, as well as the lock blade knife Sarah had brandished. Officer Fabian took the two knives to place on property.


We determined there was probable cause to arrest Sarah for one count of Assault 2nd D. V., one count of City Assault D.V. (Stephen Bayless as the victim) and one count of City Malicious Mischief D.V.

At about 0136 hours we returned because Sarah returned and threatening suicide. When we arrived I heard Sarah screaming she wanted to die. Upon entering the house I heard Stephen Bayless yelling something like "help me she is trying to cut her throat." I entered the kitchen and saw Stephen struggling with Sarah. Based on the totality of the circumstances I Tased Sarah in the torso so we could safely take her into custody.

Once Sarah was taken into custody and treated by Fire for the Taser application she was booked into the Spokane County Jail for Assault 2nd D.V.
