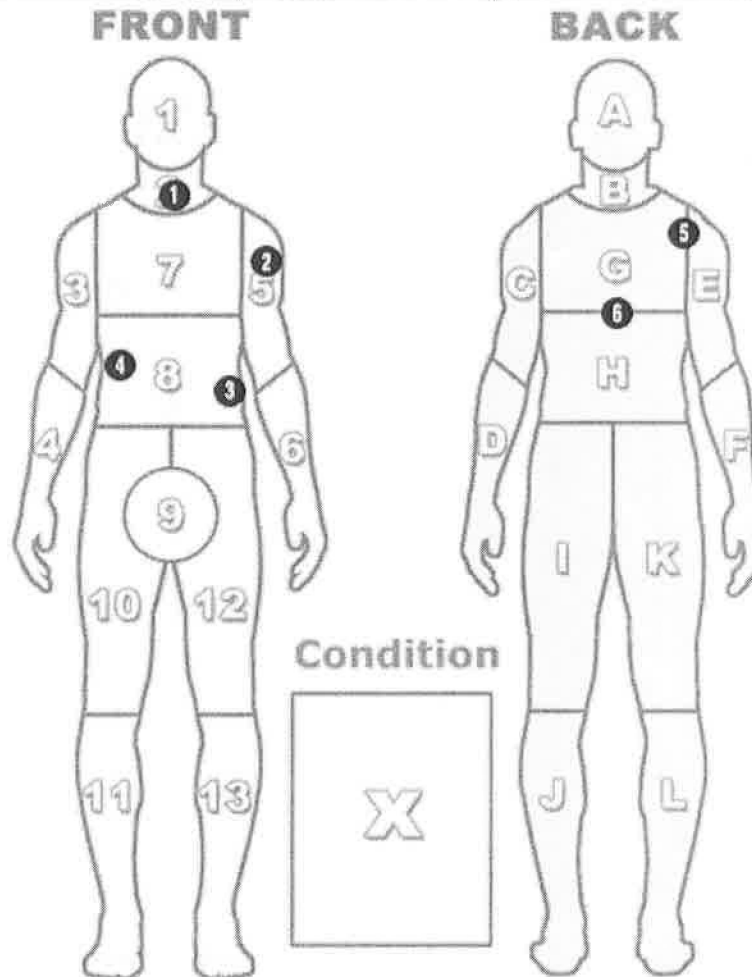

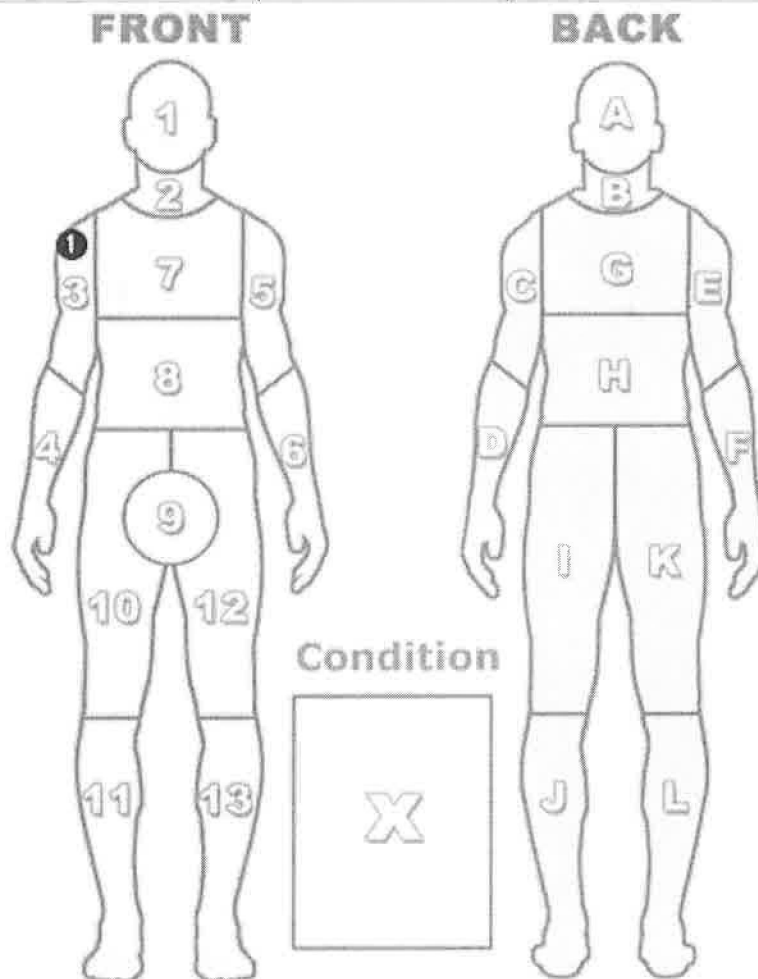

Use of Force (14-190341)

Complainant Interview Summary

I contacted Adam Butler at Deaconess Hospital after he had been in an altercation with a K9 and Officers. Mr. Butler was being treated for his injuries. I asked Mr. Butler what happened. He stated he should have listened to the officers. I asked him to tell me what happened. He stated his girlfriend threw him out last night because he had been doing some acid: 3 hits. He was running around the apartment complex, saw the police car and was told to stop. He then ran into the garage. He heard the officers telling him to come out, but he couldn't move. He stated, "It was my fault. I should have come out when they asked me to." He then fought to get out of the garage. He stated the officers were "All under control," "Did a super job," and were "choreographed." He stated their actions were "not excessive."

Ms. Halterman, Mr. Butler's girlfriend, contacted me by phone and indicated her shoulder hurt from the altercation. She did not complain about this; however, she wanted to advise SPD. She also stated that she went to the garage because she heard Mr. Butler screaming and she wanted to help him.

Officer Interview Summary

Officers responded to Mr. Butler, naked, under a porch. Once located, Mr. Butler ran from officers and was ordered to stop. Mr. Butler ran into a garage at the location. Numerous commands were given to Mr. Butler to exit the garage; however, he did not comply. A SCSO K9 responded to assist. The complainant advised Mr. Butler did not live at the location. After more commands from the K9 officer, Mr. Butler refused to exit the garage. Officers entered the garage with the K9 searching for Mr. Butler. Mr. Butler began fighting with the K9, including kicking and hitting the K9. Numerous commands were given to Mr. Butler to stop fighting and lie on the ground, but he did not comply. Ms. Halterman entered the garage, yelling at the officers and approaching them from the rear. The situation became tense, uncertain and rapidly evolving. As Ms. Halterman was about to jump on Officer Lyons' back he pushed her away. Officer Conrath who was now trying to control Mr. Butler, let go of him to address Ms. Halterman as she was now assaulting officers. He took arm control and escorted her out of the garage away from other officers. During this time Ms. Halterman was pushing into him and flaying her arms. Her actions were assaultive in nature she needed to be controlled. Ms.

Halterman was taken to the ground with an arm bar take down and handcuffed for the following reasons:

Crime: She was actively hindering and delaying officers in the arrest of a subject. She had assaulted an officer as she was interfering with the arrest.

Threat: Ms. Butler imposed herself in an active arrest of a subject that was fighting with police by trying to jumping on the back of an officer.

Resistance: Ms. Butler has been pushed away from jumping on an officer's back. She was physically escorted out of a small garage away from an active arrest situation with Mr. Butler. During this time she pushed into the officer and flayed her arm around actively resisting Officer Conrath.

Mr. Butler finally complied with officers' commands to get on the ground. Deputy Kullman stepped in to restrain his dog, allowing officers to take control of Mr. Butler. As officers approached Mr. Butler he began swinging his arms and kicking toward the officers. He kicked toward Officer Lyons and kicked Officer C. Lesser. Level II Strikes, TASER and a Level 1 LNR were deployed by officers for the following reasons:

Crime: Mr. Butler obstructed officers and officers believed he did not have standing to be in the garage. He had assaulted the K9 and officers at the scene.

Threat: Mr. Butler was not following commands to stop fighting or to get on the ground. There was broken glass on the floor. Mr. Butler appeared to be under the influence of a controlled substance.

Resistance: Mr. Butler assaulted a K9 and was actively assaulting officers with his hands and feet.

Officer Lyons delivered 3 knee strikes during the incident and deployed his TASER 2 times. Officer C. Lesser attempted a Level 1 LNR, but was unable to hold onto Mr. Butler. Officer Lyons applied a Level 1 LNR and Mr. Butler conceded. Officers were then able to handcuff Mr. Butler. Medics were summoned to the scene to evaluate Mr. Butler and he was transported to the hospital.

Officer Lyons reported a failed TASER cartridge deployment during the incident.

SCSO Deputy Kullman deployed his K9 and he will be completing a K9 use of force under their policy. See SCSO K9 use of force report.

Witness Interview Summary

Mr. Browning heard someone outside and went to investigate. He saw his tail gate on his PU down, items on his porch and clothes were scattered everywhere. He confronted Mr. Butler who screamed profanities at him. He did not believe Mr. Butler lived in the neighborhood.

Mr. Moore stated he heard officers giving commands to Mr. Butler to exit the garage and he was under arrest. He heard the dog barking and the fighting. He did not believe Mr. Butler lived at the duplex, as he talked to him yesterday and Mr. Butler said he lived a few blocks away. He stated Mr. Butler's girlfriend lives at the duplex.

Ms. Halterman stated the garage belongs to her and Mr. Butler is her boyfriend who lives with her. Mr. Butler was not suppose to be at the residence because he had been using meth and she kicked him out.

Physical Evidence

Photographs and written statements.

Investigative Summary

Officer C. Lesser responded to a suspicious person and located Mr. Butler wearing a thong with his penis exposed. Mr. Butler ran from Officer C. Lesser who gave him commands to stop. Mr. Butler then secreted himself in a garage. Numerous commands were given to Mr. Butler telling him he was under arrest and to exit the garage. Mr. Butler did not comply nor did he communicate with officers. The complainant believed Mr. Butler did not live at the location and Mr. Butler never advised officers he lived at the location. Believing Mr. Butler had no standing at the duplex or the garage, a K9 was deployed as Mr. Butler refused to exit the garage. Once contact was made with Mr. Butler he fought violently with the K9. After assaulting the K9 he turned his aggression toward officers assaulting Officer Lyons and Officer C. Lesser. Officers were forced to defend themselves with Level 2 strikes, TASER and a Level I LNR in order to take Mr. Butler into custody. Mr. Butler received multiple scrapes and cuts from rolling around on the ground where broken glass was present. Further he received K9 bits that were documented by SCSO K9 Deputy Kullman. Medical care was provided at the scene and hospital for Mr. Butler due to his injuries and drug usage.

Ms. Halterman obstructed officers during the altercation by attempting to jump on an officer's back. She was pushed away and Officer Conrath disengaged from Mr. Butler to escorted Ms. Halterman out of the garage. This added to the danger of the scene. During this time she resisted Officer Conrath's efforts by pushing into him and flaying arm around. She was taken to the ground and detained in handcuffs. She received a sore shoulder from this incident. Reasonableness of using force on Ms. Halterman in based on these factors:

- (a) Immediacy and severity of the threat to officers or others.
- (b) The conduct of the individual being confronted, as reasonably perceived by the officer at the time
- (g) The degree to which the subject has been effectively restrained and his/her ability to resist despite being restrained.
- (h) The availability of other options and their possible effectiveness.
- (i) Seriousness of the suspected offense or reason for contact with the individual.
- (j) Training and experience of the officer.
- (k) Potential for injury to officers, suspects and others.
- (l) Whether the person appears to be resisting, attempting to evade arrest by flight or is

attacking the officer.

(n) The apparent need for immediate control of the subject or a prompt resolution of the situation.

Ms. Halterman posed a serious threat to the officers, she assaulted an officer and she was actively resisting. Officer Conrath's actions of escorting her out of the active arrest scene and taking her to the ground were objectively reasonable based on the totality of the circumstances. Officer Conrath's actions were within departmental guidelines and state law.

Mr. Butler admitted to using acid prior to the altercation. He admitted to not following officers' commands, assaulting the K9 and officers. He created a situation that was tense, uncertain and rapidly evolving that put officers in fear of great bodily injury. Mr. Butler stated the officers' actions were not "excessive." The officers' actions were objectively reasonable based on the totality of the circumstances. The officers' actions were within departmental guidelines and state law.

On 6/14/2014 at approximately 0503 hours, I responded to 1824 W 2nd #1 in regards to a partially naked male that was hiding under a front porch.

As I arrived on scene I observed a partially naked male later identified as Adam Butler running around in the grass. Adam was wearing a thong and his penis was fully exposed as he ran around. As I exited my marked patrol vehicle in my duty uniform, Adam began to run towards the backyard of the residence. As Adam ran around I was yelling "Police, Stop!" Adam ignored my commands and ran into the back yard. I arrived on scene at 0503 hours

While I waited for back up to arrive, I contacted the complainant, Robert Browning. Robert stated that he was in his living room when he heard the tail gate on his pick up began slamming up and down. Robert went outside to investigate. As Robert exited his house he observed the buckets of flowers on his porch were overturned and scattered everywhere. Robert's weed-whacker had been thrown on top of a 10 ft bush, and there was a pile of unknown clothes on his porch. Robert stepped off of his porch and witnessed Adam Butler hiding under his neighbors porch half naked. Robert confronted Adam and Adam began to scream profanities at him. Robert separated himself from the situation and called 911. Robert stated that Adam does not live in the neighborhood, and that he does not belong in the area. Robert confirmed with me that the man I witnessed was the same man he was dealing with due to the large "Butler" tattoo across Adams shoulder blades.

Ofc C. Lyons arrived on scene and I informed him of the situation. I told Ofc Lyons that I believed Adam was hiding in a attached garage in the backyard of a duplex that contains 157 and 159 South Elm St.

At 0507 hours, we began to check the back yard I observed Adam naked from the waist down go into a garage on the north side of the building that was attached to the duplex. As I came around the corner the door to the garage was open by about 1-2 feet and there was a large folding camp saw lying under the door. The blade on the saw was locked open and the blade was facing up. The locking mechanism on the saw appeared as if it had just been broken and forced open.

At 0508 hours, Ofc Lyons gave several verbal commands identifying ourselves as the police, and that Adam was under arrest. Adam did not respond. Ofc Lyons attempted several more times and continued to identify ourselves with no responses from Adam. I could hear banging noises inside the garage, but Adam did not respond back to our verbal commands.

I could hear loud banging noises coming from inside the attached garage. I was unsure if Adam was attempting to gain entry inside one of the duplexes through an exterior wall.

At 0509 hours, Ofc Lyons requested a k9 to assist with the situation. While awaiting the K9 the original complainant walked up to myself and Ofc Lyons and confirmed that Adam does not live in the duplex, and has no right to be in the attached garage.

We tried several more times to order the male out of the garage and continually identified ourselves as the police. Adam would not respond and I could hear things being broken inside. I was concerned that Adam was becoming more agitated, and that he was attempting to gain access into the duplex through the wall.

The open blade saw was in close proximity to Adam and he could access it quickly and easily if he wanted to.

At 0510 hours, K9 Deputy Kullman arrived on scene and was advised of the situation by Ofc Lyons. Myself and Ofc Lyons had probable cause to arrest Adam for 2nd degree burglary at that time.

Deputy Kullman made several more K-9 announcements from the door of the garage. Ofc Lyons also gave several more announcements stating that Adam was under arrest. After several announcements Adam yelled "Ok, Ok, I'm coming out!" We waited for approximately 1 minute and Adam still did not come out. Deputy Kullman began making more announcements and Adam did not respond. I could not hear Adam inside and he was not responding to our verbal commands. I was in fear that Adam had gained entry into the duplex and could be inside harming an innocent person.

Deputy made several more announcements before he opened the door and kicked the knife out of the way.

At 0512 hours We continually made announcements and slowly began to visually clear the garage from the outside. I could not see Adam at this point. I observed a small blanket in the middle of the garage. The blanket was located over a large pile of broken glass. The blanket was very small and did not look like it could conceal a person.

We gave several more announcements as we entered the garage. As the K9 searched past the blanket, the blanket began to move violently. Adam sat up and began attempting to hit the dog. Adam was naked and began to fight violently with the dog. Myself and Ofc Lyons continually yelled at Adam to lay on his stomach.

Adam ignored commands and continued to hit the dog with closed/open fists. Adam continued to ignore officers commands and fight with the dog. Adam continued to fight with the dog and began to work his way towards Ofc Lyons and myself. Adam got on his knees and looked as if he was going to tackle myself or Ofc Lyons.

At some point during the struggle, a female later identified as Caitlin Halterman sprinted into the garage from behind myself and other officers. Before I could react, she attempted to jump on one of the officers backs. Caitlin was pushed away from the fight and she began to yell something along the lines of "He's not supposed to be here!" Ofc Conrath immediately grabbed Caitlin and pulled her outside of the garage.

I moved in to arm control as Deputy Kullman removed his K9. Adam continued to fight violently and not obey commands. The male was covered in sweat and he began swinging his clenched fists. Adam then attempted to kick Ofc Lyons, he then connected a kick with me in the leg.

Ofc Lyons told Adam that he was going to be tased if he did not stop fighting and obey our commands. Adam paused momentarily and then began to fight again violently. Ofc Lyons then applied the taser on Adam. See Ofc Lyons report for additional details.

Myself and Ofc Lyons then moved back in for arm control. Due to Adam's dripping sweat and blood he was very slippery and hard to hold on to. Adam was flailing violently and continued to disobey commands. Adam continued to scream and attempted to strike Ofc Lyons and myself with his legs.

I got Adam in a prone cuffing position and began to handcuff him. Adam was able to overpower my wrist lock and grab my handcuffs from behind his back. While Adams hands were behind his back he gained control of my handcuffs and threw them across the room.

Adam then overpowered officers and stood to his feet. Adam began to drag the fight towards the garage door. Adam continued to struggle and fight violently. I attempted to place Adam in a lateral neck restraint but he was too slippery and slipped out from under my arm.

As the fight continued violently towards the door, Ofc Lyons was able to get Adam in a lateral neck restraint. Adam finally stopped fighting and told officers he was done fighting. Officers place Adams in handcuffs (d.I) as he apologized several times for his actions. It appeared as if Adam was under the influence of some sort of drug stimulant.

Medics were immediately called to the scene to aid Adam. After medics arrived on scene I observed that my arms and uniform were covered in Adam's blood.

As Adam was being examined by medics, Marshall Moore came outside and wanted to know what was going on. Marshall stated that he could hear us giving verbal commands multiple times in attempt to get Adam to come out. Marshall advised that Adam lives a few blocks away. See Ofc Lyons report for details. Ofc Lyons also obtained a written statement from Marshall.

Ofc Conrath interviewed Adams girlfriend, Caitlin. See Ofc Conrath's report for details.

As we briefed Sgt Kannberg on the situation, Caitlin waived Ofc Lyons over and gave Ofc Lyons more statements. See Ofc Lyons report for statements made by Caitlin.

Adam was transported to Deaconess Hospital by AMR. I rode in the back of the ambulance to ensure the safety of AMR personnel and Adam. After arriving at the hospital I read Adam his Constitutional Rights from a pre printed department card. Adam acknowledged his rights and agreed to answer my questions.

Cpl Harding responded to the scene and took photographs of the garage, the saw, broken clasp on the door, taser cartridge, and the blanket Adam was hiding under.

Adam stated that he had done 3 hits of acid, and didn't think he was out of control. Adam admitted that he kicked/attempted to kick officers 12 times. Adam admitted to running from the me as I arrived and hiding in the garage. Adam also admitted to hearing our commands, and purposely ignoring them. Adam stated that officers on scene were very professional and that we used the minimum amount of force that we had to. See Ofc Lyons report for further statements made by Adam.

A name check of Adam revealed that he is a registered sex offender.

Sgt Kannberg gave me a ride back to my patrol vehicle and Ofc Tilley check on scene at the hospital and took custody of Adam. Ofc Tilley was briefed on the charges for Adam.

Throughout the incident, probable cause was established to arrest Adam with two counts of 3rd degree assault on a law enforcement officer, harming a police dog, resisting arrest, and

On 061414 at approximately 0503 hours, I responded to 1824 W. 2nd #1 regarding a male hiding under a front porch that was partially naked.

Ofc. C. Lesser arrived onscene and advised that a half naked male wearing a thong ran from him.

Upon arrival Ofc. C. Lesser advised that he believed that the male was hiding in a shed in the back yard. We began to check the back yard behind the duplex that contains 157 and 159 S. Elm. As we rounded the corner, I saw a male naked from the waist up go into a garage on the north side of the building that was attached to the duplex. The door of the garage was standing open about a foot, there was a large folding camp saw lying under the door blade up and open, and the lock clasp was broken off and it appeared to have just been done. I identified myself as "Spokane Police" and ordered the male out of the garage. The male did not respond. I ordered the male out several more times and continued to identify myself with no response other than hearing banging sounds inside the garage. It should be noted that both Ofc. C. Lesser and I were wearing our duty uniforms.

At this point I believed the male had broken into the garage that was attached to the residence and was not sure if he was trying to break further into the residence. It also concerned me that the male was almost naked and feared that he might be trying to commit a sex crime.

I requested a K-9 and continued to order the male out of the garage. The initial complainant came over and I asked him who lived in the duplex and he advised that it was not the male and that

the male had broken into the garage.

I continued to order the male out of the garage and identify myself. The male did not respond and I could hear banging inside, further concerning me that he was attempting to break through a wall or the ceiling. It also concerned me that the saw was sitting in the doorway and easily accessible to the suspect.

K-9 Deputy Kullman arrived and I advised him of what we had. I advised Deputy Kullman that with the information we had at this point we had probable cause to arrest the male for 2nd degree burglary and that it sounded like the male was trying to break further into the garage.

Deputy Kullman made several K-9 announcements. I also made several more announcements and told the male that he was under arrest several times. After several K-9 announcements, the male yelled, "Ok, Ok, I'm coming out!". We waited for a another minute or so and the male still did not come out. We made several more announcements and the male did not respond. At this point I wasn't sure if the male had made it through a wall or the ceiling. Deputy Kullman gave several more K-9 announcements and then moved up and threw the door open. The open saw moved a little and I ran up and kicked it away. We continued to make announcements and slowly visually cleared the garage from the outside and did not see the male. Towards the back of the garage I could see a blanket, but it appeared to small to have anyone under it. The blanket was also lying on top of broken glass, which further led me to believe that there was no one under the blanket. I began to scan the garage looking for holes. Right behind the blanket there was a large board leaning up against the wall and I suspected that there might be a hole behind it.

We gave several more commands and entered the garage. As the K-9 searched past the blanket it began to flail violently. The male sat up and began screaming and attempting to hit the dog. I could see that the male was naked. The male fought violently with the dog and I yelled commands telling him to lie on his stomach. The male ignored my commands and continued to hit the dog with both closed fist and open hands. The male continued to flail around, fight with the dog, and ignore commands. Each time we would get close to the male he would kick at me with both legs trying to assault me. As the male fought with the dog he made his way to his hands and knees and looked up at me as if he were going to jump towards me. I delivered one knee strike to the males left shoulder area knocking him to his side and continued to tell him that he was under arrest and to stay down. The male continued to fight with the dog and kick at myself and Officer C. Lesser. The male made his way to his knees a second time and again looked up as if he were targeting one of us. Fearing that the male was going to attempt to tackle one of us I delivered a knee strike to his left torso area knocking him to the ground.

As I gave the male verbal commands I felt someone move quickly up behind me. I turned and saw a female, who was later identified as Kaitlin Halterman moving up as if she was going to grab or jump on me. I immediately pushed the female backwards to the garage wall and I could hear her say

something to the effect of, "He's not supposed to be here!". Ofc. Conrath immediately grabbed Kaitlin and pulled her from the garage.

I moved in to take an arm and Deputy Kullman removed his K-9. The male continued to fight and thrash around. I could see that the males fists were clenched. The male was covered in sweat and there was some blood making it hard to hold onto him. The male again tried to kick us. I drew my X26P Taser, turned it on displaying the laser, pointed it at the male and told him that if he didn't stop he was going to be tased. The male initially stopped fighting and Officer's moved in to take control of him. The male immediately started fighting again. The male was thrashing around and I could see that his fists were still clenched. I pointed the taser at the males back and pulled the trigger in an attempt to probe him. The taser malfunctioned, did not deploy the probes, and arched out the front of the cartridge. This caught me by surprise and I drove the taser into the males back in an attempt to salvage the malfunction with a drive stun application. The male was thrashing so violently that the taser appeared to be bouncing off of him. As I drew the taser back the probes deployed striking the male in the right shoulder. This appeared to be a continuation of the taser malfunctioning and had little effect on the male. I applied another drive stun to the male's back hoping to make better contact and the male continued to thrash violently. When I again had no success with the taser I dis-connected the cartridge, and tossed the taser off to the side.

I took a hold of the males left arm and the male continued to fight with use. Again, due to the sweat and blood it was very hard to hold onto the male's arm. The male continued to yell and scream and attempt to kick at us. Ofc. C. Lesser attempted to place the male into handcuffs and the male grabbed the handcuffs, while his arm was behind his back, and threw them. The male began trying to make his way towards the door and was still kicking and now hitting towards Officer's. I delivered another knee strike to the male's left torso and we were able to get a hold of his arms. The male got to his feet and lunged for the doors pulling us outside. The male continued to fight and struggle. I placed the male in a lateral neck restraint and used my body weight to push the male to the ground. As I worked to apply the neck restraint, the male stopped fighting and told us that he was done. We placed the male into handcuffs (DL). The male apologized several times and appeared to be under the influence of a stimulant.

Once the male was in custody I requested medics to come and check on the male due to the length of the fight and the taser applications. I also noticed that I had the suspects blood on my hands and arms. Once medic's arrived I decontaminated myself.

As I decontaminated myself, a male came out of the 157 S. Elm. I contacted the male and he identified himself as Marshall G. Moore. I asked Marshall if he had witnessed what had happened and he stated that he heard us telling the male to come out and that he was under arrest. He heard the dog barking and then fighting. Marshall advised that he did not believe the male lived at the duplex and that he talked to him yesterday and the male told him that he lived a few blocks away. Marshall advised that the males girlfriend lived at the duplex. Marshall advised that he would write a

written statement for us. (See Marshall's statement)

Sgt. Kannberg arrived and I advised him of the situation. As I spoke with Sgt. Kannberg, Kaitlin waived me over. Kaitlin, who had been speaking with Ofc. Conrath, advised the male, who was identified as Adam T. Butler was her boyfriend and that he had relapsed on meth tonight so she kicked him out. Kaitlin advised that Adam has had prior problems with meth but that he was aloud to be at the location. Kaitlin advised that all of the neighbors would tell us that Adam does not live there and that he isn't supposed to be there.

Adam was transported to Deaconess Hospital by AMR.

Cpl. Harding responded and took photographs of the garage, the saw, the broken clasp on the door, the taser cartridge, and the blanket. I collected the taser cartridge and the saw as evidence. It should be noted that when I looked at the taser cartridge, only one side of the wire deployed properly and the other half was stiff in the cartridge.

As I walked back to my patrol car I could see that there was clothing on the corner of 2nd / Elm, which was not wet and appeared to not have been there that long.

I responded to Deaconess Hospital where Adam was talking to the doctor. Adam was apologizing for what he did and telling the doctor that he did 3 hits of acid and thought he was ok. Adam rambled on that we were just doing our job and that he was sorry he fought with us.

I asked Adam why he was kicking us and he advised that he was just trying to the outside and that he was sorry. I asked Adam how many times he kicked at or kicked as and he said, "At least 12". Adam advised that he ran from the Police car and hid in the garage and then ignored our commands to come out. Adam blamed the acid and advised that he always reacts violently and that he had to fight at first. Adam bragged about being able to fight through the taser and stated that after he fought through the taser he thought he could fight to get away because he had already beat the taser. I advised Adam that the taser malfunctioned. Adam stated several times that we were very polite and professional and used the minimum amount of force that we had to. Adam advised that if he were us, he would have killed him. I advised Adam that we did not want to kill, hurt, or even fight with him, and that we only wanted him to come out and give up. Adam advised that he couldn't due to the acid.

A name check of Adam showed that he was a sex offender.

Ofc. Tilley responded and took custody of Adam. I advised Ofc. Tilley that Adam was under arrest fro 2 counts of 3rd degree assault (law enforcement) and Deputy Kullman advised that he had probable cause to charge Adam with harming a police dog. I gave Ofc. Tilley the saw and taser cartridge to place on Police Property as evidence.

When I arrived, Officer Lyons, Officer C Lesser, and K-9 Deputy Kullman were already on scene. I deployed my bean bag shotgun. I approached the area near the shed and observed Deputy Kullman administering multiple advisements to the man inside that he was going to deploy his dog, and that he would be bitten if he didn't surrender. I looked inside the garage where I saw what appeared to be a person hiding underneath a blanket. There was a shattered pane of glass on the floor beneath the person. The large shards of glass, aside from seeming highly uncomfortable to lay on, could easily have been used as weapons. At that time, I believed that there was PC to charge Butler with Burglary 2nd Degree.

The K-9 was released into the garage. It appeared to me that when the dog went near Butler he popped up from the ground and started trying to punch the dog. It was clear to me that Butler was not simply thrashing around in an attempt escape, but was actually attacking the K-9. The other officers got involved in effort to restrain Butler. I heard multiple commands to stop fighting, and to lay on his stomach. Butler continued fighting the K-9 and the officers. He was punching and kicking in every direction. During that time, the K-9 performed well and was not deterred by Butler's assaults. Butler sustained several contacts from the dog. I stood back initially because I still had my bean bag shotgun in my hands. I quickly set that off to the side to assist. Moments after I took control of Butler's right arm, I heard a loud scream from a female approaching us from behind. A woman, wearing only a tank top and underwear ran towards us and seemed to nearly jump on the back of Officer Lyons who was positioned to my immediate left. I only had time to turn and put up my left hand/forearm to fend her off. She was screaming something similar to, "What are you doing!? He's not supposed to be here!" Officer Lyons and I simultaneously shoved her back against the wall of the garage. I turned my attention to the female. I forced her out of the garage, and quickly took her to the ground using an arm bar takedown on her right arm. The woman, later identified as Caitlin Halterman resisted my efforts and my instructions with all her strength. I placed her under arrest for assaulting officers and applied handcuffs(dl). I looked up briefly to see two small children standing in the yard watching the whole incident. They were Caitlin's kids, twelve year old #2d and five year old #2d. Both children were crying hysterically and were clearly and understandably upset. I told the kids to go back in the house.

As I dealt with Caitlin outside, I could hear that the fight inside the garage was escalating. I heard the sound of a taser deployment, which was louder than usual which indicated to me that there wasn't a good connection. I told Caitlin to stay where she was, then went back inside to help my partners. I saw Butler kicking and punching in the direction of the other officers, though I didn't notice if he landed any of his strikes. At the same time, I didn't take notice of any strikes delivered by the other officers.

Butler was bleeding in several places from the dog bites. He was sweaty and had blood on him as well which made controlling him very difficult as he was slippery. At one point, I had control of his right arm again while I believe Ofc Lesser had his left. Ofc Lyons was attempting to apply a neck

restraint. I suggested that we take him outside onto the grass where it would be safer to deal with him. We were quickly able to overpower him and apply handcuffs with a minimal amount of force.

When I questioned Caitlin, she told me that the garage belonged to her. I started to explain that the police were there to take custody of a man who had burglarized her garage. Then she stated that Butler was her boyfriend, and was allowed to be there. She clarified by saying that she and Butler had been together for more than seven years. Apparently he is a long time meth addict who had been working towards a recovery until just recently when he relapsed. #2d is Butler's son, and they both live there with Caitlin at her apartment. Caitlin had told us that he "wasn't supposed to be there" because she had kicked him out just hours prior to the incident that morning. He had come home high again and she didn't want him to be around the kids in that condition. In other words, she didn't want him there but he had every right to be.

Ultimately, after consulting with the other officers it was determined that there was no PC for a burglary. We did however take Butler into custody for that crime with the good faith belief at that time that it was legitimate. He was charged with two counts of Assault 3rd Degree against Officer Lyons and Officer Lesser, as well as with Harming a Police K-9.

Caitlin was not charged with a crime although she did directly interfere with a lawful arrest that we were making, and in doing so assault officers. She was very shaken up by the incident as were her two small children. It was best for all involved that she not be charged criminally.

I sustained only minor scrapes and bruises to my forearms/elbows as a result of the altercation, in addition to some direct exposure to Butler's blood. I was not assaulted by Butler.

I requested that Caitlin give a formal written statement, which she did, but she failed to include any pertinent information in the brief statement which is included with this report.

See reports from Officer Lyons and Officer Lesser for additional information from the incident.

It was brought to my attention that some clarifying information was needed regarding my interaction with Caitlin Halterman during this incident, and the reasons that I felt it necessary to take her to the ground using an arm-bar takedown.

It should be noted that at the time Caitlin interjected herself into the situation, I, along with three other officers and a K-9 were actively involved in a rather violent confrontation with a naked male who we believed had burglarized an attached garage. The situation was not only volatile, but highly dangerous for all involved, including the arrestee and officers. Butler, the arrestee, had clearly demonstrated that he had no intention of surrendering, and that he was going to fight until police managed to contain him by force. There were shards of broken glass covering the floor which could easily be used as weapons. I cannot speak to the mindset of the other officers, but it is common knowledge among the people I work with that incidents like this one often result in cases of excited delirium, and possible death to the arrestee if it is not handled swiftly and efficiently. There is no doubt that this was more than just a scuffle with an arrestee, but more importantly it was a medical emergency.

As I noted in my first supplemental report, the other officers and I were already engaged in a physical fight with Butler. Ofc Lyons and I had our backs to the open garage door, when Caitlin came running into the garage and leapt onto Ofc Lyons' back. We had no idea as to who she was, or why she was there. All we knew at that time was that she just appeared and attacked Ofc Lyons. Luckily both of us heard her screams, and were able to turn slightly towards her and put up one hand each. At that moment, Caitlin was behaving in an equally irrational manner as Butler. She was hysterically screaming and flailing her arms. There was no time to ask questions of her or to have a conversation. She assaulted an officer, and my belief was that she needed to be taken into custody immediately. I felt the need to place her into handcuffs as quickly as possible, so that I could return to the garage and help my partners. This portion of the incident happened within about three seconds. When I was forced to turn my attention Toward Caitlin, I lost control of Butler's right arm which I was holding onto at the time. That gave him a momentary advantage against my partners, and may very well have resulted in more force being used than would have been needed otherwise.

I first removed Caitlin from the garage area because that space was being used by the officers who were fighting to gain control of Butler. I took ahold of Caitlin's right arm in what we call "the escort position." My left hand was just above her elbow while my right hand was on her wrist. I physically

forced her back outside while she pushed against me and swung her left arm around. I moved her outside and just to the north where there was a grassy area in the yard. She continued to fight with me. I did not have the time to give her many verbal instructions other than to say "you're under arrest!" and "get on the ground," as I applied the arm-bar. When I first applied the technique, Caitlin resisted by trying to stand up again. Normally, with a larger subject, the appropriate counter to that would be to move with them and take them down in a rearward direction by using their momentum against them and applying a figure-four. In this case, I simply overpowered Caitlin due to the fact that I was bigger and stronger than she was. Once she was face-down on the ground, I applied handcuffs, instructed her not to move, and ran back into the garage where I was needed.

After the incident was over, I had a lengthy conversation with Caitlin about exactly why things happened the way they did. I explained to her that she had committed a felony assault on an officer, and that a much greater amount of force would have been justified under the circumstances. At that time, she seemed to understand that she was lucky to not have been hurt as a result of her behavior.

Again, as I mentioned in my previous report, it was decided that charging Caitlin with a felony in this case was not the best course of action. Officer discretion was utilized, though there was probable cause to charge her with Assault 3rd Degree.

The undersigned, a law enforcement officer, competent to testify, states as follows: That he/she believes a crime was committed by the above named defendant/defendants in the City and County of Spokane, State of Washington, because: There is probable cause to believe that the defendant committed the crime of harming a police dog and two counts of 3rd degree assault. The crime occurred on 6/14/14 at approximately 0445 hours at 157 South Elm Street, Spokane WA.

Witness, Robert Browning , can testify to the following:

- 1) Resides at 1824 W 2nd Ave, Spokane WA.
- 2) On 6/14/2014, at approximately 0445 hours, was in his home sitting in the living room
- 3) Heard a noise he recognized as the tailgate on his truck slamming up and down
- 4) Walked outside and observed the defendant naked from the waist down hiding under the neighbors porch
- 5) Observed the defendant run around the neighbors house several times
- 6) Contacted Ofc C Lesser as he arrived on scene
- 7) Immediately told Ofc C Lesser that he did not recognize the defendant, and that the defendant did not belong in the neighborhood.
- 8) Observed the defendant run into the attached garage of 157 S Elm Street
- 9) Told Ofc C. Lesser that the defendant was not the owner of the garage and that the defendant had no right to be inside of it

Ofc. C Lesser can testify to the following:

- 1) Is an employee of the Spokane Police Department in Spokane WA currently assigned to the patrol division.
- 2) On 6/14/14 at 0445 hours, was dispatched to 157 S Elm St in regards to a naked male (the defendant) that was hiding under the neighbor's porch.
- 3) Arrived on scene at 157 S Elm Street and observed the defendant running around the front yard wearing a shirt and a thong.
- 4) Exited my marked patrol vehicle and yelled at the defendant to stop, and identified myself as the police
- 5) Observed the defendant run into the attached garage of 157 S Elm Street
- 6) Approached the open door of the garage and observed a large folding camp saw laying in the door of the garage
- 7) Observed the defendant's arm flailing around inside the garage.
- 8) Heard noises consistent with the defendant attempting to gain entry into the house through the garage.
- 9) Developed probable cause to believe the defendant was committing a burglary
- 10) Witnessed Ofc C Lyons give numerous verbal commands to the defendant who was hiding in the garage.
- 11) Witnessed several K-9 announcements, which the defendant ignored.
- 12) Witnessed as the defendant punched and kicked at the K-9 in effort to resist arrest.
- 13) Witnessed the defendant punch and kick at Ofc C Lyons
- 14) Was kicked and punched several times by the defendant
- 15) Took the defendant into custody
- 16) Established probable cause to arrest the defendant for harming a police dog, two counts of 3rd degree assault, along obstructing a public servant and resisting arrest

Ofc. C Lyons can testify to the following:

- 1) On 06/14/14 at 0506 hours, he responded to 1800 W. 2nd regarding a half naked male hiding under a porch.
- 2) When he arrived Ofc. C. Lesser advised that a half naked male ran from him and was possibly hiding in shed behind 157 S. Elm.
- 3) He and Deputy Kullman identified themselves numerous times and ordered the Defendant to come out and told him that he was under arrest.
- 4) The Defendant ignored commands and fought violently with the K-9, hitting the K-9 several times.
- 5) The Defendant kicked and struck at Officer's several times before being taken into custody.

- 6) The Defendant advised that he tried to kick Officer's at least 12 times and advised that he had to fight because he was on acid.

Ofc. C Conrath can testify to the following:

- 1) Is an employee of the Spokane Police Department in Spokane WA currently assigned to the patrol division.
- 2) On 06/14/14, at approx 0512 hrs, he responded to 157 S Elm to assist officers who were dealing with a nude male (the Defendant) who had run from them and hidden in an attached garage there. At that time it was believed that there was a legitimate burglary.
- 3) He observed the Defendant inside the garage, lying on the floor under a blanket, refusing to cooperate.
- 4) He witnessed the K-9 announcements, which the Defendant ignored.
- 5) He witnessed as the Defendant punched and kicked at the K-9 in effort to resist arrest.
- 6) He also witnessed as the Defendant kicked and punched at Officer C. Lesser and Officer Lyons.
- 7) He assisted in taking the Defendant into custody.

Dep. T Kullman can testify to the following:

- 1) On 06-14-2014, he was working patrol for the Spokane County Sheriffs Office. He and his K9 Deacon are a WAC certified police patrol dog team and also accredited with the Washington State Police Canine Association (WSPCA).
- 2) He was called by the Spokane Police Department to assist with a male burglary suspect who had previously ran from officers and then had broke into a garage that was attached to 157 S Elm Street.
- 3) Upon arrival, he was advised by Officer Lyons that they can hear the suspect inside the shed moving around and that there was probable cause to arrest the suspect for Burglary. He noticed that the lock on the garage door was broken off and that the open door was propped open with a large folding camping saw.
- 4) He gave multiple loud announcements into the garage, advising "This is the Sheriffs Department K9 Unit. You are under arrest. Come out now or I will release my dog and he will bite you". After the last announcement, the suspect finally acknowledged our presence and said "Ok". After another minute or so, the suspect still had not made any attempt to come out of the garage. Another announcement was made and the suspect refused to come out and it sounded like he was possibly attempting to hide himself more, possibly arm himself with a weapon or possibly attempt to get into the house somehow. We could hear lots of movement inside the garage. Due to the suspects refusal to obey commands and come out and the possibility that he may be

arming himself or attempting to get into a home that could be occupied and for the safety of officers and the public, He grabbed the open door and pulled it open to make one last attempt to look inside and possibly locate the suspect prior to sending the canine. After not being able to locate the suspect, he sent his dog into the garage to apprehend the suspect.

- 5) His dog, K9 Deacon, located the male in the back of the garage. The male was wrapped up in a large blanket. His dog pulled the blanket off the male suspect and made contact with the male on the ankle. The suspect kicked the dog off his ankle with his free leg so He ran into the garage to assist his Canine. While attempting to gain control of one of the suspect's arms, K9 Deacon re-contacted the suspect's upper right arm while the suspect was resisting arrest. The suspect tried to rip his arm out of Deacons mouth while punching and kicking the dog with his free arm and legs.
- 6) During K9 Deacons contact with the suspect, he was kicked and punched multiple times in an attempt to free himself from the dog. This caused Deacon to lose his contact with the suspect multiple times, also making it unsafe for other officers to move in to take control of the suspect, due to the violent fight that was happening with Deacon and the suspect.

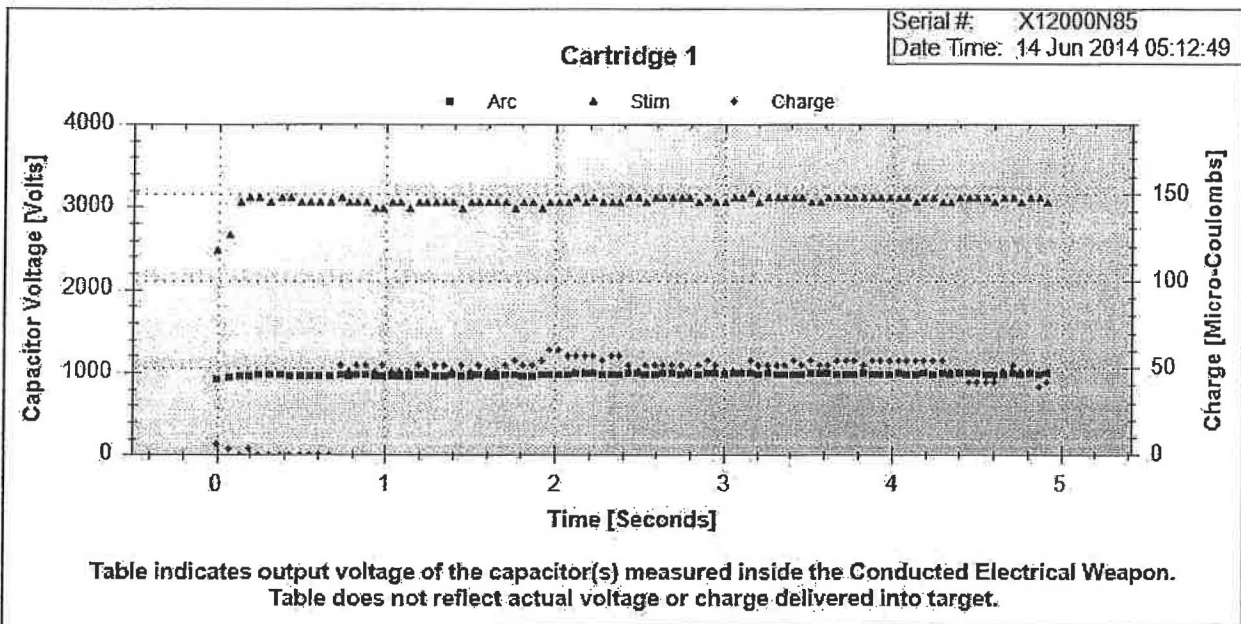
