



#### Report Narrative

On 06-28-14 at about 2237 hours, I responded to 5422 N. Audubon to assist on a DV. Officers were on scene and requested additional units to respond.

I responded with K9 Talon. We are a WAC certified police patrol dog team. We are also accredited with the Washington State Police Canine Association (WSPCA). Talon and I are in our first year as a team.

We responded in a fully marked "Spokane Police K9"car and parked in the front of the address. I was wearing the uniform of the day, which clearly identified me as a Police Officer. Talon was wearing a harness with "POLICE" marked along both shoulders and a Spokane Police patch on the left side of his chest. We were clearly identifiable as Spokane Police.

Upon arrival, I contacted Lt. Hendren. He advised that there was probable cause to arrest the resident, Edward Ritchie, for City Assault DV. He advised that the female victim had blood on her face from the assault. He advised that Ritchie was in side the residence, but refusing to come out. They were starting the process to obtain a search warrant for the residence to enter and arrest Ritchie.

I observed a booking photo of Ritchie on my vehicle computer. I also checked Ritchie's criminal history, which was extensive. He showed to have previous arrests in Spokane County for numerous assaults, riot, 2nd Degree Assault (strangulation), reckless endangerment, 1st Degree Burglary (armed), and Residential Burglary. This history indicated to me that Ritchie had a propensity for violence.

I assisted in containing the residence by standing at the northeast corner. While waiting for the warrant, I observed a male, who I immediately identified as Ritchie, walking inside the house. He walked to the front door, closed and locked it and then walked to the back door, which I was near. He locked that door as well and then disappeared into a doorway, which I believed led to the basement. I did not see him again before the warrant was obtained.

While waiting for the warrant, periodic announcements were made, ordering Ritchie out of the residence. There was never any response from Ritchie inside. I was advised that multiple announcements had also been made before I arrived.

After a short time, I was advised by Sgt. Hallock that the warrant was signed and valid. I went to his patrol car and observed a valid and signed copy of the warrant on his vehicle's computer.

I retrieved Talon from my patrol car and approached the front door with other Officers. Another loud knock and announcement was made at the front door, again with no response. Since Ritchie had locked the door, Officers were forced to breach the front door. Once the door was breached, I moved up with Talon to the doorway. I made a loud and clear announcement, saying, "Spokane Police K9 Unit. Eddie Ritchie, you are under arrest. Come out now or the house will be searched by a Police dog and when he finds you, he will bite you." Immediately following the announcement, Talon barked loudly, further showing Ritchie that a K9 was on scene and about to be deployed. After at least 30 seconds, there was still no response from inside. I made another announcement, Talon barked and we waited another 30 seconds, still

After receiving no response from either announcement, I deployed Talon to search. He checked the main floor of the residence and did not indicate that anyone was there. I moved forward to the kitchen area and held there with Talon as other Officers cleared the main floor to ensure no one was there. In the kitchen was the doorway to the basement, which was standing open.

From the kitchen, I made another announcement, attempting to get Ritchie to surrender peacefully. I said, "Spokane Police K9 Unit. Eddie Ritchie, you are under arrest. We know you are in the basement. You need to come out now or the basement will be searched by a Police dog. When he finds you, he will bite you." Talon again barked loudly and then remained silent for 30 seconds as we waited for a response from Ritchie. We again received no response and I deployed Talon to search.

Talon went down the stairs and began searching. We moved forward to the basement doorway and remained there as Talon searched. After a short time, Talon began barking and alerting. Lt. Hendren was outside of the residence and advised over the radio that he could see talon at a doorway that was covered with a sheet. Talon remained in the same area and barked occasionally. I also heard rustling around. After a few seconds I heard a male voice yell out, "Okay, I give up, call your dog." I recalled Talon to me and he returned immediately. I secured Talon and called Ritchie to the stairs. He appeared at the bottom of the stairs and I moved Talon out of the way so that other Officers could give him commands and take him into custody.

Officers struggled with Ritchie on the stairs briefly and took him into custody. I secured Talon in my patrol car.

Ritchie was brought out of the house and sat down on the curb. I contacted him and asked if Talon had made contact. He initially was not sure and said that he thought he was able to keep away from the bites. He said he was covered with a sleeping bag and Talon bit the sleeping bag near his feet. He then said that he did think that he did get bit on both of his feet.

I observed Ritchie's legs and feet (he was wearing shorts and a t-shirt). I observed several scrapes and scratches on his legs and feet, but they all appeared to be old injuries. The only recent looking marks were some slight swelling and redness to his feet. He also had a small bump on his right shin.

I went back into the house and Lt. Hendren pointed out the room where he observed Talon contacting Ritchie. I moved the sheet covering the doorway and observed a heavy sleeping bag on the floor. Part of the sleeping bag appeared damp, which appeared to be saliva from Talon's mouth.

The approximate distance from where I deployed Talon to Ritchie's hiding location was less

Ritchie had also sustained a small laceration to the left side of his head during his altercation with other Officers during his arrest.

Medics bandaged Ritchie's laceration on his head. Ofc. Chimienti transported Ritchie to Deaconess Hospital for treatment and clearance for jail. Once there, Ritchie had an x-ray of his right foot and was examined by Dr. Evans. No other injuries were located and he was cleared medically.

At the hospital, I spoke with Ritchie while waiting to be examined. He told me that he hid inside the house because he did not want to go to jail. He said he heard my announcements and knew the dog was there, but he thought he could hide from the dog and would not be found. He said, "that's a good dog. He did good."

Talon was wearing a harness with "POLICE" marked along both shoulders and a Spokane Police patch on the left side of his chest. We were clearly identifiable as Spokane Police.

Upon arrival, I contacted Lt. Hendren. He advised that there was probable cause to arrest the resident, Edward Ritchie, for City Assault DV. He advised that the female victim had blood on her face from the assault. He advised that Ritchie was in side the residence, but refusing to come out. They were starting the process to obtain a search warrant for the residence to enter and arrest Ritchie.

I observed a booking photo of Ritchie on my vehicle computer. I also checked Ritchie's criminal history, which was extensive. He showed to have previous arrests in Spokane County for numerous assaults, riot, 2nd Degree Assault (strangulation), reckless endangerment, 1st Degree Burglary (armed), and Residential Burglary. This history indicated to me that Ritchie had a propensity for violence.

I assisted in containing the residence by standing at the northeast corner. While waiting for the warrant, I observed a male, who I immediately identified as Ritchie, walking inside the house. He walked to

At the same time, Officer Childress advised that he could see two children and a adult male, who he recognized as Ritchie, in the bedroom. Ritchie had barricaded himself in the bedroom along with the kids.

I knocked and announced my self as a police officer. I gave verbal commands to Ritchie to exit the residence so I could speak with him. As I was knocking on the door the door was unlatched and opened while I was knocking. I did not enter the residence but stood outside the threshold and gave my verbal commands.

At some point, Ritchie exited the bedroom and Officer Childress was able to get the girls attention and have them exit the residence.

I continued to give verbal commands for Ritchie to exit the residence.

Cpl Busch then advised that there was probable cause to arrest Ritchie for City Assault DV. I made several more announcements directed at Ritchie, identifying myself and other officers as police, that he was under arrest, we were not going away and were applying for a search warrant.

Ritchie never responded to the commands. At one time he came into the living room. I verbally confronted him from outside the front door. He told me to leave and that I was not coming inside his house. I again identified myself and advised Ritchie that he was under arrest and to come outside. Ritchie came to the front door, did not exit the threshold, and shut and locked the front door. He then continued to the back door off the kitchen, shut and locked that door. I did not see where Ritchie went from there, but suspected he went into the basement.

Sgt Hallock authored and applied for a search warrant based on probable cause to arrest Ritchie for

I viewed a copy of the signed search warrant. I saw the judges signature, with today's date, and listed 5422 N Audubon as the residence to search for Edward L Ritchie.

After viewing the search warrant. A contact team was put together.

I knocked and announced directing my verbal commands to Edward Ritchie that we were the police, we had a search warrant and that he was under arrest. I knocked twice, with a significant pause between to allow Ritchie the opportunity to come to the door and surrender.

Ritchie never acknowledged my verbal commands.

I then used a ram to breach the front door.

I assisted in searching the main floor of the residence after the K9 had been inserted and conducted an initial search of the main floor. Ritchie was not located on the main floor.

The K9 then searched the basement. After a short period of time, the K9 started barking as if he had located someone in the basement. After the K9 had been barking for a short time, we could hear a voice in the basement say, "call off the dog!"

Ritchie then showed himself at the bottom of the stairs. Officer Brasch was giving Ritchie verbal commands but Ritchie was not complying. He continued to ignore Officer Brasch's command to keep his hands up and walk up the stairs. Officer Brasch, Officer Harvey, Officer Wells, and myself contacted Ritchie on the stairs approximately halfway. The stairway was very narrow and had a steep decline. Ritchie continued to ignore our commands. We went hands on and had to apply force to apply handcuffs. During the incident, Ritchie ended up on my lap with Officer Wells below him on the stairs. I was able to apply my handcuffs (dl) and take Ritchie into custody with any further incident.

During the incident Ritchie received a small cut above his left eye.

Ritchie was walked outside where Fire and paramedics rendered aid. They advised that Ritchie would need stitches for the cut above his left eye.

I was advised by Officer Geren that probable cause also existed to charge Ritchie with assaulting his daughter, #1a

Based on the that and the possibly K9 contact, I transported Ritchie to Deaconess Medical Center. He received three stitches and was cleared to be transported to jail.

On June 28, 2014 at about 2211 hours, I was dispatched to 5422 N. Audubon Street to assist Officer Chimienti investigate a reported domestic violence call. While en route. I was advised a male was outside with three young kids screaming at them. It was also reported a female could be heard yelling.

I arrived on scene at the same time Officer Chimienti did and we began walking towards the location. I stood by the address, while Officer Chimienti spoke with a neighbor, who had previously spoken with one of the small kids from the target location.

I walked onto a deck of the home, which was located on the south side. There was a man door leading into a bedroom from the deck. I saw the light was on inside the bedroom, so I looked inside to see if I could get an idea of where the residents were. When I looked through the door's glass window, I saw two small juvenile females sitting on the bed. I also saw an adult white male standing in the bedroom drinking beer. I was close enough I could see the brand was "Natural Ice." The male was standing in front of the closed interior bedroom door, leaning with his hands up against it, in a manner of barricading it closed. I immediately recognized the male as the suspect male (Edward Ritchie) from a booking photo I viewed prior to arriving on scene.

Within just a few minutes, I heard Corporal Busch advise a female was exiting the home through the rear door and he was speaking with her. From my location, I could hear the female arguing with Corporal Busch, screaming at him at times. It appeared the female was attempting to hinder our investigation. However, I kept watch over the male and the kids in the bedroom. I saw Ritchie continue to drink beer from several cans he had in the room, stored on the dresser and night stand. I then saw Ritchie open the interior door and in walked another small juvenile female, as Ritchie closed the door and began leaning on it once again. The three girls in the room, I estimated there ages at 10, 8 and 3.

I saw the girls hug each other from time to time as I stood watch and it was very apparent they were very nervous and scared. I also saw Ritchie hold his hand out and point his finger at the girls several times, in what I interpreted as a directive to "be quiet." I was worried for the safety and welfare of the young girls as he was defiantly holding them in the room, keeping them from leaving and restricting them from talking.

After several minutes, Officer Chimienti began knocking at the front door, announcing to Ritchie numerous times we were the Police and to come out. I watched, and Ritchie never responded to Officer Chimienti's requests. He just stood leaning against the door. I did see Ritchie hide a beer can under some clothing on top of a dresser and then hide a glass smoking pipe (common w/marijuana use) under a shelf on a night stand. I saw Ritchie walk over and look out the window, which looks into the backyard. He turned around and then opened the interior door and exited the room. I turned the knob of the door I was standing at and discovered it unlock, as well as the dead bolt lock. I pushed the door open and all the girls looked over at me. Without enter the home. I told the girls to come out and waved at them to come. All three girls quickly walked over to me and began climbing over clothing and other debris to escape. They all willingly exited the room as I help each one through the door. As they exited, I heard one of the girls say, "he's gunna kill us." Corporal Busch was with me at this time and escorted the kids over to the neighbors for a safe place to be until we could resolve this situation.

Officer Chimienti and I started yelling into the home, commanding Ritchie to exit as he was now under arrest. I made at least four loud verbal announcements for Ritchie to exit, but I got no response or compliance. About five minutes later, Ritchie entered the room I was watching and closed the door and locked it. He then walked out of the room and I did not see him again until he was taken into custody after a search warrant was secured to enter the home.

I did not enter the home to arrest Ritchie, as I was instructed to stand by outside watching the west and south sides of the home in the event Ritchie attempted to escape. However, Ritchie was located in the home by other Officers and placed into custody. When Ritchie was walked to the living room, I assisted by escorting him outside to the curb where he sat down and waited for medical attention from the Fire

On 062814, at 2304 hours, I responded to assist officers with a domestic violence call at 5422 N. Audubon, in the City of Spokane.

When I arrived on scene, Coporal Busch told me that the male suspect, Edward Ritchie, had assaulted his girlfriend and also one of his juvenile daughters. At one point Ritchie had locked himself and three juveniles in a back bedroom.

I observed that the suspect, Edward Ritchie, was barricaded in the house and had been advised he was under arrest, by officers on scene.

The children that had been in the house were being placed with Child Protective Services-See reports by Officers for further details.

Ritchie has a history of assault and has also been armed on occasions in the past. Ritchie had an arrest for Burglary 1st Degree in his criminal history.

A search warrant was written and signed for the residence. I viewed the signed search warrant.

I assisted Officers with the clearing and securing of the residence. Ritchie had been inside the house for over an hour and had plenty of time to arm himself and fortify the area he was hiding in.

The front door was breached and announcements made into the residence. Officer Buchmann deployed his K9 partner into the main floor of the residence.

I was holding a ballistic shield and provided cover for the other officers on scene, in case Ritchie was armed with a firearm. The ballistic shield offers protection from handgun ammunition and has "police" markings on the front as well as lights.

We entered the residence and did a thourough search to make sure Ritchie was not on the main floor and had evaded detection from the K9 unit.

Officer Buchmann and I made our way to the kitchen and held our position at the door to the

basement. Announcements were made again prior to sending the K9 into the basement of the residence.-See Officer Buchmann's report for details.

I could hear a male voice yell for us to "call off your dog". The K9 was called back to the kitchen area and I began making verbal commands to Ritchie from the top of the stairs.

I told Ritchie to put his hands above his head and come to the bottom of the stairs. Ritchie appeared at the bottom of the stairs, but did not have his hands up in the air as I had told him to.

Ritchie also had an object in his right hand. I told Ritchie to drop the object and put his hands on top of his head. Ritchie yelled, "It's just a lighter!".

Ritchie still refused to obey commands and did not put his hands up or place them on his head, as I was requesting. Ritchie began walking up the stairs and finally put his hands level with his shoulders, but refused to put them on his head.

I wanted Ritchie to place his hands on his head, so that I would be able see if he tried to access a weapon. From my training and experience I have found that most weapons are carried in the waistband area of a person's pants or in their pockets.

By placing Ritchie's hands on his head. I would afford myself more time to react if he suddenly reached for a weapon. However, Ritchie was not complying with commands and refused to place his hands on his head

Ritchie continued to advance up the stairs. When he was about three steps away from me, Ritchie suddenly reached into his left hand pants pocket.

I stepped from the landing in the stairway, which was a very tight and confined area. I executed a vertical stun technique with the ballistic shield. I used the shield to disrupt Ritchie's balance and then pin his body to the side of the stairway as a way to de-escalate the situation and take Ritchie into custody. I was concerned that Ritchie might be trying to access a weapon from his pocket.

Ritchie pushed forward against my body as I pressed the shield against him. Ritchie's head collided with the upper portion of the shield as he pushed into me.

I saw that Ritchie's hand had come out of the pocket and I kept pressure on the shield so that his hand stayed against the wall of the stairway.

Officer Wells and Officer Harvey were able to maneuver around me and place Ritchie into handcuffs. I observed that Ritchie was bleeding slightly from his left eyebrow. I informed Sqt. Hallock that Ritchie may have been injured during the altercation in the stairway.

On 06-28-2014 at approximately 23:04 hours, I (Ofc. Harvey) responded to 5422 N Audobon St to assist other officers on a DV call. Upon my arrival, I was informed there was probable cause to arrest Edward T. Ritchie Jr (6-20-75) for City Assault-DV. At the time Edward had barricaded himself in the house. I was also informed Sgt. Hallock was writing a search warrant so we could lawfully enter the house and arrest Edward. Officers had already given verbal warning to Edward that he was under arrest and he needed to exit the house. Edward refused to cooperate. Edward closed and locked the doors.

The search warrant was completed and I read the warrant. At that point we gave more verbal warning into the house, "Spokane Police Department, we have a search warrant, Edward you are under arrest, and you need to exit the house." Two announcements like that were given. We waited a reasonable amount of time and Edward did not cooperate as he refused to exit the house. At that time it was believed that he was in the basement.

We breached the front door. Ofc. Buchmann made several more K-9 announcements. Edward still refused to cooperate and he would not exit the house. A slow search of the house was conducted. At one point the K-9 appeared to have alerted on a room that Edward was in. Edward yelled to us to get the dog away and that he would come upstairs and comply. Edward appeared and started coming up the stairs. At the time he was holding what appeared to be a lighter in his hand. We told him several times that he should have nothing in his hands and that he needed to drop the lighter. Edward replied to us. "I'm coming up to smoke the cigarette."

We made physical contact with Edward in the stairwell where he was still physically resistive. Edward would not allow us to put his hands behind his back so we could hand cuff him. Several officers had a hold of his arms and one was pinning him against the wall with a shield. At one point I grabbed the back of his neck and pulled his head down. I was able to bend him downwards which allowed us to place Edward into handcuffs. At some point during the process Edward received a cut to his forehead. He was later seen by medics.

On 6-28-14 at 2228 hours, I was listening to the radio traffic of Officer Childress and Officer Chimienti. I was aware they had one person with a warrant and one person who was barricading himself in a back bedroom with kids. I put myself on the call at 2228 hours. I arrived and located Sgt. Hallock on the back side of the house. Sitting on the back porch was who was heavily intoxicated. I looked at her face and could see she had several scrapes which were still bleeding. She also had a small tear on her pants below her hip on the right side. Sgt. Hallock advised me to arrest for her misd. trespass warrant. I placed her in handcuffs and then in the back of my car. I was advised we had probable cause to arrest Edward Ritchie for DV assault 4 and he was the person inside of the house. I stayed at the house and made sure no one entered or exited until I was asked to take to jail. I transported her and then booked her on her warrant.

I returned to the scene at 2334. I assisted with serving the search warrant on Ritchie who we believed was in the basement of the house. Ofc. Buchmann released his dog into the basement after giving repeated warnings for Ritchie to come out. After the dog located Ritchie, Ritchie called out from the basement, "Call off your dog. I'm coming up." Ofc. Buchmann took his K-9 into the kitchen area of the house. Ofc. Brasch was in front of me and was carrying the shield. Ritchie walked to the bottom of the very narrow staircase and then stopped. Ofc. Brasch was giving Ritchie commands, but Ritchie failed to comply. Ritchie was told to keep his hands in the air and walk up the stairs. Instead, at the bottom of the stairs Ritchie pulled out a lighter and told us, "I'm going to smoke a cigarette first." Ofc. Brasch told him not to and then Ritchie started to come up the stairs, but Ritchie did not keep his hands where we could see them. Ofc. Brasch told Ritchie to keep his hands up and to stop, two times. Ritchie continued to walk towards us. Ofc. Brasch was forced to use the shield to stop Ritchie from advancing by pushing the shield toward Ritchie. Brasch used the shield to pin Ritchie to the right side of the staircase and I moved past him on his left. I grabbed Ritchie's right arm and tried to put it behind his back, but Ritchie resisted by tightening the muscles and locking his arm at his side. I could not see his left arm which was against the wall. I was able to move his right arm behind his back and into a goose neck lock. Ofc. Chimienti grabbed Ritchie's right arm and we were able to place him into handcuffs. After Ritchie was detained, I could see he was bleeding from a small cut on his face. He was taken outside where he was treated by medics. I did a frisk for weapons of where Ritchie was hiding but did not locate any.

I contacted #1a and asked her what was going on. She said, "only an argument". I noticed that she had fresh, bleeding abrasions to the right side of her face and forehead, and blood on her nose. I asked what had happened and she said she fell, pointing to a spot on the rear patio (there were no indications on the patio - scuff marks, blood, etc. - that she fell there). I asked what her name was, and she refused to tell me. I asked what her husband/boyfriend's name was, and she said she had no husband or boyfriend. Sgt. Hallock obtained a signed search warrant for the residence. A tactical plan was made, and Ofc. Chimienti made two, distinct, knock/announcement at the front door. When no compliance was gained, he breached the front door. The house was then searched, utilizing the K9.

Ritchie was eventually located in the basement and was taken into custody.

I (Sgt. Hallock) responded to 5422 north Audubon on a report of a domestic violence call. While en route, I heard officers indicating that they could see a male and a female inside the house. They could also see three young children in the house as well. As I arrived on scene, I heard an officer in the back indicate that a female, later identified as come out the back door and was speaking to officers. I went around the back and saw corporal Busch speaking with #1a She was being extremely uncooperative. She was obviously intoxicated, and a kept repeating, "I fell down, I fell down." I could see that she had numerous fresh injuries to her face. The injuries did not appear consistent with a fall; rather, they appeared to be consistent with an assault. I asked her what had happened in the house. She refused to talk to me about it. I could see two small children looking out a back window at us. The children had worried looks on their faces. Their eyes were very wide and they kept looking back and forth to ward to someone or something in the room and the officers on the back porch. Based on other officers' statements over the radio, they could see a male, later identified as Edward Ritchie, in the same bedroom as the little girls that were looking out the window. I asked #1a if she was concerned for her children. She did not answer and would only say she just fell and that we needed to leave.

Ritchie left the room that the children were in. Officers were able to coax the children out a side door so that we could ensure their safety. I walked the three girls (identified as and #1a over to the neighbor's house. While walking them over, #1a stated, "daddy was beating mommy up again." I asked her who daddy was. She said his name was Eddie Theodore Ritchie. She said he was not her real dad but he was the real dad of #1a They all had the same mom #1a #1a. I spoke to the neighbor, who agreed to sit with the children until CPS could be notified.

Based on the injuries to #1a and the statements of the children, I determined there was probable cause to charge Ritchie with domestic violence assault. I went to the front door of the home, which was ajar, and called in very loudly, "This is the Spokane Police. Edward Ritchie, you are under arrest for fourth degree assault domestic violence. If you do not come

to the door and give yourself up, I will be requesting a search warrant to enter your home and a place you under arrest. Come to the door now!" Ritchie ignored my directions. I returned to my vehicle and completed a search warrant. While I was completing the warrant, officers indicated that Ritchie had gone around the inside of the house locking both doors. He retreated into the basement where officers lost sight of him. The search warrant was electronically signed and returned to me by Judge Peterson.

The search warrant was executed at 2343 hours on 6/28/14. Officers made contact with Ritchie in the basement. I was in the kitchen and could not see him; however, I could hear that he was not complying with the orders being given by officers. Officers stated he was quitting his hands in his pockets and was not keeping them in view. I heard Ritchie state that he was going to have a cigarette before being arrested. Officers told him repeatedly that he could not and that he needed to put his hands where they could see them and cooperate. Officers were finally able to take him into custody (see officers' additionals). Ritchie was removed from the house without incident. I did see that he had suffered a minor injury to his eyebrow during his arrest. He was treated by medics at the scene and was also transported to the hospital for evaluation. A copy of the search warrant was left at the house. Photographs were taken of the damage done making entry. Officers secured the home as best they could and cleared the scene. CPS was called and the children were placed with them as both parents had been arrested that night.

standing up in the doorway of the patrol car, a matter of inches from me. I used my right hand to push her on the chest, making her sit back down in the backseat of the patrol car.

The children were asked about firearms and they did not indicate that any firearms were present. While waiting for the search warrant, an adult male arrived claiming to that Edward was his father, from another relationship. In my conversation with him he also stated that there were no firearms in the residence.

After reviewing Edward's criminal history and evaluating the information at the scene, it did not appear to me that SWAT would be necessary to execute the search warrant.

While we were waiting for the search warrant, officers observed Edward lock all of the doors and it appeared he went into the basement to hide. Once the search warrant was obtained, officers executed a knock and announce at the front door. I was at the back of the residence and could clearly hear the knock and announce. Officers could see into the residence through various windows and there was no sign of Edward responding to the demand to open the door.

After waiting a period of time that would have allowed for Edward to open the door or at minimum allowed him to let officers know he was en route to open the door, the front door was breached. When reviewing Edward's criminal history we did find prior felony assault arrests. Based on the investigation that night, we had PC for another assault and it was believed he was also intoxicated. It was also clear that Edward was intentionally hiding within in the residence to avoid arrest. This caused concern as he could be hiding with the intent to launch an attack on an officer searching for him. Even though we had information he did not have firearms, there are still plenty of lethal weapons in a residence that pose a threat to officers. Due to all of these factors, I gave authorization to use a K9 to search the residence, if Edward refused to surrender when given the opportunity.

Once the door was breached, officers made announcements into the residence that Edward was under arrest and needed to exit the residence. Officer Buchmann also gave multiple announcements as to the use of the K9, see his report. I was again at the back of the residence and could hear the announcements made by the officers at the front door.

Officers waited for a response from Edward. After waiting approximately 45 seconds to one minute with no response from Edward, officers then began the search. (It should be noted that Edward had been told numerous times prior to obtaining the search warrant that he was under arrest and told that he could surrender. He had also been told that if he did not surrender we would obtain a search warrant and at that point we would enter his residence and arrest him.) They did not locate Edward on the main floor. Officers stopped at the top of the stairs to the basement and conducted another series of announcements prior to searching with the K9. Once again, Edward made no effort to make himself known or surrender to the officers.

As the K9 proceeded into the basement, I was positioned on a basement window on the north east side of the residence. I could see most of the northern portion of the basement through that window. I saw the K9 appear to locate Edward in a small room on the northwest corner of the basement. It appeared Edward was hiding in that room, but the entry way to that room was covered by a blanket.

After several seconds of watching the dog bark at the room, enter part way and then retreat, Officers heard Edward request for them to call off the dog. Officer Buchmann recalled the K9 which followed his command.

I then saw Edward exit from that room. I saw that his hands were empty but as he moved toward the stairs I saw him put his hand in his pants pocket. From there he walked out of my sight. I could hear officers giving him commands and it was clear from the repeated commands and nature of the commands that Edward was not following directions. Officers ended up closing space and taking Edward into custody.

I saw that Edward received a small cut to the area above his left eye. Officer Brasch advised that he had attempted to pin Edward to the wall during the arrest, due to his non-compliance, and as a result the shield made contact with his head, causing the minor injury. I directed Sgt. Hallock to conduct a use of force investigation.

Medics responded to evaluate Edward. The children were placed with CPS. I assisted with trying to replace the trim to the front door so that it could be secured.
