



Investigative Summary

On 092114 at approx 2048 hrs, officers responded to 3144 E 31st Ave to assist Frontier Behavioral Health in recovering a patient who had left the facility and was under a court ordered 14 day stay. The 14 day stay began on the 11th of this month.

The suspect, **#14** the has limited criminal information or contacts but he does show a FBI number. **#14** is 5'10" and has a record of being 210 pounds, however today he appears to be approx 175 pounds.

The suspect has suffered several psychotic episodes according to the suspect's mother. The DHMP advised that he was being seen for having a psychotic disorder and having previously been diagnosed as having a psychotic disorder. The DHMP advised that the suspect's drug of choice was THC

The officers encountered the suspect in the paved driveway of the residence that is a duplex with both entrances facing the driveway. The area was lit up by the exterior lights of the duplex, which were on at the time.

Officers contacted the suspect in the driveway of his mother's house (see officer's report). Officers attempted to detain the suspect who became assaultiveⁱ; in response to the suspects actions Officer Rogan applied a level 2 neck restraint. During the application of the technique neither the subjects breathing or airway were compromised. The suspect was rendered unconscious and he was handcuffed (DL). Medics had already been called to the scene and were standing by to transport the suspect, they arrived and the suspect was placed into 5 point restraints on the gurney.

I arrived on scene and was briefed by the officers. Officer Rogan had a abrasion on his right arm that did not require any medical attention. Officer Arredondo had a small scratch on his forehead and he advised that his left thumb had been bent backwards and that he was having difficulty establishing a grip with that hand. He was ordered to go to the hospital and have the injury examined, the doctors would later advise that the thumb had a sprain and would not require him to be removed from duty.

I contacted the suspect in the ambulance. The suspect's skin was ashen grey, his eyes were sunken in his skull and he had a slick, oily complexion. The suspect was staring straight ahead and he appeared to be chanting something over and over again. The suspect was unresponsive to any questions. The suspect had no visible injuries; there was no redness or bruising around the neck.

I asked the medic in the ambulance if he had any medical issues and he said that there didn't appear to be any. I told the medic that I couldn't see any injuries and I asked him if he did and he said he did not see any obvious injuries. He added that his blood pressure was within normal levels at 132/59 but he did say that his heart rate was at 154.

I contacted the suspect's mother, Joyce Anderson. She advised that he son has suffered several mental breakdowns and that he had been admitted but because of his age she was unable to get any information on him or his progress. She said that the officers, "tried very hard to calm [her son] down" and that her son was, "acting crazy". She said that when the officers arrived her son was, "out of control" and that her son was, "fighting and trying to hit the officers". I asked if she thought that the officer's actions were appropriate and she said that she thought that they were and added, "What else could they do?" The witnesses' statements were consistent with the statements the officers had provided.

Based on the officer and witness statements and the available physical evidence, all indicators are that the suspect was an assaultive resistor. The application of a level 2 neck restraint against an assaultive resistor is an objectively reasonable application of force and is consistent with department training and practices.



On 09-21-14 at about 2048hrs, MHP requested that L/E assist them in trying to apprehend #14 Olsen who had walked away from Frontier Behavior Health. MHP was informed by #14 mother (Joyce) that #14 had arrived at her home but he was acting irrational and making odd statements.

I made phone contact with Darci Hoover who was the DMHP requesting assistance. I asked Darci why L/E was needed and if she had a court order to detain #14 ?? She stated that he was court ordered and detained on the 11th of this month and she still had a 14 day hold in place. I advised her that we would be enroute to assist her and requested that AMR be requested to transport #14

I informed Officer Rogan that Darci would meet us at the residence and AMR was being requested. Upon arriving in the area, I saw #14 walking down the driveway with a w/f following him. #14 saw me and immediately turned around and started walking back towards the house. I exited my patrol car and made several announcements for #14 to stop. He stopped, turned around but refused to make eye contact with me. The female was #14 mother who re entered her home. I advised Officer Rogan to pull right up to the residence as I was out with #14.

I asked #14 how he was doing tonight and where was he going. He said that he was going to the back yard to smoke a cigarette. He started to walk away and I again had to tell him to stop. He started pacing back and forth but refused to make eye contact. I told him that I needed him to stop moving around and he kneeled down. Officer Rogan had arrived and joined us. Joyce had returned back outside and was now standing next to me and trying to hand me some clothing that belonged to #14. Darci arrived in the driveway and made contact with Joyce.

As Officer Rogan and I were attempting to engaging in verbal communication with #14. I took hold of his right arm and Officer Rogan took control of his left arm. I told #14 that I was going to pat him down for any weapons he may have. Officer Rogan told him he was not in trouble and also informed him he was going to pat search him.

As I took control of #14 right arm I noticed that he was sweating profusely and clenching his fist. He was shaking and attempted to twist his body towards Officer Rogan. Officer Rogan informed him that we were going to place him in handcuffs which I agreed with. He was becoming more agitated and started making off the wall comments such as: he was God and he fucked his mother. He said that he believed in incest and wanted us to screw his mother. He started calling us fagots and made some comment about sex with animals. Officer Rogan was able to place his handcuffs on #14 left wrist before he pulled away from his grip. I feared that he was going to possibly use the handcuff as a weapon by striking me. I immediately took control of #14 body and guided him towards a metal fence. During this incident the open end of the handcuff struck me on the right side of the forehead. I was able to grasp the handcuff on #14 left wrist as Officer Rogan took control of #14 left arm. #14 grabbed my duty belt with both hands as Officer Rogan was yelling at him to stop fighting and resisting.

I informed Officer Rogan that #14 needed to be taken to the ground so I could attempt to get his right wrist handcuffed. He was still refusing to follow our verbal commands and I was fearing that he was starting to exhibit indicators of excited delirium. He was sweating profusely, stiffening his whole body, and making delusional comments. As he was guided to the ground, I struck my left thumb on the ground while attempting to keep control of his left wrist. Officer Rogan continued to hold #14 in a level 1 LNR as he was guided to the ground in a seated position. #14 was still twisting his body and attempting to get away. Prior to using a level 2 LNR, I requested an additional unit to assist us. In order to control #14 I informed Officer Rogan that #14 needed to be rendered unconscious so I

could get the handcuffs on his person.

#14 had been fighting with us for approx 3-4 minutes and he was starting to labor with his breathing. Once he was rendered unconscious, I was able to take hold of his right wrist and apply both handcuffs to his hands. During this time #14 defecated on himself. He was rolled to his side and then sat up in a recovery position as medics were requested for the level 2 LNR. We also requested Sgt Boothe to our location so he could be briefed of the incident.

Once #14 started coming around he said that he was sorry for his comments and for fighting with us. As he was mumbling that he was sorry, he was trying to remove the handcuffs from his wrist. He was still sweating and almost slipped his right wrist out of the cuff. He tried to stand up and had to be held down for his protection. Fire and AMR arrived on scene and confirmed that #14 was responding well. He was escorted to the gurney and transported to SHMC on MHP hold without any further incident.

I informed Sgt Boothe of the incident and of the injury to me left thumb. I was ordered to report to Deaconess and have my thumb looked at and cleared for duty. The ER doctor advised me that the x-ray showed no break to the thumb, but appeared to have a sprain. He recommended I follow up in 3-5 days with L&I doctor.

After briefing the call with Sgt Boothe, it was determined that 3rd degree assault charges be recommended on **14** for assaulting Officer Rogan and myself.

It should be noted that both Darci and Joyce were present during the entire incident. Both of them contacted us after he was placed in the ambulance and were apologetic for his behavior.

Corporal Kakuda responded to our location and took photos of Officer Rogan's left elbow area which had sustained a small scrape/scratches from the altercation. There did not appear to be any injuries to #14 person

On 092114 at 2136hrs, I responded to 3144 E. 31st to assist officers who were on an assist another agency call. Officer Arredondo advised that he was out front with the male, and shortly thereafter requested that the channel to be restricted.

Upon arrival, I observed Officer Mohondro holding onto a male (later identified as being #14) seated down on the driveway in handcuffs. I then took photographs of an abrasion on Officer Rogan's right elbow. I also took photographs of #14 face. See photo-log. It

should be noted that #14 was wearing a long sleeve shirt and sweatpants. Next, I interviewed Frontier Behavioral Health employee, Darcy Hoover who said that she is the complainant on this incident. They were advised mother that he was at her residence. Hoover requested law bv #14 enforcement assistance in taking #14 back to the facility (transport

paperwork in hand). Hoover explained to me that #14 had "eloped" from the facility, which he was on a 14 day detention since September 11th. Hoover added that #14 drug of choice is THC, and has been diagnosed as having a psychotic disorder.

Hoover explained to me that she was awaiting police arrival, east of the 31st address. She stated she observed a male walk down to the end of the driveway, but did not know for sure if it was #14 . She observed an officer approaching/contacting the male in the driveway of the 31st address. She then noted that another officer arrived on scene. She stated that "he was fighting them," referring that #14 was fighting with

the officers. She said the officers were "wrestling him, trying to get him to the ground to cuff him."

Hoover added that she did not witness a lot of the incident, due to her "talking" with #14 mother in an attempt to keep her calm. She stated she did not hear much, nor did she see any punches throw. She did add that at one point, she heard the officers telling #14, "stop resisting."

On 09/21/2014 at about 2134 hrs I responded to 3144 E. 31st Ave to assist Ofcs. Rogan and Arredondo on an assist agency call.

Upon arrival, **#14** was already detained in handcuffs. I stood by with him until the Fire Department responded to evaluate him and I assisted in restraining him to a gurney. **#14** was rambling, saying "seven and seven" among other things over and over. I tried to engage him in conversation several times and it appeared that he did not realize I was there or hear me.

I contacted **#14** mother Joyce S. Andersen. She told me **#14** had a mental breakdown last year and has been receiving treatment from Frontier Behavioral Health's Touchmark facility since. Prior to his mental break **#14** was completely normal. **#14** had been admitted to Touchmark and was staying there. At about 1900 hrs **#14** showed up at her house. She knew he was supposed to be at Touchmark and assumed he had escaped. She called them and they advised her to keep **#14** there and they would respond.

Andersen said #14 was acting erratically while he was there, repeating "seven days and seven days" over and over and slapping his chest. #14 was pacing back and forth and "very agitated." #14 had not assaulted Andersen or damaged any property. Andersen apologized to me for #14 behavior, and made comments about how well Ofc. Rogan and Ofc. Arredondo had handled the situation and treated her son throughout the incident.

On 09-21-14, at 2117 hours, Officer S. Arredondo and I were dispatched to 3144 E. 31st Ave, to assist Spokane Mental Health. See Ofc. Arredondo's report for more details.

I was parked next to Ofc. Arredondo when he called the complainant Darci Hoover (MHP). After he spoke to her he told me that Hoover had a client, **14** who had walked away from treatment. I was advised that Hoover had a hold for **14** to go back to Sacred Heart for evaluation.

As I was arriving on scene Ofc. Arredondo advised he was out with #14 in the driveway of the residence. I pulled up and as I got out of my patrol car I could see Ofc. Arredondo talking to a white male in the driveway, later ID as #14.

Ofc. Arredondo was telling #14 who was attempting to get by him to sit down. #14 kept attempting to walk by Ofc. Arredondo, stating he was just going inside. As I walked up #14 stopped in the middle of the driveway.

As Ofc. Arredondo was attempting to talk to him he was looking around as looking for a place to run. I saw #14 was sweating and it was dripping off his chin and nose. The outside temperature was cool at the time of us talking with him. #14 was wearing a sweat shirt, sweat pants and cowboy boots.

Ofc. Arredondo advised #14 why we were there to talk to him. He was asked to sit down and he did. While sitting on the ground a female, later ID as Joyce Andersen, #14 mom came outside to the driveway. Hoover then spoke with Andersen while Ofc. Arredondo and I spoke with #14

#14 was stating he was wanting to go back in the house and stood up. As he stood up I took a hold of his left arm in an escort hold. As I was holding his arm I could feel that he was shaking and tense. I told #14 he was not in trouble and we were there to assist him getting him back to the hospital. I told him the ambulance would be taking him not the police. He rambled about, someone having to do with incest and animals.

Ofc. Arredondo started a frisk of right side and I asked him if he had an weapons. He told me, "I might." As he told me that he flexed both his arms outward.

As he did I advised #14 I was going to put handcuffs on him for his safety and mine. I had not searched him at this point and he advised me he might have a weapon on him. I did not know if by flexing and attempting to pull away he was going to access a weapon. He was also acting very erratic with his speech and actions.

As I got a handcuff on his left wrist he immediately turned into Ofc. Arredondo pulling away from me. I held onto the cuff as he spun right, twisting to get away. He fell or was pushed down to his knees, rolled on the ground, where I lost my hold on the handcuff. At this point there was a handcuff free on #14. He stood up and as we tried to control him went into a chain link fence. I then was struck by the free handcuff in the top of my head. With #14 now with his hand free the handcuff became a weapon.

While at the fence I heard Ofc. Arredondo say he was also hit by the handcuff. I then applied an upper body control technique to get him to stop moving around with the handcuff. I was telling #14 to stop fighting and to stop resisting. I told him several times to put his hands behind him and relax. Ofc. Arredondo was to my left and attempting to get ahold of the left hand (the one handcuffed).

I then heard Ofc. Arredondo state, "He is grabbing my gun belt!" #14 was grunting and making several odd sounds as I was controlling him. Ofc. Arredondo advised he could not control his grip on the left arm, unknown to me at the time Ofc. Arredondo had injured this thumb during the incident and could not keep a grip on the arm. #14 was also grabbing and attempting to pull my right arm out away from his neck.

I was able to place #14 straight down on his butt in a seated position. He put his legs straight out in front of him. He then pulled his right leg towards him and reached his right hand down into his cowboy boot. His boot had not been searched and I did not know if he was accessing a weapon. I advised Ofc. Arredondo he was reaching into his boot and I rolled to my right to place #14 flat on his stomach to get his hand out of his boot.

At this point with granting, talking gibberish, and sweating prior to the incident he was exhibiting indicators of excited deleruim. At this point for his safety I did not want to prolong the fight. I was also advised by Ofc. Arredondo we needed to end the struggle so I decided to apply a lateral neck restrain level 2. grant was rendered unconscious.

Ofc. Arredondo was able to handcuff #14 at that point. I then sat him up in a seated recovery position. He again began talking gibberish and attempting to pull out of the handcuffs. I stayed with him attempting to talk to him. I checked #14 for injuries and did not see any visible injuries.

I called for medics to come check #14 out due to the LNR. I also called for a supervisor to my location.
