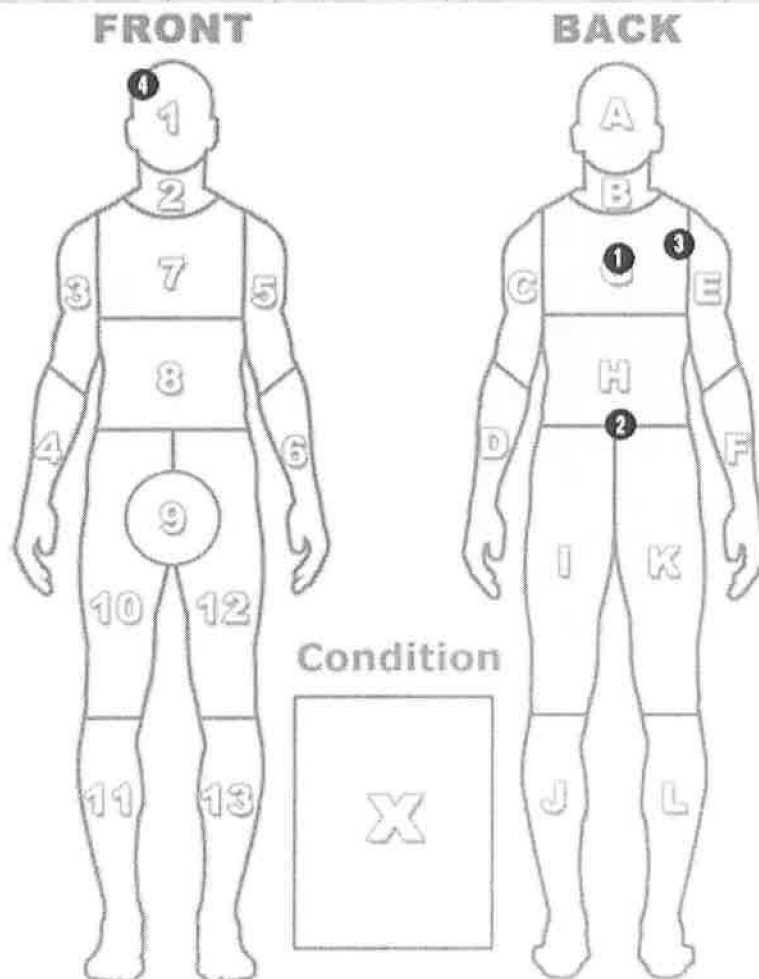

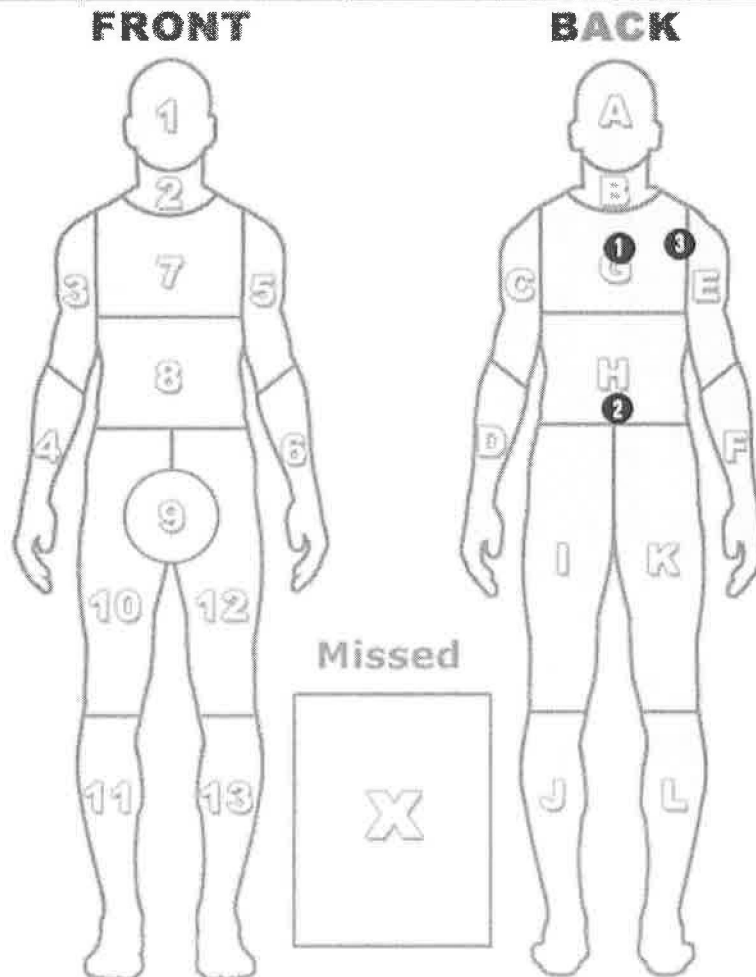

Use of Force – Taser application

Officer Interview Summary

Officers were interviewed at the scene and their reports are consistent with the statements given. All details are within their individual reports. The only additional comment made was that a body camera in this particular incident would have given great evidence of the suspect's aggressive actions and behavior.

Anest talked briefly with me but would only say he "didn't do anything" and "I didn't fight with the officers." He did inadvertently admit that he had sprayed some lady with "mace" because she "was coming at me." He would not let me look at the Taser contact points on his body. He was obviously intoxicated and/or on unknown drugs. Anest is very large and muscular. He had a small abrasion on the right side of his forehead. He did not complain of pain or injury.

Witness Interview Summary

Witness Angela Archuletta refused to talk to me probably because she was under arrest for assaulting one of the officers when Anest was being taken into custody. There were no other witnesses.

Physical Evidence

Justin Anest refused to allow pictures to be taken. He also refused to let me look at the Taser contact points. His booking photo does show the small abrasion on his forehead from when he fell to the ground. The Taser cartridge was placed onto Property.

Investigative Summary

The conclusion of the investigation indicates that the two probe and one contact Taser applications were appropriate and within policy given the circumstances. Officer Belitz articulated well the reason for each of the individual applications which were a response of the active and assaultive behavior exhibited and exercised by Anest. During the struggle to get Anest into custody the danger and significance of Anest's resistance was amplified when his wife, Archuletta, jumped into the fray and ultimately assaulted one of the officers.

Policy 309 states, "The TASER device is intended to control a violent or potentially violent individual, while minimizing the risk of serious injury." In this case, the Taser device application accomplished that intention.

On 10/01/2014 I (Officer Groom) was dispatched to Snoops Tavern located at 805 E. Rosewood in Spokane WA, reference an assault call. It was reported that a male maced a female and a male in the parking lot outside Snoops Tavern. The suspect was described as a WM, in his 40's, about 5'05", heavy, bald head wearing a tank top and had tattoos. It was mentioned that the male was the husband of a bartender that worked at Snoops.

I arrived on scene and contacted John T. Mahoney. John explained that the following happened:

He over heard an argument that happened while he was in the bar. He went outside to the parking lot and was just hanging out. He saw a male later identified as, Justin Anest, exit the bar and get into an argument with a female, Debra Arguellez.

John saw Justin go to his truck a Gray full size truck with WA license plate #B37548U and grab a can of OC. John saw Justin spray Debra and another male, David Arguellez, in the face. John saw the male go back into the bar after spraying them.

I contacted Debra Arguellez, she was very distraut and was complaining of her eyes and face hurting. She explained that the following happened:

She got into an argument with Justin inside the bar around the pool table. The bar staff was able to break up the argument and nothing else happened inside the bar.

She exited the bar and was in the parking lot talking to bar staff when Justin exited the bar and continued arguing with her. Justin went to his truck and grabbed a can of OC Spray.

At first Debra thought it was a gun and she could not see what he had. Justin walked up to her and sprayed her in the face. She was able to turn away and her son, David jumped in front of her and got

sprayed as well. Justin continued to spray her and David.

Justin then returned to the bar and only left when he got word that the police were coming. He got into the truck and drove towards the crowd in the parking lot, but turned off missing them.

Through a license plate check it showed that the vehicle was registered to an Angela Archuleta that lived at 13204 E. 9th in Spokane Valley WA.

Myself, Ofc. Mohondro, Ofc. C. Lesser, Ofc. Belitz, and Ofc. Gorman responded to Justin's residence at 13204 E. 9th Ave in Spokane Valley to contact Justin.

I knocked on the door several times and announced that I was a police officer. We received no answer at the door. Justin's vehicle was not parked at the house. As we were walking back to our patrol vehicles, Justin's vehicle drove by the location going EB on 9th Ave.

Justin's vehicle continued past his house and turned SB on S. Clinton Rd. I went back to my patrol vehicle and went EB on E. 11th Ave to attempt to stop Justin.

I turned NB on Clinton and saw Ofc. Mohondro and Ofc. Lesser had Justin stopped on S. Clinton between E. 9th Ave and E. 10th Ave. I pulled to the right of Ofc. Mohondro's patrol vehicle and activated my emergency lights.

Ofc. Lesser and Ofc. Mohondro conducted a felony stop on the vehicle. See there reports for further.

Justin had assaulted two individuals using pepper spray. He flipped us off when we arrived which already showed that he was uncooperative. I drew my gun to the low ready position and took a position of cover near the back of Ofc. Lesser's patrol vehicle.

I ordered Justin to step away from the vehicle and show his hands which he refused to do. He was yelling "I didn't do anything".

After several commands to do so Justin finally stepped away from the vehicle. He was yelling "I didn't fucking do anything" over and over and saying "fuck you leave me alone." We continued to order Justin to show his hands and stay away from the vehicle. Justin yelled "for what" and I advised him that he was under arrest for third degree assault.

I booked Anest into the Spokane County Jail for Assault 3, Obstructing, and Resisting arrest on citation #4Z0932006.

Cpl. kakuda responded to jail to photograph Anest's injuries and he declined to have photos taken.

On 100214 at approximately 0042 hours, I responded to assist other officers in arresting a felony assault suspect. The suspect was identified as Justin M. Anest. Officer Groom had PC to arrest Justin for 3rd Degree Assault. It was discovered that Justin was living at 13204 E. 9th Ave in the Spokane Valley.

We arrived at the location in an effort to contact Justin. When we knocked at the house, we received no answer. After we decided to clear the location, we were walking back to our patrol vehicles when I observed Justin's Nissan truck turn east on 9th from McDonald.

As the truck passed us, I observed Justin driving the vehicle. He continued east on 9th Ave, past his house and then turned south on Clinton St. Officers Lesser, Mohondro and Groom ran to their vehicles and attempted to get Justin stopped. Officer Gorman, his K9 partner Axl, and I ran back to the house in case Justin returned.

As I was at the house, I heard officers giving Justin orders to "get his hands out of his pockets" and to "get on the ground." These orders seemed to be coming from the area of Clinton and 9th Ave. I then heard Officer Lesser say over the radio that they had the vehicle stopped and it was occupied by 2 people.

Officer Gorman and I ran east on 9th to Clinton and then headed south. We located Justin and the other officers about mid block on Clinton between 9th and 10th. Officers Lesser, Mohondro and Groom were attempting to conduct a felony stop on Justin but he was very aggitated and non-compliant.

As I approached, the first thing I heard was Justin yell loudly "fucking shoot me!" Justin was shoving his hands into his pockets and rapidly removing them. He appeared to be attempting to provoke a lethal encounter by getting officers to think he had a deadly weapon. Officer Gorman and I were able to sneak up behind Justins vehicle while the other officers continued verbal commands with Justin. I could hear the officers loudly and clearly tell Justin several times that he was under arrest.

Meanwhile, his wife Angela, was also very aggitated and screaming profanities at the officers. I could hear her screaming "fuck you, you shut the fuck up" as the officers were attempting to give

Justin orders. Angela would step in front of Justin and yell at officers and then step away telling Justin that he did not need to follow orders because he did nothing wrong.

Neither Justin or Angela were compliant with anything the officers asked or ordered. At one point, Justin yelled "fuck this shit, I'm done" and headed back to the truck and started to get into the drivers seat. Justin was reaching all over the drivers area and it was unknown what he was reaching for. He refused all orders from officers to show his hands and to stop reaching in the vehicle.

Justin emerged from the vehicle in a violent manner throwing his hands out in front of him again yelling "come on, fucking shoot me." Justin stopped just in front of the front bumper of his vehicle and flexed his muscles and yelled to the officers in front of him "come one, bring it on" and took a fighting stance.

*******At this point, Justin was under arrest for 3rd Degree Assault, a felony. This crime of assault is a crime of violence.**

*******As Justin was being contacted, he was clearly very aggitated and cussing at officers. Justin had not been frisked or searched and therefore I was uncertain if he was in possession of or concealing any weapons on his person. Furthermore, Justin appeared to be attempting to provoke a lethal encounter with his behavior. He was continually reaching into his unsearched pockets and even dove back into his vehicle at one point and appeared to be searching for something. I was very familiar with Justin and his criminal history throughout my 10 years in law enforcement between SPD and the Spokane County Sheriffs Office. Justin has a long history of violent felony crime ranging from DV assault to 2nd Degree Assault with a deadly weapon. If Justin was able to escape, he had the potential of creating a danger to the community. Justin was wearing a tank top shirt and I could clearly see that he was a very large individual. He was fit and muscular and the muscles in his arms were large and he appeared to be a weight lifter or someone who routinely works out. We needed to control the situation as quickly as possible as Justin seemed to be escalating.**

*******Justin refused all orders to get on the ground and to stop reaching into the vehicle or into his pockets. It was very clear that Justin completely disregarded the fact that we were police officers and showed no signs of following orders or directions. Justin continually looked around as if to be looking for an escape route to avoid going to jail. Justin had placed himself in a situation where he knew he was under arrest and seemed to be willing to whatever it took to avoid going to jail. Justin was very aware that we were the police as all officers on scene were in full uniform with badges and department patches and the vehicles that were in front of him were fully marked police cars with their overhead emergency lights activated. Justin then looked directly at the officers in front of him and yelled "fuck you, bring it on" and took a fighting stance. Justin clearly had some fighting experience based on his stance and the fact that he had rolled his shoulders forward. Justins hands were**

clenched into fists and I could see the muscles in his back and shoulders start to bulge as he did this. His behavior was assaultive and there was no telling what Justin would do to get away.

For the above mentioned reasons, when Justin rolled his shoulders forward, I stepped out from the rear of his truck and yelled "index" and applied the probes (Cartridge #H09-1343667) from my TASER (Serial #X12000MMH) to Justin's back. The probes contacted Justin in the top middle of his back and the other was just below the belt line.

Justin stiffened up and fell backwards to the ground. Officers Mohondro and Groom moved in to take Justin into custody during the 5 second application. Angela was interfering so Officer Lesser took control of her (see Ofc. Lessers report for details). I told Justin to roll over to his stomach while the TASER was still in cycle. Once Justin was on the ground, Officers Mohondro and Groom attempted to get Justin into handcuffs. See their reports for details.

After the 5 second cycle from my TASER was over, Justin again started to become assaultive. He now appeared to be more angry. As Officer Mohondro was attempting to gain control of Justins left arm, it appeared that he was attempting to strike Officer Mohondro with a clenched fist.

***** Justin had already had the TASER applied to him and knew that he was still connected to it. He seemed to not care that he was still connected. I told him to stop resisting and to give up his left arm. Justin seemed to be completely ignoring all of my commands. Justin outweighs both Officer Mohondro and Officer Groom by over 100 pounds each and was clearly taking advantage of this significant size mismatch. Justin appeared to be focused on assaulting Officer Mohondro. I gave Justin one last warning to stop resisting or I would again apply the TASER to him. Justin again refused my commands and continued to swing his left arm at Officer Mohondro.

For the above mentioned reasons, I again pressed the trigger of my TASER (Serial #X12000MMH) and delivered another 5 second cycle to Justin with the already connected probes. During the 5 second cycle, Officer Mohondro attempted to gain control of Justins left arm. He was finally able to maintain control of Justins arm and wrist.

I continued to give Justin commands to stop resisting and to calm down. At first, Justin, appeared to be complying. Approximately 20-25 seconds later, Justin again began yelling at us and was able to pull his left arm away from Officer Mohondro. He then grabbed onto Officer Mohondros wrist and appeared to be pulling him down towards him.

When Justin did this, I could see the veins in his arm bulge and his knuckles turned white. The size of Justins hand compared to Officer Mohondros wrist was significant. His hand appeared to completely engulf Officer Mohondros wrist.

***** At this point, Justin had already had the TASER applied two times. He clearly did not care that he was still connected and completely disobeyed every order we gave him. Justin appeared very focused and committed to get away and not go to jail. Justin was very strong and was winning the battle with Officer Mohondro. Justin did not appear to be tiring. In fact, he appeared to be gaining strength and stamina. Justin appeared to be set on continuing this fight at any cost. Justin had already attempted to provoke a lethal encounter several times and it was clear to me that he was not ready to stop his resistance and assaultive behavior. I had to stop the fight before an injury to officers or Justin occurred.

For the above mentioned reasons, I knelt on Justins shoulder area to the left of his neck and told him that he better stop resisting or he would get another TASER application. He did not stop his resistance so I applied a third application from my TASER to Justin. This time, I applied a drive stun to the upper right shoulder area on Justins back. I maintained contact with Justins shoulder for the 5 seconds while Officer Mohondro was able to gain control of Justins left wrist and arm.

It was at this time that Officer Mohondro and Officer Groom were able to place handcuffs on Justin (D/L). Justin ceased all resistance at this time and said "alright, I'm done." We rolled Justin onto his right side and into the recovery position. After Justin began to calm down, we sat him up to the seated position.

I called for medics and a supervisor to respond to the scene. Medics arrived and removed the probes from Justins back. and cleaned the probe marks. When Justin fell, he received a small abrasion to his forehead and it appeared that he had a small amount of blood coming from his mouth. Medics also cleaned these injuries.

Sergeant Teigen arrived on scene and I briefed him of the incident. After the incident was complete, Justin was booked into jail for 3rd Degree Assault, Obstructing and Resisting Arrest. Also, during the incident, Angela assaulted Officer Lesser (see his report for details) and therefore was arrested and booked for 3rd Degree Assault L/E along with Obstructing.
