Incident Summary

See additional. This is in Xref to incident #14-332057. Also, note the TASER used is registered to Officer M Schneider. ERU took his TASER during this incident and gave it back at its conclusion.

Lt Meidl's report:

I received this assignment on 11/12/14. This review is based on reports filed by officers that responded to this incident (I was not present at the scene). Walette was wanted for Felony Harassment and City Assault / DV.

Officers from the ERU team responded to assist detectives and DOC with efforts to safely arrest the suspect, who had barricaded himself in a bathroom allegedly while armed with a knife. ERU members placed several obstructions (multiple chairs) in front of the closed bathroom door to slow Walette down should he suddenly exit the bathroom unannounced while armed. They staged first aid supplies in their proximity in the event they were necessary for officers or Walette. ERU officers also tied the door off with nylon rope in an effort to prevent Walette from exiting until the team was prepared to safely receive him. Finally, ERU officers cleared the kitchen area (in close proximity to the bathroom) of any potential weapons that Walette could use were he to successfully exit the bathroom and reach the kitchen.

ERU officers pre-deployed less lethal options, including a TASER, a beanbag shotgun, and 40mm blunt impact munitions. OC10 and CS gas were also available. Officers attempted to "bark out" Walette after negotiations were not successful. Walette threatened to stab the K9.

Efforts to gain intel using a pole camera were not successful due to Walette throwing shampoo and water bottles at the camera.

Walette refused to exit the bathroom after being told multiple times that he was under arrest and made comments that he would stab himself in the heart if officers forced entry into the bathroom. He also said he would kill officers and/or negotiators if they tried to enter the bathroom and that he would not go back to prison. After approximately 5 hours of negotiations (including efforts by MHP staff), officers inserted OC spray into the bathroom through an exterior window in an effort to get Walette to exit the bathroom. Walette attempted to stab the ERU officer's hand as he deployed the OC spray (the canister was knocked out of Ofc Stone's hand by the knife Walette was using). As he did this, Walette continued to yell that he would kill officers.

The decision was made to deploy a CS gas canister through the window after the OC was ineffective. Walette threw the canister back outside as soon as it entered the bathroom. A second canister was deployed and the window blocked to prevent Walette from throwing the second canister outside.

After the second canister was deployed, Walette began making sounds at the bathroom door that led officers to believe he was going to peacefully surrender (due to the effects of the chemical agent). The rope securing the door was released and Walette exited still holding the knife. The knife was in an elevated position most commonly used to launch a knife attack. Ofc Lesser deployed a TASER cartridge, but was not successful in making contact with both probes.

Ofc McMurtrey noted the lack of effect and deployed two beanbag rounds at Walette, aiming for the front thigh area (a primary target). These had no effect. Ofc Lesser was able to deploy a second TASER cartridge

as Ofc McMurtrey deployed a second round of two beanbag shots. The first round of the second volley struck Wallette's bicep but had no visible effect on Wallette. Ofc McMurtrey's last beanbag round fortuitously knocked the knife out of Wallette's hand (the constant body movement of Wallette made exact target acquisition challenging, and Wallette and just lowered his hand towards his hip [which was where Ofc McMurtrey was aiming when he fired the fourth and final round]).

As soon as the knife was knocked from Wallette's hand, he immediately began searching the kitchen and ground in an apparent effort to locate the dropped knife or another knife. Ofc McMurtrey was able to replace the TASER cartridge on Ofc Lesser's TASER and successfully deploy the TASER to Wallette's mid-section. This incapacitated Wallette, allowing officers to utilize a shield to immobilize Wallette on the floor and safely handcuff him. Throughout this entire incident, verbal commands were given to Wallette to drop the knife and get on the ground.

Wallette was transported to the hospital for treatment. A subsequent medical exam showed Wallette suffered a ruptured testicle from the beanbag deployment as well as a broken bone in the hand that was holding the knife. Wallette told Ofc Geren, while he was being treated at the hospital, that his intent in exiting the bathroom while still armed with the knife was to force officers to end his life.

Lethal force was justified based on the continual threat Wallette posed. He was given numerous verbal commands and a full spectrum of less lethal force was utilized to end what otherwise could have been a deadly force incident. All use of force was within policy.

On 10-1-14 at about 0845 hours Officers and Detectives with the DV Unit responded to 3217 N Nelson to arrest Walette on DV charges stemming from an incident the day before. The charges were Felony Harassment and City Assault DV. When confronted by officers Walette barricaded himself in the bathroom and claimed to be armed with a knife. Other people in the house were cooperative and evacuated. Sgt Reynolds called me reference the armed and barricaded situation. I advised I would activate an ERU contingent to respond. I notified a total of 9 ERU members to respond, most of who were on duty, or would be within a few hours. I also notified Lt Wohl, who fills in as the ERU Commander in the event LT Meidl is not available. He and I both responded to the scene. Sgt Keller also responded to assist in the command post. The overall IC on scene was Captain Olsen.

Officers on scene continually negotiated with Walette for a peaceful surrender throughout the incident. Trained members of the Hostage Negotiator Team arrived and also worked toward this end. Mental Health Professionals also responded and did go inside to negotiate with Walette. Through the nearly 5 hours of negotiations there was no measurable amount of success. Walette refused to disarm and come out of the bathroom. In addition, he made threats to kill the officers and negotiators. He also said he would not go back to prison.

Captain Olsen, Lt Wohl, Sgt Keller and I all conferred on the matter. Negotiators informed us that Walette was demonstrating anti-social behavior that would indicate he may never voluntarily surrender. It was determined that action would have to be taken to affect the arrest. A search warrant was secured before this next phase began.

It is important to note that members of ERU immediately began taking measures to prevent a deadly force encounter with Walette. This included tying off the door to the bathroom to hold it shut. This would ensure that he could not simply charge officers and force a "suicide by cop" scenario. They also placed pieces of furniture outside that door to slow him down should he somehow get the door open. The immediate area (kitchen) just outside the bathroom door was also cleared of knives and other potential makeshift weapons. Further, they brought in less lethal tools such as a TASER, bean bag shotgun, and 40mm blunt impact munitions. Also munitions such as OC10 and CS gas were available.

The first action taken by ERU to persuade Walette to surrender was to use Officer Buchmann's dog to bark outside the door. It has been a successful tactic on many occasions to simply have a police K9 bark outside. Some suspects are very averse to dogs and give up. This was not the case with Walette. He only threatened to stab and kill the dog.

We then directed ERU to break out a part of the bathroom window (on the outside of the house) and utilize a pole camera to view Walette. There had been no confirmation that he was actually armed and his condition was unknown. However once the pole camera was positioned to look into the bathroom he began throwing water and shampoo bottles at it. Again he made threats to the officers. We were not able to gather much information through the camera.

We then directed ERU to deploy OC10 into the bathroom through the window. Officer Stone then sprayed OC10 (liquid form) through the window. As he did so, Walette began stabbing at his hand and the canister through the window. This was our first confirmation that Walette did in fact have a knife. The canister was actually knocked out of Officer Stone's hand. Walette continued to yell death threats to the officers and coughed some, but did not surrender. ERU was then authorized to use CS gas. Officer Stone deployed one of the CS munitions through the window. Walette threw it back out. They threw another in and blocked the hole so it could not be thrown out.

ERU members on the inside of the house then began to hear the CS effect Walette. He continued to make threats, but began hitting the door. Officer Baldwin interpreted this to mean he was giving up and released the rope holding the door shut. Walette emerged with the knife still in hand and making threats to kill officers. Numerous verbal commands were given to drop the knife and surrender but Walette did not comply.

Officer Lesser noted the manner in which he held it as overhand, typical for stabbing, and could see his hand was white from gripping it so tightly. He was in the closest proximity to Walette and armed with a TASER. He fired the TASER at Walette but one of the probes missed and there was no effect.

Officer McMurtrey noted that Walette had taken steps toward them. (The distance was later measured to be about 14 feet). He also noted they were now in a lethal force encounter. He then fired two bean bag rounds to the front of Walette's left thigh. There was no effect. He fired these two rounds at the same time Officer Lesser fired the TASER cartridge. Officer McMurtrey then fired an additional two bean bag rounds, this time at the hip area. Again, they did not have the desired effect. Officer McMurtrey recognized that he only had two rounds left, and the chances of avoiding lethal force were dwindling. He elevated his sights and delivered a bean bag round to Walette's right bicep. He re-evaluated after this shot and again saw it had no effect. He fired his last bean bag round while aiming for his hip area again. However the round struck him in the hand that was holding the knife. At this point he dropped the knife but began looking for it.

More verbal commands were given to Walette as the knife left his hand but he still refused to cooperate. Officer McMurtrey took over Officer Lesser's TASER and reloaded a new cartridge. He fired this at Walette's abdomen area and successfully achieved contact with both probes. Walette was incapacitated by the TASER. Officer Lesser pinned him to the ground with the shield and he was subsequently handcuffed without further use of force.

The entire sequence discussed above occurred in a manner of seconds (Walette coming out the door to the point he was handcuffed). The use of multi-force options and planning by the ERU members was the key to taking Walette into custody alive, despite his efforts to force them to use deadly force. The force used by the officers was objectively reasonable. Their willingness and patience in working in close proximity to lethal force encounter is evidence of their

commitment to preserve life. By the letter of the law deadly force could have been used on Wallethe during this incident on several occasions. This group of officers however has trained together extensively as a team, but as individuals they each made a decision not to shoot. Their training and experience gave them confidence to continue with less lethal efforts even after the repeated failures of those measures. This is not always possible, and ultimately the suspect's actions will determine our response. It is also worth mentioning that during this incident each of the ERU members was wearing a gas mask. These and the actual CS gas in the air greatly reduce a person's ability to see. The fact that reduced visibility did not affect the officers under these conditions should not be overlooked.

After Wallethe was handcuffed he was placed on a litter and taken outside to fresh air. He was placed in proximity of this family so that they could see that he was alive. He was transported to the hospital for evaluation and later booked into jail. The only injuries received were bruising from the bean bag rounds and the TASER probe penetrations.

We advised the residents of the home how to decontaminate the home of the CS gas and OC10. While SFD brought in a portable fan to draw in fresh air.

Photographs were taken of the damaged window, the involved scene and spent munitions.

Use of Force Additional

One final detail to note in this additional: Blue Team will not allow me to correct the placement of the bean bag rounds on the sketch of the person. Essentially I cannot move the red dots to better denote where the impacts occurred. This more correct information was obtained after medical treatment was received by Wallette. One round should show hitting in the groin area and another on the right hand that was holding the knife.

This additional is being submitted to better document the injuries sustained by Walette in this use of force. Walette was transported to the hospital per policy regarding the delivery of Blunt Impact Munitions. It was found that he sustained a broken bone in his right hand and a ruptured testicle. Neither of these are primary targets, but they were not intended either. The dynamic nature of the incident and Officer McMurtrey's efforts to disarm Walette to avoid the use of lethal force are in line with department policy and procedure. Walette had other abrasions and swelling in his right bicep from the bean bag impacts. There was also the typical puncture wounds associated with TASER probe applications. The doctors attended to these as well.

It should also be noted that Officer Geren spoke with Walette at the hospital about the incident. Walette stated that he came out of the bathroom armed because he believed officers would shoot him. It was his desire at that moment to commit suicide and hoped the police would be the means to that end. He has also ingested methamphetamine and a quantity of pills as part of his effort to die.

On 10-1-14 at approx. 0942 hrs. I responded to 3217 N. Nelson to assist other officers with a man with a weapon. Det. B. Byington advised officers had Terrance Walette barricaded in a bathroom with a knife.

I arrived and assisted several other officers. Detectives and DOC officers were trying to talk Terrance out of the bathroom. The bathroom was off the back kitchen and back exterior door. I placed four bar stools in front of the bathroom door in hopes to slow Terrance down if he decided to come out uncooperative. Hostage negotiators were on scene and talking to Terrance for hours. I kept hearing him say he was not going back to prison. Negotiators talked to him for several hours, trying to convince him to come out peacefully. He refused and later was saying that if officer's came into the bathroom, he would stab himself in the heart. He was told several times that he was under arrest and needed to come out peacefully, he still refused.

Some time around 1330 hours, officers inserted OC spray and OC gas. He came out a short time later. I was assisting officer from the living room where I had medical supplies if needed. I could not see the bathroom door but heard what sounded like him banging on the door and then him finally coming out. I heard officers tell him over and over to put down the knife and get on the ground. I heard some banging around in the kitchen and then I believe I heard a Taser going off, less lethal bean bags from the shot gun and then another Taser. Officer McMurtry and Ofc. S. Lesser then moved in to arrest him. I entered the kitchen to assist and observed Terrance lying on his back. He was in the middle of this small kitchen with his head towards the bathroom door. I could see Taser wires around him and he appeared to be feeling the effects of the Taser. I grabbed onto his right hand and assisted officer in rolling him onto his stomach. I placed handcuffs on his wrists without to much resistance. The room was still filling up with OC gas so we pick him up as much as we could and partially drug him into the living room. We obtained a flexible, fabric tarp and rolled him onto it in order for us to safely carry him out the front door to waiting paramedics.

We got him outside to the sidewalk where paramedics were waiting with their gernie. They applied soft restraints to his wrists and ankles for his safety and paramedic safety. Ofc. N. Geren went in the ambulance with Terrance while detectives followed.

I located one of the used cartridges outside, on the front yard. It had been still attached to

Terrance by the wires and fell off while carrying him outside. I collected this cartridge. Ofc. D. Stone collected the other cartridge's and the six spent sock rounds that were used in the kitchen area. I took custody of all of these and later placed them on property as evidence. The cartridge serial numbers were C4102CPMV and C4102C4AK. The Taser that was used belonged to Ofc. M. Schneider and was serial # X12000NOK. I took custody of the Taser and at approx. 1630 hrs, it was down loaded and recorded by Sgt. M. McNab. The results were sent to Sgt. Z. Storment. I had also collected a black handled kitchen knife from Ofc. Stone. Officers advised this was the knife Terrance was holding when he came out of the bathroom. I placed this knife on property as well.

On 10-01-14 at about 1036 hours I responded to 3217 N. Nelson on a male barricaded in a bathroom, armed with a knife. I received information that there was PC for the male for several charges of assault DV. He was identified as Terrence Walette. Walette has a very extensive criminal history and has been armed in the past. Officers had been on scene for about an hour and a half already, trying to get Walette to give up and come out of the bathroom.

I was briefed by officers and supervisors on scene. I went into the house and began to take over the team leader duties with the contact team inside. Other ERU members arrived and eventually took over the incident. We were requested to provide tactical coverage and solutions to this incident.

The negotiators were involved in trying to talk to Walette, for over three hours. He was not cooperative and did not talk very much. The MHP personnel even arrived and worked with negotiators to try to talk Walette out of the bathroom. He continued to be uncooperative and would not exit the bathroom, drop the knife that he had, or even communicate about the situation. Meanwhile a search warrant was applied for and received for the house, and to arrest Walette. During the negotiations, I heard Walette say things like, "I will do what I have to, I am not going back to prison", and "bring that dog in here, I will stab that dog in the head", showing his level of resistance and threat.

After all attempts to de-escalate the situation and to get Walette out of the bathroom safely and without incident, the IC gave confirmation to the team to start the tactical plan of removing Walette from the bathroom and to get him into custody as safe as possible.

The bathroom door was controlled by officers so that Walette could not charge officers from a place of advantage. The exterior bathroom window was breached so that a camera could be used to look into the window to check the status of Walette. He did not allow that and tried to grab the camera. Due to the limitations, the camera could not be used.

OC spray was introduced into the bathroom to try to force Walette into compliance. Verbal commands were continually given by the inside team and the outside team. Walette again tried to grab the OC and stabbed at the officers hand as he deployed that spray. The spray was not very effective due to the amount that was able to be put into the window.

The next step in the progression, was to introduced CS chemical into the bathroom, to again try to force Walette to comply and to give up. He removed the CS canister and threw it back outside. A second CS canister was introduced which had a lot more affect but it too was thrown outside.

After a short time, Walette began banging on the bathroom door and it seemed to me that he was requesting to get out. Believing that the chemical agent had taken affect, the door was slowly opened and he exited the bathroom. He was wearing jeans, and no shirt. He still held the knife in his hand in a raised position. He was still very agitated and was yelling at officers to, "just kill me". Due to the close distance(14 feet) to officers, and Walette's actions, this was very much a deadly force situation. Due to our advanced training and experience, we were able to stop that from happening.

Walette did advance toward officers but was only allowed to take one step, which is when a taser was deployed, but had no affect. (later determined one probe missed) Kinetic energy Bean Bag rounds were then deployed in an attempt to stop Walette's aggression at officers. The less lethal rounds were successful, and Walette did drop the knife. But he still did not comply with commands and continued to be uncooperative. Walette even began searching the nearby counter for more weapons, to re-arm himself with.

A second taser cartridge was deployed, which was also successful and did lock up Walette to where he could not move. I gave the order to move. Officer S. Lesser, who had a shield, used it to push Walette to the floor, and to pin him down with his shield. Walette was detained and handcuffed. He was pulled out of the Chemical environment, where he was then removed from the house by litter and taken out to medics.

Damage was done by officers to the bathroom window and the introduction of chemicals to the residence. The house was aired out and fans were used by Spokane Fire Department, to remove as much of the chemical as possible. The owners were informed of clean up procedures.

I could see a lot of damage to the inside of the bathroom, done by Walette, such as broken mirrors, water sprayed everywhere and shampoo and lotion sprayed all over. Photos were taken of the scene and the injuries to Walette.

I did measure the distance from the bathroom door to the location of the taser and bean bag shots, which was 14 feet. The house was turned over to investigators and family.

On 10/01/2014 at approximately 1020 hours I received a phone call from Sgt. Storment reference a barricaded subject at 3217 N. Nelson in Spokane, WA. Sgt. Storment advised he needed me to respond to the station to assist in grabbing the equipment and bag trucks for an ERU (Emergency Response Unit) call out.

I responded to the station and picked up the equipment truck and Ofc. Stone picked up the bag truck. We responded to the scene at 3217 N. Nelson and parked the trucks to the east.

We were informed there was PC to arrest Terrence Walette (021788) for Felony Harassment (Threats to Kill) and City Assault Domestic Violence. He was currently barricaded in the bathroom and stating that he had a knife.

I responded to the back yard of the location to the N/W corner of the house. There was a window that was approximately 1' X 2'. It was compromised of one piece of frosted glass and glass blocks surrounding it. Ofc. Bishop and I used the pole camera to try to look in the window of the bathroom. We were unable to see through the frosted tempered glass or through the glass blocks. As we attempted to look through the glass all you could see was a reflection. We were unable to see into the bathroom at all. We both attempted to use the pole camera but could not see inside the location.

I provided security on the back side of the house since we were unable to see inside the residence. I was then contacted by Ofc. McMurtrey who contacted me to go inside and give him relief on the ballistic shield.

I went inside the residence and took over the shield. The shield was located approximately 14' to the door of the bathroom. There was a slight angle between me and the doorway. I was the closest person to the door if Terrence was to come out of the door. The kitchen was small in size and there was access to knives and other items that could be used as weapons within the area. Next to the bathroom door was a door to the right if you were exiting the bathroom. The door would lead to another door in close proximity that would lead outside.

Officers had webbing tied off to the door handle to prevent him from quickly emerging from the room

without first alerting us. There were several stools in the middle of the room that had been stacked there to allow us reaction time when he emerged from the bathroom, especially with the close proximity of the kitchen.

I stood by the shield and was equipped with a taser. I was the first less lethal option if Terrence exited the bathroom armed with a knife. I was in close proximity of Ofc. McMurtrey who was next to me armed with a bean bag shotgun. There was lethal cover on the stairs.

I stayed on the shield providing cover with my taser. Hostage Negotiators attempted to talk with Terrence and get him to peacefully exit the bathroom. They continued to try to get Terrence to come out but he refused to de-escalate and exit the bathroom. MHP came inside the residence and also tried to convince Terrence to come out of the bathroom peacefully but Terrence still refused to come out of the bathroom. He advised he was not going to prison and stated that he "wasn't going back for 5 years." He advised that if any cop tried to come inside the bathroom he was going to stab them and kill them. He stated, "If you try to come in here I'm going to fucking kill you. I'm going to stab you." He advised, "he wasn't coming out alive and was going to stab a cop in the face."

MHP continued to try to convince him to come out but he would not exit the bathroom. A K9 was taken in the residence. He started to scream, "You are going to have to kill me, I'm not leaving here alive. I'm going to stab and kill that fucking dog. I'm going to stab you in the face." He yelled, "I'm going to kill an officer and you are going to have to kill me. Bring that fucking dog, I'm gonna fucking kill it. Fuck you, you fucking Niggers."

The dog was taken outside of the residence. Officers on the outside attempted to introduce OC spray into the bathroom using the outside window. As the officer was spraying the OC Terrence knocked the OC out of his hand. Officers on the back were able to see some type of "black object" in his hand. He continued to hold the item in his hand. They then introduced a CS Tri-Chamber into the bathroom. Terrence picked up the cannister and threw it back out the window. They then put in another cannister while the smoke was still thick so hopefully he wouldn't be able to throw it back out the window.

Terrence continued to yell from inside the bathroom. He screamed, "You fucking Niggers, I'm going to fucking kill you. I'm not going back I'm going to kill you fucking cops. I'm going to stab you with this knife in the fucking face." He kicked the door several times as he continued to state he would kill a cop, stabbing in the face.

The door opened and Terrence had a black handled knife in his right hand. He was holding the knife in an offensive position with the knife held approximately shoulder length or just higher. The blade appeared to be 4-5" in length and was silver in color. As he exited the bathroom we gave him several loud and clear commands to drop the knife. He continued to take a couple steps with the knife towards us, still keeping the knife high in a firmly gripped offensive position. I was only

approximately 12' away from Terrence at this time as he continued to step out towards us with the knife in his hand, closing distance. He continued to refuse all verbal commands to drop the knife and get on the ground. He continued to yell that we were going to have to kill him or that he would kill us. He screamed, "I'm going to fucking stab you in the face, fucking kill me." He stated, "I'm going to fucking kill you. You are going to have to kill me." He took another step towards us and I realized we were quickly losing ground.

I deployed a taser which had no effect. He was shot with several bean bag rounds but still refused to drop the knife. He kept the knife and still continued to try and go towards us and close distance. I feared for my life as he continued to approach towards me and gain distance, still firmly gripping the black handled knife.

I transitioned from taser to my handgun due to my growing concern for my safety as he was gaining ground and was still armed with a knife. He continued to hold the knife offensively and firmly gripped with one hand. The way he was holding the knife was consistently with how you would hold the knife stable to stab other people. The way he was holding the knife was not consistent with how you would hold the knife to only harm yourself. His hand was in a fist on the knife and his thumb was towards the bottom of the knife and his pinky was closest to the blade. I could see his hand was turning white in color from him squeezing the knife tightly. He was holding the knife in a way that would make him in the strongest position to swing the knife with force, most likely in a downward angle. Both the taser and bean bags had little to no effect on him up to this point. He continued to close distance. Finally one of the bean bag rounds caused him to drop the knife.

He went towards a drawer in the kitchen that had actually been removed and was gone. He started looking around and appeared to be looking for another knife or weapon to access.

We were able to move up and kick the knife away from him. I utilized the shield to pin him to the ground and prevent him from moving or retrieving the knife or another weapon. I then assisted with the prone cuffing.

On 10-01-2014 at approximately 1035 hours, Officer G. Baldwin and I responded to 3217 N Nelson in Spokane, WA to assist patrol with a barricaded subject inside the house.

I responded as an operator on the SPD Emergency Response Unit. Our arrival time was 1035 hours per CAD. I have been an ERU/SWAT operator for four years and a police officer for over eight.

Upon arrival, I was informed that Terrence C. Walette was inside a bathroom in the residence. He was under arrest for Felony Harassment and City Assault, both charges were for domestic violence.

I donned my standard ERU uniform to include black BDU uniform, armored vest marked "police", and helmet. I was armed with my department issue Glock 21 .45 caliber handgun.

Sgt. Austin, ERU team leader tasked me with being inside the residence using the ballistic shield. The shield is equipped with lights and marked "Police" in the front in large lettering.

I entered the residence and took up a position. I was directly in front of a window on the South side of the residence in the entrance to the kitchen. I took a position blocking the kitchen entrance, so as to provide ballistic cover for other officers on scene. A ballistic shield is made of kevlar layers encased in plastic. It is rated to stop most handgun rounds, however kevlar is typically ineffective with rifle rounds and is not rated to withstand penetration by objects such as arrows, or knives.

Walette was reported to be inside the bathroom and admitted to being armed with a knife. I heard him say numerous times that he would stab anybody that entered the bathroom.

I was present for well over an hour of negotiations by the SPD Hostage Negotiation Team. Mainly it was officer Kirn. Never once did Walette cooperate and agree to surrender. He was told well over a dozen times that he was under arrest for assault. Walette stated numerous times that he was not going back to prison. He told us we would have to kill him several times. A mental health professional also attempted to negotiate a peaceful surrender with no results.

At one point, I heard Walette threaten to stab the police K9 (handled by Ofc. Buchmann) and I heard him threaten to stab Officer Kirn in the face. He told us all outside that he would, "Fucking kill

you [us]".

Officers had barricaded the exit route with four bar stools in an effort to slow Wallette's advance should he attempt to flee or assault officers. These stools would possibly slow his advance, but would not stop it. Officer Baldwin used Nylon webbing and tied the inward swinging bathroom door by the doorknob to be able to control his exit. See his report.

It was clear to me that Wallette was not going to surrender based on his continued defiance of our lawful commands to exit the bathroom by crawling out. He did not one time attempt to surrender, agree to surrender or open the door.

ERU officers outside inserted OC (pepper spray), which had no effect. See Officer Stone's report.

Officers then attempted to throw in hand held gas expulsion device, which Wallette then threw back out of the window. He appeared to be effected somewhat by the gas, as he was coughing. At that time, Wallette was thrashing around inside the bathroom, yelling at us that he was not going to prison, he threatened to kill us and then asked to say goodbye to his family several times.

He was able to open the door and when he did, he did not exit unarmed and crawling as directed. He exited the bathroom standing up. I was 14 feet per our later measurements from Wallette. We were unable to set up in position any further from Wallette, which would have been desired due to the layout of the kitchen. Should we have tried to set up further back, he would have been able to access the rest of the kitchen where there are numerous knives and improvised weapons. All said weapons are capable of causing serious bodily injury to officers should they be used in an assault. We also would not have been able to see Wallette when he exited, as well as the fact that there was a black door directly adjacent to the bathroom door he could use to escape, placing officers outside and the public at large in an unacceptable amount of danger. Much of the area he had access to was unsearched.

Wallette exited the bathroom holding a black handled kitchen knife in his right hand. The knife blade was estimated at over six inches long. The weapon Wallette armed himself with was no doubt easily capable of inflicting serious injury and death on officers on scene.

He first exited the bathroom with the knife held up in an assaulting manner. I felt at that time, that based on his actions and statements that he was intent on assaulting us officers with the knife.

He was given numerous verbal commands to drop the knife and get on the ground. He complied with none, rather he stood with the knife pointed out towards us officers in a threatening manner.

He did step towards us officers at that time. Based on my training and experience, I interpreted this to be a lethal force encounter. However, we were able to pre plan several multi force options in an

effort to prevent such from happening to the best of our ability in doing so, we could better protect ourselves and Walette.

I had switched from using the ballistic shield to now being armed with an orange 12 gauge shotgun. The shotgun was loaded with blunt impact munitions. The shotgun was two man loaded by Officers Bishop and Lesser earlier. I confirmed this with them prior to it's deployment. I was standing directly to Officer Lesser's left, which is described above.

I determined it was necessary to deploy the blunt impact munitions based on the following reasons:

Crime:

Walette was under arrest for city assault- DV, Felony harassment- DV, resisting arrests, and a minimum of second degree assault on police officers.

Threats:

Walette made numerous threats to stab officers, kill himself. He stated numerous times that he would not go back to prison. He told us we would have to shoot him. He said he would only leave in a body bag. Walette was currently armed with a knife, which is by all accounts is a deadly weapon. Walette, after hours of negotiations exited the bathroom armed with the knife, knowing the police were just outside the bathroom door. I had no other safe alternative to effect his arrest.

Resistance:

Walette resisted arrest for hours by arming himself with a deadly weapon and using the bathroom and door as a mechanical means of resistance. He threw out the gas expulsion device, and held the knife at us in a threatening manner, prevent police from merely taking him into custody without the use of physical force. Hours of de-escalation techniques were used by negotiators. None of which were effective in convincing Walette to disarm himself or surrender peacefully.

From 14 feet away, I deployed two blunt impact munitions, which were Super Sock bean bag shotgun rounds. I struck him both times (to my belief) in the front thigh and left thigh area. The munitions had absolutely no effect on him.

Officer Lesser simultaneously deployed a Taser in probe mode. This also had no effect on Walette. Despite continued verbal commands to drop the knife, Walette still held the knife and refused to surrender. I raised my target area to his hip girdle. I deployed two more rounds for the above reasons. These also had no effect on him. He did not surrender after being tased and struck with four blunt impact munitions.

I was running out of less than lethal options. The Taser was ineffective, and four impact munitions were ineffective. I only had two more rounds left available to me.

I was confident that I could accurately deliver a round to his upper arm in attempt to get him to drop the knife.

He was still resisting arrest, and still a lethal threat to us officer who were attempting to place him in to custody for numerous crimes of violence.

I delivered a single round to his right biceps muscle. The round struck where intended. It had seemingly no effect on Walette. He still held on to the knife in a threatening manner.

I used my last blunt impact munition. I struck him in the right hand, while aiming for his hip. His hand holding the knife had moved to my target area. The round struck him in the hand, just above the thumb. He immediately dropped the knife. The knife remained at his feet. Another officer continued to order Walette to surrender to which he refused.

Officer Lesser had dropped the Taser, which had one more cartridge. I picked it up and reloaded the last cartridge.

I determined it was necessary to deploy the Taser in probe mode for the following reasons:

The Taser is considered a less than lethal tool. It had failed one time already and I was on my last Taser cartridge.

Crime:

Walette was under arrest for city assault- DV, Felony harassment- DV, resisting arrests, and a minimum of second degree assault on police officers.

Threat:

Walette made numerous threats to stab officers, kill himself. He stated numerous times that he would not go back to prison. He told us we would have to shoot him. He said he would only leave in a body bag. Walette was currently armed with a knife, which is by all accounts a deadly weapon. Walette, after hours of negotiations exited the bathroom armed with the knife, knowing the police were just outside the bathroom door. I had no other safe alternative to effect his arrest. Six blunt impact munitions and a Taser were ineffective. He was still armed with a knife, which was just at his feet. he had moved to what I presume is a knife drawer, which was missing. He searched in the drawer, in what I perceived as an attempt to further arm himself.

Resistance:

The above stated, plus that fact that he continued to refuse to surrender and was in the process of attempting to arm himself again.

I deployed the Taser, Serial number X12000N0K in probe mode. I aimed for his left abdomen, under his chest. My goal was to have the probes enter his abdomen and also below his waist, per my training, to achieve the desired effect which it to incapacitate him for 5 seconds. This was effective.

We used the short window of opportunity to advance on Wallette and safely take him in to custody.

We then moved up and he was taken into custody by other officers.

He was immediately evacuated to medical attention, see their report.

I later collected the knife from the kitchen floor where it had been left, see photos.

On 10/1/2014 at approximately 1020 hrs, I was called by SGT Storment for a Emergency Response Unit call out at 3217 N Nelson. I am a member of the Emergency Response Unit (ERU) and Chemical Agent Response Team (CART).

I arrived at the station and drove the bag truck out to the scene. I arrived at approximately 1055 hrs. I loaded up the 40 mm launcher with six 40 mm blue nose rounds. I conducted two man loading with OFC Bishop.

I was ordered to be the less lethal cover in the kitchen. The suspect, Terrence Walette, was barricaded in the bathroom which was attached to the kitchen. Wallatte was armed with a knife. PC existed to arrest Walette for City Assault DV and Felony Harassment threats to kill.

Negotiators were attempting to resolve this situation peacefully, but Walette refused to cooperate and kept stating that he was not going back to prison. Walette mentioned several times that he was going to kill LE and stab the K9 dog in the head if the dog was used.

Walette kept stating that he was being told what to do by the voices in his head. Walette continued to yell at LE and refuse to cooperate. Walette mentioned over and over that he was not going to prison and that he was going to kill LE.

A signed search warrant arrived on scene. I transitioned from inside the residence to the backyard. The bathroom was on the NW corner of the residence. There was only one window into that bathroom that was about one foot by 2 feet. The window consisted of six glass blocks and a very small piece of frosted tempered glass. Negotiators were unable to get Walette to de-escalate.

The CP told us (ERU) to try and "bark" Walette out with the K9. Walette refused to come out and stated again that he would stab the K9 dog in the head if it came in. The CP authorized myself to break out the tiny tempered glass window and then OFC Bishop would utilize the pole camera to look in. I broke out the small window and Walette began yelling that he was going to kill LE and stay out. OFC Bishop began to try and look into the elevated window (approximately 8 feet off the ground) but Walette began to throw items out at us. I could hear Wallette coughing now, but still continuing to yell that he was going to kill LE.

I could hear LE yelling at Wallette to drop the knife and cooperate at this time. I was unable to see, but I assumed that Wallette had opened the bathroom door that led to the kitchen.

I stayed outside in the backyard until I heard that Wallette was in custody.

PC existed to charge Wallette with Assault 1st (knife) for stabbing at my right hand that had the OC can in it.

Photographs were taken of the scene and shampoo bottles that were thrown out. I was later informed that a bean bag shotgun was utilized in the kitchen. The distance between the deployment of the bean bag rounds and the suspect was approximately 14 feet. OFC McMurtrey deployed the bean bag rounds.

I opened all the windows on the first floor and the back door to help ventilate the CS smoke from the bathroom. The fire department was advised and deployed their fans to help ventilate the residence as well.

SGT Keller filled out the chemical agent use paperwork (in regards to the OC and CS devices) and delivered it to family members who lived at 3217 N Nelson.

I was then released from the scene and drove the bag truck back to the station.

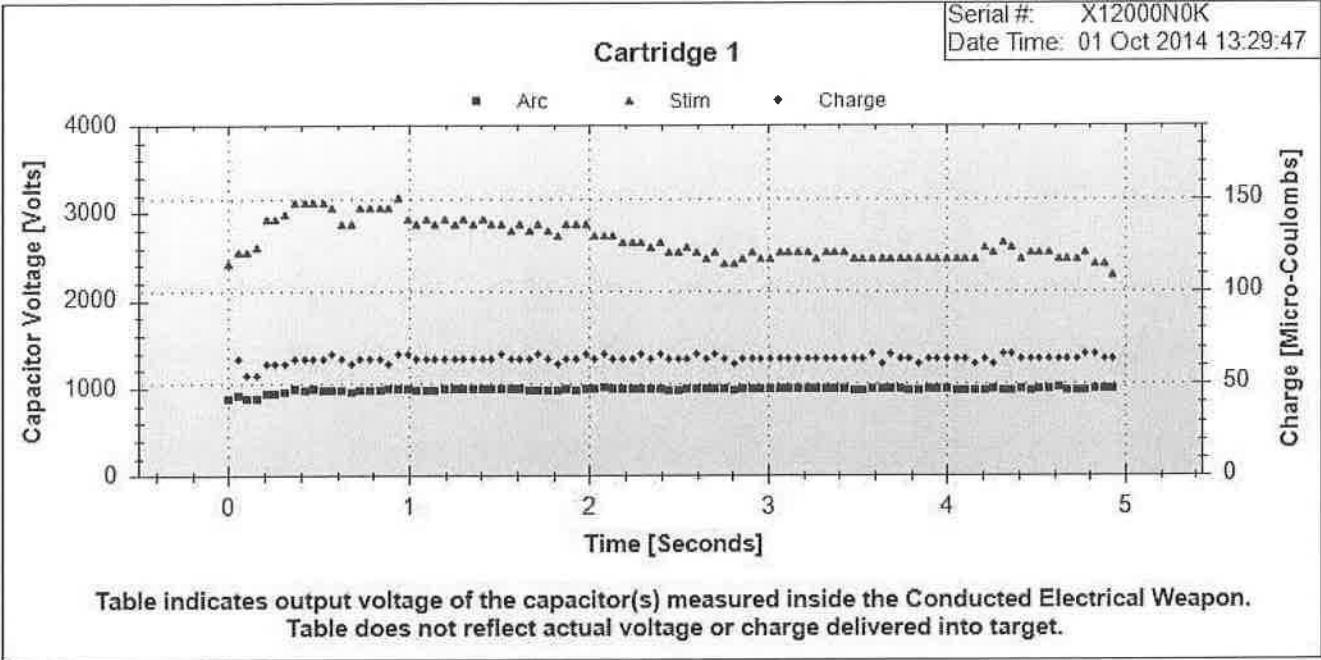

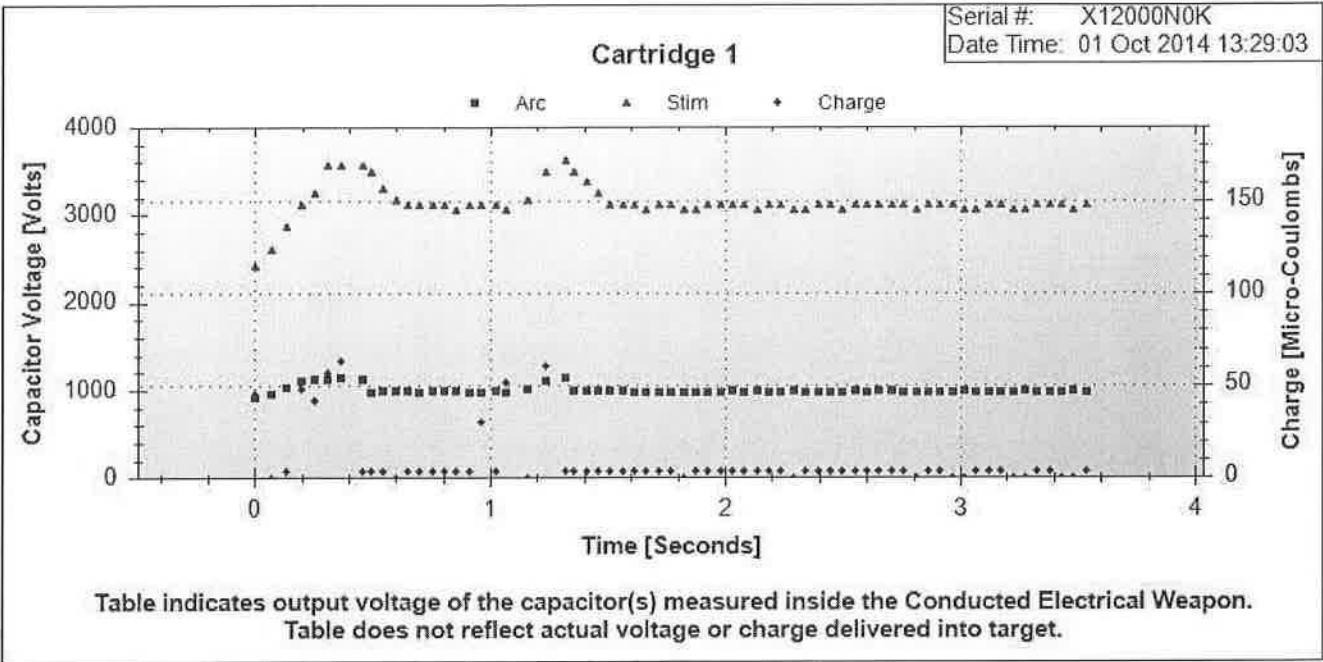
