Incident Summary

After reading the attached documentation and debriefing Officer Hamilton I find that his deployment of K-9 "Leonidas" during this incident as a searching and apprehension tool was reasonable, within State and Federal Law, within Department Policy and met Department expectations.

This incident appeared to be random in nature involving a very violent 1st Degree Robbery. The suspects were at large in a highly populated area of Spokane. If not apprehended these suspects posed a great risk to the unaware public in the area.

The victim of this crime was mentally disabled and vulnerable to this type criminal behavior.

This incident contained similar circumstances to other robberies and assaults that have occurred in the down town area recently. 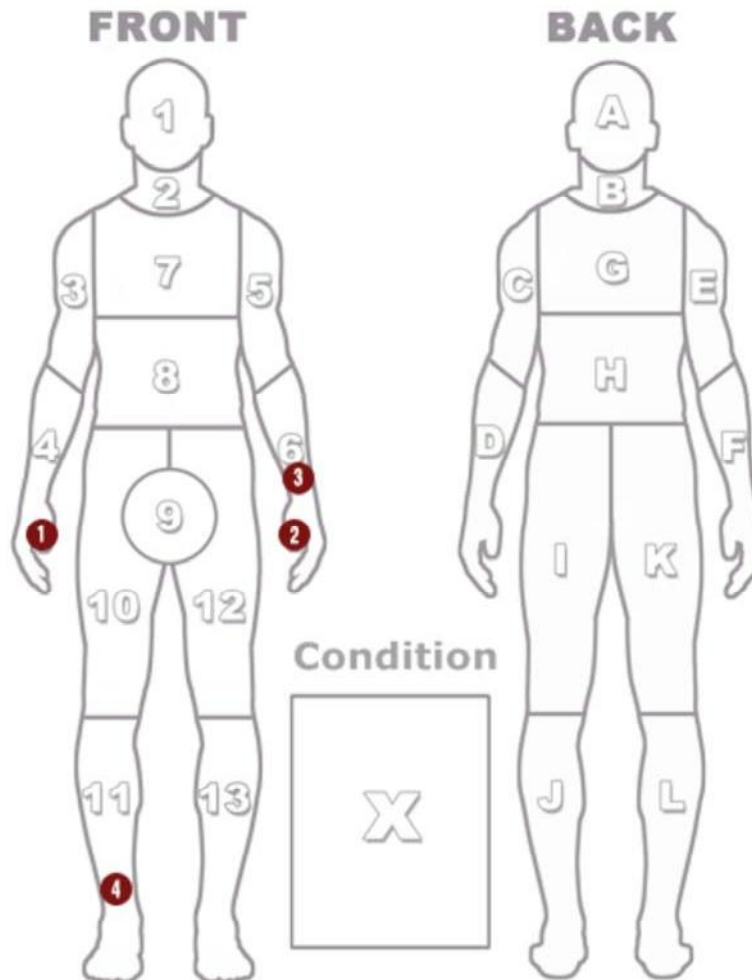

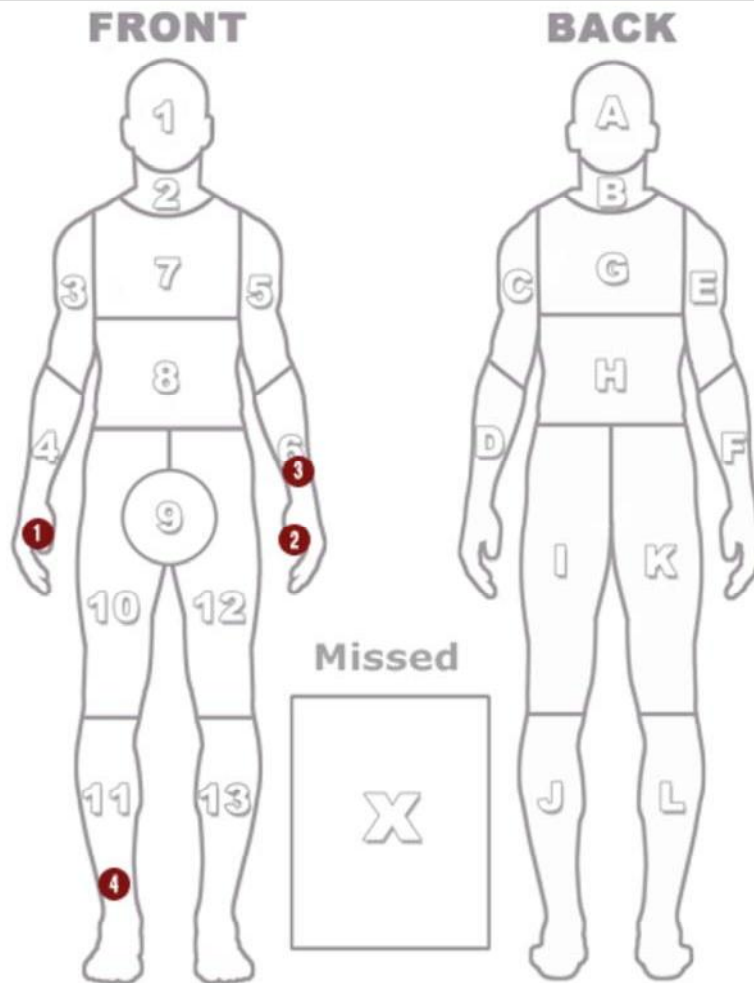

Report Narrative

On 10-26-14 at about 2333 hours, there was a report of a robbery in or near Riverfront Park, where 2 males were seen assaulting a homeless man then stole his belongings. The suspects were seen fleeing on foot and the victim walked toward the Riverpark Square Mall. The complainant was a witness to the incident. There was further information that two females were seen leaving with the male suspects.

It turned out the victim wasn't homeless but rather mentally disabled and had just gotten off work from Anthony's restaurant. He was walking home when he was randomly robbed and brutally beaten.

Several officer's responded and a perimeter was quickly set up.

I responded with K9 Leonidas (Leo). We are a WAC certified police patrol dog team and have been for 6 years. We are also accredited with the Washington State Police Canine Association (WSPCA). I'm accredited with the WSPCA as a Master Handler. I'm also a Master Trainer with the WSPCA. Leo is my second working dog in over 10 years of being a handler.

I was wearing the uniform of the day and driving a fully marked "Spokane Police K9" car. Leo was wearing a harness with "POLICE" marked along both shoulders and a Spokane Police patch affixed to the left side. We were clearly identifiable as police.

I arrived from the north along Washington near North River Dr. I saw Sgt. Kannberg stop with a couple people that were on the N/E side of the bridge at the stairs, which led down to the Centennial Trail.

I pulled right up to the stairs and saw a W/M halfway down the stairs and a female standing at the top. The male put his hands in his pockets and looked up towards me. I noticed he had blood on the front of his grey shirt, which matched one of the suspect's descriptions, in addition to there also being females.

The female threw her hands up in the air, and seemed quite scared. She quickly said, "I didn't do anything" and appeared to be almost crying. I assumed the male was one of the suspects in the robbery so I told him if he took off running, I would send my dog and he would get bit. The male stopped going down the stairs and was compliant with me from then on. He came back up and was eventually detained.

Sgt. Kannberg told me he saw two other people but they fled down the stairs. He said one of them was wearing a black jacket and the other was a female. All of this information matched the description of our suspects.

I saw the two fleeing suspects on the west side of Washington, walking with a fast pace N/W through the trees and under the cover of the dark. I grabbed Leo and tried to close my distance on the two suspects. They had about a 100 yard lead on me and I was only getting glimpses of them as they ran and walked along the fenced maintenance yard for Riverfront Park. They were heading towards the covered picknick area (Pavilion) near Mallon and Howard by the

large "butterfly". I saw them cut through the pavilion where all the picknick tables had been stacked. I lost sight of them as they continued N/B to the wide open gravel parking lot, which was west of Howard. A few seconds later, I saw the male suspect dressed in black in a full sprint running across the grass heading towards the bridge S/B. Leo and I were about 50 yards away to the east but as we were running, I yelled, "Police stop or my dog will bite you!" The suspect never slowed down and was obviously trying to escape capture.

I decided to release Leo to apprehend the fleeing suspect for the following reasons:

CRIME

- There was probable cause to believe the suspect had just been involved in a VIOLENT and RANDOM 1st degree robbery where the victim had been beaten. In addition, there was probable cause to arrest the suspect for obstructing our investigation by running from the police when lawfully ordered to stop.

RESISTANCE

- The suspect was actively fleeing on foot.

THREAT

- The suspect posed an immediate danger to the public and showed how violent his tendencies were by randomly attacking innocent victims within the City of Spokane. The method of robbery was similar to several other recent robberies in the Downtown area that have gone unsolved to this point. He was showing an extreme level of desperation to escape, which made him even more dangerous for whomever crossed his path. He was running back into Riverfront Park which provided numerous hiding locations with very low lighting. He was also heading towards Downtown Spokane, which was populated by people on foot. It was unknown if he was armed or what his intent was? He was wearing a backpack and a coat which could have easily concealed weapons. Its likely the suspect's identity would have gone unknown if not for the use of Leo to apprehend the suspect.

After yelling my announcement and the suspect failed to stop or even slow down, I released Leo to capture him and I followed. As I was running towards the bridge, I lost sight of the suspect as he made it around some bushes and was running S/B on the bridge. I saw several patrol cars pull up with their overhead emergency lights on, which I'm sure is what the suspect was also running from. I then lost sight of Leo as he too made the corner S/B onto the bridge. I couple seconds later, I heard the suspect screaming and I knew Leo had captured him.

I saw Ofc. McMurtrey and Ofc. Bode running up as well. After getting onto the bridge, I saw Leo had control of the suspect's left hand/wrist as the suspect was on his back, on the ground with Leo at his feet. The suspect was screaming and trying to push Leo off with his other hand. I saw his hands were clear of any weapons so I took control of Leo and he immediately came off the contact. The other officer's took the suspect into custody (see the other reports for further info).

After taking the male suspect into custody, I saw the female that was also running with him walking in the gravel parking lot. We ran up towards her and she was detained without incident by a couple other officers.

The suspect verbally identified himself as Patrick E. Curry.

The other male suspect, who we first detained, was identified as Gaudalupe Alvarez. The females were identified as Sandra R. Stanfield and Sherirea Chambers.

After returning to the bridge when I got my car from Washington St., I saw that Curry had been treated by Ofc. McMurtrey and Ofc. Lesser till he could be transported to Deaconess Hospital. However, Curry was acting very violent, was yelling at everyone, and claimed he was simply trying to get home. After he was put in the back of a patrol car, I saw him intentionally slam his

head repeatedly into the prisoner transport front shield. He was also crying but then calmed down enough and was transported to the hospital for further treatment of his injuries.

Curry's injuries were very minor. They consisted of some very small punctures and scrapes on his lower right shin and just below his right knee. He had a small tear on the inside of his left thumb that was bleeding and some scratches on his left wrist, which were not bleeding. His right thumb had a couple very small tears.

These injuries were consistent with a running apprehension and the injuries to the hand are most likely from trying to push the dog off the contact and getting the hands into the dogs mouth.

Curry was pretty calm at the hospital. When I asked him what was going on? He replied, "I should have stopped!" He told me he saw the police car with the lights on sitting on the bluff above the gravel parking lot (west of Howard on Cataldo). He said he saw me pull up in my police car so he took off but he denied hearing me yell a K9 announcement.

After Curry was treated, he was transported to the SCSO jail and booked for 1st degree robbery.

On 10-26-14 I responded to the area of Post and Spokane Falls Blvd for a Robbery. Upon arrival I contacted victim Yates. He was bleeding from the mouth and had blood on his face. Reserve Korpi interviewed Yates, see his report.

I was contacted by witness Sinchenko. He was walking through Riverfront Park. Sinchenko witnessed Yates walking. Two males approached Yates. One of the males punched Yates in the face, knocking him to the ground. Sinchenko watched both males start to kick Yates in the head. One of the males then removed the backpack off of Yates as he lay there. Sinchenko said that there was two females standing close by. The two males walked over to the females and all four fled into Riverfront Park. Sinchenko said that they did not cross the bridge. He watched them walk north and east, up to the river. They walked along the river and then he lost sight of them.

I advised over the Radio the last known direction of the suspects. A short time later Sgt Kannberg advised he had several people running from him, see his report for further.

I transported Yates to Sgt Kannberg's location for a showup, he had detained Guadalupe Alvarez. Yates looked at Alvarez. He said that Alvarez looks like the guy, but he had something dark on his head. Yates said it was either a hat or a hoodie sweatshirt. It should be noted that Alvarez had a black bandana in his pocket that was tied in a position that could be placed over your head.

I transported Yates to where Curry was for a show up. As soon as we pulled up Yates said, "Yup, that is him". Yates said that Curry was the male who took the phone from him.

Ofc Juarez had one of the females involved. She took him to where Curry and Alvarez dumped the backpack. We walked through the park and along the river. The female showed us a concrete wall and said it was thrown over that. We located a black backpack on the ground just feet from the water.

After photographs were taken, we went down and retrieved the items. The backpack had a wallet inside that had the ID of Yates. There was also numerous access devices (credit cards) inside his wallet. The items were all returned to Yates.

On 10-26-14 at about 2333 hours, there was a report of a robbery in or near Riverfront Park, where 2 males were seen assaulting a homeless man then stole his belongings. The suspects were seen fleeing on foot and the victim walked toward the Riverpark Square Mall. The complainant was a witness to the incident. There was further information that two females were seen leaving with the male suspects.

It turned out the victim wasn't homeless but rather mentally disabled and had just gotten off work from Anthony's restaurant. He was walking home when he was randomly robbed and brutally beaten.

Several officer's responded and a perimeter was quickly set up.

I responded with K9 Leonidas (Leo). We are a WAC certified police patrol dog team and have been for 6 years. We are also accredited with the Washington State Police Canine Association (WSPCA). I'm accredited with the WSPCA as a Master Handler. I'm also a Master Trainer with the WSPCA. Leo is my second working dog in over 10 years of being a handler.

I was wearing the uniform of the day and driving a fully marked "Spokane Police K9" car. Leo was wearing a harness with "POLICE" marked along both shoulders and a Spokane Police patch affixed to the left side. We were clearly identifiable as police.

I arrived from the north along Washington near North River Dr. I saw Sgt. Kannberg stop with a couple people that were on the N/E side of the bridge at the stairs, which led down to the Centennial Trail.

I pulled right up to the stairs and saw a W/M halfway down the stairs and a female standing at the top. The male put his hands in his pockets and looked up towards me. I noticed he had blood on the front of his grey shirt, which matched one of the suspect's descriptions, in addition to there also being females.

The female threw her hands up in the air, and seemed quite scared. She quickly said, "I didn't do anything" and appeared to be almost crying. I assumed the male was one of the suspects in the robbery so I told him if he took off running, I would send my dog and he would get bit. The male

stopped going down the stairs and was compliant with me from then on. He came back up and was eventually detained.

Sgt. Kannberg told me he saw two other people but they fled down the stairs. He said one of them was wearing a black jacket and the other was a female. All of this information matched the description of our suspects.

I saw the two fleeing suspects on the west side of Washington, walking with a fast pace N/W through the trees and under the cover of the dark. I grabbed Leo and tried to close my distance on the two suspects. They had about a 100 yard lead on me and I was only getting glimpses of them as they ran and walked along the fenced maintenance yard for Riverfront Park. They were heading towards the covered picnic area (Pavilion) near Mallon and Howard by the large "butterfly". I saw them cut through the pavilion where all the picnic tables had been stacked. I lost sight of them as they continued N/B to the wide open gravel parking lot, which was west of Howard. A few seconds later, I saw the male suspect dressed in black in a full sprint running across the grass heading towards the bridge S/B. Leo and I were about 50 yards away to the east but as we were running, I yelled, "Police stop or my dog will bite you!" The suspect never slowed down and was obviously trying to escape capture.

I decided to release Leo to apprehend the fleeing suspect for the following reasons:

CRIME

- There was probable cause to believe the suspect had just been involved in a VIOLENT and RANDOM 1st degree robbery where the victim had been beaten. In addition, there was probable cause to arrest the suspect for obstructing our investigation by running from the police when lawfully ordered to stop.

RESISTANCE

- The suspect was actively fleeing on foot.

THREAT

- The suspect posed an immediate danger to the public and showed how violent his tendencies were by randomly attacking innocent victims within the City of Spokane. The method of robbery was similar to several other recent robberies in the Downtown area that have gone unsolved to this point. He was showing an extreme level of desperation to escape, which made him even more dangerous for whomever crossed his path. He was running back into Riverfront Park which provided numerous hiding locations with very low lighting. He was also heading towards Downtown Spokane, which was populated by people on foot. It was unknown if he was armed or what his intent was? He was wearing a backpack and a coat which could have easily concealed weapons. Its likely the suspect's identity would have gone unknown if not for the use of Leo to apprehend the suspect.

After yelling my announcement and the suspect failed to stop or even slow down, I released Leo to capture him and I followed. As I was running towards the bridge, I lost sight of the suspect as he made it around some bushes and was running S/B on the bridge. I saw several patrol cars pull up with their overhead emergency lights on, which I'm sure is what the suspect was also running from. I then lost sight of Leo as he too made the corner S/B onto the bridge. I couple seconds later, I heard the suspect screaming and I knew Leo had captured him.

I saw Ofc. McMurtrey and Ofc. Bode running up as well. After getting onto the bridge, I saw Leo had control of the suspect's left hand/wrist as the suspect was on his back, on the ground with Leo at his feet. The suspect was screaming and trying to push Leo off with his other hand. I saw his hands were clear of any weapons so I took control of Leo and he immediately came off the contact. The other officer's took the suspect into custody (see the other reports for further info).

After taking the male suspect into custody, I saw the female that was also running with him walking in the gravel parking lot. We ran up towards her and she was detained without incident by a couple other officers.

The suspect verbally identified himself as Patrick E. Curry.

The other male suspect, who we first detained, was identified as Gaudalupe Alvarez. The females were identified as #2d and #2d.

After returning to the bridge when I got my car from Washington St., I saw that Curry had been treated by Ofc. McMurtrey and Ofc. Lesser till he could be transported to Deaconess Hospital. However, Curry was acting very violent, was yelling at everyone, and claimed he was simply trying to get home. After he was put in the back of a patrol car, I saw him intentionally slam his head repeatedly into the prisoner transport front shield. He was also crying but then calmed down enough and was transported to the hospital for further treatment of his injuries.

Curry's injuries were very minor. They consisted of some very small punctures and scrapes on his lower right shin and just below his right knee. He had a small tear on the inside of his left thumb that was bleeding and some scratches on his left wrist, which were not bleeding. His right thumb had a couple very small tears.

These injuries were consistent with a running apprehension and the injuries to the hand are most likely from trying to push the dog off the contact and getting the hands into the dogs mouth.

Curry was pretty calm at the hospital. When I asked him what was going on? He replied, "I should have stopped!" He told me he saw the police car with the lights on sitting on the bluff above the gravel parking lot (west of Howard on Cataldo). He said he saw me pull up in my police car so he

On 10-26-2014 at about 2338 hr. I (Sgt. Kannberg) responded to the area of River Front Park to assist officers in looking for 4 subject involved in a robbery. The suspects were described as (1) WM with a gray shirt, (2) Black male with a black jacket/shirt traveling on foot with 2 females.

Radio was setting up a perimeter and it sounded like the suspects were headed north from Post and Spokane Falls Blv area. I headed north bound on Washington and began checking the area. As I was northbound on Washington I crossed the Washington ST. Bridge on the north side of Riverfront Park just south of the Red Lyon. Walking on the east side of the bridge I saw 4 subjects walking north bound on the sidewalk; 2 males and 2 females. One male was wearing a gray shirt and then I could not see the 2nd male. I passed the subjects and slowed. It appeared the 2nd male had ducked down behind the cement barrier next to the sidewalk and then stood up or he got behind one of the other subjects. I did see he was wearing a dark jacket/shirt. I immediately stopped and began backing up. I advised radio of the suspects' location.

The subjects reached a set of steps down to a foot path on the north side of the Spokane River. I saw the male dressed in dark clothing and a female go down the steps. K9 Officer Hamilton had seen me stop and pulled up to the subjects. I confirmed with Officer Hamilton that I saw 2 subjects go down the steps. I then detained the male, ALVAREZ, GUADALUPE, 1995, 10, 13, in handcuffs D/L. When I handcuffed Mr. Alvarez, I advised him he was being detained for 1* robbery. When I cuffed Mr. Alverex he had blood on his left hand. I asked him about this and he sated he fell down. Mr. Alvarez was with #2d I also advised her she was being detained for 1* Robbery.

I asked who the people that took off were. Mr. Alvarez stated he did not know them. Ms. #2d stated it was Charles and Iva or something similar. MR. Alvarez told her not to say anything. I advised radio of the names. Ms. Stanfield indicted he was not involved in it. I again advised her she was being detained.

At this time I was by myself and only Mr. Alvarez was handcuffed. Other officers were attempting to detain the

subjects that ran. Ms. #2d and Mr. Alverex were cooperative. Mr. Alverex asked if he was under arrest a couple times. I informed him he was being detained for Robbery.

Officer Juarez arrived on scene and took control of Ms. #2d. See his report. I then conducted a pat search for weapons on Mr. Alverex, none were located. Officer Wilkinson arrived on scene and took control of Mr. Alverex.

Officer Juarez informed me Ms. #2d implemented Mr. Alverex and Mr. Curry in the assault/robbery. See his report. He also informed me they were out looking for a second person to assault.

Mr. Curry had been detained in River Front Park off Mallon and Howard. I responded to this location. Upon my arrival officers were trying to search Mr. Curry. Mr. Curry was being very vocal to officers and moving about as officers were trying to search him. Once he was search, he was placed in a patrol car. In the patrol car, Mr. Curry began slamming his head on the shield in the vehicle. After an officer talked to him he stopped.

Mr. Alverex advised officers he would take them to where the stolen items were discarded. He took officers over to the area of the old YMCA. I talked to Mr. Alverex at this location. Mr. Alverex stated Mr. Curry had thrown the stolen items under a bridge. Officers then located the victim's backpack next to the river. The victim's phone was not located.

I contacted officers up at the hospital with Mr. Curry. Mr. Curry was receiving treatment for a dog bite. No further police action was taken at this time.

Complainant advised that a male victim was assaulted by (2) males who fled E/B towards the 'blue bridge' in Riverfront Park. Complainant also advised that (2) females were seen running after the (2) male suspects, although it was not known if they were witnesses or possible suspects according to the complainant. Multiple units were responding to the area to establish the aforementioned perimeter.

Upon my arrival I took an elevated position to the north of Riverfront Park overlooking the Howard St entrance into Riverfront Park near the large gravel parking lot JNO of the park entrance.

A short while later, Sgt. Kannberg (L220) advised that he located (4) subjects crouching down along the footbridge near the Red Lion Hotel (JSO) Washington/ North River. Sgt. Kannberg was requesting units to focus on this area as he indicated via radio transmissions that these were possibly the suspects. As I directed my attention through the tree line towards Sgt. Kannberg's patrol vehicle I could see (2) subjects exiting through some bushes behind a building located on the S/E corner of the gravel parking lot. One of the subjects was wearing a light colored long sleeve shirt and a white knit beanie hat and the second subject was wearing dark colored clothing. The subject dressed in dark colored clothing immediately sprinted W/B across the south side of the gravel parking lot through the pavilion and towards the 'blue bridge' leading back into Riverfront Park. I advised the units in the immediate area down below of the subject seen running back towards the park entrance and this subject was subsequently contacted and detained. The other subject wearing the light colored shirt was also detained as she walked through the gravel parking lot. These subjects were later identified as Patrick E. Curry (03-25-93) and **#2d** (07-29-98).

After the subjects were all detained, Sgt. Kannberg requested a patrol unit to assist him at his location with the subjects he had detained. I arrived on scene with Sgt. Kannberg and contacted the female that he had detained, identified as [REDACTED] #2d (03-12-99) and the male was later identified as Guadalupe Alvarez (10-13-95).

Ms. [REDACTED] #2d was escorted to my patrol vehicle and a pat down frisk for weapons was conducted. Ms. [REDACTED] #2d was advised of her CR's and she waived her rights and agreed to answer any questions pertaining to the incident (see attached CR card). Ms. [REDACTED] #2d advised me that she and her friend ([REDACTED] #2d) were with the two males who she only knows as 'Charles' (Curry) and the 'gang member' (Alvarez). According to Ms. [REDACTED] #2d she only met Curry a few weeks ago and she just met Alvarez a short while ago. Prior to the incident they were all walking S/B on Post (JSO) the Post St. Bridge, the males were walking at a faster pace away from Ms. [REDACTED] #2d and Ms. [REDACTED] #2d as they approached an unknown male who was also walking S/B on Post St. Ms. [REDACTED] #2d heard Alvarez ask the male for a lighter and the male replied that he didn't have a lighter. Ms. [REDACTED] #2d witnessed Alvarez pushing the male down to the ground and once he was down on the ground both Alvarez and Curry kicked and punched him while he was on the ground. Alvarez took the victim's black colored backpack and ordered the male victim to give him his cell phone too. The male victim did provide his cell phone to Alvarez and left the male on the ground as they fled E/B through Riverfront Park with Ms. [REDACTED] #2d and Ms. [REDACTED] #2d following after them. Ms. [REDACTED] #2d saw Alvarez going through the victim's backpack and once they reached the stairway going up to the 'blue bridge' leading to the Howard St entrance, Alvarez threw the backpack over the side of the stairway. As they continued to walk through the park, Ms. [REDACTED] #2d overheard Alvarez make the statement that he wanted to find another victim to beat them down so that they could get more money. Alvarez supposedly bragged about being a gangster who beat people down to get money. Ms. [REDACTED] #2d subsequently completed a witness statement (see attached).

Officer Vantassel arrived on scene a short while later and advised that the (2) males were the primary suspects and the females were with the males and were not identified by the victim as suspects in the robbery. I eventually transported Ms. [REDACTED] #2d to the area where the incident occurred in an attempt to locate the crime scene. In doing so I located a blue jacket on the sidewalk (JSO) the Post St. Bridge which Ms. [REDACTED] #2d identified as Alvarez' jacket that Ms. [REDACTED] #2d was carrying for him at the time of the incident. I was unable to locate any other evidence of the crime scene and the area where the jacket was located was photographed for evidential purposes. Ms. [REDACTED] #2d also directed me to the location where the victim's backpack had been thrown over the side of the stairwell and I observed the black backpack with clothes strewn around the immediate area. This was also photographed for evidential purposes. The backpack and its contents which also included the victim's wallet were subsequently returned to the victim. The cell phone was not located at this time.

After performing a wanted person check on Ms. [REDACTED] #2d dispatch advised that she was reported as an active juvenile runaway (refer to #14-361610). Dispatch contacted CRC and was advised that she had been discharged from their facility and I would need to contact CPS in order to complete an AEP to place her back into the CRC facility. I contacted the runaway placement (CPS) at tel# 363-3333 and spoke to Pete who instructed me to return Ms. [REDACTED] #2d back to the facility and

On 102614 at approximately 2333 hours 911 received a call regarding a male who had been assaulted by two males and the two suspect males stole the victim's backpack.

Officers had began a K9 track and had located the suspects, now believed to be two males and two females, who were running through Riverfront Park.

On my arrival several subjects had been detained. The last outstanding subject was a female, who was standing in an empty parking lot near Mallon and Howard. Myself and another officer placed this female in handcuffs (DL). I frisked her for weapons, none located.

The female was identified as #2d I read #2d her Miranda Rights from a pre-printed rights card at 2351 hours. She advised she understood her rights and would answer my questions.

When I initially spoke with #2d about what had happened she was very vague, stating she did not want to get anyone into trouble and only spoke vaguely about seeing someone getting assaulted. #2d then stated the following:

#2d had just ran away from CRC, 201 W. 6th several hours ago. She stated she met up with her friend #2d (identified as #2d) and the two were hanging out with one another during the evening. About 30 minutes prior to the incident #2d advised #2d two guy friends, who she described as a B/M and a W/M showed up and they all began to hang out (unknown names of subjects). #2d verbally pointed out the male other officers had detained, Patrick Curry, as the B/M that they had met up with.

#2d advised all four of them were walking, though she was not exactly sure where besides believing she was near the running statues at the park (This area is near Post/Spokane Falls Blvd).

#2d advised she and #2d were about 30-50 yards behind the B/M and W/M suspects. The two suspects approached a victim described as W/M, grey sweater and backpack.

The B/M suspect punched the victim once, who then fell to the ground. The B/M suspect kicked the victim "a couple" of times and the W/M suspect kicked the victim once-all kicks being placed near the victim's stomach area.

#2d observed one of the suspects take a backpack from the victim though she was not sure which suspect did so or where the backpack was at in relation to the victim.

#2d advised they all began walking, she was nearly crying over the incident and the two males began looking through the victim's backpack which they had taken.

About this time the police arrived and the B/M suspect yelled "You're going to go to jail" and began running, so she also began running.

#2d stated she never looked through the victim's backpack, never assaulted anyone and didn't know that the assault was going to occur.

#2d showed to be an active runaway from CRC. I contacted officers on scene regarding #2d statements.

#2d was sitting in the back of my patrol vehicle at this time, handcuffed (DL). She had agreed to help point out where she believed the victim's backpack had been dropped in the park (as at this time it still had not been recovered). The back pack was eventually recovered by other officers.

I transported #2d to CRC where she was checked in.

On Sunday October 27, 2014 at 2333 hours I responded to the report of Robbery at Riverfront Park near the intersection of N. Post and Spokane Falls BLVD. I responded to assist OFC Vantassel as he conducted his investigation.

When I arrived on scene I initially took a perimeter position near the IMB Performance center. I maintained that perimeter position until I was advised by dispatch that all suspects were being detained. I was then advised that SGT Kannberg needed assistance near Washington and the Spokane River. I responded to that area and took custody of the suspect that he had detained in handcuffs. The suspect was identified as Guadalupe Alvarez. I immediately read Guadalupe his Constitutional Rights. Guadalupe stated that he understood his rights and agreed to waive those rights and answer my questions.

Initially Guadalupe stated that he met his friend Charles near the fountains in the park. He then attempted to tell me that he had no idea why he was being detained. I noticed that Guadalupe was bleeding from his left hand. When I questioned Guadalupe why his hand was bleeding he said he had hurt it earlier in the day. When I told him that he was being detained as a suspect in a robbery, Guadalupe said that he hadn't attacked anyone but he heard Charles said that he had "jumped" a guy in the park and stole his backpack. Guadalupe attempted to maintain that he was not with Charles during the assault. When I advised him that we had witnesses that placed him with Charles during the assault, Guadalupe admitted that he was with Charles during the assault but he never hurt the man. He saw Charles take the backpack from the man. He then helped Charles go through the bag and discovered that it was just packed with old dirty clothes. Charles then took the bag into the park and threw it away. Guadalupe said he did not know where the bag had been disposed of.

I was then advised by OFC Vantassel that there was Probable Cause to arrest Guadalupe for 1st degree robbery. I transported Guadalupe to the Spokane County jail where he was booked for the above mentioned charge.

On 102614 at approximately 2333 hours, I responded to the area of riverfront park on the north side near Mallon/Post reference a robbery.

Sgt. Kannberg advised he saw the described suspects attempting to hide from him. I was advised a black male, wearing black shorts and a black sweatshirt was felling with a female.

I heard Officer Hamilton advise the male and female were running on the North river path towards the "Butterfly" a statue on the entrance of the park at Mallon/Howard.

I observed the described male, later identified as Patrick Curry, running on the jogging path WB towards the foot bridge.

I exited my patrol vehicle to attempt to apprehend the suspect on foot.

Just as I exited my patrol vehicle and began to run, I observed Officer Hamilton's K9, Leo, running after the suspect. I heard Officer Hamilton advise, "Dog's out!", warning me that he had deployed his K9.

Both Curry and the K9 turned a blind coner around some bushes. I heard the male yelling, then turned the corner and observed him on the ground, being contacted by the K9. It appeared to me the K9 had contacted Curry's hand, see Officer Hamilton's report.

We then moved in as soon as Officer Hamilton caught up, almost immediately. When Officer Hamilton gained control of his K9, I moved in and detained Curry in handcuffs with another officer. He did sustain injuries possibly from the K9 contact, see Hamilton's report.

After detaining Curry, I provided medical assistance. I bandaged both his hands with gauze. The gauze controlled what bleeding was present.

I also bandaged his right leg near the knee and calf. That injury appeared to be abrasions from a fall and did not appear to me to be cause by a K9 based on my experience. The wound had no saliva near them, and the leggings he was wearing only had a small tear, not consistent with K9 apprehension. His leg was also covered in dirt and small gravel, more consistent with a fall.

On 10-26-14 at 2352 hours I responded to the report of a robbery at Spokane Falls Blvd. and Post St.

Upon arriving I contacted Thomas Yates. Yates told me that he was leaving work at Anthony's when he was approached by a white male later identified as Guadalupe Alvarez, a black male later identified as Patrick Curry, and two females. Alvarez asked Yates if he had a lighter. Yates told him that he didn't because he didn't smoke. The white male then punched Yates in the face. Yates was not expecting to be punched and said he did not know which hand Alvarez used. Upon being punched Yates fell to the ground. Alvarez then stomped on Yates's face. Yates could not remember much after Alvarez stomped on his face, but he did remember receiving multiple additional kicks to the head, stomach and arms. However, Yates did not know who was kicking him.

Yates felt someone pulling his backpack off of him, but was uncertain which male grabbed it. While Yates was laying on the ground Curry started yelling at him telling him "you better not snitch." He also told Yates to give him his phone. Because he was afraid of being hit again, Yates threw his phone to Curry. Alvarez, Curry and the two females then left him and went into riverfront park.

Yates told me that his backpack contained his wallet and his clothing from both of his jobs. Yates said his wallet contained his debit card and a Kohl's credit card. The phone taken by Curry was a black Tracfone flip phone (509-981-7106).

Yates's injuries consisted of a gash on his lower lip and multiple bruises and abrasions around his right eye. Yates said that he could also feel, by running his tongue over them, that one of his teeth was chipped. Yates also informed me that his nose was started to swell up and was very sore.

On 10/26/2014, I responded to assist with a robbery call at Post St and Spokane Falls Blvd.

Upon arriving on-scene, I took a perimeter position at Lincoln and Mallon. While waiting at that location, several of the suspects were located, one of which took off running through Riverfront Park. I made my way to the park and assisted with controlling a male, who had been contacted by a police K9.

After the male was placed in handcuffs, I escorted him to my vehicle, where he received field aid from Officer McMurtrey, for the dog bites. The male verbally identified himself as Patrick Curry.

A show up was performed while I stood with Patrick next to my patrol car. I was advised that the show up was a positive ID, for Patrick being one of the suspects involved in the Robbery. I advised him he was under arrest, searched him, and placed him in the back of my patrol car. He attempted to bang his head against the shield in my car, but stopped when I told him to.

I transported Patrick to Deaconess Hospital, to receive proper medical treatment for his injuries. While at the hospital, his injuries were cleaned and bandaged. He received several stitches to his left thumb.

After being treated, I was advised by medical staff that he was clear to take to jail. I collected his papers, placed them with the rest of his property, and transported him to county jail.

All booking paperwork for Patrick was filled out by Officer Vantassel.
