Sender's Instructions: The use of the rifle under the circumstances outlined in the attached reports as a blunt force instrument is an exceptional technique apparently taught during ERU training. It is my finding that this exceptional technique was justified under the totality of the circumstances as detailed at length in Sgt Eckersley's and Lt Walker's reports. Areas for consideration include development of policies regarding the use of a rifle as a blunt force instrument to subdue a violent resistor and appropriate documentation of this training when conducted (to be included in the officers' training records managed by the Training Unit). The investigation does not indicate that ERU has documented this training; this and other similar types of training should be documented even if conducted exclusively during the course of specialty team training.

Incident #15-154745; use of force review.

Officers Brasch and Brownell fall within my chain of command. My review is of their use of force in this incident.

I agree with Sgt. Eckersley that the use of force by both officers was reasonable and within department policy. This incident involved a suspect who was wanted for 1st degree assault with a firearm. This warrant was the result of an incident just weeks prior where the suspect, Brandon Hutchinson, had fought violently with Officer Dan Cole. In that incident, Hutchinson had fled from a vehicle, forced entry into a citizen's home during flight and then fought with Officer Cole. Hutchinson disarmed Officer Cole of his Taser and it appeared he believed it was an actual firearm. Hutchinson was able to discharge the Taser at Officer Cole and then apply a touch stun to Officer Cole before officers were able to gain control and take him into custody. Officers also discovered that Hutchinson had been armed with a firearm during part of the incident. Additionally, PACT officers had multiple sources of information advising that Hutchinson was again armed with a firearm. Based on the information officers had, it was reasonable for officers to view Hutchinson as an extreme threat to both officers and the general public.

Officers attempted to arrest Hutchinson outside of a vehicle. Hutchinson responded by diving into the nearby vehicle and according to officers reports the officers on scene were convinced he was going for a weapon. Hutchinson then slid over to the driver's seat and fled in the vehicle. Officers pursued Hutchinson until he was involved in a collision with a parked vehicle. Hutchinson fled on foot, into the backyard of a residence. At that time there were civilians, to include children, in the yard. Officers noted that if Hutchinson responded with an assault or violent act, both the pursuing officers and the civilians were in danger.

Officers caught up with Hutchinson in that yard. In Officer Stone's report he indicated his perception that Hutchinson had balled his fists and swung them toward Officer Brasch when Officer Brasch reached Hutchinson. This action could reasonably be viewed as assaultive behavior.

As officers attempted to take Hutchinson into custody, all three officers, and the civilian witnesses, described Hutchinson reaching under his body. All three officers documented their perception and belief that this action was Hutchinson attempting to retrieve a weapon. Based on Hutchinson's criminal history, most recent arrest, and the current intelligence officers had available, this was a reasonable conclusion on the part of the officers. It was clear that each feared that Hutchinson was going to retrieve a weapon which posed great danger to them and the civilians in the yard. This action was reasonably perceived by the officers as an assaultive action, if not escalating to the point where officers may have to use lethal force. It also

demanded that officers quickly control Hutchinson to prevent him from succeeding in accessing a weapon.

Officer Brasch responded by applying a lateral neck restraint and was eventually able to render Hutchinson unconscious. This use of force was reasonable and justified under the totality of the circumstances.

Prior to Officer Brasch rendering Hutchinson unconscious, Officer Brownell documented attempting to prior Hutchinson's arm from under his body without success. He then switched tactics and applied 4-5 closed fist strikes to Hutchinson's back. After applying the strikes, and either as a result of the strikes or Hutchinson being rendered unconscious, he was able to remove Hutchinson's arm from under his body and place him in handcuffs. Again, the use of the strikes were reasonable and justified under the totality of the circumstances.

Once Hutchinson was in custody, he complained of difficulty breathing. Officers immediately began first aid on Hutchinson until medical personnel arrived. It was later determined that Hutchinson sustained broken ribs during the incident. It is unclear if this as a result of the force used by officers, or as a result of the collision Hutchinson was involved in, prior to the arrest.

On 5/30/11, Sgt. Eckersley and I viewed portions of each of the recordings from the body cameras on scene, in Evidence.com. Sgt. Eckersley was logged into the system, and we viewed the recordings together on his computer. Officer McMurtrey's recording clearly shows officers performing first aid on the suspect after he was in custody. All of the recordings, however, were of the post arrest activity. I was informed that Officer Stone, who was the only officer involved in the use of force equipped with a body camera, failed to turn the camera on until after the suspect was in custody. Officer Stone had advised Sgt. Eckersley that he forgot to activate the camera due to how quickly the incident unfolded. This is understandable, but should be addressed by the department. This new technology is designed to document incidents and is only effective when actually recording. Additional training on the use of body cameras, particularly in high stress incidents, should be a continual part of in-service training so that the activation of the camera becomes routine and consistent.

I have reviewed this incident and concur with Sergeant Eckersley's findings regarding Officer Stone's use of force. The suspect was clearly a dangerous individual based on the facts and circumstances known to the officers at the time, which is why an exceptional technique was acceptable. Officer Stone is very experienced and had received both SPD and additional training from the military in the use of utilizing a weapon as an impact tool.

I do however have concerns regarding the training involving the use of a rifle and/or barrel as an impact weapon. I would recommend a review of the training to ensure that this technique is utilized in those situations where officers are bordering on a potential life and death situation. The potential for an accidental discharge of a weapon is possible and depending on the circumstances there could be other officers and civilians in close proximity. The level of experience for all officers trained in this technique may not match that of Officer Stone, which is another reason this technique should be reviewed and closely monitored.

On 051115, Officer Brownell advised that he had just received reliable information that Brandon K Hutchinson (031485) was currently at the Deja-Vu at 8722 E. Sprague. Hutchinson was listed as a Repeat Offender with active felony warrants for 1st degree assault with a firearm and felony DOC warrant for Burglary 1st degree. He is listed as a possible Skinhead Gang Member and shows to have a mental history and be a violent offender. His history shows cautions such as "Possibly Armed", "Assaultive to Law Enforcement" and "Resistive to law enforcement" with a risk level of "High Violent". He has a history of assault 3rd, Robbery 1st, drugs, Burglary 1st (armed), stolen cars, assault, and commercial robbery. His criminal history alone clearly shows that he is a violent suspect who Officers should always consider to be armed and dangerous towards law enforcement and the general public.

All Officers involved in this incident were also well aware of Hutchinson's most recent arrest (15-125228) just 3 weeks prior. During that incident Hutchinson was a passenger in a vehicle pursuit that was terminated. After the pursuit was terminated the vehicle he was riding in was involved in a collision and Hutchinson ran on foot. During that time he was armed with a handgun which was later recovered. Hutchinson was free of pursuing law enforcement but still chose to gain entry into an innocent civilian's residence in attempt to steal a vehicle to continue evading Officers. At that time he became an extreme threat to citizens as he clearly was capable of doing anything to avoid capture by law enforcement. He had stolen car keys from a female resident and struggled with her as he exited the house after forcing entry through a door.

Officer Cole located Hutchinson at that residence and he fought violently with Officer Cole. During the struggle, Hutchinson disarmed Officer Cole of his Department issued taser. He made statements that he was going to kill Officer Cole and pointed it at him. Hutchinson believed he had disarmed Officer Cole of his duty firearm and attempted to shoot and kill him to carry out his threat. Hutchinson was able to take the taser off safety and deploy the dart probes at Officer Cole. He then used the touch stun mechanism on Officer Cole when the probes failed to incapacitate him. Hutchinson was eventually taken into custody on his DOC warrant after that violent encounter. Officers in this case were aware of the facts in that recent case and knew that Hutchinson had fired the taser at Officer Cole in attempt to kill him. Officers were also aware that Hutchinson had been bonded out of jail shortly after that last arrest and had since had active felony warrants issued.

All of the Officers in this incident also were advised before making any contact with Hutchinson, that several cooperative individuals provided information to law enforcement that Hutchinson was again carrying a firearm. Based on the previous incident, Officers in this case all believed that he was armed, dangerous, and an extreme threat to any Officer or citizen that came into contact with him. Officers were also concerned about the extreme danger that Hutchinson posed to any law enforcement officer that could come into contact with him and being without the information described above. To protect innocent citizens and fellow Officers, Hutchinson had to be taken into custody.

Officer Brownell contacted me and other members of the team to respond to the Deja-Vu. Due to his threat level, on duty ERU members were also contacted. Those officers who immediately responded to the scene were 5 active ERU members and 1 TAC member. All 6 of those Officers have a level of tactical training that is far above the standard patrol officer level. They included ERU personnel, Sgt. Terry

Preuninger, Officers Christopher Brasch, Scott Lesser, Kyle, Heuett, David Stone, and TAC Officer Mark Brownell. I am a TAC member and was responding to the scene as the unit Supervisor for PACT officers. Sgt. Preuninger is an ERU overall team leader and highly capable of developing and implementing an arrest plan. I contacted dispatch and advised medics to stand by while in route. A k-9 unit was also called out but was unable to make it to the scene before Hutchinson was observed leaving the Deja-Vu.

Those 6 Officers on scene had double up in 3 vehicles. They coordinated a takedown plan and were waiting for additional resources when Hutchinson emerged from the establishment. Officers identified Hutchinson by sight and there was no doubt that it was him. They saw Hutchinson at the passenger side of a vehicle in the parking lot and believed that they could make contact with him before he could gain access to the driver's seat of the vehicle or flee back inside the business.

Officers moved in and Hutchinson dove in the passenger seat of the vehicle. Officer's reports describe his actions and body movements that caused them to believe that he was accessing or concealing a firearm in the vehicle. The driver of the car immediately gave up and exited the vehicle. Hutchinson was able to slide into the driver's seat and take control of the vehicle. Hutchinson drove over some concrete parking barriers and fled the parking lot in the vehicle. Officers initiated a vehicle pursuit at 1617 hrs. Officers knew that he was the only vehicle occupant as the original driver did not return to the vehicle.

The pursuit went W/B on Sprague at about 65 mph and then N/B on Park Rd. Hutchinson ran a steady red light at Vista. Hutchinson's vehicle was damaged and pieces of a tire were breaking off as they continued N/B on Park. Speeds reached approximately 70 mph. Park Rd is a main arterial however there was significant traffic due to the time of day. Hutchinson drove recklessly by swerving from his N/B lane into oncoming traffic and back into his lane. There was no doubt that this was a dangerous pursuit. Hutchinson's vehicle was losing a tire so his ability to proceed for an extended period of time was diminishing.

Officers chose to continue with the pursuit. Due to Hutchinson felony warrants for the violent crimes listed, the pursuit was within policy. I believe that Officers were obligated to continue and stop Hutchinson. Hutchinson had shown in the previous incident that he was capable of anything to avoid capture. If officers terminated the pursuit at this time, Hutchinson would be forced to leave his disable vehicle and his past behavior shows that he would be capable of committing home invasion robberies, a carjacking or any other act of violence to acquire another vehicle or hide from law enforcement.

Hutchinson passed vehicles on the shoulder, and disregarded traffic lights at Valleyway. It was about that time when his rear tire came off of the vehicle. Hutchinson lost control of the vehicle at Park/Sinto and crashed into a stop sign. Hutchinson's vehicle was at a stop so Officer Brasch attempted to use his front bumper to pin his driver's door shut to prevent escape. Hutchinson was able to drive through a yard and continue on Sinto. Hutchinson drove a short distance before losing control on a N/B turn onto Ella where he struck a parked car. Officer Brasch again attempted to block the driver's side door and made contact with the stopped suspect vehicle.

Hutchinson was able to escape through the passenger door and run on foot. Officer engaged in a foot pursuit that went through the back yard of a residence. There were several small children and two adult females in that back yard. Officers reported that they were concerned that Hutchinson was still armed and capable of taking hostages or engaging in a firefight with Officers while citizens were present. Officers yelled to those citizens to get back to protect them from Hutchinson. Officers were able to catch up to Hutchinson when he reached a back fence and used force to take him into custody. Officers explained their reasoning to use force as follows:

- 1) Crime: Hutchinson had warrants for Felony Assault 1st Degree with a firearm, first degree robbery, first degree burglary, residential burglary, first degree unlawful possession of a firearm, possession of a controlled substance, and third degree assault, and a department of Corrections Warrant. He was also wanted for Felony Eluding. Hutchinson had violated his release for assaulting a Spokane Police Officer with a Taser.
- 2) Hutchinson has been armed with firearms on several occasions and has violently assaulted Officers and citizens in the past. His most recent conviction was for assault 3rd degree.
- 3) Hutchinson had fled in a vehicle from Officers and had driven recklessly through streets and neighborhoods attempting to avoid capture. Hutchinson ran on foot, through yard, after crashing his vehicle into a parked car. Officers had information that he was currently armed.

During the lawful arrest, Hutchinson turned his body towards Officers Brasch and Stone and shoved violently back into Officer Brasch. Officer Brasch placed Hutchinson in a vascular neck restraint. He resisted violently and reached towards his waist band with his right hand. Hutchinson refused to obey lawful commands and they fell to the ground.

Officer Stone was closely behind Officer Brasch and saw Hutchinson ball his fists and swing towards Officer Brasch when he turned back towards him. Officer Stone saw Hutchinson, while on the ground; rapidly reach for something under his body with his hands. Officer Stone had his patrol rifle in his hands and was unable to use any other means to gain compliance without compromising his weapon and making it accessible to Hutchinson. Officer Stone's rifle was on "safe" and he was indexed with his finger off the trigger. Concerned for Officers and nearby citizens, Officer Stone used the barrel of his rifle to deliver 4 power jabs to Hutchinson's left lower back area.

While Officer Brasch was tied up with Hutchinson, Officer Brownell arrived and saw Hutchinson dig under his body with his left hand. Officer Brownell attempted to use a lesser degree of force by prying on his arm to remove it from under his body. When he was unable to accomplish this, Officer Brownell delivered 4-5 punches to the left side of Hutchinson's back and body.

At about this point, Officer Brasch was able to render Hutchinson unconscious with the vascular neck restraint. Officer Brownell was able to get Hutchinson's left arm out while Officer Stone was able to get his right arm out and Officers were able to get him handcuffed without further use of force. Hutchinson gained consciousness and complained of labored breathing. Officers maintained control of him while giving aid and assisting medics who arrived on scene. All three Officers advised me that they still believed Hutchinson was armed until he was cuffed and searched. They still believed that he had been

armed and called for a county bomb dog to search the area for a discarded weapon. Officers checked the surrounding area including the freeway that was separated from the yard by a brick wall. Officers were so convinced by past information and Hutchinson's behavior (described in detail in all reports) that he was armed. Officer Brownell obtained a search warrant for the vehicle but no firearm was located. It is possible that he was armed and able to discard the firearm from the vehicle during the pursuit. At the time of this report, no firearm was ever located.

I was unfamiliar with Officer Stone's technique of using the patrol rifle as an impact tool. After the incident I contacted Sgt. Preuninger who is a Master Firearms Instructor and ERU Overall Team Leader. He advised that Officer Stone was trained in such a technique and provided a detailed summary of the technique and its uses. He also provided me with documentation from Sgt. Rob Boothe who is the Spokane Police Departments firearms Sgt., Master DT instructor, and the Lead Firearms Instructor for the Department. Sgt. Boothe's documentation also describes the techniques and training that Officer Stone had in using that technique.

After reading their synopsis of the technique, I determined that it was justified under the circumstances and within policy as well as department training and practice (see their attached reports). Officer Brasch and Officer Brownell were also reasonable, justified, and within policy for their uses of force against Hutchinson. As stated above, all of these officers involved in the pursuit and subsequent uses of force were informed of all the elements that made Hutchinson such a dangerous felon, who they believed was armed at the time, and were justified and within policy in all aspects.

I interviewed the two adult females and one juvenile that were in the back yard of the residence when Hutchinson was taken into custody. The adult females expressed how they too were scared that Hutchinson would try to take one of their children hostage as he ran within a few feet of a 3-year old child. They observed Officers knock Hutchinson off the fence and saw Hutchinson fighting with and resisting Officers attempts to restrain him. Both adults also observed Hutchinson digging at the ground under his body while Officers struggled to take him into custody. A 12 year old girl in the yard, observed one Officer use his long gun to strike Hutchinson 5-6 times in what she thought was the back or head. Her statement was consistent with Officer Stone's explanation of his use of force. The adults were complimentary of the Officers actions and felt that the Officers were genuinely concerned about their well being and safety and impressed with how quickly they handled the tense situations.

A copy of all Officers reports, collision reports, CAD, and related information will be attached to my Use of Force Report and Pursuit Review.

At the scene, Officer Stone advised me that the initial contact and pursuit happened so quickly that he forgot to turn on his body camera. He did activate his body camera once the scene was secure. On 053015, Lt. Hendren and I viewed portions of each body camera video. The video from Officer

McMurtrey's body camera shows Officers and AMR applying medical treatment to Hutchinson in the back yard of the residence. Officer Stone's first video shows portions of the medical treatment and then Officers searching for the firearm. Stone's other videos shows Hutchinson being treated in the ambulance and hospital.

There was a delay in me completing this review while I gathered video evidence, a scene photograph request, and additional reports from officers that I requested after their initial reports were completed. Those additional reports were for Officers Stone and Brownell, as well as the explanation of training from Sgts Boothe and Preuninger regarding Officer Stone's use of his patrol rifle as an impact device. Once I had all of the information I was able to review the statements and evidence to make my determination.

In conclusion, I find the following:

My findings regarding the initiation and continuation of the pursuit are that all officers were reasonable and justified under the totality of the circumstances. Two units were actively involved in the pursuit. Officers attempting to catch up to the pursuit were obligated to assist due to the extreme officer safety threat that Hutchison posed when the pursuit would eventually end and at no time were there too many units involved.

In regards to Officer Brasch using his vehicle to make contact with the suspect vehicle, I would recommend a finding of Legal Intervention. The contact was made (in both instances) when the suspect vehicle was at a complete stop. Damage to both vehicles from that contact was minimal and designed to prevent further flight by the suspect. Stopping the suspect from exiting the driver's door also gave Officers valuable distance if he chose to fight or fire upon officers.

I find the use of force by a lateral neck restraint by Officer Brasch to be reasonable and justified under the circumstances as Hutchinson was actively fleeing, resisting, and believed to be armed at the time.

I find the use of fist strikes by Officer Brownell to be reasonable and justified under the circumstances where he believed Hutchinson was attempting to gain access to a firearm and the force used was immediately stopped once he was rendered unconscious and he was able to gain control of the hand that was reaching towards his waistband.

I find the rifle strikes used by Officer Stone were an exceptional technique under the totality of the circumstances at that time. Officer Stone had been trained on that technique through ERU and he applied those strikes at a time in which he believed the suspect was armed and attempting to access a firearm.

I debriefed all officers involved shortly after the suspect was finally controlled. All of the officers believed that Hutchinson was armed the entire time and believed that their lives and the lives of other officers and innocent civilians were at risk. Everyone expressed to me that they believed there were multiple occasions where they believed lethal force was imminent. From the moment they first made contact in the parking lot until the suspect was handcuffed, officers showed significant restraint in the

amount of force they did use and chose to use any other means short of lethal force in a situation where they all believed they may have been forced to.

Reference our conversation on the use of a firearm as an impact device.

Is the use of a firearm as an impact device an objectively reasonable application of force? A reasonable objective use of force is based on the officers' training, experience and if they were operating within the law and department policy, and is the technique legally, tactically and medically reasonable. Officers of the Spokane police department are taught in weapon retention the braced contact position to hold their firearm. The hand holding the handgun remains in the grip and the non-primary hand goes over the slide and secures the slide to the receiver. The officers are then taught to use the handgun as an impact device. This technique is also taught at the Washington State Criminal Justice Training Commission as well as several independent firearms and defensive tactics schools such as Arrestling and Force Options. As a technique that is taught by the department and several other recognized entities it is reasonable to assume that the use of the firearm as an impact technique is reasonable objective, and that when used against a resistor that the officers reasonable believes to be life threatening (to include substantial bodily harm) that the use of a firearm as an impact device is an reasonable objective use of force.

When the firearm used is a rifle platform, the mechanics of the encounter all favor the suspect as the rifle represents a greater lever to be used against the officer who also may or may not be secured to the firearm with a sling.

If the firearm can be used as an impact device for retention of the firearm, it is also reasonably objective for the officer to use it as a impact device to gain control over a suspect, given that the officer reasonably perception that the imminent and or immediate actions of the individual could cause the death or serious bodily injury to an individual or officer.

This memo addresses the use of a firearm as an impact tool during a violent encounter, specifically the use of an M4 / AR15 platform.

Anytime an officer is in a struggle with a citizen there is the added inherent danger because there is always at least one weapon present, the firearm carried by the officer. What is already a very dangerous situation is magnified when the officer is holding a shoulder fired system as there are less options available for securing the system, the larger weapon is more difficult to control and the officer is greatly limited in the use of his hands as one or both of them are needed to secure the weapon.

SPD ERU members get a higher volume, and more advanced level of training in this area as they are often holding a shoulder fired platform. Their training mirrors standard SPD and WSCJTC training as well as increased and diverse reality base training and more time spent on exceptional techniques, due to the very nature and frequency of the calls they respond to.

In most cases the tactics use by an ERU member will be to protect the weapon and effect whatever lawful act is necessary when dealing with the citizen. For example, in the case of a passive resister the officer may secure his weapon with one hand, using a tactic of pulling the weapon in close with the support hand on the fore end and then using the strong hand to move or escort the resister. Or, he may use his strong hand to continue controlling the weapon with his master grip on the firearm and use his support hand to control the citizen. This tactic can be elevated in the case of an active or assaultive perpetrator by increasing the level of force delivered by the free hand or using a different tool like a knee strike or kick depending on what the level of resistance is being offered, the terrain, the officer skill level, the suspect size and strength and many other variables.

However in some cases where the threat of harm rises exceptional techniques may be used to overcome the limitations presented by holding a shoulder fired weapon in a physical encounter. An example of this would be in basic weapon retention taught not just in SPD ERU training but also by SPD and WSCJTC for dealing with a person who is attempting to take or control an officer's rifle. The officer will begin with a series of moves and counter moves to get the suspects hands off the weapon, if unsuccessful the officer may rise to a series of strikes to effect the desired outcome. If these tactics are unsuccessful the officer may have to use the weapon itself as a striking tool, either using the butt, fore end, grip, fore grip or even barrel as a an impact point. While driving the barrel of a riffle into the torso of a citizen or striking him in the head or face with that barrel is an elevated level of force, the alternative is likely the use of deadly force to prevent the citizen from taking control the officer's weapon.

If a situation where an officer was struggling to retain his weapon were to rise to a level where deadly force was becoming imminent or likely, and one of these exceptional techniques is used the officer has to take great care to stay consistent with their SPD and WSCJTC training and remain indexed and ensure the manual safety on the rifle is engaged (as they have not made the decision to fire). They also have to be mindful of limitations in using the butt, fore end or pistol grip as a striking tool as those tactics have a high likely hood of pointing the muzzle away from the aggressor and in the direction of the head or torso of other officers involved, the officer himself or of an innocent citizen.

In addition to weapon retention these exceptional techniques are discussed and taught during SPD ERU training in cases where a physical struggle is rising or has almost risen to a level of deadly force. For example, if an officer or officers are struggling with a perpetrator who is attempting to draw or place into action a weapon, or resisting at a level they are increasing the likely hood of taking an officers weapon, then an officer may use an exceptional technique. Such as a strike from a rifle to stop the action and reduce the level of threat. Exceptional techniques may also be used when a traditional strike, baton or other tactic like an LVNR would be effective but the officer is limited because of the long gun in his or her hands.

The officer must use care to minimize the dangers of the technique and understand the limitations of the technique used. If a fore end, or grip or butt strike is used the officer must remember the increased danger to other officers, himself and innocent citizens in the area if an errant round leaves the weapon, as the muzzle is pointed away from the suspect. The officer should try to ensure the safety in engaged and he is indexed on the weapon. If a barrel strike is used the officer must remember the increased danger to the suspect as the muzzle is touching the suspect and he would be struck by an errant round. Again the officer should try to ensure the weapon is on safe and they are indexed.

It cannot be overstated that a strike from a weapon, rifle or handgun is remarkable and should not be taken lightly or used indiscriminately. However, when an officer has a gun in their hands and is placed into a situation where they have to struggle with a suspect that incident is immediately elevated in its potential mortality to the public at large, the officer and the suspect.

This increased potential mortality is magnified to an even greater level if the officer / officers are struggling with a known violent criminal, with a history of being armed, who has used weapons against innocents in the past, who has attempted to injure or kill officers in the past, who has injured officers in the past, shown no concern for the lives or well-being of innocent citizens, is believed to be armed at the time of the encounter and is violently resisting officers lawful attempts to safely take him into custody. In such a case we should expect our officers to fall back on the training they have received and use the tools and techniques they have been taught to safely and lawfully effect arrest and protect the public as well as themselves.



On 5-11-15, at approx. 1530 hrs, I received information from a concerned citizen that Brandon Hutchinson (wanted for 1st Degree assault with a firearm and DOC Escape) was at the Déjà vu (8722 E Sprague) in Spokane Valley.

I know that Brandon was recently arrested for assaulting a law enforcement officer, 1st degree burglary, and other felony crimes. I have had several people in the last couple days tell me that Brandon has been carrying a firearm with him. I know that based on Brandon's history, it seems like he would do just about anything to get away from law enforcement.

I coordinated with Sgt Preuninger and other ERU units for an arrest plan. I set containment units up to the south of Déjà vu. I had Ofc. Heuett and Ofc S. Lesser in my vehicle. The plan was that we would get a visual on the front entrance to this business which was located on the east side.

Once we arrived in the area, I drove into the Hyundai parking lot to the north of the Déjà vu. I immediately saw Brandon at the passenger's side of IA Reg CQZ706, 1996 Acura. There was a white male about 28 years old, 5'9", and light build who was standing on the driver's side of the vehicle. Brandon looked in my direction and appeared to have seen me. I drove my vehicle (Tahoe) behind a row of vehicles in the parking lot. I used my binoculars to view Brandon. He was wearing a white t-shirt and blue jeans. When Brandon turned towards me, I saw that he had a bulge in the front of his waistband. At this point, due to his history, I was concerned he may have a firearm.

We radioed to assisting units that we were going to go in and contact him for an arrest. Brandon got into the passenger's side of the vehicle and the other male into the driver's side. We pulled into the lot and I activated my emergency lights. I was wearing tan 5.11 pants and a black vest that had the word "police" on it. I had a fabric badge on my left breast that was visible.

Brandon saw I was LE and he drove in between the seats onto the floorboard of the vehicle. He was digging hard under the seats and into the center console of the vehicle. At this point, I was sure he had a firearm and that he was going to assault officers with it. I immediately became scared for the officers on scene.

The driver of the vehicle got out of the car with his hands up. Brandon jumped into the driver's seat of the vehicle after he ignored several commands to surrender. Brandon drove over an 8" concrete parking barrier and then over another. He clipped the front end of a vehicle which I thought was going to be impossible for him to get past. The vehicle was parked on the south side of Déjà Vu at the corner. It appeared that there was about 8'-9' distance between this parked vehicle and the corner of the Déjà vu. At this point, it was very obvious that Brandon was not going to surrender without using all his options of escape or assault against LE.

Brandon drove WB on E 1st Street through the stop sign at Sargent and 1st. I have extensive knowledge of this area because I was worked for Spokane County SO for over 9 years. I know that AutoNation Honda has a couple lots. The main building of AutoNation is off Sprague. To get to the parking lot where all their vehicles are stored is across 1st street to the south. There is a constant flow of people crossing during business hours. When Brandon drove through this stop sign, I saw over 15 people lined on the streets on the north side. Brandon put each person at risk for their lives because he was driving a vehicle at excess of 30 mph and he had shown he wasn't going to stop. Brandon continued on E 1st past this business which then takes a turn NB onto Sipple and runs into E Sprague Ave. There is a stop sign at this intersection and Brandon drove through the stop sign and turned WB onto E Sprague with the flow of traffic. There was a light flow of traffic at this point. The light at the intersection of Vista and Sprague was red. There was a vehicle stopped for this light on the south side of Sprague. Brandon put this driver at risk as he drove through this intersection t approx. 45 mph. Brandon continued WB on Sprague Ave. Since I was in my Tahoe, I was looking for a patrol vehicle to take over the pursuit. I looked in my rearview mirror and saw that Ofc Brasch was closing in. I advised Ofc Brasch that he was to take over the pursuit and I would call it. Ofc Brasch took over the primary vehicle in the pursuit. Since I was driving the Tahoe, I was looking for other patrol vehicle's to take my position so I could take myself out of the pursuit. I stayed in the pursuit due to the highly violent tendencies of Brandon and the fact that I thought he had a firearm. He already showed me that he wasn't going to stop for anything unless he was forced to stop by LE. I feared that he would use all his means available to escape LE even by facing LE with a possible lethal force confrontation.

I remained behind Ofc Brasch and called the pursuit. We passed several vehicle's which were yielding to the south side lanes of E Sprague. The light at Park Rd was red. Brandon drove in the north bicycle lane and passed vehicles that were stopped for the red light. Brandon drove through the red light and turned NB on N Park Rd. Brandon had lost one of his tires and his vehicle was not as responsive. Park Rd is an especially wide road with wide shoulders and fields on both sides. There is an 8 block stretch of Park Rd between Sprague and Broadway. Brandon reached speeds of over 55 mph on N Park Rd and drove into the SB lane of travel. There was several vehicle's stopped for the NB red light at Park and Broadway to include a large box truck. As we got to the intersection, vehicles were yielding. We safely made it through this intersection and continued NB from Broadway on Park Rd. We crossed over the I-90 overpass passing several vehicles which were traveling both NB and SB. All vehicles were yielding to the pursuit.

As we came to the end of the overpass on a slight grade at E Sinto Ave, Brandon attempted to turn EB on E Sinto. Brandon drove into the yard of the house at the NE corner of Park and Sinto. He drove into the passenger's side of a pickup which was facing WB at the stop sign at Park and Sinto. Brandon continued EB onto Sinto. There was no traffic or pedestrian traffic on Sinto. Once we reached Ella, the roadway goes N without any other options. Brandon turned

NB onto Ella and drove into a parked vehicle WA Reg ACB6869. Ofc Brasch used a technique to pin Brandon's vehicle so it could not drive any further. I saw Brandon run out of the passenger's side of the vehicle through the yard of 1420 N Ella. Ofc Brasch, Ofc Stone, and I were quickly after Brandon as we were now in foot pursuit. As we came to the back of the house and into the back yard, there were several kids and adults there. I was now concerned he may try and do something with them. I ran in a diagonal direction to protect this family as Brandon continued running EB. Brandon ran into a wood fence and Ofc Brasch, Stone, and I met him there. Ofc Brasch was able to take Brandon to the ground. I saw Brandon's left hand dig underneath his body. I tried to pry it out without results and started punching him using a closed fist in his left side/back of his body until his left arm came out. I grabbed his left arm and put my handcuff on his left arm. I heard Ofc Brasch say, "He's out." I looked at Brandon's face and saw he appeared to have been rendered unconscious. I was able to grab his right arm with one of the other Ofc's assistance and handcuff it. When Brandon came too, he was breathing rapidly and we talked to him to try and calm him down. He kept saying that he couldn't breathe. We moved him to the yard where Ofc McMurtrey would provide him medical assistance until medics arrived.

Brandon was searched and a knife was removed from one of his pockets (see other Ofc's reports). I thought that since Brandon didn't have a firearm on his person, there may be one in the vehicle.

I saw that Brandon appeared to be under the influence of a controlled substance. He kept repeating things, his skin was clammy, and he had pin point pupils. He did not smell of alcohol. Ofc Stone wrote a search warrant for a sample of Brandon's blood for a DUI. Since Brandon did not have any AOB, and there were no drugs found on his person, I thought he may have an illegal substance in the vehicle.

I wrote a search warrant for drugs and weapons that was signed.

Sgt. Eckersley executed the search warrant without results.

Brandon was booked into Spokane County Jail for attempting to elude LE.

On 05-11-15, at 1551 hours, I responded to the Deja Vu, located at 8722 E. Sprague Ave, in the City of Spokane.

Officer Brownell had advised that Brandon Hutchinson might be at the location. Hutchinson had a felony warrants for Assault with a Firearm, First Degree Robbery, First Degree Burglary, Residential Burglary, First Degree Unlawful Possession of a Firearm, Possession of a Controlled Substance, Third Degree Assault and a Department of Corrections warrant.

Hutchinson had recently assaulted Spokane Police Officer Cole during his last arrest. Hutchinson had violently fought with Officer Cole and had taken his Taser during the assault. Hutchinson had tried to shoot Officer Cole with the Taser and had then delivered a drive stun to the side of Officer Cole's neck.

Hutchinson had been armed with a handgun during that encounter-See that incident for further information.

DOC had Hutchinson listed as a "high risk caution and violent offender". Hutchinson is also a Repeat Offender.

Officer Brownell and Officer S. Lesser were able to see into the parking lot of the establishment and positively identified Hutchinson-See their reports for further details.

A plan was made to drive in and try and apprehend Hutchinson as he was getting into the passenger side of a silver Acura, Iowa license plate CQZ706.

Officer Stone and I were both in my black Ford suv patrol vehicle, equipped with blue and red emergency lights and sirens. Officer Stone was in the passenger side of my police vehicle and we moved in with other officers to block in the exits of the parking lot and take Hutchinson into custody.

I exited my vehicle, with my patrol rifle and observed the vehicle backing up at a high rate of speed. I moved to the passenger side of Sgt. Preuninger's unmarked vehicle and thought that Hutchinson was going to drive into me. I began raising my patrol rifle as I was in fear for my life.

I knew from Hutchinson's previous encounters with police that he would do anything to avoid apprehension by law enforcement. Hutchinson did not continue towards Officer Stone and myself and instead drove to the left and sped out of the parking lot. I jumped into my patrol vehicle and began to follow Hutchinson's vehicle.

There had been people in the parking lot just prior to us trying to contact Hutchinson. Hutchinson sped through this area at a high rate of speed.

I turned northbound on Sargent and turned onto Sprague Ave, westbound. I observed that Hutchinson was traveling at a high rate of speed and saw him drive across all lanes of traffic towards the north side lane.

I was traveling about 65 mph on Sprague Ave. There was minimal traffic on Sprague at the time.

I was able to get behind Hutchinson and I activated my emergency lights and sirens. Officer Brownell was giving our directions, speeds, and road conditions over Spokane Police Radio.

Hutchinson ran the red light at Sprague and Vista without making any attempt to stop for the light or traffic.

Hutchinson turned northbound onto Park from Sprague Ave, and I observed that his rear driver side tire was flat. Hutchinson continued to elude us by traveling in the middle of the roadway.

Pieces of Hutchinson's tire were breaking off and hitting the front of my patrol vehicle.

It appeared that Hutchinson was trying to prevent me from performing a PIT (Patrol Intervention Technique). Hutchinson was swerving back and forth in the middle of both lanes.

My SUV patrol vehicle is not PIT certified and I was not planning to perform this maneuver. As we were traveling North on Park Road, approaching Valley Way, I observed Hutchinson was traveling at about 70 mphs.

Hutchinson was driving into the on coming traffic lane as well as his lane of travel. I observed a large brown UPS van traveling south on Park Rd. Hutchinson swerved back into his lane as the UPS van drove past.

Hutchinson drove onto the east side of the road (Park) as he went through the intersection at Valleyway. Hutchinson passed a long line of stopped vehicles, about five or six, on the right side. He passed the vehicles on the east shoulder of the road and proceeded through the red light.

There was a green light for northbound traffic at the time that Hutchinson went through the intersection.

It was about this time that the rear tire came off of the vehicle. Hutchinson continued to travel northbound on Park. There had been a limited amount of traffic in the area, while we were on Sprague, but there were more cars on the roadway once we turned onto Park Road.

I was concerned that Hutchinson was going to hurt someone with his reckless driving. He was driving with complete disregard for the safety of other drivers or pedestrians.

Because Hutchinson is such a violent and dangerous criminal, I felt that Hutchinson posed a substantial threat to the public by being at large, trying to avoid capture.

Hutchinson appeared to lose control of the vehicle as we approached Sinto, at Park Road. Hutchinson's vehicle crashed into the stop sign at that intersection.

There was a vehicle parked at the stop sign and Hutchinson just narrowly missed colliding with this vehicle. I could not see how many people were in this vehicle, besides the driver.

I thought that Hutchinson was going to exit the driver side door and attempt to flee on foot. I was worried that Hutchinson was armed and did not want him running into the neighborhood or breaking into someone's home.

I drove my patrol vehicle up to Hutchinson's vehicle and tried to pin his driver side door shut with my front bumper. Hutchinson drove his vehicle into the yard at Sinto and Park (north east corner) and then back out onto Sinto.

Hutchinson was traveling eastbound on Sinto. This is a residential neighborhood and it was in the afternoon, on a week day. I was concerned that there would be children playing in the roadway.

Hutchinson drove east on Sinto to Ella and then turned northbound on Ella. Hutchinson was traveling too fast to make the turn and collided with a parked car at Ella and Maxwell. The vehicle was a Pontiac with Washington license plate ACB6869.

It appeared that Hutchinson was opening the driver side door, in an attempt to

flee from the vehicle. I again pinned Hutchinson's driver side door with the front bumper of my patrol vehicle.

Hutchinson crawled over to the passenger side of the front compartment, and exited the passenger side of the vehicle.

Hutchinson fled into the front yard and began to run to the east. Hutchinson ran into the side yard, at 1420 N. Ella.

I began to chase Hutchinson on foot through the yard. I noticed several children in the back yard of 1420 N. Ella. I yelled to Officer Stone that there were children in the yard and to be aware of their presence.

I was concerned that Hutchinson might attempt to grab one of the children as a hostage to prevent us from taking him into custody. He appeared to be quite desperate and irrational at this time.

Hutchinson ran towards the rear fence in the yard and threw his right arm up towards the top of the fence.

1) Crime: Hutchinson had warrants for Felony Assault 1st Degree with a Firearm, First Degree Robbery, First Degree Burglary, Residential Burglary, First Degree Unlawful Possession of a Firearm, Possession of a Controlled Substance, and Third Degree Assault, and a Department of Corrections Warrant. He was also wanted for Felony Eluding. Hutchinson had violated his release for assaulting a Spokane Police Officer with a Taser.

2) Hutchinson has been armed with firearms on several occasions and has violently assaulted officers and citizens in the past. His most recent conviction was for Assault 3rd Degree.

3) Hutchinson had fled in a vehicle from officers and had driven recklessly through City Streets and neighborhoods attempting to avoid capture. Hutchinson

ran on foot, through yards, after crashing his vehicle into a parked car.

As I was closing distance with Hutchinson, I observed him start to turn his body slightly towards me.

I was a short distance behind Hutchinson and ran into him with my left forearm hitting him in the right side of his body. The force of our bodies colliding sent us into the wooden fence that Hutchinson had been attempting to climb.

Hutchinson violently shoved back against me and I placed him into a vascular neck restraint. Hutchinson was tensing his muscles and pushing against my body. We both fell to the ground and I observed Hutchinson reach towards his waist band with his right hand. Hutchinson was not giving up or following my commands to place his hands behind his back.

I know from my training and experience that the front waist band is a common area where people conceal firearms and other weapons. I was concerned that Hutchinson was attempting to access a weapon.

Hutchinson was thrashing he legs back and forth and trying to twist his body away from me. Hutchison refused to stop resisting arrest and would not comply with commands.

Officer Stone and Officer Brownell arrived and assisted in taking him into custody. I rendered Hutchinson unconscious with the neck restraint and only then were we able to place him into handcuffs (double locked).-See their reports for details.

Medics responded to examine Hutchinson because he had been rendered unconscious by the neck restraint. Hutchinson started to complain that he couldn't move and that something was wrong with him. Hutchinson could not tell us where he was hurt and just continued to state that he could not breathe.

Hutchinson was speaking incoherently and I noticed that his pupils were very small. His face was also ash colored. I began to think that Hutchinson was under the influence of some type of drug.

Hutchinson was transported to Deaconess Medical Center. Officer Stone rode in the ambulance with Hutchinson and completed a Blood Search Warrant.

I called for an evidence tow for the silver Acura that Hutchinson had been driving. I completed a tow impound form.

Officer Stone and I transported Hutchinson to SCSO Jail after he had been cleared by medical staff. Officer Stone and I transported the blood vials to Spokane Police Property and logged them into the facility.

I assisted Officer Brownell execute the search warrant on the vehicle that Hutchinson had been driving.

On 5/11/2015 at approximately 1551 hrs, I got into OFC Brasch's patrol vehicle with him that was equipped with emergency lights and sirens. I was wearing my police patrol uniform. Intel came in that Brandon Hutchinson (wanted for violent felony warrants - Attempted Assault 1st, Robbery 1st, Burglary 1st, Residential Burglary, Unlawful Possession of a Firearm 1st, Possession of a Controlled Substance, Assault 3rd, and a Dept. of Correction Escape warrant) was at Deja Vu (8722 E Sprague Ave.) OFC Brasch and I arrived on scene and was staged off to the west in the Toyota Car Lot. I could see the south wall of Deja Vu and a little bit of the west side of the building. There were two vehicles parked towards the SE corner of the building.

I heard over the radio that other Officers saw Hutchinson standing on the East Side of the building wearing a white shirt and jeans. He was standing near a vehicle - Iowa plate#CQZ706. There was another male with Hutchinson. The Officers stated that Hutchinson was looking over at them numerous times as if Hutchinson knew it was the police. I heard over the radio that the vehicle take down was going to happen soon due to that information.

OFC Brasch was driving and I was in the passenger seat of his patrol car. We pulled into the parking lot of Deja Vu from the south with our emergency lights activated. Sgt. Preuninger had pulled into position in

front of us. I exited the patrol vehicle and began to move towards the passenger side of Sgt Preuninger's vehicle. As I approached it, I saw Hutchinson recklessly back up the Iowa license plate vehicle extremely fast and face SB directly at me. It was obvious to me that Hutchinson was attempting to flee and avoid capture since there were several police vehicles with emergency lights activated around Hutchinson's vehicle. Hutchinson was the sole occupant of the vehicle at this time. Hutchinson squealed the tires as he accelerated rapidly. I first thought that he was going to try and run me over since it appeared he had no other place to go, but directly towards me. I was between Sgt. Preuninger's vehicle and a fence to my east. Hutchinson drove towards me and then suddenly turned towards the SW in the parking lot. Hutchinson nearly missed striking Sgt. Preuninger's vehicle.

Hutchinson really wanted to evade LE because he drove over several parking barriers and drove off the roadway to escape WB on 1st Ave. I could hear the vehicle striking those barriers and scraping on the uneven terrain that he drove through. Dust and debris were in the air. Hutchinson was driving so fast without any regard for the safety of others. By the time I got back into the passenger side of OFC Brasch's patrol vehicle and we turned WB onto 1st Ave. Hutchinson was about a block away speeding through Toyota and Auto Nation car lots. OFC Brasch had activated his sirens at this point to go along with his already on emergency lights.

There were citizens walking all over the area through the car lots that Hutchinson was speeding through. I observed five citizens who were on the side of 1st Ave that Hutchinson blew past at a high rate of speed. OFC Brasch and I turned NB onto Sargent St and then WB onto Sprague Ave. I looked WB down Sprague and saw Hutchinson swerving across all lanes of traffic to the far north lane of Sprague without signaling. I estimated his speeds at approximately 80 MPH since he was pulling away from us and we were traveling at approximately 65 MPH. There was no traffic on Sprague Ave at that time. It appeared that Hutchinson got onto Sprague Ave through a car lot road. I could see that the driver side rear tire was flat. There was another police vehicle (driven by OFC Brownell) in front of us that had their emergency lights and sirens on. Hutchinson refused to cooperate and pull over. OFC Brasch and I passed OFC Brownell so he could call out the pursuit.

Hutchinson ran the steady red light at Vista Rd. Hutchinson suddenly turned NB onto Park St through a red light causing traffic to slam on their brakes. Three vehicles had to slam on their brakes in order to not be hit by Hutchinson. OFC Brasch and I cleared that intersection and

continued NB on Park St. There was no vehicle or foot traffic at that time going NB or SB on Park St. Hutchinson was swerving across all lanes of travel and ended up going NB in the SB lane. Hutchinson was speeding at approximately 75 MPH in the wrong lane because he was pulling away from OFC Brasch and I who were traveling at approximately 65 MPH. I looked further up North and observed approximately four vehicles traveling SB. Hutchinson continued to speed directly towards on-coming traffic. At the last minute, I saw Hutchinson swerve back over to the NB lane and avoid hitting the on-coming SB traffic. Hutchinson was recklessly putting the public in danger. He had no regard for anyone's safety. It was obvious to me that Hutchinson was an extremely dangerous threat to the public due to his warrants and reckless driving behavior. The flat tire had now completely come off the vehicle and he was driving on the rim only.

Hutchinson continued to speed NB and was approaching a red light where he passed approximately six vehicles who were stopped for the red light facing NB. He passed these vehicles by driving on the east shoulder of the road. Hutchinson nearly struck all the vehicles due to his erratic speeds and missing a back tire. Hutchinson did not strike those vehicles and ran through the red light. He continued NB on Park St. Hutchinson's vehicle was throwing sparks due to the rim it was riding on.

Hutchinson attempted to turn EB onto Sinto Ave, but lost control. He nearly struck an occupied vehicle that was stopped at the stop sign of Park/Sinto. Hutchinson struck the stop sign and knocked it completely over. OFC Brasch put the front of his patrol car next to Hutchinson's driver door so that he could not escape on foot and in danger the citizens that were out in the area. Hutchinson again stomped on the accelerator and speed through the yard on the NE corner of Sinto/Park and got back onto Sinto EB. I could see that a small child was playing in the street further East as Hutchinson was approaching. Hutchinson had no regard for anyone and sped right towards the child. An adult quickly grabbed the child out of the street as Hutchinson continued EB.

OFC Brasch and I got back onto Sinto Ave EB. There was a fairly sharp turn approaching Hutchinson. Hutchinson began the turn onto Ella NB and lost control. Hutchinson struck a parked vehicle on the east side of Ella St. Hutchinson struck the vehicle so hard that it caused it to spin out in to the middle of the roadway. I saw several people in the yard to the north of 1420 N Ella. OFC Brasch put the right front of his patrol car on the driver door of Hutchinson's vehicle so he could not escape. I opened up the passenger door of the patrol vehicle and was within five feet of Hutchinson. I could see him turning towards me and OFC Brasch inside the

driver's seat while he was reaching for something with right hand. It was obvious and very scary that Hutchinson was not going to give up at all. I thought that Hutchinson was reaching for a weapon to fight since there was no other reason for him to turn towards OFC Brasch and I. Hutchinson had to completely turn around in the driver's seat to face back. I was telling Hutchinson to show me his hands and that it was the police. Hutchinson quickly turned towards the passenger seat and dove out the open passenger window.

Hutchinson began to run EB through the yards of 1420 and 1426 N Ella St. There multiple children and two female adults in the backyard of 1420 N Ella St. I became extremely fearful that Hutchinson would use the children or females in some form to escape custody. I took off after Hutchinson in a foot pursuit with my department rifle in my hands since it was on my person since the beginning of this incident. I began yelling to the children and female to get back and waved my arm at them to run south away from Hutchinson. I was yelling at Hutchinson to stop and that he was under arrest, but he refused to cooperate. I attempted to put myself in between Hutchinson and the children/females in order to protect them as best I could. Hutchinson reached the back fence of 1426 N Ella St. and looked back to see where I was at. OFC Brasch grabbed Hutchinson prior to him attempting to jump over the fence and Hutchinson began to fight violently. He balled up his fists and began to swing them towards OFC Brasch.

OFC Brasch and Hutchinson fell to the ground. Hutchinson was tensing up and refusing to cooperate with commands to stop resisting. OFC Brasch was on the right side Hutchinson's body as Hutchinson was laying on his stomach. Hutchinson rapidly began to reach for something underneath his body with his hands. I became extremely concerned for our safety, his safety, and the kids and females safety again when he refused to cooperate and began to dig his hands underneath him. I did not know what he was reaching for. At this point, I knew that we needed to get Hutchinson in custody for everyone's including his safety. This situation was extremely dangerous and moving extremely fast. My hands were occupied at the time with my department rifle which was still on safe. Hutchinson was kicking and tensed up his entire upper body.

1. Crime: Hutchinson had warrants for Felony Assault 1st degree with a firearm, First Degree Robbery, First degree burglary, Residential Burglary, First degree Unlawful Possession of a firearm, Possession of a Controlled substance, Third degree Assault, and a Department of Corrections Warrant. Probable cause now existed for Felony Eluding,

Obstructing, and resisting arrest. Hutchinson had violated his release for Assaulting a Spokane Police Officer with a taser.

2. Threat: Hutchinson had been armed with Firearms on several occasions and has violently assaulted Officers and Citizens in the past. His most recent conviction was for Assault 3rd on a Police Officer. Hutchinson outweighed me by approximately 40 lbs. He had not been frisked for weapons yet. He was known to carry a firearm. OFC Brasch and I were the only Officers that I knew were there at the time. There were several children and two females that Hutchinson was running towards.

3. Resistance: Hutchinson fled in a vehicle from Officers and had driven recklessly through City Street and neighborhoods attempting to avoid capture. Hutchinson had no regard for the safety of the public or Officers in his attempt to avoid capture. Hutchinson exited his vehicle after he crashed it into a parked car and began to flee on foot away from Officers through a backyard occupied by children and two females. Hutchinson was attempting to climb a fence and escape. Hutchinson began to fight (balled up his fists and swung at OFC Brasch) in an attempt to escape. It was obvious that Hutchinson would do anything to avoid being captured by LE.

It was at this point, that I delivered four strikes to Hutchinson's left lower back area with the fore-end portion of my rifle since it was what I had in my hands at the time of this rapidly evolving situation. I was using my rifle as an impact tool consistent with baton strikes in order to get him to cooperate and remove his hands while telling him to stop resisting and get his hands out. As soon as Hutchinson stopped tensing up, the strikes were stopped and I was able to remove his right hand from underneath his body. Hutchinson was detained in handcuffs (DL). Hutchinson was not bleeding. He did not state he was injured other than he could not breath well.

Dispatch was advised and medics were requested because Hutchinson stated that he could not breathe very well; however, Hutchinson was talking the entire time. I was unable to make out what he was saying at the time because his speech was slurred. I could see that his pupils were pin-point. It was obvious to me that Hutchinson was impaired on some drug.

I contacted the home owner (Darla Bedow) of 1426 N Ella St. Bedow told me the following: She stated she heard the crash to the west on Sinto Ave and heard the cars and sirens coming her direction, so she and some children stepped outside to see what was going on. She saw Hutchinson

come flying around the turn and crash into a vehicle that was parked in front of her neighbor's house due to going way too fast. The crash was so violent that it moved and spun the parked car several car lengths. She saw the police vehicle with its lights and sirens on come up and block the driver side door. She saw the male (Hutchinson) quickly climb out of the passenger side window and begin to run EB.

Bedow stated that she told Hutchinson to stop running and just give up, but he continued to run anyway. She heard LE telling him that they were the police and that he was under arrest. She heard LE telling the children and females to get back. Bedow stated that Hutchinson ran over her mailbox. Bedow did not have anything further.

Due to Hutchinson's slurred speech, pin point pupils, erratic driving, and previous drug history, probable cause existed to charge Hutchinson with DUI (alcohol and/or drugs). Hutchinson was in the back of AMR and I rode with them to Deaconess ER. It was inside the back of the Ambulance that I read Hutchinson his constitutional rights which he verbally stated he understood (1734 hrs.). Hutchinson made several unsolicited statements throughout the contact of AMR, Deaconess ER, and enroute to Spokane County Jail. Hutchinson stated that he knew did meth before he went to sleep last night (5/10/15). Hutchinson stated that he ran because he believed that the US Marshalls were out to kill him and that he was scared. He stated he got that information from his bail bondsmen. I asked Hutchinson if he knew there were children in the roadway and backyard during this incident. Hutchinson stated that he knew there were children in the backyard but did not see the child in the roadway.

I wrote a search warrant for two vials of Hutchinson's blood. The search warrant was reviewed by Sgt Eckersley. The search warrant was signed by Judge Maurer at 2000 hrs. I showed Hutchinson the signed Search warrant for two vials of his blood.

The search warrant was executed at 2020 hrs. The two vials had gray tops and were not punctured. The vials expired on 8/31/2016. There was a powder present in the two vials. Iodine was used to clean the area prior to the blood draw. After the blood was extracted by the trained technician to draw blood (Debi Minton) the two vials were inverted eight times to mix the blood and powder. Minton then initialed the blood vials. I gave a copy of the search warrant to Minton.

Hutchinson was cleared from the hospital and OFC Brasch and I transported

him to Spokane County Jail to be booked on his warrants. The other charges were going to be added on him at a later date.

I placed Hutchinson's blood samples onto property as evidence. I placed the original copy of the warrant down in records so it could be returned to the courts per our protocol.

The entire incident was a dangerous and rapidly evolving situation dealing with a very violent suspect - Hutchinson. From the start of the vehicle take down turn pursuit, to getting Hutchinson in custody was approximately three minutes.

On 5/21/2015 at approximately 1930 hrs, SGT Eckersley contacted me via phone. SGT Eckersley wanted me to write an additional clarifying the use of my rifle during the altercation with Hutchinson. SGT Eckersley did not know about the technique and wanted further details.

My department issued M4 was attached to my body during this whole incident via a sling. During my contact with Hutchinson, my rifle was still attached to me by the sling and I had both hands on the rifle for control. I was indexed on the weapon and I knew my rifle was on safe. I did not release my rifle for fear that Hutchinson would gain control of it and possibly use it against myself or OFC Brasch. Hutchinson had previously gained control of an Officer's weapon during his last arrest. He took the weapon off of an Officer's belt and used it against the Officer. If I had released my rifle in an attempt to use another type of force, Hutchinson could not only gain control of my rifle, but would have control of me since it was attached to me via a sling.

See my previous report for further details in regards to this incident. To remind everyone of my Graham statement I have pasted it again:

1. Crime: Hutchinson had warrants for Felony Assault 1st degree with a firearm, First Degree Robbery, First degree burglary, Residential Burglary, First degree Unlawful Possession of a firearm, Possession of a Controlled substance, Third degree Assault, and a Department of Corrections Warrant. Probable cause now existed for Felony Eluding, Obstructing, and resisting arrest. Hutchinson had violated his release for Assaulting a Spokane Police Officer with a taser.

2. Threat: Hutchinson had been armed with Firearms on several occasions and has violently assaulted Officers and Citizens in the past. His most recent conviction was for Assault 3rd on a Police Officer. Hutchinson outweighed me by approximately 40 lbs. He had not been frisked for weapons yet. He was known to carry a firearm. OFC Brasch and I were the only Officers that I knew were there at the time. There were several children and two females that Hutchinson was running towards.

3. Resistance: Hutchinson fled in a vehicle from Officers and had driven recklessly through City Street and neighborhoods attempting to

avoid capture. Hutchinson had no regard for the safety of the public or Officers in his attempt to avoid capture. Hutchinson exited his vehicle after he crashed it into a parked car and began to flee on foot away from Officers through a backyard occupied by children and two females. Hutchinson was attempting to climb a fence and escape. Hutchinson began to fight (balled up his fists and swung at OFC Brasch) in an attempt to escape. It was obvious that Hutchinson would do anything to avoid being captured by LE.

I was on my knees in an unstable position in the bushes. My rifle was in the low ready position. I used the fore end of my rifle (the barrel and flashlight attached underneath it) as an impact weapon - like a baton. That was the only position I could get my rifle in due to being on my knees and already having it in the low ready position. I delivered four power jabs to Hutchinson's lower left back area in an attempt to gain compliance and end this dangerous situation quickly and as safely as possible.

I have trained in this modified technique in my two years on the department's Emergency Response Unit as well as my ten years in the United States Army. I have had thousands of hours operating an M4/AR-15 platform. The technique was used because I did not have time to access any other tools. I was in fear that Hutchinson was reaching for a weapon.

On 05/11/2015 at approximately 1550 hours I responded to the Deja Vu located at 8722 E. Sprague in Spokane, WA reference attempting to arrest wanted subject Brandon Hutchinson (03/14/85).

Hutchinson is currently listed as a ROP (Repeat Offender Program). His active warrants were for 1st Degree Assault w/ a Firearm and a Felony DOC Warrant for Burglary 1st Degree. Dispatch advised the warrants to be confirmed. He is listed as a possible Skinhead Gang Member and shows to have mental history and be a violent offender. A search showed him to possibly be armed. He also shows to be assaultive to law enforcement, resistive to law enforcement and is suspected of gang activities. It lists his risk level as high violent. He has a criminal history of Assault 3rd, Robbery 1st, Drugs, Burglary 1st (armed), Stolen Cars, Assault and Commercial Robbery.

We requested a K9 to be paged out to assist us due to the risks associated with trying to arrest Hutchinson. We also advised medics to start and stage.

On 04/17/2015 Hutchinson was arrested after a pursuit with the P.A.C.T. team (Patrol Anti-Crime Team). During that incident Hutchinson was the passenger and fled from the car and dumped a handgun (Later charged with Felon in Possession as well as several other charges). He later broke into a residence and tried to steal the keys to the residents car as he attempted to continue to flee. He fought violently with officers and stole an officers taser and actually tased the officer with the taser in the neck. He has proven a propensity for violence and shows time and time again that he will run away and fight with officers. See Incident #15-125228.

I was wearing a black vest carrier that is clearly marked on the front and back with markings reading "Police." There is a Spokane Police Badge on the front.

I parked my patrol vehicle at Sprague/Thierman and was picked up by Ofc. Brownell who was also with Ofc. Heuett.

I was equipped with a drop-down pouch that clips on to my belt that contains extra medical supplies (scissors, combat gauze, chest seals, tourniquet) etc. The drop-down platform contains 2 handgun and 2 rifle magazines. I was sitting in the back seat of the vehicle and was equipped with my ERU Colt Commando.

Ofc. Brownell parked to the north in the Larry Miller car lot. We could see two males standing around a vehicle on the east side of the Deja Vu Building by the east exit. Ofc. Brownell was able to use binoculars and identify the male standing on the passenger side as Hutchinson. I could see Hutchinson had baggy and loose-fit type clothing.

I saw Hutchinson looking at us several times suspiciously as he stood by the vehicle. It appeared the he spotted our vehicle as possibly being a police car because it was obvious the vehicle quickly caught his attention. He kept taking quick glances over his shoulder and looking at Ofc. Brownell's patrol car.

I did not see anyone besides Hutchinson and the male he was hanging out with on the east side of the Deja Vu building. The side of the building appeared to be made of brick or concrete.

We made the decision that Hutchinson had possibly identified Ofc. Brownell's vehicle and decided we needed to move before Hutchinson could attempt to run and flee in the vehicle, creating more of a risk to the public. We knew we were getting close to rush hour traffic and made the decision to try and prevent the vehicle from going mobile and attempting to flee. We were concerned because Hutchinson has shown he is willing to run in a vehicle and put other's lives at risk. He has also shown he is likely to carry weapons.

We communicated with other officers and moved up on the vehicle. We exited the vehicle and yelled, "Police" and yelled at Hutchinson that he was under arrest. He was told several times to show his hands to comply with police commands.

The driver (not Hutchinson) had entered the vehicle and I could see the brake lights as if the vehicle was going to leave. Hutchinson saw and heard our commands and dove into the vehicle frantically. I could see him diving into the center console area and towards the floorboard. He also appeared to be rummaging towards the backseat of the vehicle. He sunk down in the vehicle and I lost visual of most of his person. I feared for my life as it appeared he was attempting to retrieve a gun or some type of weapon. We had obtained reliable information that he was supposed to currently be armed and my safety concerns continued to increase as he desperately dug through the center area of the

vehicle.

Hutchinson dug around the center of the vehicle for several seconds despite the fact the vehicle was already started and running. I knew that he wasn't looking for keys to the vehicle to flee since the vehicle was already started and running. This increased my concern that he was attempting to retrieve a weapon.

Hutchinson then dove into the driver's seat and started fleeing in the vehicle. He drove W/B over the curbing that is approximately 8" tall. He then made a quick left and stayed close to the building and rammed a parked vehicle to get out of the parking lot to go W/B. He then peeled out of the parking lot at a high rate of speed.

I hopped into to Sgt. Preuninger's vehicle and we attempted to catch up to the pursuit. We were advised by Ofc. Brownell that the vehicle had crashed and lost control at Sinto/Ella. As we turned on to park there were approximately 10 people out in the street. They were pointing us towards Sinto/Ella. There was a large amount of foot traffic and people/children on bicycles in the area. There were also several groups of people in front yards in the area. Several people pointed towards the scene of the crash.

I was able to locate the crash and officers had taken Hutchinson into custody.

I spoke to Witness Jason Gohl who told me the following:

He heard a boom noise and then a motor revving up from a vehicle going really fast. He saw the Acura, "Flying down the street." He could tell the Acura wouldn't make the corner. He told me, "I had to get several kids off the street or he would have hit them with the car." He specifically had to grab his own child out of the street to prevent his child from being struck by the vehicle. His son was out in the street as they were getting ready to go to a baseball game when he had to go to the street to grab his son to protect him.

I later responded back to the Deja Vu to check for the vehicle Hutchinson had struck when fleeing the parking lot but the vehicle had since left. We contacted security who advised there is no exterior security at the Deja Vu and stated they were attempting to get the video from inside but they had to contact corporate in Seattle. He advised he would call back when they can get the video.

On 051115, I assisted other Officer's reference a warrant at 8722 E. Sprague (Deja Vu). Sgt. Preuninger called and advised that he needed assistance with an ERU response to an violent felon who was currently wanted. He identified the suspect as Brandon Hutchinson.

I immediately recognized Brandon Hutchinson as a ROP and violent offender based on past contacts with other Officers and a recent call with Officer Cole that he was assaulted with a Taser and was armed with a handgun.

I met up with Officer Brownell at the Home Depot on east Sprague. We responded to 8722 E. Sprague to get containment on the north side of the business. Officer Brownell confirmed that Brandon was wanted for a status one DOC warrant and a 1st degree assault with a firearm warrant. He also had information that Brandon was currently armed with a handgun and knew that he was wanted.

As we got to the north side across the street from 8722 E. Sprague, I immediately observed two males standing next to the a small compact vehicle. One of the males appeared to look like Brandon and he looked over at us. He said something to the other male and again looked back over toward us. I believed that Brandon observed our location and was going to quickly leave the area. Officer Brownell looked through Binoculars and immediately identified one of the males as Brandon.

Brandon then got into the front passenger side seat and we advised that other units that we were going to come in from the north and contact Brandon at the vehicle.

At this time we had knowledge that Brandon is wanted for a violent felony warrant with a handgun and a local DOC warrant. He is considered armed and dangerous and has a history of violence and third assault against Police Officers. He is also a ROP and a danger to public safety and poses a threat to the public and others and try's to escape Police Custody by running, hiding and resisting arrest. On his last arrest, he was armed with a loaded handgun, fought with the arresting Officer's and during the struggle was able to disarm one of the Officer's Taser from his gun belt. He made a statement that he was going to shoot the Officer and did deploy the Taser probes at the Officer. He then delivered a touch stun with the Taser. We have been told to use extreme caution when contacting Brandon.

As we pulled up into the parking lot of 8722 E. Sprague, I observed that the vehicle was running and parked in a parking spot on the east side of the business. Brandon was in the passenger seat and it was occupied by a male driver. Brandon was not wearing his seat belt and was wearing a white shirt, blue jeans and running shoes. I exited my vehicle and immediately identified myself as Spokane Police and told Brandon that he was under arrest and to show us his hands. I was wearing a full Police Uniform and Brandon looked directly at me. He very quickly placed both hands under the front passenger seat as he looked back at me several times. I immediately thought that Brandon was accessing a firearm and again told Brandon to show me his hands and pointed my M-4 rifle at him. I quickly brought it back down to a low ready position and moved to another piece of cover at the back of my vehicle after Brandon took his eyes off of me. I did not want to be at the same location when Brandon accessed a firearm, so that he could quickly identify me again as a target. I continued to give Brandon verbal commands to show me his hands. He then quickly moved across the seat to the middle console and started pushing the driver out the drivers side door. He was refusing to show us his hands and kept looking back at our location. The driver exited the vehicle and Brandon jumped into the drivers seat. He put the vehicle in reverse and quickly drove backwards with disregard to our location and then drove forward over several parking cement barricades, onto the sidewalk and between a parked vehicle and the southeast corner of the building. He left the location at a high rate of speed and made no attempt to surrender or stop his vehicle.

I got into Sgt. Preuninger's vehicle and drove the exact route that the pursuit was going. I observed a stop sign down on the northeast corner of Park and Sinto and several people were standing out in their yards and in the street. They were all pointing to the east on Sinto and Officer Brasch advised that they were taking one into custody.

I contacted witness Kelly Turner, who lives down the street on Sinto. He advised that he was standing in his yard and observed Brandon drive by his address at a high rate of speed and stated, "at least 100 fuck he had to have been doing 100." He identified Brandon as the suspect who was driving, by the male that Officer's had detained in the backyard of 1420 N. Ella.

I assisted Officer Brasch, McMurtrey and Brownell with restraining Brandon, while medical attention arrived on scene.

I rode with Brandon to the Hospital with Officer Stone. See his report for further.

Officer Stone read Brandon his warning of constitutional rights which he understood and waived. At the Hospital, Brandon admitted to running from us in the vehicle and told me that he thought we were the Marshall's and that he was being shot at. He thought that we were going to shot him based on what happened to Officer Cole and was scared when we pulled up in the parking lot. He said that he panicked and just wanted to get away.

On 5-11-15 at approximately 1600 hours I was contacted by SPD ERU / PAC team member Scott Lesser, he advised Officer Brownell had a source who was providing information on the current location of Brandon Hutchinson. Lesser requested ERU support in taking him into custody. Hutchinson was wanted for first degree assault and other crimes relating to an incident a few weeks prior. During this previous incident Hutchinson threatened to shoot an officer, fought with police, took an officer's Taser and used it on an officer, forced his way into a citizen's home and attempted to elude police.

(Note, it is believed he had possessed and then dropped a handgun during that incident, that investigation is still ongoing. I was involved in the original call, and arrest of Hutchinson's partner in that incident.)

Hutchinson has a violent and extensive local criminal history with over 70 local entries including multiple arrests for first degree robbery, first degree burglary (armed), assaults, burglary, other thefts, property crimes, drug and alcohol charges, vehicle thefts, eluding police and more.

A CI of Brownell advised Hutchinson was in the Déjà vu and had contacted him / her asking for a ride. Brownell said the CI was reliable and was willing to stall Hutchinson and / or comply with police requests to help get him into custody. There were approximately 8 ERU members working or just coming on shift, I had radio help me in notifying them to respond to the area of the Déjà vu and I notified Lt. Wohl, (the ERU commander) that ERU was going to assist Officer Brownell and we would not need to call in any additional assets.

While en-route to the area Lesser, Brownell and I discussed options for the safest way to take Hutchinson into custody, we were all in agreement that the likely hood of him fighting police (with his hands or with a gun or trying to flee was great). We also agreed that every moment he was at large he posed a serious threat to the community and it was imperative that we took him into custody as soon as possible. The options we discussed were an arrest in the Déjà vu, or in the Déjà vu parking lot. Having the CI pick him up and go to a location at our direction, having him walk out on foot and go where we directed, (through the CI) waiting for him to leave on his own accord and follow him, and others options as well.

These options were all susceptible to numerous variables which include but are not limited to; the foot traffic, volume of customers, and vehicle traffic in the area. Compliance on the part of Hutchinson (who according to police sources knew he was wanted, was very paranoid, and saying he would not go back to jail.) And the ability of the CI to effectively act in a ruse, along with the timing and arrival of police resources.

As I arrived in the area Brownell set up a temporary "eye" across the street while myself and other ERU members closed in on the area to prevent any escape and / or assist in surveilling the subject.

Within two or three minutes of our arrival to the area, while we were still discussing options for the arrest, before we could re-contact the CI or get a more covert eye set, Hutchinson came out of the Déjà vu.

I was to the south and could see Hutchinson as he walked to a small metallic colored car occupied by a lone male driver parked against the building near the center of the lot. He stood at the passenger side of the car, looking around and talking with the driver. This went on for close to half a minute when he began to look more frequently to the north where officers Brownell, Lesser and Heuett were parked. It appeared to me he made them as law enforcement. At least three other ERU officers were on scene which gave me seven police officers (6 ERU members and 1 PACT member) to initiate the arrest and I had at least two other ERU members responding from the city along with Sgt. Eckersley whom I had just spoken with.

Hutchinson's hands were clear and empty, he was standing at the passenger side of the sedan and the car had a male already in the driver's seat. There were about two or three other cars in the lot, no other pedestrian traffic was visible in any direction and traffic on Sprague was very sparse. As they spoke it appeared Hutchinson and the driver knew each other and Hutchinson was trying to get a ride.

Given all the variables we were dealing with, (suspect to officer ratio, lack of innocents immediately in the area, his separation from the driver's seat, his hands out and clear, and the knowledge that every minute he spends in the community he poses a great threat not just to the public but any police officer who crosses his path) I decided we should make the arrest.

As we pulled into the lot (see rpts and additional) he immediately jumped into the passenger side of the car which began to slowly roll backwards. Note, I had not directed officers to block in the car as the defendant was outside the vehicle making flight on foot just as likely if not more than flight in the car, and he has a history of being armed. It would have been an unnecessary risk to have officer close space to that distance.

My vehicle was to the south and rear, Brownell was to the north and rear and other officers parked just outside the lot and came in on foot. Prior to my exiting my car, I had activated the police lights in my vehicle, a green Chevy Tahoe. The driver immediately recognized us as LE and put his hands out the window, (which is most likely why the car rolled backwards). As I exited my car and identified myself (I was wearing my ERU Uniform) the passenger said he wanted to comply and something to the effect of he wanted to surrender. Hutchinson was in the passenger seat frantically searching for something in the car, he was quickly moving from the area of the center console to the floor in front of his seat. He was also periodically lifting his head to watch LE, he had a deranged almost panicked look on his face and was completely ignoring LE commands.

I considered getting back into my car to block the target car but if the driver were to suddenly exit the car this would put him at a greater risk of harm.

I was in fear throughout this time that Hutchinson was going to come up with a gun and begin to shoot at LE. Due to his proximity to the driver and the angle they were at to me I would not have been able to stop Hutchinson with gunfire. I then began to move away from cover to get a better angle and reduce the risk to the driver.

Hutchinson continued to frantically search the car and when his efforts were unsuccessful he shoved the driver out of the vehicle who now stood between me and Hutchinson with his hands in the air creating the same problems for officers he had while he was in the driver's seat.

Hutchinson then abruptly backed up the car and the driver ran away. Hutchinson then accelerated forward driving over concrete parking curbs, the sidewalk and narrowly passed the sedan between a parked car and the building. Officers still in vehicles initiated a pursuit while other officers scrambled to cars to assist.

While there are inherent dangers in any police chase especially involving vehicles the failure to apprehend this suspect posed a greater and more immediate threat to the community than those posed by the pursuit. To continue the pursuit in that part of the county, considering the light traffic, the experience of the officers involved and the damage Hutchinson did to his car at the outset of the chase I chose to continue the pursuit.

See officer additional, reports and CAD for the specifics of the eluding.

The chase ended when the defendant struck a parked car, was blocked in by pursuing officers, fled out a driver's window, was chased on foot, caught by officers, fought with officers and was taken into custody. At the time he was captured I was still a block away and did not arrive until he was in cuffs and officers were beginning to examine him and themselves for physical injury as well as check the area for weapons or contraband.

On 051115 at approximately 1609 hours, I responded to assist PACT Officers with the arrest of wanted felon Brandon Hutchinson.

While responding, I heard over the police radio that they were engaged in a vehicle pursuit with Hutchinson.

I arrived on the scene of the collision at Sinto and Ella where they stopped the suspect vehicle.

At the time of my arrival, Hutchinson was in custody in the back yard.

Hutchinson was pale in the face, had pinpoint pupils and complained of breathing trouble.

As a SWAT EMT, I gathered my medical equipment to render aid.

Hutchinson was handcuffed behind hi back. We moved him to the grass, out of the shrubs where he was arrested.

I elected to hold C-spine and place him in a cervical collar based on the significant damage to the vehicles involved in the collision. Hutchinson complained of difficulty breathing, however it appeared to me he was breathing in and out sufficiently, although his breathing was rapid.

He was taken out of his handcuffs and placed in the supine position. An officer controlled his legs, while other officers controlled his arms. I plaed him on his back with his arms out in the anatomical position. I held his cervical spine in alignment, however Hutchinson continually fought it and tried to get up. I warned him numerous times to keep still, despite his constant attempts to get up.

Upon the arrival of AMR and SCFD 8 medics, I passed patient care of Hutchinson.

On 051115, I responded to 1420 N. Ella to assist fellow PACT officers following a vehicle pursuit with Brandon Hutchinson. Our team had been looking for Hutchinson after a warrant for his arrest was issued for 1st degree assault. During a previous incident a few weeks prior, he had assaulted Officer Cole and had been in possession of a firearm. Hutchinson had been bailed out of jail and since then had the warrants issued. Since that time we obtained several tips that he was again carrying a firearm.

Officer Brownell had contacted me and advised that he had information that Hutchinson was at the Deja Vu. I was responding to that location to assist when he evaded capture and engaged in a vehicle pursuit with Officers.

When I arrived on scene at 1420 N. Ella I found Officers and medics in the back yard treating Hutchinson. I assisted by contacting residents and searching the area for any weapons that Hutchinson may have thrown during the short foot pursuit. I did not locate any weapons. Deputy Melton responded with his bomb dog to assist with locating a possible firearm. We were unable to locate one outside the suspect vehicle. We did not enter or search the suspect vehicle as it was impounded for a search warrant.

I contacted and interviewed Jennifer Bristow and her daughter **#2d** who live at that location and were in the back yard when Hutchinson came running through with Officers chasing him. Bristow's 5 year old daughter **#2d** was also in the back yard. I also interviewed Lacie Estrada who was in the back yard visiting. She had her 3 year old son **#2d** with her at the time.

Lacie, Jennifer said they heard the tires screeching and then the crash. A couple seconds later they saw Hutchinson running from the street and into the backyard they were in. Following behind him were at least two police Officers with "big guns".

Hutchinson ran within a foot or two of Lacie's 3 year old son, #2d. She said she was so scared and thought that he would be able to grab him and use him as a human shield. Lacie heard one Officer yelling "Kids in the yard, kids in the yard" as if warning the other Officer. They both heard the Officers yelling at them to "get back, get back" and "Get down, get down". They both felt the Officers were "in control" and "handling it" and believed that they were doing everything they could to make their children safe. Although they were frightened of the situation one of them said that they could see by the look in one of the Officers eyes, that he was concerned about their safety.

Hutchinson ran to a chain link fence behind the residence which is the fence between Jennifer's back yard and Lacie's back yard. Lacie's rottweiler "Sancha" came to the fence and jumped up on it while Hutchinson was starting to climb it. They both yelled the dog to "get him" (referring to Hutchinson). They gathered there children and moved them into the house because they were afraid there may be a shooting because of all the things they have seen on the news lately.

While heading in they saw Hutchinson move from the chain link fence to a wood fence where he was contacted by Officers. They said they saw Officers push him into the fence and then to the ground. Hutchinson was still fighting with them and struggling to get away "as if he thought he wasn't caught". At some point it looked like Hutchinson was digging at the ground but they could not tell what he was doing. Lacie and Jennifer took the children in the house and did not see any strikes from Hutchinson or the Officers. When they came back out a few minutes later they saw Officers and medics treating Hutchinson.

Jennifer's 12 year old daughter #2d gave the same statement about Hutchinson running to the fences and Officers yelling to get back. She added that she saw one of the Officers swinging a "big gun" in a downward motion to hit Hutchinson in the back or head when he was on the ground. She thought that happened about 5 or 6 times but she was moving inside at the time and did not have a clear view of everything that was happening at the time.

I did not interview #2d or #2d due to their ages. Both mothers asked me to talk to them and reassure them that it was safe because they were scared to go in their back yards. Everyone was still visibly shaken when we arrived but after talking to all of them we were able to calm them down and reassure the children.

Officer Bode did the vehicle collision reports. I followed the suspect vehicle to property and secured it at that location for the search warrant.

He was a sworn Deputy Sheriff for the Spokane County Sheriff's Office, Spokane WA, from 2005 to 2014. He was a sworn Deputy Sheriff for the Pend Oreille County Sheriff's Office, Newport WA, from 2003 to 2005. He has attended the Spokane Police Academy and has received training in all areas of law-enforcement including but not limited to theft, burglary, robbery, and possession of stolen property, trafficking in stolen property, vehicle prowling, fraud, forgery, money laundering, and criminal profiteering. He has worked for the Spokane County Sheriff's Office in the Patrol Division and the following: Spokane Police Reserve Officer 2002, Spokane International Airport Police Officer 2003, Pend Oreille County Sheriff's Office November 2003-August 2005; He has investigated numerous crimes against both persons and property to include; thefts, burglaries, trafficking in stolen property, vehicle prowling, robberies, assaults, controlled substance possession, domestic violence crimes, and many others. He has attended classes/schools with specialized topics in manufacture, packaging, smell, growing, appearance, possession, sale, and methods of transporting and transferring of controlled substances, to include but not limited to marijuana, cocaine, prescription drugs, L S D, hashish, methamphetamine, and heroin. Officer Brownell has written and executed search warrants with the Pend Oreille County Sheriff's Office, ATF, Spokane County, Spokane Police Department,

and has participated in several investigations that have led to arrests and convictions for same. He has attended several classes for roadside drug interdiction and has been trained in the same. He is currently assigned to the Spokane Police Anti-Crime Team (PACT).

Circumstances supporting probable cause:

Your affiant can testify to the following:

He was working as a police officer for the City of Spokane. That a concerned citizen contacted him and said that Brandon Hutchinson (who had a confirmed warrant for his arrest for 1st degree assault with a firearm and DOC Escape) was at Déjà vu at 8722 E Sprague, Spokane Valley. He knows that Brandon has a history of carrying a firearm because Brandon was recently arrested for carrying the firearm. Your affiant has a lot of people who have told him that Brandon is carrying a firearm with him. These people are not gaining anything by telling your affiant this. Due to these high risk factors, your affiant requested that members of the SPD ERU unit assisted with the arrest of Brandon. As soon as your affiant arrived at the Déjà vu, he immediately spotted Brandon in the parking lot standing on the passenger's side of a 1996 Acura passenger's vehicle (IA Reg CQZ706, VIN JH4UA2654TC009489). Your affiant saw Brandon turn his body and look in your affiant's direction. Your affiant used a pair of binoculars and was able to describe Brandon's attire to other officers assisting with this arrest. Brandon was wearing a white t-shirt and blue jeans. Your affiant observed a slight bulge in the front waistband of Brandon when Brandon turned his (your affiant's) direction and looked in his direction.

Your affiant knows Brandon has a history of running and fighting with law enforcement officers. Your affiant was concerned that if Brandon became mobile he would put civilian's at risk. Your affiant drove to Brandon's location and activated his emergency lights. At the same time, members of the ERU unit also moved in. Brandon clearly saw and identified your affiant as a law enforcement officer. Brandon immediately dove like he was reaching for a weapon or concealing a weapon into the center console/under the driver's seat of the vehicle. The driver of the vehicle got out of the vehicle quickly with his hands up and Brandon jumped over the center of the vehicle as he was still reaching underneath the seat (or into the center console). Brandon drove over an 8" concrete parking barrier and attempted to elude officers down Sprague, Park Rd and E Sinto Ave by driving in a willful and wonton disregard for property or life of others. Brandon crashed into a parked vehicle at Sinto and Ella Rd and your affiant was able to take him into custody.

When your affiant searched Brandon incident to arrest, your affiant was not able to locate the item that bulged out of the front of his waistband.

Your affiant has contacted and arrested (as well as released) many people who have carried firearms in the waistband of their clothing. Your affiant has been trained to recognize bulges in clothing as potential weapons based on LE history. Your affiant has a lot of training and experience identifying weapons and teaching other law enforcement officers to identify weapons on people based on bulges and other factors. Your affiant has seen many people with bulges and has successfully removed a shotgun, multiple pistols, and multiple knives.

Based on Brandon's history of carrying firearms, over 4 concerned citizens in the past couple days telling your affiant that Brandon is carrying a firearm that have nothing to gain and they don't have any reason to lie, your affiant is requesting this warrant to enter the vehicle to search/recover and firearms.

In addition, after Brandon was taken into custody, your affiant observed that Brandon's skin was clammy, his speech was repetitive, fast, and slurred. Brandon's pupils were pin point dilated. Brandon did not have any alcohol of his breath. Your affiant is trained in SFST's and holds a current certification. Your affiant had completed Advanced Roadside detection and Enforcement school (A.R.I.D.E.). Your affiant has arrested many people for DUI and released many people for same. Your affiant has extensive training and experience in recognizing people who are on drugs. Your affiant believes that based on these facts and circumstances, Brandon was under the influence of a controlled substance. When Brandon was taken into custody, he did not have any controlled substances on his person which lead your affiant to believe that they may be illegal controlled substances in the vehicle.

Ofc Stone wrote a search warrant for a sample of Brandon's blood to be tested which was signed and executed for DUI. Brandon admitted to Ofc Stone that he had methamphetamines in his possession less than 24 hours ago.

Your affiant ran a criminal history report on Brandon for previous convictions and learned that he has a conviction for possession of a controlled substance. Your affiant is also requesting permission to search the vehicle for any controlled substance.
