After reading the attached documentation and debriefing Ofc. Jensen I find that Ofc. Jensen's deployment of K-9 "Cruz" as a searching and apprehension tool was reasonable, within State and Federal Law, within Department Policy and met Department expectations.

I also read the attached documentation reference the force used by Sgt. Preuninger and Ofc. Kernkamp. Their use of Level 2 Tactics, Level 1 LVNR, and a taser were also reasonable and within Department Policy.

Officers had developed PC for the suspect, Janssen, for Felony DVOPV, 1<sup>st</sup> Robbery, and 1<sup>st</sup> Burglary and Janssen had attempted to conceal himself in the attic of the house. All Officers onscene were also concerned about the medical wellbeing of Janssen due to the extremely high temperatures. They were able to take him into custody with relatively minor injuries considering the circumstances of working in a very confined space, the high temperatures, and his assaultive behavior.

It should be noted that there was body camera footage of the incident.

I collected the photographs that were attached to this report number from the forensics department. There were no photographs of injuries to the suspect or the scene. The only pictures were of the initial victim of the DV.

#### Report Narrative

On 063015 at about 1153 hours my K9 partner, Cruz, and I were paged out from home to assist other officers in locating a suspect who was hiding in an attic area at [REDACTED] #1d I arrived on scene at about 1214 hours and contacted Sgt. Hartman who told me the following;

Sgt. Hartman said officers had the attic locked down in the apartment building and that he had requested Sgt. Preuninger to respond to the location to assist in coming up with a tactical plan in locating and arresting the suspect. Sgt. Hartman advised me there was PC to arrest the suspect for serious felonies, including robbery and burglary, so he was concerned for the safety of his patrol officers on scene.

While Sgt. Hartman waited outside, I went inside and contacted Ofc. Aitken. Ofc. Aitken advised me the suspect's name was Travis A. Janssen (100577). He said he had PC to arrest Janssen for multiple felonies; 1st degree robbery DV, 1st degree burglary DV and felony DVOPV. Ofc. Aitken advised Janssen was in violation of a DV order being at the apartment building, more specifically apartment #303. Ofc. Aitken said his unit (DV unit) was conducting follow up today hoping to locate and arrest Janssen for his felonies that he had committed on 062515 (15-214112). Ofc. Aitken said Janssen had broke a hole in the ceiling within apartment #303 and crawled into the attic in an effort to avoid arrest. Ofc. Aitken said officers cleared out all 3 apartments on the 3rd floor because the attic area covered all apartments, giving Janssen a large area to hide in. Ofc. Aitken advised me that Janssen had been in the attic for about 2 hours prior to my arrival and refused to give up to constant negotiations and a SCSO K9 announcement in which the dog barked loudly. I asked Ofc. Aitken about weapons history on Janssen and he said he did not think Janssen had any weapons history and the crimes committed on 062515 did not involve weapons.

I observed Ofc. C. Johnson positioned in a small room that led into several different parts of the attic. This small room could be accessed by a ladder from the common area on the 3rd floor of the apartment building. I climbed up this ladder to assess what the area to be searched looked like. I observed several small openings which branched off from the small room atop the ladder. I also observed that it was extremely hot in this area which was adjacent to the attic space. I was dripping with sweat after being in the small room for only a few minutes.

I climbed back down the ladder and before going downstairs, Ofc. Schneider advised me that he believed Janssen was hiding above the stairwell area in the attic because prior to me getting there he heard movement at this location, through the ceiling. It should be noted that this area could not be viewed from the small room that I had just been in. There was a wall in between, preventing straight line of sight.

I went downstairs and contacted Sgt. Austin and Sgt. Preuninger who were now both on scene. I advised them of my concerns about the area to be searched in that it was a confined space, dark and presented serious safety risks in that officers could fall through the ceiling if not extremely careful. I advised both of the seriousness of the offenses and that the suspect had not been searched and could be in possession of weapons. Sgt. Preuninger and Sgt. Austin both began an assessment of the call.

I returned back up to the 3rd floor. At about this time, Ofc. K. Gately and Det. M. Hill arrived on scene and began more negotiations in an attempt to get Janssen to give up peacefully. I heard Ofc. K. Gately stating that the police were not going away, that we had a police dog that would bite him if he did not give up. Ofc. K. Gately and Det. M. Hill continued their negotiations for at least 10 minutes, yelling into the attic, without any response. I was then told to get my K9 partner, Cruz.

I put a leash on K9 Cruz and made my way back upstairs to the 3rd floor. I placed a long leash on Cruz' tracking harness and pulled him up into the small room at the top of the ladder. When I reached this area, I observed that officers had broken out a large section of dry wall so that visual access could be gained into the area in which Janssen was believed to be hiding. These officers (Johnson and Heuett) advised me that they could see the suspect and that he was moving around a little bit.

I heard officers give numerous commands to Janssen to give up and to crawl towards officers. Janssen refused. I then decided to try and persuade Janssen to give up with a K9 announcement with K9 Cruz by my side. I gave K9 announcements which included language similar to, Spokane Police K9 Unit, come out now, I'm going to release the police dog, when he finds you he will bite you. K9 Cruz barked after the announcements. Janssen refused to comply and remained in the same spot. This spot was about 20 feet from where we were yelling commands. However, there were numerous obstructions (support beams, insulation,

wiring and duct work) which prevented us from accessing Janssen. All of these obstructions also prevented us from clearly seeing Janssen. I was unable to see either of his hands and would only catch a glimpse of his back and head from time to time.

I voiced concern to Sgt. Preuninger who was next to me that Janssen might be in need of medical attention and the safest way to get him out would be to punch a hole through the ceiling next to him and pull him through the hole. I was concerned for Janssen in that he was not talking at all, moving only slightly and had been inside the extremely hot attic area for over 2 hours. It did not look safe for officers to crawl to Janssen due to all of the obstructions and the issue of the ceiling breaking out right over the stairwell, which presented a longer fall.

Officers began to poke through the ceiling near Janssen while other officers yelled to him that officers were going to help him down so that he could get medical attention. I observed Janssen's behavior change immediately. Once Janssen figured out officers were attempting to get him to come out through a hole in the ceiling, he began crawling in a deliberate manner away from the hole being created. In fact, Janssen crawled out of sight and hid behind tubular duct work which was located about 15-20 feet from my location. Now with Janssen completely out of view, I became more concerned. Janssen had clearly avoided our attempt to get him medical attention and physically assisted himself in bolstering his hiding location in his quest to avoid arrest.

I opted not to send K9 Cruz back into the attic because we now knew where Janssen was and the effectiveness of the canine's contact was in question because it had not worked the first time. I observed that K9 Cruz was panting frantically and it was apparent that he was overheating. I returned him to the patrol car where he was in air conditioning with fresh water available. I returned back upstairs and a plan was devised again to poke a hole through the ceiling near the stairwell to get Janssen to come through.

I remained in the attic area in which I had deployed K9 Cruz while other officers began poking a hole through the ceiling near Janssen. When officers began getting the hole bigger, I observed Janssen crawl over the tubular duct work and crawl quickly to the east and north. At one point, Janssen looked right at me as I was telling him just to give up. Janssen ignored my commands and continued to crawl out of sight. I had last seen Janssen crawling near the NE corner of the attic space above the 3rd floor. I advised officers of this.

A plan was devised that a team of officers would go into the attic area to apprehend Janssen. I was near the stairwell when a team of officers confronted Janssen in the attic. I heard over the radio that Janssen was being uncooperative and that a taser had been deployed. I then heard officers advise they had him in custody and were bringing him back to the area where the ladder access led to. I crawled up the ladder to help officers get Janssen down the ladder, but prior to them making it to the ladder area, officers and Janssen broke through the floor of the attic and almost all fell into the apartment on the NE corner of the 3rd floor.

I then crawled down the ladder and assisted officers in guiding Janssen from the attic to the living room of the apartment they had broke the ceiling of. Janssen was safely guided down and placed on a stretcher for medical treatment. Janssen was transported to Deaconess ER.

I went to Deaconess ER where I observed Janssen receiving medical treatment. Janssen was not talking to anyone. I observed he had a singular canine contact on his right thigh. I

observed the upper canine marks on the front of this right thigh and the lower canine marks on the back of his right hamstring. The marks were punctures, but there was not excessive tearing. I did not see any other canine contacts on Janssen. Dr. Preiss was the primary doctor treating Janssen at Deaconess. Cpl. Beckley responded and photographed Janssen's injuries.

I advised Sgt. Hartman of the injuries and Janssen's status. See other officers' reports for further information. It should be noted that several officers had body cameras on during this incident.

However, there were numerous obstructions (support beams, insulation, wiring and duct work) which prevented us from accessing Janssen. All of these obstructions also prevented us from clearly seeing Janssen. I was unable to see either of his hands and would only catch a glimpse of his back and head from time to time.

I voiced concern to Sgt. Preuninger who was next to me that Janssen might be in need of medical attention and the safest way to get him out would be to punch a hole through the ceiling next to him and pull him through the hole. I was concerned for Janssen in that he was not talking at all, moving only slightly and had been inside the extremely hot attic area for over 2 hours. It did not look safe for officers to crawl to Janssen due to all of the obstructions and the issue of the ceiling breaking out right over the stairwell, which presented a longer fall.

Officers began to poke through the ceiling near Janssen while other officers yelled to him that officers were going to help him down so that he could get medical attention. I observed Janssen's behavior change immediately. Once Janssen figured out officers were attempting to get him to come out through a hole in the ceiling, he began crawling in a deliberate manner away from the hole being created. In fact, Janssen crawled out of sight and hid behind tubular duct work which was located about 15-20 feet from my location. Now with Janssen completely out of view, I became more concerned. Janssen had clearly avoided our attempt to get him medical attention and physically assisted himself in bolstering his hiding location in his quest to avoid arrest.

At this point it was clear to me that Janssen was attempting to avoid arrest and he was clearly desperate in his attempt which caused me great concern. I decided to deploy K9 Cruz into the attic area to locate Janssen for the following reasons:

Crime:

There was PC to arrest Janssen for 1st degree robbery DV, 1st degree burglary DV, and 2 counts of felony DVOPV. It should be noted that Janssen was currently violating a DV order by being in the attic at #1d

Threats:

Janssen had committed violent felony crimes a few days prior and was attempting to avoid arrest for those crimes. Janssen chose to break into the attic area and hide. This attic area was extremely hot (over 100 degrees) and Janssen remained hidden for more than 2 hours showing how desperate he was to avoid capture. Janssen's desperate behavior concerned me because he could be willing to do whatever in an effort to avoid arrest, including assaulting or killing law enforcement. Janssen had not been searched and it was unknown whether he possessed any weapons to carry out such attacks. Janssen also presented a legitimate safety concern to the victim of the crimes he had recently committed. She lives in apartment #303 which could still be accessed by Janssen if he was not captured. Janssen also presented a threat to other residents on the 3rd floor if not captured in that he could break through their ceilings in his attempt to get away.

In addition to the threats that Janssen presented, the area he was hiding in presented serious safety concerns for officers as well. The attic was dark and full of hiding locations. There were several obstacles throughout the attic including support beams, insulation, wiring and tubular duct work. These obstacles would make it extremely difficult for officers to navigate in a tactical manner without potentially falling through the ceiling and into an apartment below. Even more concerning was the area in which Janssen had disappeared to was located over the stairwell of the apartment building which would mean a longer fall for officers if they fell through the ceiling. The extreme temperature in the attic was also concerning for both officers and Janssen in that extended exposure in this heat could lead to heat exhaustion related injuries.

#### Resistance:

Janssen had fled from responding officers by breaking through the ceiling in #303 and crawling into the attic. Janssen furthered his effort to evade arrest by refusing to give up and secreting himself once spotted in the attic.

I determined that the safest manner in which to apprehend Janssen would be to allow K9 Cruz to search the attic and locate Janssen in his newly acquired hiding location. Once Janssen was located and contacted, I was planning on verbally outing Cruz and recalling him to my position. From there I was hoping to call Janssen out from his hiding location. This plan would mitigate many of the safety concerns addressed.

I gave 2 more K9 announcements as before giving Janssen the opportunity to give up, but also advising him that a police dog was being used to find him and that he would be bitten if he did not give up. K9 Cruz barked loudly after each announcement and I waited around 30 seconds after each announcement for a reply. I did not hear any replies from Janssen nor did he make any physical efforts to give up.

I gave K9 Cruz the command to search and he began working into the attic area towards the area in which Janssen had disappeared. K9 Cruz was having difficulty navigating the obstacles in the attic, having to work back and forth over numerous support beams. K9 Cruz then worked towards the west and out of sight. A short time later I heard a male screaming to get the dog off. I heard the screaming coming from the area in which Janssen had disappeared to; behind the tubular duct work. I verbally outed Cruz and he disengaged his bite and wiggled his way out, above the duct work and returned to me. I was unable to see the bite occur, but my estimation of the bite duration based upon the scream and verbal out was about 5-10 seconds. I put a leash on Cruz and heard officers talking back and forth with Janssen which had not been done up until this point in the incident. It sounded as if Janssen was going to give up and crawl out, but this was not the case. Janssen remained in his hiding location, still out of our visual sight. Janssen also went quiet again, refusing to talk with officers.

I opted not to send K9 Cruz back into the attic because we now knew where Janssen was and the effectiveness of the canine's contact was in question because it had not worked the first time. I observed that K9 Cruz was panting frantically and it was apparent that he was overheating. I returned him to the patrol car where he was in air conditioning with fresh water available. I returned back upstairs and a plan was devised again to poke a hole through the ceiling near the stairwell to get Janssen to come through.

I remained in the attic area in which I had deployed K9 Cruz while other officers began poking a hole through the ceiling near Janssen. When officers began getting the hole bigger, I observed Janssen crawl over the tubular duct work and crawl quickly to the east and north. At one point, Janssen looked right at me as I was telling him just to give up. Janssen ignored my commands and continued to crawl out of sight. I had last seen Janssen crawling near the NE corner of the attic space above the 3rd floor. I advised officers of this.

A plan was devised that a team of officers would go into the attic area to apprehend Janssen. I was near the stairwell when a team of officers confronted Janssen in the attic. I heard over the radio that Janssen was being uncooperative and that a taser had been deployed. I then heard officers advise they had him in custody and were bringing him back to the area where the ladder access led to. I crawled up the ladder to help officers get Janssen down the ladder, but prior to them making it to the ladder area, officers and Janssen broke through the floor of the attic and almost all fell into the apartment on the NE corner of the 3rd floor.

I then crawled down the ladder and assisted officers in guiding Janssen from the attic to the living room of the apartment they had broke the ceiling of. Janssen was safely guided down and placed on a stretcher for medical treatment.

Janssen was transported to Deaconess ER.

I went to Deaconess ER where I observed Janssen receiving medical treatment. Janssen was not talking to anyone. I observed he had a singular canine contact on his right thigh. I observed the upper canine marks on the front of this right thigh and the lower canine marks on the back of his right hamstring. The marks were punctures, but there was not excessive tearing. I did not see any other canine contacts on Janssen. Dr. Preiss was the primary doctor treating Janssen at Deaconess. Cpl. Beckley responded and photographed Janssen's injuries.

I advised Sgt. Hartman of the injuries and Janssen's status. See other officers' reports for further information. It should be noted that several officers had body cameras on during this incident.

On 06-25-15 at approximately 1709 hours, SPD dispatch received a call from off-duty DV unit Officer Geren indicating that he received information a Travis Janssen was at **#1d** a locating he was prohibited from being. Records indicated that there was a valid served no-contact order protecting **#1a** at that location, and that Janssen was restrained from coming within two blocks of the location. (Post conviction domestic violence no-contact order, issues 09-24-14, expiring 5-7-16, case #N45082, report #14-97331).

Officer Erdman and I (two officer training unit) arrived at approximately 1728 hours, and Officer Conrath had arrived at approximately 1724 hours. Officer Conrath advised that the suspect was not seen upon his arrival.

We made contact with apartment #303, and **#1a** answered the door. I noted that her face appeared flushed and she seemed on edge. She stated that Janssen had fled the location about 15 minutes prior to our arrival.

I interviewed **#1a** who stated the following in summary; she and Janssen had a relationship which lasted about seven years, and had ended over a year ago. Since that time Janssen had been stalking and harassing her, and had been arrested numerous times for violating the court order protecting her.

This incident started when **#1a** accidentally left the front door to her apartment unlocked and Janssen walked into the apartment. Janssen stated that he just wanted to talk and **#1a** repeatedly told him to get out, which he did not do. Janssen went to **#1a** bedroom and sat on the bed, repeating that he just wanted to talk. **#1a** repeatedly told him to leave. **#1a** keys and cell phone were on top of her purse in he bedroom, and Janssen took the items and placed them between his legs on the bed. **#1a** demanded the items back at which point Janssen told her to "shut the fuck up" and then struck her in the face with a small plastic pen box (about 4"x6" in size). Janssen then stuck his finger into her nostril, and pushed her head down onto the floor so she was positioned half on the bed and half pinned to the ground. **#1a** was able to free herself and grabbed a hold of Janssen's shirt as he got up to leave, ripping it. She indicated that he had gotten away with her cell phone and keys (**#1a** later found her keys on the bed, and indicated that Janssen had only stolen her cell phone which she was positive was missing).

The cell phone was described as a white ZTE phone that did have a pass code required to utilize it.

**#1a** chased Janssen out of the apartment and yelled for someone to call 911.

I observed a small cut to the right side of **#1a** nose, which was located next to her right nostril opening. **#1a** also had a lump behind her left ear, and some abrasions on her knee.

Officer Erdman interviewed witness Quinn Valdez who resides at the apartment with **#1a**. He indicated that he was returning to the apartment when he saw Janssen, who he was very familiar with and had known for a long time, run from the apartment wearing a torn shirt and flee the building. See Officer Erdman's report for further.

Cpl. Spiering arrived on scene and photographed **#1a** injuries. We were escorted into her bedroom where she showed us the pen box. I noted that one side of the box was caved in, and **#1a** indicated the indentation was from where the box and struck her face. The box was also photographed.

**#1a** was provided a crime victim card with corresponding report number. Officer Erdman also performed a LAP assessment and **#1a** spoke with an advocate. See Officer Erdman's report for further.

**#1a** could provide no potential locations that Janssen would flee to. She indicated that Janssen frequently watched her apartment building from the alley to the south of Mallon Ave, and the east of the apartment building.

**#1a** indicated that Janssen was likely using methamphetamine. She displayed what appeared to be genuine concern for her safety, and cited Janssen's complete disregard for the no-contact order, as a reason for her concern.

**#1a** gathered her children, who were present at the time of the incident, into her van and departed the scene to go to her mother's house where she felt safer. Officer Erdman and I stood by until she left to ensure her safety.

An NCIC III check was conducted on Janssen which yielded three convictions for order violations:  
-01-07-15 felony domestic violence court order violation  
-05-07-14 Gross Misdemeanor domestic violence court order violation  
-05-06-15 Gross Misdemeanor domestic violence court order violation

Based on Janssen's prior convictions for DVOPV, and his assault during this order violation I determined that there was probable cause to arrest him for felony order violation. Based on Janssen

On 06/25/15 at 1716 hrs, I was sent to **#1d** on a report of a Violation of a No Contact Order. Dispatch advised a 3rd party caller was reporting Travis Janssen was at the apartment of **#1a**

Dispatch confirmed a valid and served DV-No Contact Order between the two with **#1a** as the protected person from Travis Janssen.

I arrived onscene along with Officer Briggs. We entered the secured building and contacted **#1a** at her apartment. **#1a** stated Travis had left approx. 10-15 minutes before our arrival. He had stolen her car keys and phone and assaulted her in the process. Officer Briggs took statements from **#1a** -see Incident report.

I contacted **#1a** roommate Quinn Valdez. He stated he has known Travis for a "long time". When he was arriving home today, Travis came running down the stairs from their apartment. Travis' t-shirt was torn and he appeared to have some sort of scratch/abrasion on his chest.

We were unable to locate Travis in the area.

Based on the statements of **#1a** and Quinn as well as **#1a** injuries consistent with those statements, Officer Briggs and I developed probable cause Travis Janssen committed the crimes of Felony Violation of a No Contact Order, Robbery 1st Degree, and Burglary 1st Degree-see Officer Briggs' report for further information.

**#1a** screened into the Lap program. She answered "yes" to questions 2,3,5,6,7,8,9, and 11. I facilitated the referral to a LAP advocate at the scene.

On 063015 at 1208 hours, I assisted other Officer's doing follow-up at **#1d** The call was reference a Dv call that the Dv unit was doing follow-up on.

Upon arrival, I contacted Officer Aitken in the attic area. I immediately started sweating and the air was very humid in the attic area. He advised that there was pc to arrest Travis Janssen, for 1st degree burglary/ Dv, 1st degree Robbery/ Dv and Felony DVOPV from 062515. There was also pc for residential burglary/ Dv, felony DVOPV and 2nd degree malicious mischief/ Dv from today's incident.

Officer Aitken advised that he has attempted verbal commands to Travis in the attic since 0928 hours and I arrived on scene at 1208 hours. The attic was about 150 degrees and we were concerned for his safety and health, do to the heat and the amount of time he had been in the attic. I attempted to talk to Travis through the small access door that was about two feet by four feet, that leads into the attic. I told him several times that he was under arrest and that he needed to come out of the attic. I advised him that we did not want to use force against him and that a K9 unit was on the way. I was yelling into the attic area loud enough to hear from the back corner. Travis made no responses and refused to exit the attic area. I also observed Officer Aitken attempting verbal contact with Travis and there was no response.

At this point in the call, there was pc to arrest Travis Janssen, for 1st degree burglary/ Dv, 1st degree Robbery/ Dv and Felony DVOPV from 062515. There was also pc for residential burglary/ Dv, felony DVOPV and 2nd degree malicious mischief/ Dv from today's incident. He was also an immediate threat to us in the attic, by not knowing his position in the attic and it was unknown if he as armed with a weapon. There was other Officer's on scene that advised Travis was possibly under the influence of Methamphetamine and was sending the female victim threatening text messages. He was also actively resisting arrest by hiding in the attic and refusing to exit and attempting to evade arrest by moving around in the attic, prior to other units coming on scene.

Officer Johnson removed dry wall allowing us to see deeper into the attic for officer safety reasons. As soon as the first piece was removed I could see Travis, hiding under the insulation, at the far northwest corner. He looked directly at us and refused to show me his hands and refused to follow simple commands to exit the attic. I talked to him for several minutes at which time he raised his

head to see out positions, but continued to refuse to follow directions. He would dig around in the insulation as if he was looking for something and was looking around as if he was looking for an escape route. I had my handgun out in a low ready position, based on his actions and him refusing to show us his hands. When he would move around, it also provided a cloud of cover for him with all the insulation getting blown up and over him. I continued to tell him that he was under arrest and that he needed to follow directions. Officer Johnson had to continue to remove dry wall based on Travis moving around and us not being able to see him. When he moved from position to position, he moved with a purpose and did not seem to be affected by the heat in the attic.

See Officer Jensen's K9 report for further.

Travis eventually moved quickly across the attic from the west to the east and then through another small space between the rafters and back to the northeast corner. At one point he was about two feet from me, but I was not able to go hands on due to a 2x4 crossing over the small attic space opening. He also refused to follow simple commands and continued to evade arrest.

I then assisted Sgt. Preuninger and Officer Kernkamp at the northeast corner. Travis was hiding in the far northeast corner against the roof line and outside soffit. I took a position to his west not allowing him to get back across the attic. He refused to follow commands to show us his hands and refused to come to us. He was laying on his stomach with his head against the north roof line and his feet were towards us. His hands were under his body and he was moving them around under the insulation near his waistband. It was dark and we had to light the attic up with several flashlights. It was also hotter than the common space in the attic, with insulation particles floating around and was a small confined space between the floor joists. We were also concerned for our safety and his to not fall through the dry wall into the apartment below us.

Several commands were given to Travis and he refused to comply with all of them. See Officer Kernkamp's report for further.

After a taser was deployed I took right arm control and Travis immediately pulled his arm away from me and put his right hand into a fist. I took head control, into a hair hold take down and pulled Travis towards me. He ended up getting into a wrestling position onto his hands and knees and was pushing away from us. I took left arm control and told Officer Johnson to place a handcuff on Travis. He was tensing his arm the entire time and was trying to pull it towards his body. He was also kicking his feet towards me and was trying to get leverage by placing his feet against the floor joist. We eventually were able to get him into handcuffs and wanted to remove him from the attic heat. I was clearing a space for Sgt. Preuninger, when I observed Sgt. Preuninger and Travis start to fall through the dry wall ceiling. I grabbed onto Sgt. Preuninger to support him from not falling and we were able to guide Travis down to other Officer's.

It should be noted that I had to go back to the station to change out uniforms and take a shower

because of the amount of insolation all over me. I was also very dehydrated from the heat and was sweating very hard and I had to clean all of our equipment before going back into service.

On 063015 at about 1153 hours my K9 partner, Cruz, and I were paged out from home to assist other officers in locating a suspect who was hiding in an attic area at #1d. I arrived on scene at about 1214 hours and contacted Sgt. Hartman who told me the following;

Sgt. Hartman said officers had the attic locked down in the apartment building and that he had requested Sgt. Preuninger to respond to the location to assist in coming up with a tactical plan in locating and arresting the suspect. Sgt. Hartman advised me there was PC to arrest the suspect for serious felonies, including robbery and burglary, so he was concerned for the safety of his patrol officers on scene.

While Sgt. Hartman waited outside, I went inside and contacted Ofc. Aitken. Ofc. Aitken advised me the suspect's name was Travis A. Janssen (100577). He said he had PC to arrest Janssen for multiple felonies; 1st degree robbery DV, 1st degree burglary DV and felony DVOPV. Ofc. Aitken advised Janssen was in violation of a DV order being at the apartment building, more specifically apartment #303. Ofc. Aitken said his unit (DV unit) was conducting follow up today hoping to locate and arrest Janssen for his felonies that he had committed on 062515 (15-214112). Ofc. Aitken said Janssen had broke a hole in the ceiling within apartment #303 and crawled into the attic in an effort to avoid arrest. Ofc. Aitken said officers cleared out all 3 apartments on the 3rd floor because the attic area covered all apartments, giving Janssen a large area to hide in. Ofc. Aitken advised me that Janssen had been in the attic for about 2 hours prior to my arrival and refused to give up to constant negotiations and a SCSO K9 announcement in which the dog barked loudly. I asked Ofc. Aitken about weapons history on Janssen and he said he did not think Janssen had any weapons history and the crimes committed on 062515 did not involve weapons.

I observed Ofc. C. Johnson positioned in a small room that led into several different parts of the attic. This small room could be accessed by a ladder from the common area on the 3rd floor of the apartment building. I climbed up this ladder to assess what the area to be searched looked like. I observed several small openings which branched off from the small room atop the ladder. I also observed that it was extremely hot in this area which was adjacent to the attic space. I was dripping with sweat after being in the small room for only a few minutes.

I climbed back down the ladder and before going downstairs, Ofc. Schneider advised me that

he believed Janssen was hiding above the stairwell area in the attic because prior to me getting there he heard movement at this location, through the ceiling. It should be noted that this area could not be viewed from the small room that I had just been in. There was a wall in between, preventing straight line of sight.

I went downstairs and contacted Sgt. Austin and Sgt. Preuninger who were now both on scene. I advised them of my concerns about the area to be searched in that it was a confined space, dark and presented serious safety risks in that officers could fall through the ceiling if not extremely careful. I advised both of the seriousness of the offenses and that the suspect had not been searched and could be in possession of weapons. Sgt. Preuninger and Sgt. Austin both began an assessment of the call.

I returned back up to the 3rd floor. At about this time, Ofc. K. Gately and Det. M. Hill arrived on scene and began more negotiations in an attempt to get Janssen to give up peacefully. I heard Ofc. K. Gately stating that the police were not going away, that we had a police dog that would bite him if he did not give up. Ofc. K. Gately and Det. M. Hill continued their negotiations for at least 10 minutes, yelling into the attic, without any response. I was then told to get my K9 partner, Cruz.

I put a leash on K9 Cruz and made my way back upstairs to the 3rd floor. I placed a long leash on Cruz' tracking harness and pulled him up into the small room at the top of the ladder. When I reached this area, I observed that officers had broken out a large section of dry wall so that visual access could be gained into the area in which Janssen was believed to be hiding. These officers (Johnson and Heuett) advised me that they could see the suspect and that he was moving around a little bit.

I heard officers give numerous commands to Janssen to give up and to crawl towards officers. Janssen refused. I then decided to try and persuade Janssen to give up with a K9 announcement with K9 Cruz by my side. I gave K9 announcements which included language similar to, Spokane Police K9 Unit, come out now, I'm going to release the police dog, when he finds you he will bite you. K9 Cruz barked after the announcements. Janssen refused to comply and remained in the same spot. This spot was about 20 feet from where we were yelling commands. However, there were numerous obstructions (support beams, insulation, wiring and duct work) which prevented us from accessing Janssen. All of these obstructions also prevented us from clearly seeing Janssen. I was unable to see either of his hands and would only catch a glimpse of his back and head from time to time.

I voiced concern to Sgt. Preuninger who was next to me that Janssen might be in need of medical attention and the safest way to get him out would be to punch a hole through the ceiling next to him and pull him through the hole. I was concerned for Janssen in that he was not talking at all, moving only slightly and had been inside the extremely hot attic area for over 2 hours. It did not look safe for officers to crawl to Janssen due to all of the obstructions and the issue of the ceiling

breaking out right over the stairwell, which presented a longer fall.

Officers began to poke through the ceiling near Janssen while other officers yelled to him that officers were going to help him down so that he could get medical attention. I observed Janssen's behavior change immediately. Once Janssen figured out officers were attempting to get him to come out through a hole in the ceiling, he began crawling in a deliberate manner away from the hole being created. In fact, Janssen crawled out of sight and hid behind tubular duct work which was located about 15-20 feet from my location. Now with Janssen completely out of view, I became more concerned. Janssen had clearly avoided our attempt to get him medical attention and physically assisted himself in bolstering his hiding location in his quest to avoid arrest.

At this point it was clear to me that Janssen was attempting to avoid arrest and he was clearly desperate in his attempt which caused me great concern. I decided to deploy K9 Cruz into the attic area to locate Janssen for the following reasons:

### Crime:

There was PC to arrest Janssen for 1st degree robbery DV, 1st degree burglary DV, and 2 counts of felony DVOPV. It should be noted that Janssen was currently violating a DV order by being in the attic at #1d

### Threats:

Janssen had committed violent felony crimes a few days prior and was attempting to avoid arrest for those crimes. Janssen chose to break into the attic area and hide. This attic area was extremely hot (over 100 degrees) and Janssen remained hidden for more than 2 hours showing how desperate he was to avoid capture. Janssen's desperate behavior concerned me because he could be willing to do whatever in an effort to avoid arrest, including assaulting or killing law enforcement. Janssen had not been searched and it was unknown whether he possessed any weapons to carry out such attacks. Janssen also presented a legitimate safety concern to the victim of the crimes he had recently committed. She lives in apartment #303 which could still be accessed by Janssen if he was not captured. Janssen also presented a threat to other residents on the 3rd floor if not captured in that he could break through their ceilings in his attempt to get away.

In addition to the threats that Janssen presented, the area he was hiding in presented serious safety concerns for officers as well. The attic was dark and full of hiding locations. There were several obstacles throughout the attic including support beams, insulation, wiring and tubular duct work. These obstacles would make it extremely difficult for officers to navigate in a tactical manner without potentially falling through the ceiling and into an apartment below. Even more concerning was the area in which Janssen had disappeared to was located over the stairwell of the apartment building which would mean a longer fall for officers if they fell through the ceiling. The extreme temperature

in the attic was also concerning for both officers and Janssen in that extended exposure in this heat could lead to heat exhaustion related injuries.

### Resistance:

Janssen had fled from responding officers by breaking through the ceiling in #303 and crawling into the attic. Janssen furthered his effort to evade arrest by refusing to give up and secreting himself once spotted in the attic.

I determined that the safest manner in which to apprehend Janssen would be to allow K9 Cruz to search the attic and locate Janssen in his newly acquired hiding location. Once Janssen was located and contacted, I was planning on verbally outing Cruz and recalling him to my position. From there I was hoping to call Janssen out from his hiding location. This plan would mitigate many of the safety concerns addressed.

I gave 2 more K9 announcements as before giving Janssen the opportunity to give up, but also advising him that a police dog was being used to find him and that he would be bitten if he did not give up. K9 Cruz barked loudly after each announcement and I waited around 30 seconds after each announcement for a reply. I did not hear any replies from Janssen nor did he make any physical efforts to give up.

I gave K9 Cruz the command to search and he began working into the attic area towards the area in which Janssen had disappeared. K9 Cruz was having difficulty navigating the obstacles in the attic, having to work back and forth over numerous support beams. K9 Cruz then worked towards the west and out of sight. A short time later I heard a male screaming to get the dog off. I heard the screaming coming from the area in which Janssen had disappeared to, behind the tubular duct work. I verbally outed Cruz and he disengaged his bite and wiggled his way out, above the duct work and returned to me. I was unable to see the bite occur, but my estimation of the bite duration based upon the scream and verbal out was about 5-10 seconds. I put a leash on Cruz and heard officers talking back and forth with Janssen which had not been done up until this point in the incident. It sounded as if Janssen was going to give up and crawl out, but this was not the case. Janssen remained in his hiding location, still out of our visual sight. Janssen also went quiet again, refusing to talk with officers.

I opted not to send K9 Cruz back into the attic because we now knew where Janssen was and the effectiveness of the canine's contact was in question because it had not worked the first time. I observed that K9 Cruz was panting frantically and it was apparent that he was overheating. I returned him to the patrol car where he was in air conditioning with fresh water available. I returned back upstairs and a plan was devised again to poke a hole through the ceiling near the stairwell to get Janssen to come through.

I remained in the attic area in which I had deployed K9 Cruz while other officers began poking a hole through the ceiling near Janssen. When officers began getting the hole bigger, I observed Janssen crawl over the tubular duct work and crawl quickly to the east and north. At one point, Janssen looked right at me as I was telling him just to give up. Janssen ignored my commands and continued to crawl out of sight. I had last seen Janssen crawling near the NE corner of the attic space above the 3rd floor. I advised officers of this.

A plan was devised that a team of officers would go into the attic area to apprehend Janssen. I was near the stairwell when a team of officers confronted Janssen in the attic. I heard over the radio that Janssen was being uncooperative and that a taser had been deployed. I then heard officers advise they had him in custody and were bringing him back to the area where the ladder access led to. I crawled up the ladder to help officers get Janssen down the ladder, but prior to them making it to the ladder area, officers and Janssen broke through the floor of the attic and almost all fell into the apartment on the NE corner of the 3rd floor.

I then crawled down the ladder and assisted officers in guiding Janssen from the attic to the living room of the apartment they had broke the ceiling of. Janssen was safely guided down and placed on a stretcher for medical treatment. Janssen was transported to Deaconess ER.

I went to Deaconess ER where I observed Janssen receiving medical treatment. Janssen was not talking to anyone. I observed he had a singular canine contact on his right thigh. I observed the upper canine marks on the front of this right thigh and the lower canine marks on the back of his right hamstring. The marks were punctures, but there was not excessive tearing. I did not see any other canine contacts on Janssen. Dr. Preiss was the primary doctor treating Janssen at Deaconess. Cpl. Beckley responded and photographed Janssen's injuries.

I advised Sgt. Hartman of the injuries and Janssen's status. See other officers' reports for further information. It should be noted that several officers had body cameras on during this incident.

On 6/30/15 at approximately 0928 Officer Aitken and I decided to check on **#1a** (DOB **#1b**) at **#1d**. We had contacted **#1a** the day prior. **#1a** is currently protected from Travis Janssen (DOB 10/05/77) by a DV No Contact Order. The order from incident #14-97331, specifically lists the address of 1403 W Mallon on it. The order shows an expiration date of 5/7/2016, and it appears to be signed by Janssen on 09/24/14. Janssen has repeatedly harassed, contacted, and committed crimes of violence against **#1a** in the past. On 06/25/15 Officer Erdman developed probable cause to arrest Janssen for First Degree Burglary DV and First Degree Robbery DV under incident 15-214112.

I am aware from previous contacts with **#1a** and her neighbors that Janssen often shows up unannounced at her apartment. **#1a** has complained that Janssen breaks into her apartment. According to **#1a** Janssen has at times entered her apartment when she was not home and waited for her to return. He has hidden her phone and not allowed her to make contact to get help at times as well. I am also aware that Janssen has stolen **#1a** van in the past.

On 6/29/15 Officer Aitken and I had contacted **#1a** at her apartment. She allowed us to search her apartment for Janssen. He was not located. However a mens bathroom kit, bolt cutters, a condom (in the package, personal lubricant and a porn DVD were located her childs room. The shell on the DVD player had been removed so the DVD was clearly visible. I also observed other electronic devices taken apart in the apartment. **#1a** children do not appear to live with her at this time, however the location and items found are indications to me that a man, likely Janssen, had been there recently.

I talked to **#1a** toward the end of our contact. **#1a** told me that she feared Janssen and that she was afraid that he would hurt her, especially if Janssen knew that **#1a** had talked to the Police. **#1a** would only talk in a hushed whisper about Janssen, even knowing that he was not in the apartment. **#1a** appeared to choke on her words, which I took as an indication of that the fear she felt of Janssen was genuine.

**#1a** told me that she knew that Janssen would watch her from outside of the apartments. She recently discovered that Janssen would watch her from across the empty field to the East.

**#1a** had installed cupboard style locks on the interior of her door. Janssen had disabled her only working

lock, the deadbolt. The deadbolt could still be used but it was disabled from the outside of the apartment. The barrel inside of the lock would come out freely and it wasn't attached to anything anymore. This means that #1a cannot lock her door when she leaves and she can only lock it when she is inside of the apartment. This has led to #1a leaving and returning to find Janssen inside of her apartment in the past.

Janssen has at times stolen #1a phone, or hid it from her. He has done that to keep her from the calling the Police, calling family, and to further isolate her from other people.

As #1a and I talked she told me that she understood that Janssen was dangerous. #1a told me that her parents were concerned that #1a could be hurt or worse by Janssen.

It appeared that Janssen was frequenting #1a apartment. I have previously received training in domestic violence, from that training and my experiences in past investigations, I recognize that Janssen's behavior puts #1a at an ongoing and substantial risk for further/future abuse from him. Janssen has previously been recognized as one of our more prolific DV Offenders.

On 6/30/15 when Officer Aitken and I returned to check on #1a and to see if Janssen had tried to contact her. Upon arrival we discovered that her door was locked and there was no answer from inside of her apartment. I know that there has to be someone inside of #1a apartment to lock the door. #1a phone was also shut off. Officer Aitken called #1a mother, Valerie Knoles. Valerie had not had any contact from #1a since the day before. According to Valerie, her daughter's phone was working on the previous evening. #1a immediate neighbors, on the third floor, had not seen her today as well. We knocked for an extended period of time.

#1a mother responded to #1a apartment. #1a mother was concerned for her daughters welfare and she wanted to check the apartment to ensure that #1a was not hurt inside. I believed that we needed to check to the welfare of #1a. Given the that someone had to be in her apartment to lock the door. I had previous information that Janssen would break into #1a apartment, and that he would not allow her to call for help. It is also a concern during DV assaults that the victim is often hurt badly, with very visible injuries, and the suspects will try to keep the victims from contacting others to avoid being caught. #1a had a working phone on the previous evening but it was now not working. I am aware that Janssen will take or hide #1a phone so she could not call for help. #1a was concerned that Janssen would come back to assault her if he found out that she had talked to the Police. She had talked to the Police the day before and he may have been watching her.

#1a lock was broken from the outside and it needed to be replaced. An apartment manager had been contacted to see if they could do something with the lock, rather than force the door. An apartment handyman was able to open the door.

I immediately noticed that the apartment was in disarray. The interior was messy, clothes were turned over and littered the length of the hallway. The floor had trash and debris on it. This type of interior can be consistent with some type of struggle. It is also the exact opposite of how I had observed the apartment on the previous afternoon. This furthered my concern for #1a.

Officer Aitken and I asked #1a mother to wait outside. We wanted to check on #1a safety and make

sure that it was safe to be inside of the apartment.

Officer Aitken quickly discovered that a hole had been burrowed into the attic area of the apartment. The hole was not there the day before. There was also insulation leaking out of the hole and in the bedroom closet, where it was located. It appears that this hole was just made. You could see a broken/bent plastic tote, and broken/bent shelf, where it appeared someone had used these items like a ladder to get to the new hole in the ceiling. The hole appeared to be approximately 12"x12" square.

That hole was not in the ceiling when I was in #1a apartment on 06/29/15.

In the past when I have checked on #1a, she has mentioned that Janssen would sometimes hide in the attic. I and Officer Geren had previously checked the attic.

On the third floor landing and within eye sight of #1a door is a ladder which leads to the attic. It has a hatch which is not locked. The opening is to a service room where the ventilation is located. In the past I have found the plastic which holds the wall insulation in and provides access to the area above #1a apartment was open. I suspect that Janssen may hide up there to avoid capture but also to listen to #1a in her apartment.

We did not locate #1a. However given the new hole in the ceiling, and all of the previous information it was clear to me that Janssen had been inside of the apartment and he was now escaping into the attic.

I made my way up the attic ladder and opened the hatch. The service entrance was on the landing within eye sight #1a front door. Upon entering the service area I made my way to the where the plastic had been opened before. I could see light in the attic from where Janssen had made a hole in the ceiling.

I made several announcements that Janssen needed to surrender and that he was under arrest. I heard Officer Aitken and Det. Palmer make announcements as well.

More Officer's were requested and a supervisor.

Officer Johnson and Officer Childress arrived.

The remaining two apartments on the third floor were evacuated. The occupants granted Officers consent to their apartments and the doors to those apartments were left open.

Officer Johnson made his way along the trusses in the attic to the hole made by Jannsen. He advised that he could see foot prints in the insulation heading away from the hole.

It was very hot, more than 100 degrees F, in the service area and even worse in the attic. It felt like looking into a hairdryer when I would move the plastic to look into the attic space. After just a few minutes in the service area I would be covered in sweat.

A K9 was requested.

#1a mother had left to look for her daughter. I gave her a business card and I asked her to call me when she located #1a. It should be noted that we had not found #1a #1a was missing and the man who has caused her violence in the past was now likely going to great lengths to avoid being arrested.

A Sheriff's Office K9 responded, but he was unable to send his dog into the crawlspace. He was aware that the City had dogs which could be sent into the space. The K9 Officer did take his dog to a service entrance to the North side of the attic. The dog barked and he made announcements. He believed that his dog was indicating that someone was hiding in the attic.

After the Sheriff's K9 stopped making announcements. I could hear noises that sounded like someone sliding along in the attic. The noises were coming from the area outside of #1a apartment door.

A short time later, Supervisor Hartman responded to the scene.

Multiple ERU Officers/Supervisor's responded to the scene, as well as City K9 Officer, and two Police Negotiators.

Officer's made multiple attempts to establish communications. It was clearly verbally explained to Janssen that he was under arrest and that he was putting himself in danger by staying in the attic. The heat in the attic, combined with the time that Janssen was in the attic, made me concerned for Janssen's health. I did not know how long a person could stay in the extreme heat without access to fresh cool air and water. The space was small enough that Janssen could not avoid hearing Officer's announcements.

Janssen did not respond to Officer's verbal requests. He did not respond to a K9 contact (dog bite). He did yell out but he did not surrender. Janssen also did not surrender after a taser application. Janssen's unwillingness to surrender or follow commands put himself and multiple Officer's at risk during his apprehension. There is always the concern that someone trying to avoid capture may be armed as well as hiding, or lying in wait to ambush an Officer or K9 dog.

Officer's eventually had to physically walk out into the attic and restrain Janssen. Janssen's decisions put Officers and himself at risk of injury. Officer's attempted to walk Janssen to the attic service door. The ceiling in apartment 302 gave way. Janssen was lowered through the hole in the ceiling and immediately handed off to medics who were awaiting him. Janssen had now been in the attic for approximately 3-4 hours.

SPD Supervisor's contacted Spokane Risk Management and the apartment Management about the damage to the ceiling.

#1a mother called me to let me know that she had contacted #1a #1a was in the Spokane Valley with a friend and that she would be responding to the Mallon address. #1a mother also told me that #1a received text messages from Janssen, where Janssen had told #1a that he was inside of her apartment.

A short time later the victim, #1a responded to scene. She showed me a text message from 509-955-1068. The message was received at approximately 0601 hours today. The message read something to the effect of, "I am sorry #1a I flipped out again the house is fucked up again." There was also a message from approximately 0949 hours which read something to the effect of that the cops were there and they wouldn't stop knocking. Cpl Beckley took photo's of those text messages.

#1a told me that she had gone to #1a home in the Valley on the previous night because she felt uneasy about staying at home. She had to leave the door unlocked because she could not lock it

On 6-30-15 I was working in my primary function as the Sgt. for the SPD Targeted Crimes Unit. At 1212 hours on that day I received a call from Sgt. Jason Hartman requesting I respond to #1d to consult with him about a suspect patrol officers and members of the DV unit were attempting to arrest. (In addition to supervising the TCU am currently the senior team leader for the SPD Emergency Response Unit.)

The suspect Travis Janssen had crawled through a hole in the ceiling of the victim's apartment to evade police and was hiding in an addict above the third floor. He was wanted for first degree robbery and first degree burglary along with numerous other crimes. He had been armed with a firearm in a past incident and had committed Residential burglary today. He had been in the addict for over an hour when I arrived, temperatures outside were nearing 100 degrees and in the addict they were most likely reaching life threatening levels. While this incident had all of the normal problems present when you have a determined suspect with a history of violence barricading himself, the temperature issues exacerbated those conditions with the threats they posed not just to the suspect but to the officers in the addict who were attempting to affect his arrest.

I and other ERU members supplemented the patrol and ERU members already on scene. Due to the temperature issues we had hostage negotiators continue attempts to talk him out, (patrol had been trying for some time) and began to implement more active plans to get him out of the addict. Up to this point the suspect made no indications he was willing to comply or even take measures to protect his own life by leaving the attic.

The incident was formally passed to ERU. Sgt. Austin and I discussed with others our options for removing the suspect. Not only were we concerned for the suspect in the extreme heat, but the ability of officers to work in that space severely compromised their safety. The heat itself and poor quality air, dehydration and falling through the ceiling (whether to the floor below, down the three story stairwell or three floors to the ground) were all concerns we were dealing with.

The suspect had made no attempts to communicate with us and we were concerned he was incapable of moving himself to us or surrendering.

Officers in the attic had a general idea of the suspect's location so we attempted to make contact with him by making small holes in the ceiling. When officers made the holes the suspect immediately attempted to get farther away and made no indication he was going to comply with our requests. We inserted a K9 team to the attic and made K9 announcements. When the suspect heard the dog he began to move; and from the position I had taken in the attic I was able to observe him attempting to conceal himself under some pipes and insulation. The dog was inserted, see K9 rpt.

The dog was recalled after a contact and the suspect verbally indicated he wanted to surrender, however I could see he was physically making no attempt to comply and in fact was positioning himself to fend off the dog if he was re-inserted. Again we both pleaded and directed the suspect to surrender and explained he needed to comply as his life was in danger if he remained in the attic. He continued to verbally indicate he was hurt and wanted to comply while physically trying to improve his position. He could not see us and did not know we were observing him.

Considering the crimes he had committed and was committing, his history of violence and being armed, the lack of compliance during this incident combined with his deception and active attempts to thwart us, the danger he posed to himself, the danger he posed to officers, the danger officers faced by remaining in the attic from both temperature and gravity related threats and his ability to resist the K9 contact we decided to take a more proactive approach to getting him out of the attic. We put larger holes in the ceiling to both remove him and or vent the confined space. This tactic posed a great risk to officers as they had no cover or ability to conceal themselves and exposed them to structural dangers as well as threats from the suspect.

The suspect who had again grown quiet and unresponsive immediately fled from the holes being cut in the ceiling and rapidly moved over and around the attic trusses, ducts and wiring away from the officers. He made it to a separate portion of the attic and secreted himself in the farthest point away from officers over a soffit again burrowing himself under insulation and now lying in space over three stories above the ground.

Myself, officers Johnson, Kerncamp and Hewitt moved into the new space and moved to his location. This area was more open although we still had to move from truss to truss and could not stand but had to crawl and or squat as we moved. The suspect continued to ignore us and concerns for his health were increasing.

Again we attempted verbal communication, we could see him, his eyes were open and he ignored us. We deployed a Taser which caused him to move but he still refused to comply with our directions. We made another attempt with the Taser and again he refused to comply. We then moved to him, grabbed him and pulled him out of the space over the soffit, he struggled violently and we were in fear his resistance would drop him through the attic floor. He kicked at us, hitting me in the shin, causing no injury but pain.

Eventually we were able to handcuff him through the use of arm control, strikes, (I delivered two to his torso) an attempted LVNR and upper body control. Once cuffed I began to pull him back to the crawl space (crawling between trusses, as there was no room for more than one man to maneuver on the path back to the attic opening). He continued to resist my efforts, at times hooking his feet on the trusses which had to be removed by the other officers. He also twisted about even though I explained numerous times he was going to drop us through the ceiling. I pulled him the length of the north portion of the apartments, about 20 to 30 yards, just as we got to the crawl space opening his thrashing about caused he and I to fall through the ceiling. I was able to hook a truss with one arm and hold him with the other. His legs were still over a different truss and my right foot caught on some insulated wiring still attached to the electrical system.

Officers below quickly moved to us and supported my feet and legs and then we were able to lower him down to waiting officers with no further injury to us.

He was immediately taken by medics who were standing by.

On 06-03-15 at approx. 1145 hrs, Sgt. Hartman requested an on-duty Emergency Response Unit Team Leader to respond to [REDACTED] #1d in reference to a wanted male who had barricaded himself in the attic of the complex. The initial call came to Sgt. Terry Preuninger, who advised me of the incident. On that day I was at my daily duties as the Special Investigations Unit supervisor, but also an on-duty ERU team leader. Ofc. J. Kernkamp was also an on-duty ERU officer and responded with me to the address.

Upon arrival at the address I noted that the building was a 3 story multi-unit apartment building. I was contacted by Sgt. Hartman. Sgt. Preuninger joined us just a short time later. I was advised by Sgt. Hartman that DV unit officers had responded to the building on an on-going domestic violence issue between Travis Janssen and his girlfriend. The DV Unit had developed probable cause from a call the day before to charge Janssen with Burglary 1st DV, Robbery 1st DV, and Felony Order Violation. In addition there was PC to charge him with Residential Burglary DV for today's incident. I was told that none of the crimes involved a firearm, but it was unknown if he could be in possession of one today. He further advised that Janssen called the victim from her apartment on the Mallon address today and when officers arrived at the scene they found a hole in apartment #303 leading to the attic area, officer had also heard someone moving in the attic area of the building. Search consent had been given by the victim, and renter of the apt. #303.

I moved to the 3<sup>rd</sup> floor to begin evaluating the situation. I found that officers had already cleared the third floor apartments and were maintaining visual cover on the attic opening as well as the hole the suspect used to gain access to the attic. On-scene officers pointed to a location in the attic, near the top of the stairs that they had last heard movement. On duty ERU officer's Kyle Heuett and Chris Johnson had arrived at the location prior to my arrival and had taken position at the main attic opening. This opening lead to a small landing area. From this area, there was a small opening that lead into the main attic over the building. There had been multiple attempts from officers at the scene to communicate with Janssen but he would not respond. At the time of my response to the scene, Janssen had been in the attic for nearly an hour. It was approx. 100 degrees outside, and I estimated the attic area was at least 150 degrees.

In my initial evaluation, I believed there were two main safety concerns. The first concern was for officer safety in the physical arrest of Janssen. Janssen was wanted for high level felony DV crimes. In two of the crimes, he had used assaultive force against the victim. It was now unknown if Janssen had armed himself with some type of deadly weapon. Janssen was actively evading police and had secreted himself in an area that was unknown to officers at the scene and had been in this area for enough time that he could easily have created a plan to ambush or assault officers upon their entry into the attic area. The temperature of the attic was also of great

concern to the officer's on-scene. Officers were wearing heavy protective gear and would be limited to the amount of time they could effectively work in the environment.

My second concern was for Janssen's safety in the attic due to the temperature. When I initially entered the attic access area, I immediately began sweating based on the extreme increase in temperature. While Janssen had already been in the attic for an extended period of time (little over an hour) without fluids, he could eventually pass out due to heat exposure.

Sgt. Preuninger and I would constantly discuss and make decisions and evaluations based upon these two primary concerns. Based on the health concerns, we had SFD medic's stage on the 2<sup>nd</sup> floor of the building for a quick response. ERU Ofc. Kernkamp is also a certified EMT and heavily involved in the operation.

Because of the safety issues of Janssen barricading himself in the attic, it was determined that ERU would handle the arrest of Janssen. I notified ERU Commander Wohl and Assistant Commander Keller, who both authorized the operation and responded to the scene. The total number of ERU officers at the scene was 8. They were Lt. Wohl, Sgt. Keller, Sgt. Preuninger, Ofc. Jernkamp, Ofc. Heuett, Ofc. Johnson, K9 Ofc. Jensen and myself. Ofc. Pavlischak would respond later. Included in the ERU response was crisis negotiators Ofc. Gately and Det. Hill.

We again had the CNT officers attempt to communicate with Janssen. He again would not respond. After the multiple attempts at communication, Sgt. Preuninger had Heuett and Johnson remove some drywall in the attic access area in an attempt to locate Janssen. Once they did this, we were able to see where Janssen had secreted himself. Janssen was about 30 feet from us and had buried himself in the insulation. He was facing the attic opening and his hands were not visible. More verbal communication was attempted with negative results. I told Janssen I was concerned for his safety and wanted to get him to a cooler place where he could have get some water and then give his side of the story. He still would not respond and then appeared to be covering himself with more insulation. After this did not work, we had Ofc. Jensen move his K9 partner into the attic access area and attempt to get Janssen to surrender to the threatened use of the K9 to apprehend him. This tactic also did not get a response from Janssen.

Based on Janssen's continued lack of cooperation and his continued attempts to hide from officers, I decided to attempt to open holes in the ceiling drywall in the general area that Janssen was. This option was to see if Janssen would have a response to the action and could also get some limited fresh, cooler air into the attic. I initially poked small 2 inch by 4 inch holes in the ceiling drywall using a fire pick tool. After several of these holes, Janssen suddenly moved slightly to the east in the attic, and I was advised that he seemed to again be making a defensive position in the insulation. Janssen's quick movement showed me that he was still cognitive and able to make decisions. This brought my officer safety concerns back to being of more consequential then that of the health concerns for Janssen.

Based on the severity of the crimes Janssen was wanted for, his continued refusal to surrender, and the fact that we still did not know if he was armed, I believed the use of a K9 was justified and warranted. My breaching of the holes in the ceiling was at approx. 1250 hrs, nearly an hour and forty minutes after Janssen was located in the attic. We had attempted multiple negotiations and talks with him during that time with no success.

Ofc. Jensen used his police K9 in an attempt to capture Janssen. See his report for further details. Janssen was contacted by the police K9, but this also did not get him to surrender to officers. Janssen had kicked at the dog and once the dog was recalled to Ofc. Jensen, he again took up a defensive position in relation to the officers in the attic.

Next we decided to breach a larger hole in the ceiling drywall, this time directly under where Jansen was believed to be. This again would elicit a response from Janssen, provide cooler air and possibly allow us to overwhelm his thought process while giving us an opportunity to grab him from below or have officers move on him inside the attic area to detain him.

At approx. 1316 hrs. once everyone was ready, ofc. Kernkamp and I used fire poles to begin breaching the area directly under where Janssen was (we had placed a mattress on the ground beneath this area just in case he fell out of the ceiling). We were able to cut a large, approx. 3 foot by 3 foot hole in the ceiling drywall. The hole ended up being directly under Janssen's feet and leg area. Janssen started to kick at the fire poles in an attempt to get us to stop our actions. Janssen also began to try and move away from the hole. The ceiling was just high enough that I was not able to grab onto Janssen. I used the hook on the fire pole in an attempt to grab his shoes, but was not successful. Janssen was able to move further to the north in the attic away from our location.

Sgt. Preuniger, Ofc. Kernkamp, Ofc. Heuett and Ofc. Johnson moved deeper into the attic after Janssen. At 1331 hrs, they were able to take Janssen into custody. See their reports for further information.

Once Janssen was in-custody, they began to move him towards the attic opening. They were not able to make it all the way and began to fall through the ceiling in one of the apartments. We assisted in getting Janssen down safely, where medics tended to him immediately.

Photos of the damage done to the building were taken. DV unit officers again took over the investigation.

On 063015 at approximately 1145 hours Sgt. Austin and I responded to #1d reference a male that had barricaded himself in the attic of a large multi-level apartment complex.

This address is very well known to Officers with frequent calls for service and violent wanted persons. In addition to housing numerous young children with a playground in the center courtyard.

Upon arrival Sgt. Hartman and other officers advised us that Travis Janssen was hiding in the attic. Officers attempted to arrest him around 0928 hours in apartment #303. He did not come to the door. Janssen had broken out the sheetrock in the ceiling of the apartment and crawled into the attic, making his way through the complex, near the area above the stairway. This also gave him access to the entire upper level of apartments. This particular attic space also gave access to the eve of the roof. This created several factors of concern, primarily the concern of him falling through the roof vents in addition to giving him access to other person's apartments.

Officers advised they had PC to arrest Janssen for 1<sup>st</sup> degree Robbery, 1<sup>st</sup> Degree Burglary, and Felony Order Violation. He refused to respond to Officers attempting to negotiate with him through an opening in the attic. Officer Kelly Gately, a member of the Hostage Negotiator Team responded and attempted to negotiate with him. She explained to Janssen that the exposure to such warm temperatures was hazardous to his health, and may be life threatening. He needed to surrender for his own safety.

This was a very dangerous situation on multiple levels. Primarily because of the charges. Janssen had been armed with a weapon and used force already,

and was actively trying to avoid capture. This situation was very tense and uncertain, with his behavior being very unpredictable. In addition to the internal temperature. It was nearly 100 degrees outside. Inside the attic with blown in insulation the temperature was nearly 50-80 degrees warmer, making unbearable.

Once we were on scene, our concern was Janssen being exposed to such warm temperatures without any source of water or other fluids to rehydrate. It was unknown if he was armed and he has a history of drugs and alcohol abuse. It was determined he was too dangerous to be left hiding in the attic and that for his own safety and the safety of the citizens in the complex, including the children and victim of the order, he needed to be apprehended and/or rescued.

After multiple attempts to negotiate with Janssen, he refused to acknowledge any verbal stimuli. It appeared he was extremely paranoid. Any attempt we made to speak to him or opening view ports in the sheet rock wall he continued to back himself into corner and cover himself with insulation. His behavior was extremely erratic and his safety and well-being became a great concern with temperatures nearing 150 degrees in the attic for nearly 4 hours.

Ofc. Jensen deployed his K9 in attempt to capture Janssen. See his additional.

Sgt. Austin and I attempted to open holes in the ceiling, in attempt to locate his whereabouts in relation to the roof line and stairways. We did not want to put him at any further risk of being possibly injured. This was also way to provide with him fresh air, cooler temperatures and Officers access in case of a medical emergency.

Officer Gately continued the entire time to get Janssen to surrender. He refused to acknowledge her. As Sgt. Austin and I were venting the ceiling, Janssen started to kick at our tools, pushing us further back. At the same time he started crawling very quickly over the access room of the attic over a stairway and into a different portion of the complex. He continued to crawl nearly 50 yards into the far north east wing of the complex's attic.

Janssen was so far away it was unknown if he could hear us. His body appeared to be very sweaty as he had stripped off most of his clothing. The effects of the high temperatures were starting to take effect. Blown in insulation was coating his entire body because of perspiration.

Sgt. Preuninger and I determined that this no longer became a mission of arrest. Rather, a mission to safely rescue Janssen from himself and the elements. At this time he had been exposed to attic temperatures for nearly 4 hours without anything to drink, under the influence of Methamphetamine, and

appeared to be very paranoid. We feared if an attempt to flee, he would perish if his body started to shut down. Also from training and experience, we also feared he may be suffering from Excited Delirium. He needed medical attention as soon as possible without any other persons getting hurt. Sgt. Preuninger and I along with other Officers made a decision to retrieve Janssen for his own safety. We did not want him to lose consciousness, fall through the vents in the eaves, and/or continue to evade the Police, placing him at a great risk.

Sgt. Preuninger continued to ask Janssen to crawl out to Officers so that we could give him some water. At this point we were very concerned about getting him into cooler elements. I could visually see Janssen in the far north east corner. His back was to the vertical exterior wall and his feet and hands were in front of him. His face and body from sweat were covered in insulation.

Sgt. Preuninger continued verbals with him as I crawled around the eaves through the roof joists to get closer. Once I was within 12 feet away, I observed he did not have any weapons in his hands, however had placed himself in a fighting position, ready to defend himself, with arms and legs out in front of him. Sgt. Preuninger continued to talk him. He never once responded.

Officer Heuett came up to my location. This attic was very hot, dark and dangerous working conditions. Officers were unable to stand and the rafters whereabouts were unknown due to the thickness of the blown in insulation.

Officer Heuett and I attempted to move closer to Janssen, placing him in arm control. However with his sitting position, he balled up his fists and put his legs up as if he was going to kick at Officers. It was clear he was going to refuse our assistance in helping him get down, and was going to be confrontational.

Janssen refused to listen to Officers and surrender. He continued to fight and not follow verbal commands. He was subsequently tased in order to safely take him into custody.

#### **Severity of Crime:**

- Janssen was wanted for 1<sup>st</sup> Degree Robbery, where he had used physical force to obtain a victim's property.
- He was also wanted for 1<sup>st</sup> Degree Burglary where he entered a building and remained unlawfully while possibly being armed with a weapon and/or assaulting another victim.
- He had repeatedly violated a valid DV-No Contact Order placing the victim in danger repeatedly.
- Refusing to surrender to Officers
- Actively trying to flee from Officers in the attic

-Covering himself with insulation to attempting to conceal his body.

**Threats to Officer/Public:**

- Actively fleeing from Officers.
- Has recently committed violent crimes of 1<sup>st</sup> Robbery and 1<sup>st</sup> Burglary
- Refusing to negotiate with Officers and acknowledge any commands.
- Placing himself in a position of advantage over Officers in attic.
- Officers being aware if he was armed or not with not being able to see his hands.
- Dangerously hot working conditions well over 100 degrees for an extended period of time.
- A workspace in an attic with limited visibility, no lighting, unsecure footing prohibiting proper protective stance.
- Dangers of falling through the sheetrock into a stairway or eve of rooftop on a 3 story building.

**Resistance:**

- Janssen refused to answer the door initially to Officers.
- Janssen broke a hole in the ceiling of apartment #303 to flee from Officers.
- He refused to surrender to Officers after hiding in the attic for hours.
- Janssen refused to surrender after a K9 contact.
- Janssen placed himself in a fighting position any chance he could.
- Janssen refused to listen to commands after being tased.
- Janssen kicked at Officers assisting to help rescue him.
- Janssen used his body to leverage and brace himself, working against Officers trying to rescue him.

Sgt. Preuninger and I developed a plan to deploy a taser. This would allow Officer Heuett and myself to close distance and take arm control, minimizing any potential risk for physical confrontation. I advised "Index", indicating a taser was going to be deployed. I aimed for his midsection and deployed the taser. This was a successful initially. It brought Janssen out of the corner where he had placed himself in a position of advantage to fight with officers and closer to us, and away from roof overhang. The conditions were still extremely dangerous, not knowing where the rafters were.

The entire time Sgt. Preuninger was advising him to crawl to us. Janssen refused. Officers were still in a position of disadvantage and could not safely reach Janssen. A second deployment of the taser was deployed to prevent any fighting in limited, unstable working conditions. Janssen starting moving towards

Officers then stopped. He pupils were fixed and he appeared to be staring us down as if he wanted a confrontation. We explained to him we were trying to get him down so that he did not perish in the extreme conditions of the attic.

Janssen was now approximately 4 feet away from us on all fours. He was pawing at the blown insulation like he was a bull ready to charge us. He started to splash his face with insulation as if he was using water. This created a very dusty and hazardous working environment and forced me several times to shield my eyes and face, in fear of getting insulation thrown in my face.

Janssen still refused to follow commands to crawl to us. At this time the probes from the taser were still attached. I deployed the taser again. This application again was very successful. With this application, it took Janssen out of a fighting position on all fours up to his knees. This allowed Officers to close distance and take arm control. Officer Heuett took right arm control and Sgt. Preuninger attempted to take left arm control. However due to the limited working conditions, the unstable environment and Janssen continuing to thrash around I applied a neck restraint to control his body motion as all officers were bracing themselves on limited access to the rafters. Janssen did not lose consciousness and Officers were able to handcuff (DL) him without incident.

Once handcuffed, Sgt Preuninger was at his head and torso, I was near his feet. We started to escort Janssen out of the rafter space. He refused to assist, and any hard object he could brace his body against to fight us, he did. At one point he was kicking at me to prevent access to his feet and legs, forcing a great strain on Sgt. Preuninger.

This space was very confined and unstable. All hard and safe objects to walk on was covered in six inches of blown in insulation. During the struggle there were two times I placed my hand through the insulation, digging for dropped equipment, only to get shocked by a live/hot wire.

There was only one entrance into the attic and our goal was to escort Janssen to that 2x2 foot entrance and hand him off to other Officers. This escort was nearly 30 yards, working on our knees and prone positioning to fit through the beams and rafters that Janssen had crawled through.

Once we were within a couple of feet to the entrance there was lumber placed on the ground, not secured to anything with blown in insulation covering it. We were using that to safely guide our way out to get Janssen the medical attention he needed. By now SFD medics were staged at the top of the stairs ready to receive Janssen.

However the board was not attached to any cross beams and the sheet rock started to give away. I heard several crack and my feet started to slip. Before I



could react the sheetrock gave away and Sgt. Preuninger and I started to fall through. The entire time trying to brace Janssen from falling through as he lay perpendicular to the beams. Officers from the top and from the bottom were able to suspend Sgt. Preuninger and hold the remainder of the sheet rock up long enough for me to brace myself on the rafters with my legs.

This environment became very tense, uncertain and rapidly evolving. While still trying to get Janssen the medical attention he needed, protect ourselves from falling through to the ground.

We explained to Janssen who had yet responded verbally to Officers at all, that we were going to guide him down through the rafters and hand him off to medics waiting below. He started kicking and bracing his legs up against the rafters. This placed Sgt. Preuninger at a greater risk of continuing to fall at least 8 feet. I applied three hammer strikes to the inner left thigh of Janssen as a distraction technique, allowing me to free his feet from the rafter and guiding them through an opening. I then placed them in the hands of receiving parties down below who assisted in guiding him down. If I had not interrupted the fighting thought process Sgt. Preuninger would have placed in great danger of falling through the roof.

Once Janssen was safely down, Officer Johnson and I assisted Sgt. Preuninger to secure rafters where he was able to crawl out. Janssen was transported to the hospital via AMR.

Although I was not severely injured I was completely exhausted from working in such an environment and suffered several scrapes and bruises on my legs, inner thighs from falling through the sheetrock and bracing myself.

Sgt. Preuninger and I both agreed that this medical rescue was needed to prevent Janssen from becoming a victim of the elements.

Janssen was transported to Deaconess Medical Center where he was treated and subsequently booked into jail.

The crime of Felony Violation of a DV-No Contact Order, 1<sup>st</sup> Degree Robbery, and 1<sup>st</sup> Degree Burglary was committed in the City of Spokane on 06/25/2015 at approx. 1709 hrs by Travis A. Janssen W/M 10/05/1977.



3. Advise that you need to call hotline and you would like for victim to speak with counselor.

4. If victim does not want to speak with counselor, tell victim you need to speak with counselor to seek guidance and gently ask victim to reconsider.
5. If victim still does not want to speak with counselor, use same procedures as in first response.
6. If victim wants to leave, arrange for or provide transportation.
7. Assist counselor with safety planning if asked.
8. Notify domestic violence unit or supervisor.
9. Prepare report.

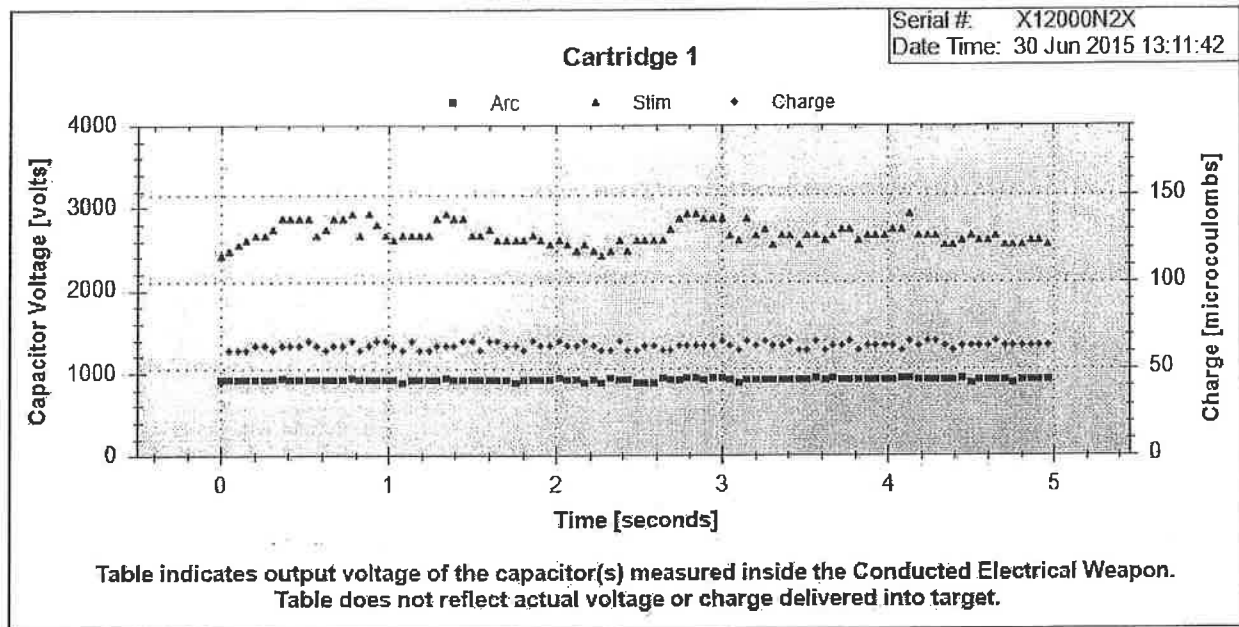

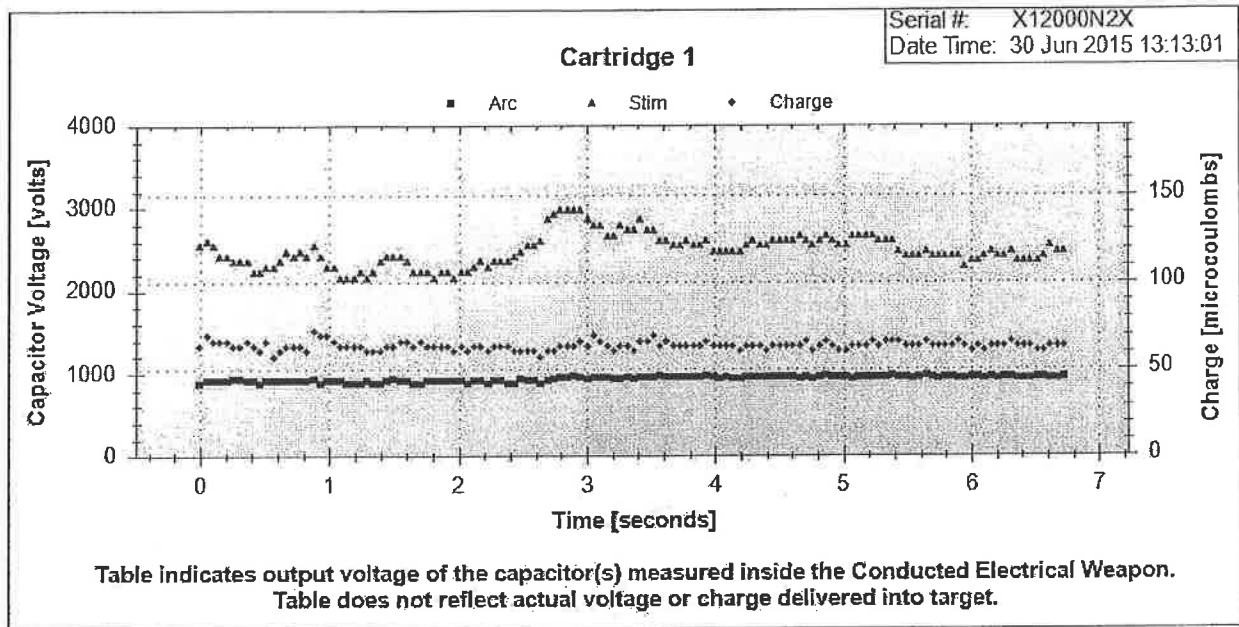

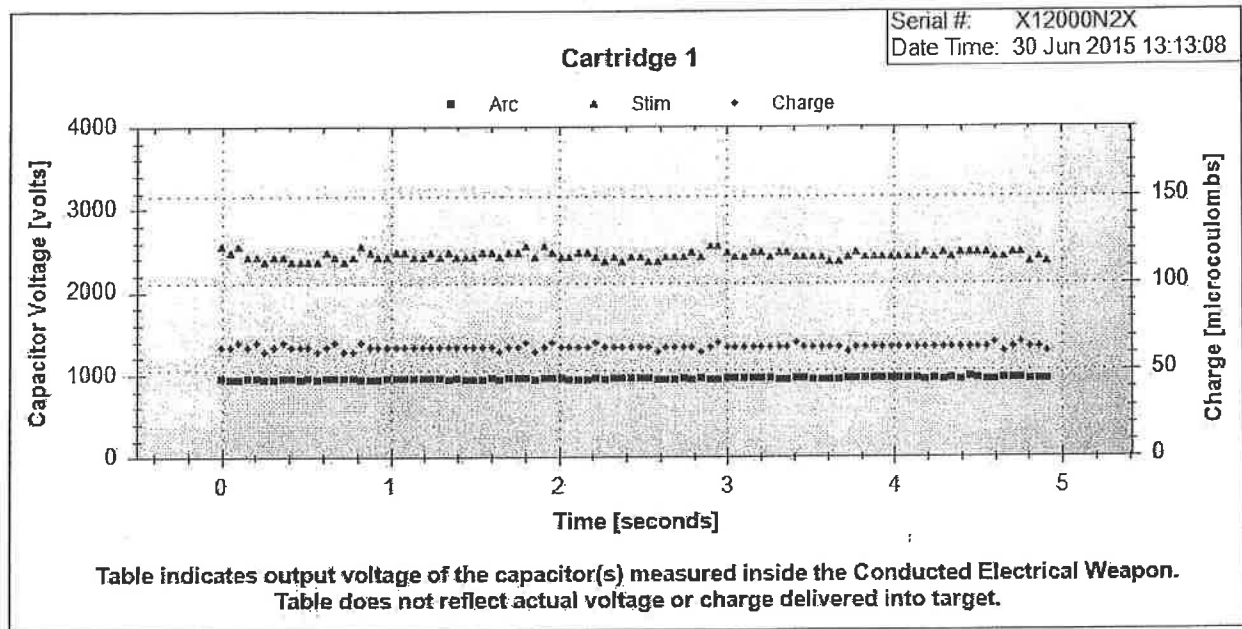
