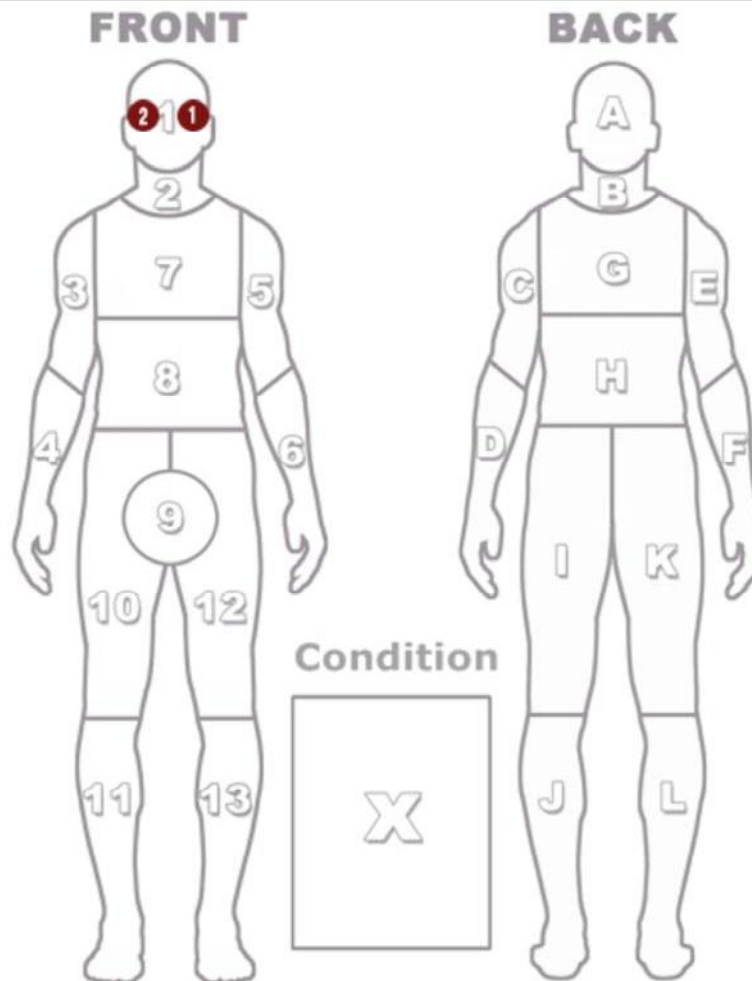

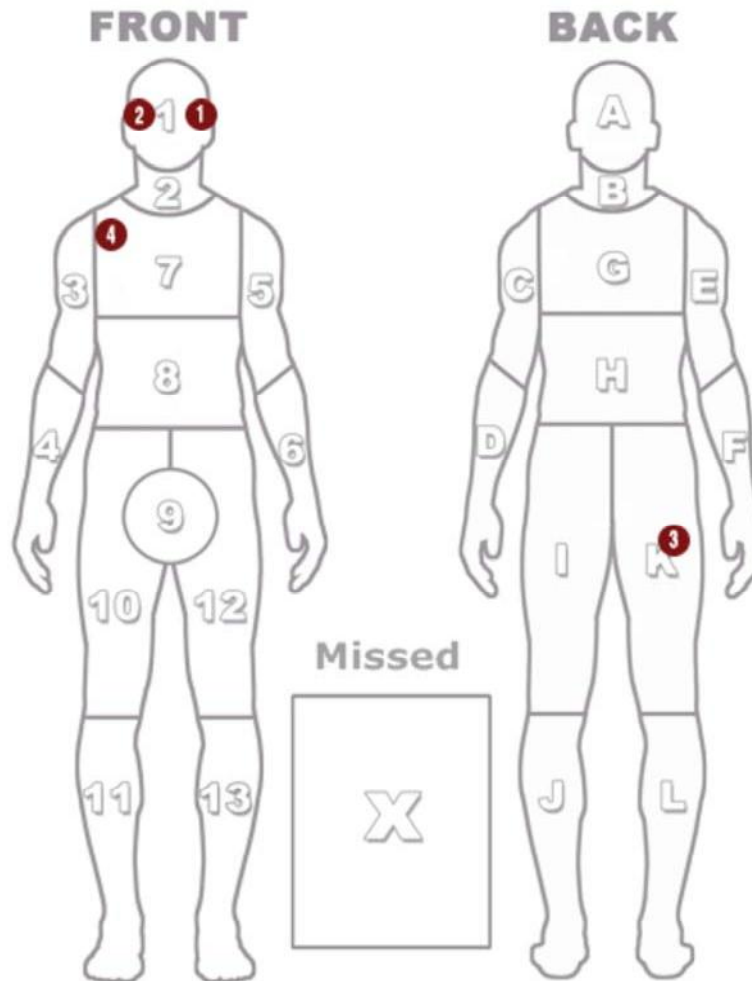

I believe it would be appropriate for his supervisor to have a discussion with him about waiting for back up prior to going hands on. They require a higher level of scrutiny and justification. In this instance, I concur with the chain of command that Ofc Conrath exercised poor discretion when he decided to initiate hands on without waiting for backup. This placed him in a more dangerous position than had he waited for backup. Though within policy, training with a DT instructor on proper method of strikes as well as ensuring safer deployment (waiting for backup), is the appropriate remedy. The documentation of counseling addresses this remedy.

**Complaint Being Investigated**

Use of Force

**Complainant Interview Summary**

I interviewed Justin Mager at Deaconess Hospital about this incident. In asking Mr. Mager what happened he stated he was "fucked up on meth" and he "thought he was dead". He was "flipping out", "lying on the ground kicking the wall". He was hallucinating and did believe the officer was real. He stated he did not think he deserved this (He did not elaborate on this). Mr. Mager did not remember any commands. He did not remember following any commands. He stated he was not injured during the incident besides the cut on his eye. When asked about being Tased he stated this saved him. I asked what he meant by this and he stated it brought him back to life. I checked his chest area where Officer Conrath stated touch stun was done and I did not see anything. He indicated he was hit in the upper leg by the probes. I requested to have the doctor check for injuries and at that time we could obtain pictures.

**Officer Interview Summary**

Officer Conrath responded to a disorderly subject refusing to leave. He contacted Mr. Mager in the entry way of the Carlisle and asked him to leave. Mr. Mager's responded with "Fuck you". Officer Conrath attempted to reason with Mr. Mager telling him he could leave on his own or he would make him leave. Mr. Mager responded with "Fuck You, make me leave". Officer Conrath attempted to take arm control and Mr. Mager responded by striking Officer Conrath in the upper body with 2 to 3 closed fists strikes. Officer Conrath was not injured by this. In a tense and uncertain and rapidly evolving situation Officer Conrath responded with 2 closed fist strikes to Mr. Mager's face followed by a probe TASER application and a touch stun. Mr. Mager was then taken into custody.

**Witness Interview Summary**

Witness Malachi Summerhill, an employee at the Carlisle, was alerted that Mr. Mager was attempting to gain entry into the building. Mr. Mager was stopped before he entered the 2<sup>nd</sup> door to the building and he refused to leave. Mr. Mager's stated he was on meth and he did not care if police were called. Officer Conrath talked to Mr. Mager for about 1 to 2 minutes trying to get him to leave before attempting to take control of Mr. Mager. Mr. Mager pulled away from

Officer Conrath and hit him 2 or 3 times. Officer Conrath then hit Mr. Mager in the face and Tased him. Officer Conrath then wrestled Mr. Mager for a short time getting him into custody. He felt Officer Conrath used the TASER as a last resort when he could not control Mr. Mager after he tried to hit him.

Witness Josophine Lindsey said Mr. Mager was asked to leave and he refused and continued trying to get into the building. Officer Conrath talked to Mr. Mager in a calm manner and she turned away. She turned back around and Officer Conrath had a TASER in hand. She did not see what occurred between the initial contact and the TASER application.

### **Physical Evidence**

### **Investigative Summary**

Officer Conrath contacted Mr. Mager, high on Meth, who was refusing to leave an apartment building where he did not live. Mr. Mager was asked to leave and he responded with "Fuck you" now committing the crime of trespassing. Officer Conrath attempted to reason with Mr. Mager for a short time (1 to 2 minutes) and Mr. Mager responded with "Fuck You, make me leave". Officer Conrath took arm control in order to get Mr. Mager up and escort out of the building. Mr. Mager responded by hitting Officer Conrath in the upper body with closed fists 2 to 3 times. Officer Conrath then used force for the following reasons:

Crime: Officer Conrath was investigating a 1\* Trespass and now the subject had actively assaulted him.

Threat: Mr. Mager advised he was on meth, a controlled substance. Mr. Mager was asked to leave the property and he responded with "Fuck you". He was advised he would be removed and he responded with "Fuck You, make me leave". Officer Conrath was acting by himself and Mr. Mager had not been searched at this time. It's unknown why Mr. Mager was in the building.

Resistance: Mr. Mager refused verbal commands to leave, he advised the officer would have to make him leave. When Officer Conrath attempted to take arm control of Mr. Mager he hit Officer Conrath in the arms and legs with closed fists, assaulting Officer Conrath.

After being hit, Officer Conrath responded by hitting Mr. Mager in the face with two closed hand strikes impacting on the right and left eye respectively. Officer Conrath gave verbal commands to, "Stop fighting and get on your stomach". Mr. Mager then grabbed onto Officer Conrath's sleeve and began pulling him down. Fearing the altercation was escalating, Officer Conrath deployed his TASER for the following reasons:

Crime: 3\* Assault

Threat: Mr. Mager was refusing to follow commands and stop fighting. He was now pulling Officer Conrath down engaging in a grappling confrontation. A grappling confrontation would expose Officer Conrath's duty equipment to Mr. Mager.

Resistance: Mr. Mager was actively assaulting a law enforcement officer and aggressing on the officer by pulling him down to him.

Officer Conrath delivered a 5 second Taser probe application to Mr. Mager's right thigh followed by a touch stun to his right upper shoulder. There was little affect by this application and a second application 5 second application was applied. He was then able to take Mr. Mager into custody.

In looking at the TASER data, it appears the first application was sporadic in completing a circuit, and thus not effective. This appears to have been caused by the clothing Mr. Mager was wearing as the probes were caught in his clothing.

Officer Conrath responded to an assaultive subject with an active counter measure technique (Level II Strikes) creating a disruption in the subjects mental capacity for a short period of time. Mr. Mager grabbed on to Officer Conrath's sleeve and pulled him in. Officer Conrath transitioned to a more effective tool, a TASER. A TASER may be used when a subject is violent and physically resisting (309.5.1). Two TASER applications were necessary to control Mr. Mager. Mr. Summerhill stated Mr. Mager was still non-compliant after he was Tased and had to be wrestled on the ground further showing Mr. Mager's intent. In Mr. Mager's own words he was "fucked up on meth' and flipping out. He stated the TASER application brought him back to life and saved him. Officer Conrath's actions are reasonable under 300.3.2 and within state law.

On the listed date and time, I responded to the Carlyle Apartments at 206 S Post St to a report of a disorderly male who was high on methamphetamine and refusing to leave. Employees had locked the inner door to the facility, containing the male to the area between the exterior door and an inner door.

Upon arrival, staff from inside the building pointed to the problem individual, later identified as Justin Mager. He was laying on the ground just outside the locked door. He layed on his back defiantly and stared at me with wide eyes. I identified myself as police and told him that he needed to leave. His response was, "Fuck you!" I advised him that he could leave on his own, or I would make him leave. Again, he yelled, "Fuck you! Make me leave!" We conversed for a few brief moments where I asked him what his issue was, and why he would not do what I asked. He justified his behaviors by telling me that he was on drugs. Finally, I told him very clearly that he was leaving. He said, "No I'm not." At that time, he was laying flat on his back and was becoming more agitated. Since he was still on the ground at that time, and even though my backup unit was not yet there, I elected to go hands on with him before I lost the tactical advantage. I reached for his left wrist in effort to gain control of his left arm and remove him. He pulled his wrist back into his body and balled his right fist as if he intended to punch me. I stood back and cautioned him, "Don't try to fight with me. If you do, you're probably going to get hurt." I reached for his left wrist again, but this time he began throwing closed fist punches at me with both fists. I estimate that about two or three of the punches landed. The punches impacted only the outside of my arms and lower body. I was uninjured, yet I was now dealing with him at very close range and was at risk of being punched in a location that could injure me. It was at that point that I elected to use force for the following reasons:

1. I was contacting Mager for the crime of Trespassing 1st Degree. He was reported by staff to have been high on some sort of drug, and was behaving in a "hostile" and generally disorderly manner. He was refusing to leave. The staff had to lock themselves inside the building because they were in fear of what Mager might do. In addition, he was actively committing a felony assault on an officer.

2. Despite my repeated advisements and polite instructions to simply leave the premises, Mager responded only with "fuck you!" He made it perfectly clear that he had no intention of cooperating. When two attempts at basic control techniques failed, Mager demonstrated assaultive behaviors by balling his fists and throwing multiple punches at me. He did in fact assault me, but I did not sustain any injuries.

3. Mager indicated both verbally and physically that he was not going to cooperate. After I attempted twice to use minimalist control techniques, Mager not only was physically resistive but actually assaulted me with multiple closed fist punches.

I determined that there was a need to contain Mager as quickly as reasonably possible for the safety of myself, others in the building, and for Mager as well. His actions had escalated to the point where I had no alternative but to respond with physical force. I delivered two closed fist strikes to Mager's face in rapid succession. The strikes impacted first his right eye, then his left. Though the strikes both landed solidly, his assaultive behaviors were not diminished. I gave clear instructions for him to stop fighting me, and to roll onto his stomach. He did not comply, and continued to punch at me. While he threw punches with his right fist, Mager grasped the right sleeve of my uniform and pulled me downward with his left hand. I heard the sound of the stitching tearing at the shoulder of my uniform. I was unsure exactly what Mager's intentions were at that point, but I interpreted his technique as similar to that which a trained fighter might use. I recognized that the situation was becoming more dangerous for me as I am not a strong ground fighter.

I was able to raise up and access my taser from its holster on my left thigh and transfer it to my right hand. I gave Mager another instruction to stop fighting with me. When he continued to punch and kick at me, I determined that a taser application was necessary. He was wearing a thick military surplus winter coat. It was likely that a taser application on the body would have minimal effect if any at all. I deployed the taser probes into the back of Mager's right thigh, then completed the circuit with a drive stun to his upper right shoulder/collar bone area. The taser application seemed to have a minimal effect, and after the five seconds, Mager began fighting again. I activated the taser a second time within seconds of the first application. I gave him very simple and clear instructions to "get on your belly!" The second taser application yielded better results. Mager finally complied. He said, "ok! ok! ok!" I had control of his right arm, and used it to roll him onto his stomach. It was at that point that I advised Mager he was under arrest. I transitioned to his left arm and applied handcuffs while he was in the prone position. The handcuffs were finger spaced and double-locked.

Medics were called, as was a supervisor. Mager had a small, open laceration above his left eye that later measured about 1.25cm at the hospital. He also had minor redness and swelling below his right eye. The taser probes did not appear to have penetrated Mager's skin. They were dangling loosely in his clothing. They were simply removed from the clothing and collected as evidence. Mager was transported to Deaconess Hospital where he was evaluated by medical staff and received three

stitches above his left eye. Doctors found no visible marks from the taser probes. Mager's injuries were later photographed by Cpl Daniel.

Sgt Kannberg completed the use of force report. Ofc Donaldson and Ofc Matthew responded to the scene at the Carlyle and contacted witnesses who were there for the incident. See their reports for additional information.

After being cleared medically at Deaconess, Mager was booked into County Jail for Criminal Trespass 1st Degree, and also for an outstanding felony DOC warrant. Though probable cause did exist for Assault 3rd, I elected not to charge him with that crime.

On 120915 at approximately 0132, I dispatched to 206 S Post (The Carlyle) to assist Officer Conrath. Ofc Conrath had responded to a trespasser. Shortly after Ofc Conrath arrived I heard him activate his police radio, but the radio traffic was garbled. Police Dispatch asked for a clarification and Ofc Conrath came on a few seconds later and said "Code 6."

I responded from 2nd and Hatch. I arrived on scene shortly after Ofc Conrath advised he had one person in custody.

I exited my patrol car and noted that Ofc Conrath was inside the vestibule of the Carlyle. He had a male restrained in the prone position. That male was identified as Justin Mager.

I walked into the vestibule and noted two shoes on the ground. I noted blood spatter on the wall of the vestibule to my right. I also noted a TASER on the ground with the cartridge removed. A spent TASER cartridge was lying on the ground near the TASER. Mager was laying near the TASER so I picked it up.

I noted two employees standing on the opposite side of the entrance doors from myself.

I contacted Malachi Summerhill. He told me the following in summary:

He was working that evening at the Carlyle. He was alerted by clients that Mager was trying to get into the building. He walked over and saw Mager inside the first set of doors. Mager is not a resident and told him to leave. Mager responded by laying down in the vestibule.

He noted Mager was acting strange and asked him if he was under the influence. Mager told him he was on 'meth.'

He told Mager several more times to leave and Mager demanded an ambulance. He told Mager that they would not do that for him and that the police would be called if he did not leave. Mager responded by saying he did not care if the police were called.

He witnessed Ofc Conrath attempt to detain Mager. Mager was laying on his back in the vestibule. Mager repeatedly pulled away from Ofc Conrath and seemed to try and hit Ofc Conrath. Ofc Conrath attempted to wrestle Mager onto his stomach. Mager would not comply and he witnessed Ofc Conrath apply a TASER to Mager. He thought the TASER had hit Mager in the arm or leg.

He felt Ofc Conrath used his TASER as a last resort when he could not control Mager after Mager tried to hit him.

The TASER allowed Ofc Conrath the ability to detain Mager. Even after being handcuffed Mager continued to resist and Ofc Conrath had to wrestle him onto his stomach.

Summerhill told me he was standing just inside the interior doors of the Carlyle. He was approximately ten feet from Ofc Conrath and Mager, viewing through a glass door. I noted the vestibule was well lit.

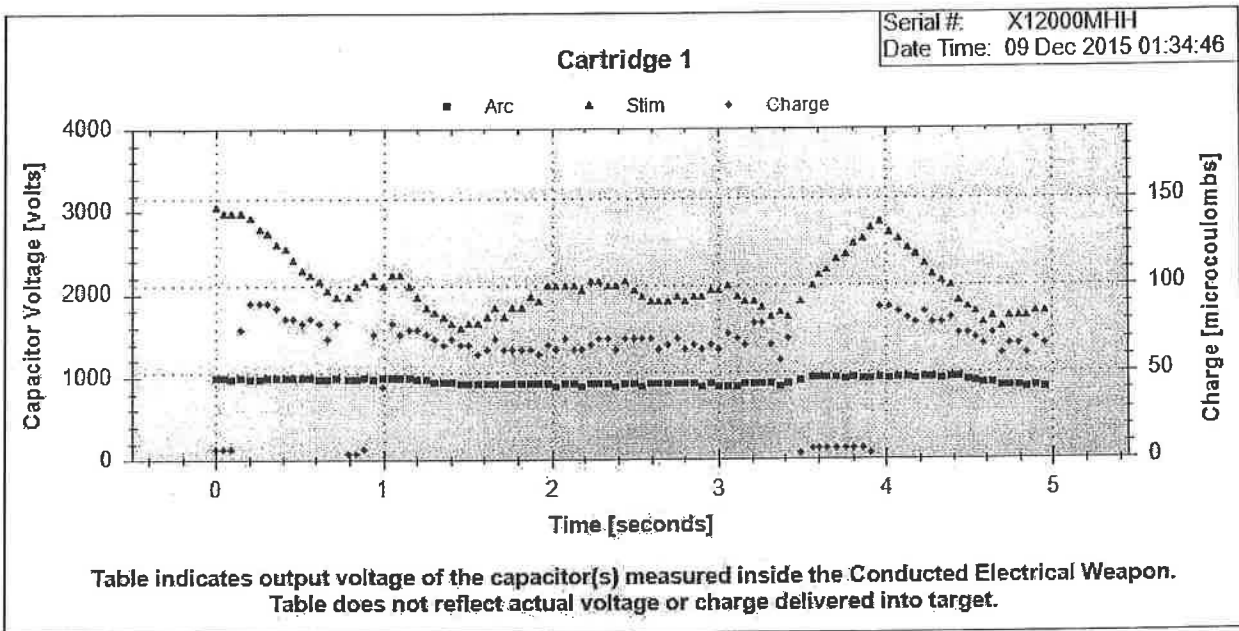
