



Report #16-009755

After reading the attached documentation and debriefing Ofc. Belitz I find that Ofc. Belitz's deployment of K-9 "Zeus" as a searching and apprehension tool was reasonable, within State and Federal Law, within Department Policy and met Department expectations.

Ofc. Belitz responded with Zeus and was advised by Officers that they had PC for Residential Burglary on the suspect, Shaver. He had also made threats that he had a gun and Officers saw him arm himself with a knife from the kitchen. He then barricaded himself in a bedroom. Officers had to force the door open to let the dog in the room. Using a K-9 made the situation safer for citizens, Shaver and the Officers onscene.

Shaver's injuries were fairly minor due to the fact that he had 5 layers of clothing on. The layers included a leather coat and other thick layers of clothing.

After being cleared by the hospital Shaver was booked for Residential Burglary.

There were 3 officers that had video footage of the incident. They are all attached.

Comments.

This review is being completed on 01/20/16. I have noticed a trend that K-9 Officers are not activating their cameras on calls that they are responding to with their dogs. Because of this, I have directed Sgt. Reynolds to provide very clear and precise expectations about their following current policy (practice) in regards to their activating their cameras on calls for service. It is the expectation that unless some exigency makes activation impractical that their own cameras are in use during calls they are responding to.

Sgt. Reynolds will document this training in his Sergeant's Log and ensure that all handlers receive the expectations.

In regards to this specific use of force.

Ofc. Belitz had responded to assist with the investigation of a Burglary in Progress at the location. Ofc. Belitz reasonably believed that the male involved (Shaver) was committing a felony in his presence.

-There was reasonable belief that the subject posed an imminent threat of violence as he had accessed knives at the location. Threatened to use a firearm, and threatened to harm officers and the K-9.

-The subject's resistance (Active physical resistance- Barricading himself inside of a residence not his own, and further secreting himself deeper into the home as officers approached.)

-Because of the subjects actions of secreting himself into a back bedroom, holding the door closed, and threatening to use a "40 caliber" it was unsafe for officers to take the subject into custody.

Conclusion:

-Sgt. Reynolds is directed to provide K-9 Handlers with this Unit's expectations reference the use of the body cameras.

-This use of force is within Policy.

Excerpt from agreed upon 'draft policy' update 05/13/15 (Latest version I could locate)

703.1.2 ACTIVATION OF THE BODY CAMERA

Patrol officers shall activate the body camera at the outset of each contact that is associated with an incident number, whether or not the contact documents a significant incident, forms part of a criminal investigation or has any perceived evidentiary value to the officer. Unless an officer holds a legitimate belief that activating the body camera would be unsafe given the facts and circumstances, the body camera shall be activated. If a safety issue has prevented activation of the body camera, the officer shall document the details in an incident report and report it to the shift supervisor. At no time should officers jeopardize their safety in order to activate a body camera. It is understood that rapidly evolving and complicated situations may delay camera activation due to incident priority. Officers will document this situation in their incident report. During the ASP no discipline will be administered for not activating the camera. Additionally, the City will not utilize videos from the cameras during the Academic Study Phase for disciplinary purposes until bargaining has been completed.

Report Narrative

010916 at approximately 0253 hours, I responded to assist other units with a possible residential burglary at **#10 #10 .** I arrived on scene and deployed K-9 Zeus from my patrol car. I contacted the officers who were conducting the investigation and I was told the following:

The owner of the residence, **11**, had contacted 911 stating that her renter of the location indicated to her that somebody was in the house that did not belong there. The renter was identified as **11**, **1**

#1a indicated that the only person with permission to be in her rental property was **#1a**. She did not give permission for anybody else to be there. **#1a** was at the location on E. Olympic and officers were conversing with him. I confirmed with Officer Guzzo who was talking to **#1a** if anybody was allowed to be inside of the residence. **#1a** indicated that he had seen the male through the window of the residence and did not know who he was.

#1a also confirmed that nobody should have been inside of the residence, he had given nobody permission to be inside, and he lived alone. Other officers could see the male walking around inside of the residence. Officer Guzzo took Doug to a safe location where he could see the male inside of the residence as well. **#1a** was asked if he recognized the person inside of his residence and he confirmed that he has never seen him before.

At this time, PC existed to arrest the suspect inside for Residential Burglary. We now had containment on the house and began to formulate a plan to handle the situation. We placed containment on both the front and rear door of the residence. I was standing on the south east corner of the residence along with K-9 Zeus. As we were waiting for more resources, the suspect poked his head outside of the bathroom window. This bathroom window was on the south side of the residence approximately 10 feet from where I was standing with K-9 Zeus. I notified the male that he was under arrest for residential burglary and that he needed to come outside or I was going to send in my dog and he would find him and bite him. The male yelled at me and told me not to send the dog in. However, the male did not indicate that he was going to come outside. I then made another announcement telling him that he was under arrest for residential burglary that if he did not come outside I would send in my dog and my dog would find him and he would bite him.

Again, K-9 Zeus was with me and the suspect could see him and I commanded K-9 Zeus to bark as well. It would have been impossible for suspect to not have seen and heard K-9 Zeus with the proximity of only 10 feet away. The suspect then went back inside of the residence and said something that sounded like he was going to come out of the front door. I relayed this information to other officers on scene.

However, the suspect did not come out of the front or rear doors. At one point, the suspect did however walk to the front door and kick it very hard from the inside. I maintained my location on the southeast corner of the residence and could hear the male yelling inside. Other units could see him through a window periodically and attempted to get him to surrender. A few minutes went by, so I walked back over to the bathroom window which was open.

This was the same window that the suspect had stuck his head out and saw me and K-9 Zeus the first time I gave him announcements and warnings. This time, I had K-9 Zeus jump up on the picnic bench that was directly outside of the window. I followed K-9 Zeus and even had K-9 Zeus prop his front legs up on the bathroom window. The bathroom door was closed the majority of the way but was still open about 2 to 3 inches.

I poked my head inside of the window and made announcements inside of the building. I yelled loudly "attention inside the building, Spokane Police K-9, suspect you're under arrest, come out now or I will send in my dog and he find you and he will bite you". I commanded K-9 Zeus to bark and then waited. I waited approximately 30 seconds and made the same announcement again through the bathroom window. I command K-9 Zeus to bark again and once he was quiet, I waited for a response.

I received no response from the suspect inside and neither did the other officers on scene. then took K-9 Zeus back to the east side of the residence and met up with other officers there. While we were waiting for more units to show up and for more resources, officers on the west side of the residence observed the male arm himself with a knife. The male then began to walk around the residence while holding the knife. The units on the west side of the residence relayed to me that they heard the suspect saying that if I send in my dog that he would kill him. As Officer Russo was conversing with the suspect, the suspect then dropped the knife. We were then given a key from #1a that he thought was for the front door. Our intention was to enter through the front door using the key. Units on the west side of the residence kept us informed of the suspects movements and actions and whether or not his hands were clear of weapons. As we were guietly attempting to use the key on the front door, the suspect heard this and came over and kicked the door. He then barricaded it closed with his foot. I was then going to go to the back door and attempt to insert K-9 Zeus from there, but as I started to move, Sergeant Meyer notified me over the air that the suspect had walked away from the front door. At this time, Officer Russo breached the door and we moved in. Due to the fact that the suspect had armed himself earlier with a knife, we had assembled a group of multi force options. The first officer at the door had a ballistic shield, followed by an officer with a less lethal TASER in hand. I was next to move through the door with K-9 Zeus.

As Officer Russo breached the front door, we could see that the front room was very small. The suspect was not in the front room so we moved in to the next position of cover. This was a short distance and then opened up to the rest of the house. Officers held there and I made an announcement to give up now I was going to send in my dog and when he found you he would bite you. I received no response from inside of the residence.

SEVERITY OF CRIME:

***There was PC to arrest the suspect inside of the residence for Residential Burglary, a class B felony.

WHETHER THE SUSPECT POSES AN IMMEDIATE THREAT TO THE SAFETY OF THE OFFICERS OR OTHERS:

***The suspect had barricaded himself inside of the home to prevent law enforcement from entering the residence to arrest him. At one point, the suspect had armed himself with a knife and made statements that he was going kill my dog. In my experience, burglary suspects are often times armed and when trapped inside of a location, become aggressive and assaultive. The suspect had not yet been searched and had complete access to the entire residence. Several items inside of the residence, could have been used as weapons and there were several knives inside of the kitchen. One of which the suspect had already armed himself with. There were several locations in the residence that we could not see and the suspect could secrete himself in and set up an ambush on arresting officers. Searching officers would be on the reactionary end of any confrontation and the suspect would have an extreme tactical advantage. Using K-9 Zeus to search and locate the suspect would be the safest and most efficient way to locate and take the suspect into custody.

WHETHER HE IS ACTIVELY RESISTING ARREST OR ATTEMPTING TO EVADE ARREST

BY FLIGHT:

***The suspect was given multiple announcements and warnings by all officers that if he did not surrender, a police K-9 was going to be used and he would be bit. I made 3 separate sets of K-9 announcements telling the suspect inside that he was under arrest along with a fourth announcement from inside the home. The first time, I specifically told the suspect that he was under arrest for residential burglary and that if he did not come out, I would send in my dog and he would be bit. When I made this announcement, the suspect was only 10 feet from me and was looking directly and me and K-9 Zeus. K-9 Zeus barked loudly several times between my announcements. There was no possible way that the suspect did not hear this or see this. A short time later, I made another set of announcements inside of the bathroom window, and while outside the front door, I made another set of announcements saying "attention in the residence, Spokane Police K-9, suspect you are under arrest, give up now or I will send in my dog and when he finds you he will bite you." The suspect clearly knew that he was under arrest but made no effort to surrender. With the fact that I was certain that the suspect heard all given announcements and knew that he was under arrest and still did not surrender, there was no telling what he would do to avoid going to jail.

For the aforementioned reasons, I made one more announcement telling the suspect to give up or I would send my dog. I received no answer so I deployed K-9 Zeus into the residence from our position of cover. K-9 Zeus ran towards the back of the residence and then had a good change of behavior and turned around and ran back toward me and up to a bedroom door. It was clear that K-9 Zeus had followed the scent to the bedroom door. Just then, Sgt. Meyer notified me on the radio that the suspect had ran into the bedroom and closed the door just as we made entry to the residence. We could not allow the suspect to set up an ambush in the room so I recalled K-9 Zeus and Officer Gorman breached the door. The suspect then attempted to hold the door closed and there was a struggle over opening the door with the suspect and Officer Gorman.

SEVERITY OF CRIME:

***There was PC to arrest the suspect inside of the residence for Residential Burglary, a class B felony.

Officer Gorman was able to get the door open and hold it open just enrough for me to send K-9 Zeus into the room. As K-9 Zeus entered the room, he immediately located and contacted the suspect on the left forearm as he was attempting to hold the door closed. I was only 2-3 feet from the suspect when K-9 Zeus made contact. However, he was behind the door when I deployed K-9 Zeus. K-9 Zeus pulled the suspect away from the door and I was able to enter the room.

Once inside of the room, the suspect had pulled his right arm under his chest and appeared to be reaching for a weapon in his jacket. I gave K-9 Zeus his command to stay on the contact and maintain control of the suspects left arm while I took control of his right arm. Once I got control of the suspects right arm, I passed it off to the other officers when they reached my position.

I then moved over and took control of K-9 Zeus. I gave him his out command and he came off of the contact immediately. K-9 Zeus was on the contact for approximately 15-20 seconds. I had to leave him on the bite for that duration due to the fact that the suspect appeared to be attempting to access a weapon in his jacket when I first came in the room. As soon as I took K-9 Zeus off of the contact, the other officers were able to place the suspect into custody.

The suspect was later identified as Jerry Shaver. Shaver was notified that he was under arrest for residential burglary. Shaver was transported to Deaconess ER for medical evaluation. Once at the hospital, we removed Shavers top layers so that he could be evaluated. Shaver was wearing 5 layers of clothing at the time of the contact. He was wearing a thick lined leather

jacket, a thick lined fleece, a denim jacket, a heavy hoody and a long sleeve t-shirt. After all of the layers were removed, I could see that Shaver had 2 small punctures on his left forearm. One on the front near his wrist and the other on the back near the top of his forearm. These punctures were cleaned and needed no further medical treatment, The doctor also took an x-ray of Shavers forearm and it showed that there were no broken bones.

While at the hospital, I spoke to Shaver and asked him if he heard my K-9 announcements. Shaver stated that he heard all of them and did see K-9 Zeus and heard him barking when he poked his head out of the bedroom window. I asked Shaver why he did not surrender after hearing my announcements and he said "well, the dog isn't going to kill me so I stayed in." After he was medically cleared for jail, Shaver was transport there and booked for residential burglary. Sergeant Reynolds was notified of the contact and minor injury to Shaver. Corporal Daniel responded and took photos of the punctures on Shavers arm.

#1a informed me that he lives at **#1d** alone. He came back into his home to find several items disturbed. It was clear to him that someone had been in his house. He frequently leaves his back door unlocked, and he believes this is how the suspect got into his house. He went to his bathroom and found that the door was closed. He believed this was odd, and opened the door. He found a male later identified as Jerry Shaver sitting on his toilet. He attempted several times to tell Jerry to leave, but Jerry just sat on the toilet mumbling to himself. **#1a** went back to his neighbor's house, retrieved an axe, and went back to **#1d** He tried several more times to get Jerry to leave his house. This was unsuccessful, and Jerry continued to just mumble to himself. **#1a** left to go outside and smoke a cigarette. It was at about this point that police arrived.

#1a told other officers that he left for the bar between 2000 and 2200 hours. he returned back to the house near the time when he called 911. Also it is worth noting that #1a appeared to intoxicated.

I confirmed with #1a that nobody was allowed to be in his house. #1a confirmed that he lived at the house alone, and was willing to press charges against anyone for being inside of his house. Furthermore, #1a gave police permission to go inside the home and attempt to arrest the suspect.

While speaking with #10 the bathroom light in the rear of the home turned off. A short time after that, Jerry opened the bathroom window. I illuminated his face with a flashlight and began giving him instructions to some out of the house. Jerry mentioned something about "call his son" or something along those lines. Jerry refused to leave the house despite being given several commands.

#1a was standing near me and also saw Jerry through the window. He confirmed that he has never seen Jerry in his life. He also informed me that Jerry does not have permission to be inside of his house. #1a also informed me that he does not have a son, step son, or anyone that someone would believe is his son.

I stood outside the home while other officers attempted to get Jerry to come outside. Someone overheard Jerry say that he was going to blow his head off. Other officers viewing Jerry from outside the home also advised that Jerry had armed himself with a knife.

I moved to the other side of the home and began speaking with Jerry through the window. Jerry paced back and forth throughout the home, moving very erratically. He moved from front door to back door, attempting to hold each one of them shut. I told Jerry several times that he needed to leave the home with nothing in his hands. Jerry informed me that he had a DOC warrant. I told him that we could handle the warrant. Jerry told me that it was not the warrant that he was concerned about, but a potential residential burglary charge. Jerry told me several times that I needed to contact **#10** son, but was unable to provide a name for this gentleman.

I told Jerry several times that we did not want to hurt him. I also told him that we did not want to bite him with a dog if we could avoid it.

Jerry became very agitated, and said that he had a .40 caliber handgun in the back bedroom. Shortly after this, he sprinted to the back bedroom. Near this time, Jerry darted quickly to the bedroom of the home, shutting the door

behind him. I shouted at Jerry to not grab a gun.

Shortly after this, other officers breached the door and went into the home and arrested Jerry. While doing this, they had to breach 2 doors. Please see their reports for further details regarding this process.

After Jerry was detained, officers walked Jerry out of the front of the home. **#1a** confirmed that he had never seen Jerry in his life. He also confirmed that this was the gentleman that he saw in his bathroom earlier. **#1a** informed me that Jerry appeared to be under the influence of drugs when he spoke with him in the bathroom. He believed this because of how wide Jerry's eyes were. I briefly walked through the home with **#1a** and he showed me several items that had been disturbed.

Items were thrown all over his living room and bedroom. I also observed a lighter, some foil, and some residue on the foil. #1a confirmed that these were not his items.

After Jerry was identified, we found that Jerry did not in fact have a DOC warrant as he thought. Also, while searching Jerry incident to arrest, other officers located the remote to an "Apple TV" in front left jeans pocket. The remote activated the Apple TV inside of #10 home. #10 also confirmed that the remote was not on his table where he normally keeps it. I returned this Apple TV remote to #10.

Cpl. Daniels responded to the scene and took photographs.

I gave #1a a crime victim card with his incident number on it.

Jerry was booked into jail by Ofc. Walker for residential burglary. I also completed a PC affidavit.

Please see other officer's reports for further regarding this incident.

#1a informed me that he lives at #1d alone. He came back into his home to find several items disturbed. It was clear to him that someone had been in his house. He frequently leaves his back door unlocked, and he believes this is how the suspect got into his house. He went to his bathroom and found that the door was closed. He believed this was odd, and opened the door. He found a male later identified as Jerry Shaver sitting on his toilet. He attempted several times to tell Jerry to leave, but Jerry just sat on the toilet mumbling to himself. #1a went back to his neighbor's house, retrieved an axe, and went back to #1d He tried several more times to get Jerry to leave his house. This was unsuccessful, and Jerry continued to just mumble to himself. #1a left to go outside and smoke a cigarette. It was at about this point that police arrived.

#1a told other officers that he left for the bar between 2000 and 2200 hours. he returned back to the house near the time when he called 911. Also it is worth noting that #1a appeared to be intoxicated.

I confirmed with #1a that nobody was allowed to be in his house. #1a confirmed that he lived at the house alone, and was willing to press charges against anyone for being inside of his house. Furthermore, #1a gave police permission to go inside the home and attempt to arrest the suspect.

While speaking with #1a the bathroom light in the rear of the home turned off. A short time after that, Jerry opened the bathroom window. Lilluminated his face with a flashlight and began giving him instructions to some out of the house. Jerry mentioned something about "call his son" or something along those lines. Jerry was referring to #1a son when he said "call his son." Jerry refused to leave the house despite being given several commands.

#1a was standing near me and also saw Jerry through the window. He confirmed that he has never seen Jerry in his life. He also informed me that Jerry does not have permission to be inside of his house. #1a also informed me that he does not have a son, step son, or anyone that someone would believe is his son.

I stood outside the home while other officers attempted to get Jerry to come outside. Someone overheard Jerry say that he was going to blow his head off. Other officers viewing Jerry from outside the home also advised that Jerry had armed himself with a knife.

I moved to the other side of the home and began speaking with Jerry through the window. Jerry paced back and forth throughout the home, moving very erratically. He moved from front door to back door, attempting to hold each one of them shut. I told Jerry several times that he needed to leave the home with nothing in his hands. Jerry informed me that he had a DOC warrant. I told him that we could handle the warrant. Jerry told me that it was not the warrant that he was concerned about, but a potential residential burglary charge. Jerry told me several times that I needed to contact #10 son, but was unable to provide a name for this gentleman.

I told Jerry several times that we did not want to hurt him. I also told him that we did not want to bite him with a dog if we could avoid it.

Jerry became very agitated, and said that he had a .40 caliber handgun in the back bedroom. Shortly after this, he sprinted to the back bedroom, shutting the door behind him. I shouted at Jerry to not grab a gun.

Shortly after this, other officers breached the door and went into the home and arrested Jerry. They had to breach the front door to the home as well as the bedroom door. Please see their reports for further details regarding this process.

After Jerry was detained, officers walked Jerry out of the front of the home. **#10** confirmed that he had never seen Jerry in his life. He also confirmed that this was the gentleman that he saw in his bathroom earlier. **#10** informed me that Jerry appeared to be under the influence of drugs when he spoke with him in the bathroom. He believed this because of how wide Jerry's eyes were. I briefly walked through the home with **#10**, and he showed me several items that had been disturbed.

Items were thrown all over his living room and bedroom. I also observed a lighter, some foil, and some residue on the foil. #12 confirmed that these were not his items.

After Jerry was identified, we found that Jerry did not in fact have a DOC warrant as he thought. Also, while searching Jerry incident to arrest, other officers located the remote to an "Apple TV" in Jerry's front left jeans pocket. The remote activated the Apple TV inside of #1a home. #1a also confirmed that the remote was not on his table where he normally keeps it. I returned this Apple TV remote to #1a.

Cpl. Daniel responded to the scene and took photographs.

I gave #1a a crime victim card with his incident number on it.

Jerry was booked into jail by Ofc. Walker for residential burglary. I also completed a PC affidavit.

On 01-09-16 at approx 0257 hours I responded to **110** reference a report of a residential burglary. Radio advised the suspect entered the occupied residence through an unlocked back door. The suspect was currently in the bathroom. Radio advised **110** lives alone at the target location.

When I arrived on-scene officers had contact with the subject was outside the residence. The suspect was still believed to be inside the location. We maintained a perimeter around the location. The suspect stuck his head out of an open bathroom window on the south side of the house. We made verbal contact with the subject. The subject was provided with directives to exit the house with nothing in his hands. The subject was very animated and excited. Initially he did not engage in dialogue other than profanities. He said he would come out the front door. He exited the bathroom and disappeared from our view. The subject did not make an attempt at that time to come to the front door. The subject secreted himself in a room for several minutes before we were able to get another visual of him.

When the subject exited the bedroom into the living room we were able to see him from a window on the west side of the residence. I stood at the window and engaged the subject in conversation. The subject was still very animated and excited. His emotional state was up and down. At times I could speak with him calmly but then he would amp himself up into a tirade. When we spoke he talked about all the points he had referring to his criminal record. He said he was not going back to prison. I explained to him that we just needed him to come outside and talk to us. I explained that he was not helping the situation by refusing to come outside. He warned us not to come into the house. I reassured him that we did not want to use force on him. I told him he would not be hurt if he just followed directives and exited the residence.

The male said his name was Jerry Shaver. Jerry at times walked to the front door. He would start to yell and hold the door closed. He talked on the cell phone several times while he excitedly paced around the living room. I continued to instruct Jerry to exit the residence and talk to us. Jerry said he would hurt the police dog if we entered the location. He became more escalated, he said if we came in he would blow his head off making gesture of a gun to his head. In a fit of rage he quickly ran to the kitchen, I still had a visual on him. He ripped a draw out of the kitchen counter and armed himself with a knife. I immediately put that information out so officers covering the front and back

door were aware. Jerry looked back at me and dropped the knife in the kitchen. It seemed at times Jerry was out of control but there were glimpses of rational thought. His erratic behavior seemed consistent with methamphetamine use. Several times when he spoke he had mentioned meth and how he was there to take the meth out of the location. Ofc Guzzo came to my location to continue verbals with Jerry. I went to the front door to assist with the entry team.

An entry plan was made to go in the front door and hold. I had the key to the door. The entry team consisted of a shield, hands team, less lethal and K9. The door was locked. I attempted to unlock the door while officers were talking to the suspect through the window. The suspect came to the front door and seemed to be holding it closed keeping the dead bolt locked. We needed to get him away from the front door so we could make entry. They distracted him away from the front door, it was relayed that his hands were clear. At this time there was a window of opportunity where we had separation from the front door. I forced entry into the residence. I kicked the door causing damage to the door and frame. The force of the kick defeated the locking mechanism giving us a positive breach. The subject retreated and attempted to barricade himself in the bedroom, due to his unstable and erratic behavior there was concern he could be arming himself and fortifying his position. It was unknown if he had any weapons on him and at one point he had already armed himself with a knife.

We forced entry into the bedroom and the K9 was inserted. The K9 made contact with the suspect. (See Ofc Belitz's report for more information) I entered the bedroom. Officers were struggling to get the suspects right arm under control. I was able to control the suspects left arm. The suspect was in the prone position on the bed. While I controlled his left arm I could feel the suspect tensing his muscles attempting to resist control. When his right arm was under control we were able handcuffs using a prone cuffing technique. Jerry was escorted out of the residence and transported to the hospital to be medically evaluated.

Cpl Daniel responded and took photos of damage to the front door.

On 1/9/16 at approximately 0252 hours, I was dispatched to a report of a Residential Burglary in progress at #10 Ave. While enroute I was informed by Dispatch that there was an unknown/uninvited male in the residence.

Once on scene I joined numerous other officers in the effort to secure the residence while other officers spoke with the resident of that home to confirm that the male is unknown and has no permission to be there. During this time he also provided us with keys to the front door to help facilitate entry into his house.

There were multiple verbal contacts with the suspect from within the house at several different windows (see other officer's reports). While they did that I held security on the front door. While there I could periodically hear the suspect inside yelling and making random statements about killing the [K9] dog if it came in. At one point the officers on the other side of the house informed us in the front that the suspect, later identified as Jerry W. Shaver, had gone to the kitchen and armed himself with a knife. Shortly after they informed us he had put it down.

While they kept him occupied on the other side of the house with verbals, those of us on the front side moved up to the door and attempted to gain access using the keys provided. Before we could do this, Jerry heard the keys and started slamming on the door from the inside. The other units were again able to draw him to the rear. The decision was made and we utilized this opportunity to breach the front door.

I was in front holding the shield. As soon as the door was breached, we pushed inside and cleared the first room as we also held the entrance to the next room. The officers on the outside informed us that he had dashed into the back bedroom just as we entered the house. I again approached the door with the shield. Another officer attempted to breach the door and in doing so it appeared that something was blocking it on the other side. The door was opened enough for the K9 Unit to be utilized at that time (see Ofc. Belitz's report). Within seconds after the dog entering the room I could hear that the suspect had been bitten and we all pushed into the bedroom to apprehend him.

I initially layed my shield down on his lower back/legs to control him from movement. Within seconds of the situation evolving and officers moving, I had to discard the shield to take control of

The owner of the residence, **11 11** had contacted 911 stating that her renter of the location indicated to her that somebody was in the house that did not belong there. The renter was identified as **#1a #1a** notified her that there was a male inside of the residence he and had entered through an unlocked back door. I asked police radio to contact **#1a** and confirm that nobody other than **#1a** was allowed to be at the residence.

#12 indicated that the only person with permission to be in her rental property was #1a. She did not give permission for anybody else to be there. #1a was at the location on E. Olympic and officers were conversing with him. I confirmed with Officer Guzzo who was talking to #1a if anybody was allowed to be inside of the residence. #1a indicated that he had seen the male through the window of the residence and did not know who he was.

#1a also confirmed that nobody should have been inside of the residence, he had given nobody permission to be inside, and he lived alone. Other officers could see the male walking around inside of the residence. Officer Guzzo took **#1a** to a safe location where he could see the male inside of the residence as well. **#1a** was asked if he recognized the person inside of his residence and he confirmed that he has never seen him before,

At this time, PC existed to arrest the suspect inside for Residential Burglary. We now had containment on the house and began to formulate a plan to handle the situation. We placed containment on both the front and rear door of the residence. I was standing on the south east corner of the residence along with K-9 Zeus. As we were waiting for more resources, the suspect poked his head outside of the bathroom window. This bathroom window was on the south side of the residence approximately 10 feet from where I was standing with K-9 Zeus.

I notified the male that he was under arrest for residential burglary and that he needed to come outside or I was going to send in my dog and he would find him and bite him. The male yelled at me and told me not to send the dog in. However, the male did not indicate that he was going to come outside. I then made another announcement telling him that he was under arrest for residential burglary that if he did not come outside I

would send in my dog and my dog would find him and he would bite him.

Again, K-9 Zeus was with me and the suspect could see him and I commanded K-9 Zeus to bark as well. It would have been impossible for suspect to not have seen and heard K-9 Zeus with the proximity of only 10 feet away. The suspect then went back inside of the residence and said something that sounded like he was going to come out of the front door. I relayed this information to other officers on scene,

However, the suspect did not come out of the front or rear doors. At one point, the suspect did however walk to the front door and kick it very hard from the inside. I maintained my location on the southeast corner of the residence and could hear the male yelling inside. Other units could see him through a window periodically and attempted to get him to surrender. A few minutes went by, so I walked back over to the bathroom window which was open.

This was the same window that the suspect had stuck his head out and saw me and K-9 Zeus the first time I gave him announcements and warnings. This time, I had K-9 Zeus jump up on the picnic bench that was directly outside of the window. I followed K-9 Zeus and even had K-9 Zeus prop his front legs up on the bathroom window. The bathroom door was closed the majority of the way but was still open about 2 to 3 inches,

I poked my head inside of the window and made announcements inside of the building. I yelled loudly "attention inside the building, Spokane Police K-9, suspect you're under arrest, come out now or I will send in my dog and he find you and he will bite you". I commanded K-9 Zeus to bark and then waited. I waited approximately 30 seconds and made the same announcement again through the bathroom window. I command K-9 Zeus to bark again and once he was quiet, I waited for a response.

I received no response from the suspect inside and neither did the other officers on scene. I then took K-9 Zeus back to the east side of the residence and met up with other officers there. While we were waiting for more units to show up and for more resources, officers on the west side of the residence observed the male arm himself with a knife. The male then began to walk around the residence while holding the knife. The units on the west side of the residence relayed to me that they heard the suspect saying that if I send in my dog that he would kill him.

As Officer Russo was conversing with the suspect, the suspect then dropped the knife. We were then given a key from **#1a** that he thought was for the front door. Our intention was to enter through the front door using the key. Units on the west side of the residence kept us informed of the suspects movements and actions and whether or not his hands were clear of weapons. As we were quietly attempting to use the key on the front door, the suspect heard this and came over and kicked the door. He then barricaded it closed with his foot.

1 was then going to go to the back door and attempt to insert K-9 Zeus from there, but as I started to move, Sergeant Meyer notified me over the air that the suspect had walked away from the front door. At this time, Officer Russo breached the door and we moved in. Due to the fact that the suspect had armed himself

earlier with a knife, we had assembled a group of multi force options. The first officer at the door had a ballistic shield, followed by an officer with a less lethal TASER in hand. I was next to move through the door with K-9 Zeus.

As Officer Russo breached the front door, we could see that the front room was very small. The suspect was not in the front room so we moved in to the next position of cover. This was a short distance and then opened up to the rest of the house. Officers held there and I made an announcement to give up now I was going to send in my dog and when he found you he would bite you. I received no response from inside of the residence.

***There was PC to arrest the suspect inside of the residence for Residential Burglary, a class B felony.

between my announcements. There was no possible way that the suspect did not hear this or see this. A short time later, I made another set of announcements inside of the bathroom window, and while outside the front door, I made another set of announcements saying "attention in the residence, Spokane Police K-9, suspect you are under arrest, give up now or I will send in my dog and when he finds you he will bite you." The suspect clearly knew that he was under arrest but made no effort to surrender. With the fact that I was certain that the suspect heard all given announcements and knew that he was under arrest and still did not surrender, there was no telling what he would do to avoid going to jail.

For the aforementioned reasons, I made one more announcement telling the suspect to give up or I would send my dog. I received no answer so I deployed K-9 Zeus into the residence from our position of cover, K-9 Zeus ran towards the back of the residence and then had a good change of behavior and turned around and ran back toward me and up to a bedroom door.

It was clear that K-9 Zeus had followed the scent to the bedroom door. Just then, Sgt. Meyer notified me on the radio that the suspect had ran into the bedroom and closed the door just as we made entry to the residence. We could not allow the suspect to set up an ambush in the room so I recalled K-9 Zeus and Officer Gorman breached the door. The suspect then attempted to hold the door closed and there was a struggle over opening the door with the suspect and Officer Gorman.

Officer Gorman was able to get the door open and hold it open just enrough for me to send K-9 Zeus into the room. As K-9 Zeus entered the room, he immediately located and contacted the suspect on the left forearm as he was attempting to hold the door closed. I was only 2-3 feet from the suspect when K-9 Zeus made contact. However, he was behind the door when I deployed K-9 Zeus. K-9 Zeus pulled the suspect away from the door and I was able to enter the room.

Once inside of the room, the suspect had pulled his right arm under his chest and appeared to be reaching for a weapon in his jacket. I gave K-9 Zeus his command to stay on the contact and maintain control of the suspects left arm while I took control of his right arm. Once I got control of the suspects right arm, I passed it off to the other officers when they reached my position.

I then moved over and took control of K-9 Zeus. I gave him his out command and he came off of the contact immediately. K-9 Zeus was on the contact for approximately 15-20 seconds. I had to leave him on the bite for that duration due to the fact that the suspect appeared to be attempting to access a weapon in his jacket when I first came in the room. As soon as I took K-9 Zeus off of the contact, the other officers were able to place the suspect into custody.

The suspect was later identified as Jerry Shaver. Shaver was notified that he was under arrest for residential burglary. Shaver was transported to Deaconess ER for medical evaluation. Once at the hospital, we removed Shavers top layers so that he could be evaluated. Shaver was wearing 5 layers of clothing at the time of the contact. He was wearing a thick lined leather jacket, a thick lined fleece, a denim jacket, a heavy hoody and a long sleeve t-shirt.

After all of the layers were removed, I could see that Shaver had 2 small punctures on his left forearm. One on the front near his wrist and the other on the back near the top of his forearm. These punctures were cleaned and needed no further medical treatment, The doctor also took an x-ray of Shavers forearm and it showed that there were no broken bones.

While at the hospital, I spoke to Shaver and asked him if he heard my K-9 announcements. Shaver stated that he heard all of them and did see K-9 Zeus and heard him barking when he poked his head out of the bedroom window. I asked Shaver why he did not surrender after hearing my announcements and he said "well, the dog isn't going to kill me so I stayed in."

After he was medically cleared for jail, Shaver was transport there and booked for residential burglary. Sergeant Reynolds was notified of the contact and minor injury to Shaver. Corporal Daniel responded and took photos of the punctures on Shavers arm.
