



Use of force summary

Sergeant Bartlett did a very thorough review of this use of force. I concur with his findings.

Officer McMurtrey engaged in a foot pursuit of a possible DV suspect who was possibly armed with an ax handle. The suspect, Lacey didn't obey commands to stop knowing it was a police officer chasing him and telling him to stop. Officer McMurtrey used a take down to stop and control Lacey. This caused minor injuries to his face. This use of force is within policy. A subsequent struggle ensued during and after cuffing as Lacey didn't comply with officer's orders.

Officer Howe assisted in the arrest. When they had Lacey cuffed and were trying to search him he continued to fail to comply with officer's commands to stop reaching for stuff. Lacey's actions led the officers to believe he might be armed.

Officer Elina Bishop was one of the last to arrive and excitedly announced, "right there" multiple times and, "whatever he is reaching for" that further alarmed the other officers. Officer Howe looked and saw Lacey clutching something with his hand. Officer Howe used a hammer strike to the side of Lacey's face to stop his further actions of reaching around. He also told Officer Bishop to TASER him. The use of the hammer strike was justified and within policy based up Officer Howe's reasonable belief that Lacey was reaching for a weapon.

Officer Bishop was unaware at that time that Lacey was handcuffed. She saw him reaching around and not complying with the officers. She saw a bulge near his waist band where he was reaching his hand and thought it was a weapon when she announced multiple times, "right there" and stated, "whatever he is grabbing right there in his waistband." After announcing TASER multiple times she did TASER him. The probes didn't make complete contact based upon his clothing. She then completed the circuit for the last 2 seconds by using a drive stun on Lacey. Officers were then able to gain control of Lacey. The use of the TASER was justified and within policy based on the Officer Bishop's reasonable belief Lacey was reaching for a weapon. It was only after the application she realized he was handcuffed.

The officers on scene thought Lacey was possible reaching for a weapon. Their words and actions support this reasonable belief throughout their contact with him.

The video shows he had an extreme range of motion for someone who was handcuffed.

The officers didn't tell Sergeant Bartlett that Lacey was handcuffed. It was appears this wasn't intentional and just an oversight on their parts. Officer Bartlett addressed this with the officers.

Lacey did mention to Sergeant Bartlett that he thought he had some MJ in his pocket. It may have been what he was reaching for as no weapon was found.

The injuries to Lacey appear to be minor and consistent with the force used.

Use of force- TASER deployment, Level 2 strike, injury from take down to prone cuffing.

Officer Interview Summary:

Officer McMurtrey advised that he "forcibly" took a male to the ground after a short foot pursuit. The take down was in a residential yard covered in snow. The male had refused commands to stop or get on the ground.

Officer Howe advised at the scene that the male was "digging" in his waistband area and he thought the male had a weapon. He advised that he struck the male on the left side of his face. When asked to clarify the strike he described a palm strike. I asked if it was the soft part of his hand. He stated it was indicated the palm of his hand.

After viewing the body camera footage it appeared that Officer Howe also yelled for Officer Bishop to tase Lacy. I asked him what led to this request. He told me Lacy had something black in his hand. He was unsure what it was, but later thought it was Lacy's underwear or a glove.

Officer Bishop advised at the scene that the male was reaching for something in his pants or waist area. She believed he was reaching for a weapon. She advised she deployed her TASER in probe mode believing the male was reaching for a weapon.

At the time of the incident none of the officers involved advised that the male was handcuffed when tased and struck. Officer E. Bishop did advise the next day she was not aware Lacy was handcuffed until after viewing her body camera video. Officer J. Howe advised that he thought other officers had told me Lacy was handcuffed while he was reaching in his pockets.

It should be noted that Officers J. Howe and E. Bishop did accurately document that Lacy was handcuffed in their written reports.

At the beginning of the following shift, (01/10/2016) Officer Bishop contacted me with a concern about her report. She explained that the male had been handcuffed at the time she deployed the TASER. She explained that she did not know that he was handcuffed until later when she reviewed her bodycam. She also added that at the time the male was reaching in his waistband that she believed he was reaching for a weapon and another officer was telling her to tase the male. I explained that she should complete a supplemental report clarifying what she had just told me. I encouraged her to include any other details she remembered.

Suspect Interview Summary:

I spoke with Lonnie Lacy at the scene. I observed that his upper lip had blood on it and appeared to be swollen. He told me the left side of his face was sore and had pain in his wrist. He later told me he

thought he had broken his tooth. I looked and could not determine if he indeed had a broken tooth. He was checked by medics and Cpl. Spiering photograph Lacy's injuries.

I asked Lacy what had occurred. He told me he was walking to the store and saw a patrol car. He knew he had a DOC warrant and walked away. He told me he ran because of the warrant. He acknowledged that he knew it was the police who were chasing him.

Witness Interview Summary: None Found

Investigative Summary

On 01/09/2016 at approximately 1815 hours Officers Spolski and Howe were dispatched to a Domestic Violence with a weapon call. The complainant advised he lives at and his roommate had struck him with an ax handle. The complainant then walked approximately one block away to the Zip Trip at 3rd and Altamont.

The suspect was a described as a B/M that was approximately 7 feet tall. Wearing dark pants and a black shirt. Radio was unable to find him in with the name given.

Officers McMurtrey Wilkinson and I self-dispatched themselves to the call.

Officer McMurtrey arrived on scene first and advised that the complainant was not at 3^{rd} and Altamont. He advised radio he was walking to the 4^{th} address.

While walking to the address a citizen stopped him and asked if he was looking for someone. The citizen advised that a tall B/M was running from him, though Officer McMurtrey did not see the male at that time. Lacy was wearing a black shirt and dark pants.

Officer McMurtrey then observed the male, later identified as Lonnie Lacy, walking towards the 4th address, where the DV reportedly occurred. Lacy looked towards Officer McMurtrey and began running north. It was dark out with ambient light from nearby houses and a street light. Lacy was approximately three to four houses away when Ofc. McMurtrey first saw him. Lacy ran west and then back south towards the address. Officer Spolski cut off Lacy's path of escape, but Lacy refused to comply. Officers believed Lacy was the suspect from the DV who had been armed with an ax handle.

Officer McMurtrey took Lacy to the ground. Officer Wilkinson and Howe arrived to assist. Officer Spolski controlled Lacy's legs as the other officers attempted to handcuff him. Lacy struggled to get away, reaching into his pockets and around his waist several times.

Officers were able to get Lacy into handcuffs, but not fully control his hands. Lacy is tall and very thin, RQPN lists him as 6'1"/160 pounds. Lacy was able to move his handcuffed hands nearly to the front of his waist. As officers were attempting to search Lacy he continually reached into his pockets and area around his waist. Lacy was told multiple times to quit reaching into his pants, but did not comply.

Officer Howe took hold of Lacy's left arm. Lacy was able to break free and grab Officer Howe's leg. Lacy continued to struggle. He heard Officer E. Bishop yell that Lacy was reaching into his waistband trying to grab something. Lacy has his hands in the back of his waistband and attempts to roll over on his side as he is lying on his stomach. Officer J. Howe saw something black in his hand and believed it could be a weapon. Howe later told me he believed the black item he saw could have been a piece of clothing or a black glove Lacy had with him. He delivered a single hammer strike to the left side of Lacy's head/face. He stated he delivered the strike after Officer E. Bishop yelled that Lacy was reaching into his waistband but, before she deployed her TASER. Officers immediately start asking Lacy where his gun is.

Lacy is continuing to struggle with officers as Officer Bishop arrives and recognizes him. She moves around to the area of his feet. She clearly states that she sees Lacy reaching for something in his waistband and Lacy begins to struggle more. Officer Bishop clearly announces "TASER" three times. Another officer advises her to tase Lacy and she deploys the TASER in probe mode. Lacy was wearing loose fitting, baggy clothing and the probes did not appear to affect him. Bishop then used a drive stun to the back of his left leg. Other officers were then able to control his hands.

The TASER probes lodged in Lacy's clothing. One fell out and the other was removed from his jacket.

No weapon was found after searching Lacy.

Conclusion

After my review of body camera footage, officer reports and interviews with officers and Lacy, I have reached the following conclusion.

Lacy reasonably matched the description of the domestic violence suspect. Officer McMutrey clearly identified himself as a police officer and ordered Lacy to stop. This is supported by Lacy's statement that he saw a police officer (McMutrey), knew he had a DOC warrant and ran from the officer. It is also supported by body camera footage.

Officer McMurtrey's take down of Lacy is reasonable based on his non-compliance, reasonable belief that he was involved in the domestic violence incident and his refusal to comply with Officer Howe's commands to stop. The DV suspect had reportedly struck someone with an ax handle, but no other description was provided.

Officer Howe took hold of Lacy's left arm and Lacy attempted to pull away. Lacy also wrapped his arm around Officer Howe's leg during the attempt to handcuff Lacy. Lacy continually tried to access the area near his waistband numerous times throughout this incident, both prior and after being handcuffed. Based on officer reports and body camera video I believe a reasonable officer would conclude that Lacy was reaching for a weapon in his waistband.

As officers continued to attempt to search him, Lacy intentionally struggled to impede the search, adding to the officer's fear that he was attempting to access a weapon. Officers verbalized this in the body camera video.

Officer Howe's use of a single "Hammer Strike" to the left side of Lacy's face was and exceptional use of the technique, but I believe reasonable under the circumstances. Officer Bishop had just yelled that Lacy was reaching for something. After the "Hammer Strike" Officer Howe yelled for Officer Bishop to tase lacy.

As this incident evolved officers were unable to control Lacy's hands, even after he was detained in handcuffs with four officers present (McMurtrey, Wilkinson, Spolski and Howe). Lacy was wearing loose fitting, baggy clothing and continued to struggle. He reached into and near his waistband numerous times. When officers would verbalize that Lacy was reaching for his waistband he would reach further into the area he was concealing his hands. At one point he attempted to roll onto his side to conceal his hands. This is supported by officer reports and body camera video.

Although Lacy was handcuffed his hands were not controlled to prevent him from accessing a weapon in his waistband. The officers were attempting to control his hands and search him, but Lacy's actions prevented them from accomplishing this.

At the time Officer Bishop deployed her TASER in probe mode she was unaware that Lacy was handcuffed. She tells other officers that Lacy is reaching for "something" and points to Lacy's waistband near the small of his back as officers attempted to search Lacy. Officer Bishop gave three TASER warning and another officer (possibly Howe) tells her to tase Lacy. After the TASER was deployed in probe mode it did not appear to be effective. During that same 5 second deployment she followed up with a drive stun to the back of Lacy's left leg. This is supported by her reports, body camera video and the download information from her TASER. Officer Bishop's TASER log indicated that the deployment was only effective during the last approximately 2 seconds of the deployment.

After reviewing the reports, body camera footage and statements I believe the force used during this incident was reasonable and within policy. The officers concern that Lacy had a weapon concealed on his person and was intentionally hindering their search of him is evident in the body camera video and their written reports.

Policy was followed after the deployment with the request of medics and a supervisor. However, I was not advised of the unusual occurrence of the person being in handcuffs when the Hammer Strike was used and the TASER deployed. This issue has been addressed with the officers present.

Officer McMurtrey's report does not read in chronological order in areas. This leads the reader to believe Lacy was not in handcuffs at the time of the TASER deployment. Officer McMurtrey did not think it led the reader to conclude the TASER was deployed before Lacy was placed in handcuffs.

During my review of this use of force. I viewed the body camera footage of Officer McMurtrey's transport of Lacy to jail. Officer McMurtrey's comments to Lacy were unprofessional, inappropriate, unnecessary and not acceptable conduct within the Spokane Police Department. It should be noted that during this transport there was also a civilian observer in the vehicle. I believe Officer McMurtey's conduct is in violation of the following standards:

Canon 4

Standard 4.9:

Members of the Spokane Police Department shall at all times conduct themselves in a manner which does not discredit the law enforcement profession or the Spokane Police Department.

Standard 4.11:

Members of the Spokane Police Department shall be courteous and respectful in their official dealings with the public, fellow members, superiors and subordinates.

Pg. 66 Defensive Tactics Manual

LEVEL II TECHNIQUES (ACTIVE COUNTER MEASURES)

The objective reasonableness of this applied technique will be judged from the perspective of a reasonable officer on the scene at the time of the incident. Any evaluation of reasonableness must allow for the fact that officers are often forced to make split-second decisions about the amount of force that reasonably appears necessary in a particular situation, with limited information and in circumstances that are tense, uncertain and rapidly evolving.

Further, determining whether the force used to effect a particular seizure was reasonable under the Fourth Amendment requires a careful balancing of, "the nature and quality of the intrusion of the subject's Fourth Amendment interests'". The severity of the crime at issue, the immediate threats to officers and others and whether the subject is actively resisting arrest or attempting to evade arrest by flight are key in determining the reasonableness of the application of this technique.

CLOSED FIST AND HAMMER FIST STRIKES

309.5.2 SPECIAL DEPLOYMENT CONSIDERATIONS

The use of the TASER device on certain individuals should generally be avoided unless the totality of the circumstances indicates that other available options reasonably appear ineffective or would present a greater danger to the officer, the subject or others, and the officer reasonably believes that the need to control the individual outweighs the risk of using the device. This includes:

(a) Individuals who are known to be pregnant.

(b) Elderly individuals or obvious juveniles.

(c) Individuals with obviously low body mass.

(d) Individuals who are handcuffed or otherwise restrained.

(e) Individuals who have been recently sprayed with a flammable chemical agent or who are otherwise in close proximity to any known combustible vapor or flammable material, including alcohol-based oleoresin capsicum (OC) spray.

(f) Individuals whose position or activity may result in collateral injury (e.g., falls from height, operating vehicles).

Because the application of the TASER device in the drive-stun mode (i.e., direct contact without probes) relies primarily on pain compliance, the use of the drive-stun mode generally should be limited to supplementing the probe-mode to complete the circuit, or as a distraction technique to gain separation between officers and the subject, thereby giving officers time and distance to consider other force options or actions.

On 1/11/2016 Captain Torok contacted me reference incident # 16-010383. He wanted me to review the documentation and provide an evaluation on the use of force deployments in this call.

After reading the documentation of this incident and viewing related BWC footage I find that the application of Officer Bishop's TASER deployment in probe mode was reasonable. Although difficult to view on video it was apparent by the officer's verbal commands and heightened officer activity that specific suspect actions warranted extreme concern. Multiple officers yelled to the suspect to stop reaching for an item. Officer Bishop documented that she believed the suspect was accessing a weapon (specifically a gun) based on where he was reaching and an observed bulge in his pants. As the threatening elements of this incident continued to unfold she alerted the officers on her plan to deploy the TASER in probe mode.

The TASER did not produce the desired effect. She attempted to complete the circuit through a Drive Stun application on the suspect's lower body. At this point Officers were able to gain better control and limit the suspect's efforts to access his belt line and pockets

Officer Bishop submitted an additional report clarifying her on scene perceptions. She wrote her original report in a manner that would lead the reader to believe that she was aware that the suspect had been handcuffed. Her additional report clarified that she was unaware until after the use of force deployment.

Officer Howe was alerted by on scene officers that the suspect was accessing something in his waist band. Officer Howe's perception at this moment was that the suspect had accessed a weapon. He specifically documented that he thought the suspect was holding a gun and was in fear of being shot. Officer Howe's deployment of a hammer fist strike was well documented and reasonable under the described circumstances.

After reading the reports it was very clear that the suspect was capable of "beyond normal" range of motion even after properly being handcuffed. All of the officers described his ability to have the range of motion and flexibility to manipulate a potential weapon near the front and back of waist band area. Whether there was knowledge of being handcuffed or not, the suspect's actions and threat concerns were contributing factors in the officer's decision of chosen force options.

Due to the fact that the applications of these force options were deployed under handcuffed conditions, this incident should warrant an in depth evaluation. After watching the BWC and reading the documentation there was a specific moment where the handcuffed suspects' actions created an out of the norm threat to the on scene officers. The heightened concern was displayed through their verbal commands, tone in their voices and chosen force options. Once this concern was brought under control the officers utilizes the

reasonable amount of force to conclude apprehension, searching and transport efforts.

We should not second guess reasonable applications of force but a tactical debrief is a healthy way to consider other options under similar situations in the future and enhance training for our officers.

Other option considerations:

- There were at least 5 officers on scene during this force deployment. Body weight and manual force could have been a consideration and would have been less intrusive. They had enough personnel on scene to assign two officers per arm on the handcuffed individual to control his movement while one officer conducted a thorough pat down search.
- Joint lock techniques may have been effective in controlling the suspect's hand and arm movement. (Reverse Goose Neck, SWTL, Goose Neck, Finger Locks)
- Strikes have limited capability but can provide windows of opportunity for control techniques. A reasonably applied strike may disrupt a mission driven suspect long enough for application of a control technique.
- Pinning the suspects hand(s) as he tried to access the perceived weapon is another control technique that could be considered during close quarter apprehension efforts. Once pinned officers can adjust tactics, equipment and assistance in controlling the removal of the hand(s) and/or weapon.

Verbal Defense and Influence:

During my evaluation I reviewed BWC footage of the transport of the suspect to jail. Officer McMurtrey's comments and conversation with the suspect did not provide positive contributions to this call. De-Escalation efforts should be a priority in our occupation and we should not fuel an emotionally driven mindset down a negative path.

The suspect, was reported to be a black male, David Everett. He was described as being tall, about 7 feet and wearing a black shirt and dark pants.

While walking to the house, a citizen alerted me that there was a black male running from me. I did not see him at the time. She advised he was tall, I asked if he was about seven feet tall, and she repeated that she believed he was tall.

She pointed at male that was walking toward the target address. She identified him as the male running from me.

I observed a black male walking toward the target address. He was tall, but from the distance, I was unable to tell exactly how tall. It was dark out. He was about half a block from the house. He saw me and began running NB on Stone. He was wearing clothing similar to the clothing of the DV assault suspect described in the call.

At that time, I was investigating a crime of domestic violence in which the suspect had reportedly struck the victim with an axe handle.

The suspect, who was running, was wearing similar clothing, appeared to have similar physicals and was in the location contemporaneous to the alleged crime.

I chased after the male on foot. I warned him several times that I was the police and told him to stop.

I was wearing department issued police uniform with badge and patches affixed.

I caught the male in the front yard of 2217 E 4th. He was yelling at Officer Howe, who was giving him commands to stop and surrender. The male did not surrender, nor stop.

I forced the suspect onto the ground and attempted to place him in to custody. He sustained a laceration to his lower lip and nose, consistent with a take down in the snow. I used a forceful takedown for the following reasons:

Crime: I was investigating a domestic violence crime involving one male assaulting another with an axe handle. The suspect was obstructing my investigation.

Threat: The suspect in the crime was reported to be armed with an axe or axe handle. This suspect matched the description was in the same location and fled at the sight of police. He was wearing large bulky clothing and had not been searched. He was fleeing into unknown houses where it was

assumed he did not live or belong. I did not know the extent to which he was willing to go to flee arrest.

Resistance: The suspect fled at the sight of police contemporaneous to a domestic violence assault with a weapon allegation. The suspect willfully and intentionally ignored several lawful orders to surrender by a police officer in department uniform. The suspect jumped over fences and ran in attempt to evade arrest. When cornered by another officer the suspect continued to aggress on his position, became animated, argumentative, and refused to comply or surrender.

The suspect, later identified as L. Lacy continued to fight and resist arrest once he was on the ground and in the prone position. I gave him numerous commands to place his arms out to which he did not comply. He continually and forcefully tried to tuck his hands under his body and into his waistband area. This caused me great concern for my safety. He was able to resist three police officers', all weighing over two hundred pounds, attempts to subdue him.

Officer E. Bishop and A. Kester arrived to assist while the suspect was still violently struggling our attempts to place him into custody. Officer Bishop warned us that she saw something in his waistband and was reaching for it. Due to our positioning, I was unable to see his waistband area. This causes me great concern for my safety and that of other officers and citizens in the area.

It is common for suspects to carry weapons capable of causing great bodily injury and/or death in their waistband area. Lacy, due to his continual violent resistance, prevented us from searching him.

Office Bishop deployed her taser, which was preceded by a verbal warning alerting officers of its imminent deployment. See her report.

Lacy was taken into custody, (HC/DL) and searched incident to arrest by other officers. His property was placed into a bag and later turned over to the custody of jail staff.

Lacy stated that he had lost his cell phone. We searched the area, however, were unable to locate it. I explained to him that it would not have been lost had he complied with police directives.

I learned that Lacy had an outstanding warrant for his arrest for a DOC escape community custody felony violation.

Sergeant Barlett was informed of the use of force which caused Lacy's injuries caused by a take down technique. See his investigation.

I transported Lacy to jail. While transporting him to jail, Lacy made numerous threats that he would shoot me and my family in the face. He also threatened to assault me. Due to his continued noncompliance, I warned jail staff that he was confrontational.

I have advised that he carries the axe handle because its a rough neighborhood and he brought it upstairs because he heard yelling.

I told the male to place his hands on top of his head and he quickly placed the ax behind the door frame.

On 1-9-16 at about 1811 hours I was dispatched to the Zip Trip at 3rd and Altamont in reference to a DV. The employee called 911 for another male to report there had been an assault at **1** #1d **1** The male victim claimed he had been assaulted with an axe handle. The victim said David Everett was the suspect and he was a very tall black male.

Other officers arrived in the area before me and advised over the radio that the victim wasn't there. Officer McMurtrey advised he was going to walk from the Zip Trip to 1977 #10

A minute or two later I heard McMurtrey advise he was in foot pursuit of the suspect through an alley. The last thing I heard was the suspect was running westbound.

When I arrived I saw other officers in the front yard of 2217 E 4th contacting a tall black male and then quickly a physical altercation began. The altercation took place in the front yard of that address about two feet away from the chain link fence near the sidewalk. The front yard was covered in snow and very slick and cold.

I was about half a block away at that point and ran to assist. When I arrived I saw Officer Wilkinson and McMurtrey fighting with the male. The male was face down and fighting wildly. I could see his left arm was loose so I stepped in and took control of his left arm. I held his arm in a wrist lock and maintained control of it until the suspect could be cuffed. While holding his arm he continued to fight and at one point he tried to break my grip of him and grabbed me around the leg. I yelled at the male several times to stop fighting and stop resisting.

We were able to cuff the male and once he was cuffed we began to search him for weapons. While the suspect was cuffed he continued to struggle and began reaching towards the front of his waist band and reaching into the back of his waist band. He was commanded several times to stop reaching for anything, but the suspect continued. He was also continuing to thrash around and struggle with us. The suspect was very flexible and he was able to reach the front of his waist band with both hands from both directions.

At this point I had started checking the left side of the suspect's body for weapons. Right about then I heard Officer Bishop yell "there it is, he's grabbing it" or something similar to that. I looked down and saw the male had reached into the back of his waist band towards his right side with both of his hands and I saw him clutching something inside his pants. At that point I believed he had just accessed a gun he had hidden and I now feared for my life and the lives of all my partners since we were all in very close proximity to each other. When the suspect's hands were pulled out of his waist band I could see what looked like something black in his hand. His hands were moving wildly as if he was trying to keep whatever he was holding. At that point because I thought he was holding a gun and feared being shot I delivered one hammer strike with my right hand to the side of the suspects face.

Crime:

We were investigating a DV assault with a weapon. The suspect was also under arrest for obstructing.

Threats to officers and public:

The suspect was digging around in his waist band. His waist band and the rest of him had not been checked yet. The suspect was very flexible and even though he was handcuffed he could easily reach areas on his body where he could conceal a weapon. The address where we were fighting with the suspect was unknown. I had no idea if the address was friendly to the suspect and all of our backs were to the front door. In my experience people who run from the police and when caught begin fighting are very dangerous and many police officers have been injured and killed in these exact situations.

Resistance:

The suspect had attempted to flee on foot when told to stop by police. When he was cornered he began fighting with multiple officers. He had at one point grabbed me by the leg and tried pulling me off him. He was continuing to ignore commands to stop fighting and stop reaching for things. He was able to reach into his waist band and appeared to be clutching an object. He was ordered several times to drop the item I believed he was holding. I ordered him to drop the gun (believing he had a gun) and told him if he didn't drop the gun he would be shot. Even after I struck him in the face he continued to resist and reach around his waist band and doing everything in his power to keep us from controlling his hands.

We were all finally able to control his hands and we searched him thoroughly fully expecting to find a firearm. Both of the suspect's hands were now empty and I could not find the item he had been holding. We finished searching the

suspect and did not find any weapon.

We stood the suspect up and searched him again because it was very difficult to conduct a full and proper search while the suspect was lying on the ground. When that search was completed I asked the suspect if he was injured.

The suspect (who was identified as Lonnie Lacey) said the side of his head hurt and his arms and wrist hurt. At that point medics were requested to check him out. I could see the suspect was bleeding from the mouth and there as blood in the snow where the fight occurred. I looked at the left slid of his face above his cheek and saw a red mark consistent with the strike I gave him.

On Saturday January 9, 2016 at 1811 hours I responded to the report of Domestic Violence at the field of the report stated that a Black Male assaulted the victim with an Axe Handle. As I approached the residence I observed a Black Male walking away from the area of the house. He looked over his shoulder and saw myself and OFC McMurtrey. He then started running North bound away from our location.

OFC McMurtrey and myself began chasing the suspect, later identified as Lonnie Lacy, on foot. Lonnie turned west through an alley, then jumped the back fence of 2217 E. 4th Ave. He had to jump a second fence of the same yard before reaching the front yard. Other officers were able to cut off Lonnie before he was able to make it back on to the roadway. When I came around the corner of the house I observed the other officer's attempting to detain Lonnie in handcuffs. I observed Lonnie continue to struggle against the officer and attempt to reach into his pockets. It was obvious to me that Lonnie was trying to access something either in his waist band or pockets. OFC McMurtrey and OFC Howe were able to secure Lonnie in handcuffs. Lonnie, however, continued to resist. He kept rolling from side to side, reaching around his waist. He kept pulling his hands away from the officers trying to hold him to the ground. At one point during the struggle I saw him reach inside the back of his pants. I then used my foot to hold his right hand to the ground. While Lonnie was on the ground pulling his arms away from the Officers, reaching for his waist band and pockets, and attempting to tuck his hands under his torso I advised him several times to stop resisting, relax his arms, and stop reaching for his waist and pockets.

- 1. At this point in my investigation I was aware that the suspect, Lonnie Lacy, had committed the crime of Obstructing a Law Enforcement Officer, and was suspected of committing Assault with a deadly weapon. He also committed the act of Burglary when jumped the fence at 2217 E. 4th Ave, by entering the yard with the intent of committing the crime of obstructing.
- 2. I believed that Lonnie Lacy posed a threat to myself and the other officers on scene because he was actively resisting uniformed police officers while reaching for his waist band and pockets. I knew that his waist band and pockets had not been PAT Frisked for weapons. I observed him take great measures to avoid being detained by running one and a half blocks and jumping two fences. I was convinced that he was willing to do anything in his power to avoid being detained by police up to and including assaulting anyone of the officers on scene with a weapon. He was so determined to reach in his waist band or pockets that after being detained in handcuffs he continued to fight against law enforcement and reach into his waist band.
- Lonnie was actively resisting Law enforcement by running away from the police of foot and continued to run
 after being advised to stop. After be taken to the ground by police he continued to resist police by pulling his

arms away from the police and tuck them under his body. After being handcuffed, Lonnie continued to resist Law enforcement officers by pulling his hands and arms away from the police while reaching into his waist band and pockets.

After Lonnie made several attempts to reach into his waist band and pockets after being advised to stop resisting and lay still OFC Bishop attempted to use an Electronic Control Device (Tazer) in probe mode. The Tazer had no visible effect on Lonnie's behavior. After quickly developing a plan to separate Lonnie's hands from his Torso and allow us to safely conduct a PAT Frisk, two officers lifted Lonnie's arms away from his body while another officer conducted a Prone PAT Frisk.

Lonnie then was escorted to a Patrol vehicle where he was evaluated by medics for the Tazer application. He was then escorted to the Spokane County Jail where he was booked for Obstructing and his DOC Warrant.

NARRATIVE:

On Saturday January 9, 2016 at about 1818 hours Ofc Kester and I (two man car) were enroute to a different call when we heard Ofc McMurtrey say over the air that he was in foot pursuit.

I knew prior to Ofc McMurtrey's radio traffic that he was on a domestic violence with a weapon call in which the complainant/victim said he had been hit in the chest with a handle of an axe by a male roommate. The complainant on that call described the suspect as a black male, 7'00 tall, wearing a black shirt and dark pants. Radio was not able to locate the name they gave for the suspect in our local database. That can be an indicator that someone is lying about their name.

I heard Ofc McMurtrey's radio traffic that he was unable to locate the complainant/victim of that call at the gas station, and he was then walking to the suspect address of **traffic**. The next radio traffic I heard from Ofc McMurtrey was that he was in foot pursuit. Due to the fact that Ofc McMurtrey was on a domestic violence call with a weapon, and was walking to suspect's residence, and then said he was in foot pursuit, I believed he was in foot pursuit of the suspect from the suspect's house.

Ofc Kester and I arrived onscene at 2217 E 4th. I observed Ofc McMurtrey, Ofc Howe, and Ofc Spolski kneeling down around the male, later identified as Lonnie Lacy. Ofc Wilkinson was there as well. As I walked up to them I heard Ofc Wilkinson tell Lonnie to stop reaching for things at least twice. They were trying to pat frisk Lonnie for weapons and Lonnie was squirming around purposefully not allowing officers to get a thorough pat frisk done on him.

I observed the male's face and recognized him as either Ronnie or Lonnie Lacy. The male verbally identified himself as Lonnie Lacy. I know Lonnie has an extensive criminal history.

Lonnie was lying on his stomach with his head up near the front fence of the yard. Ofc Howe was on Lonnie's right side up near his shoulder area. Ofc McMurtrey was on Lonnie's right side as well down near his legs. Ofc Spolski was on Lonnie's left side. I was standing up to the left of Ofc McMurtrey. As they rolled Lonnie up on his right hip to frisk the front left of him, I observed Lonnie reach his hands under his belt into the right hip area of his pants. I observed a bulge in his waistband exactly where he was now reaching. The bulge was of the size that could have easily concealed a knife or gun. Lonnie was wearing very baggy pants. The pants were baggy enough

that they could have concealed a gun or knife. Officers advised Lonnie that they were frisking him for weapons. He knew the officers intentions at that time, and he chose that exact moment to reach into his waistband and under his belt to try and gain access to whatever was in there. Based on his determination to access that item, the location of it being in his waistband, and the bulge I observed, I believed Lonnie was reaching for a gun or knife.

I yelled to the officer's "right there" numerous times and shined my flashlight on the area where Lonnie had been reaching. Other officers were trying to get control of Lonnie's hands. Lonnie is skinny and flexible and is able to reach around the front of his body even when his hands are in handcuffs.

Lonnie continued to struggle by squirming around with other officers and not take his hands out of the area of his waistband. It was very apparent that there was something Lonnie was trying to gain control of in his waist band area and now conceal from officers. I could no longer see Lonnie's hands and I was concerned he now had control of a weapon that he had previously hid in his waistband.

I deployed my taser in probe mode to the left lower back area of Lonnie for the following reasons:

CRIME: I knew Ofc McMurtrey had been investigating a domestic violence call in which the complainant said he was struck with a axe handle. Lonnie had also ran from Ofc McMurtrey in a foot pursuit and obstructed Ofc McMurtrey's abilities to investigate the initial domestic violence incident.

THREAT: In the initial domestic violence call, the suspect had used an axe to assault another person. The suspect was described as a black male, 7'00, wearing a black shirt and dark pants. Lonnie was a black male wearing a black shirt who ran from the area of the suspect's house. Lonnie loosely fit the description of the suspect male of the DV. I knew Ofc McMurtrey was unable to locate the complainant/victim on the domestic violence incident where he said he would be waiting for police contact. It was unknown if the complainant/victim of the domestic violence incident had returned home and been assaulted again by the suspect (possibly now Lonnie). The extent of the complainant/victim's injuries were unknown at that time as well.

I recognized Lonnie as either Ronnie or Lonnie Lacy when I arrived. He verbally identified himself as Lonnie Lacy. I know Lonnie Lacy to have a very extensive criminal record.

When I arrived onscene and first observed other officers around Lonnie trying to pat frisk him, I heard other officers tell Lonnie numerous times to stop reaching for things. Lonnie was purposefully trying to make it difficult for officers to pat frisk him thoroughly by rolling and squirming around. Lonnie was wearing very baggy pants held up with a belt and boxer style underwear underneath them. He also was wearing a large puffy style coat, an oversized black hoodie style sweatshirt, and a tee shirt. I thought he could possibly be the suspect in the domestic violence incident. That

suspect had been armed with an axe.

Lonnie had not been completely pat frisked for weapons, he refused numerous commands to stop reaching for things and allow offices to pat frisk him thoroughly, and now I had observed him reach his handcuffed hands into the right side waistband of his pants underneath his belt at what appeared to be a bulge in the side of his pants.

Officers were trying to get control of his hands and get them out of his waistband. Lonnie is skinny and is able to reach his arms well around the sides of his body. He is flexible enough that if he accessed a weapon, he would still be able to utilize the weapon while in handcuffs. It appeared to me that Lonnie had his hands around the right side of his body in his waistband area still, possibly now even more around the front of him. It is very common for people to conceal handguns and knives in their waistband area. I was now afraid that Lonnie had accessed a weapon and had it in his hands. Ofc Howe and Ofc McMurtrey and Ofc Spolski were so close to Lonnie that they were touching him. I was concerned Lonnie could seriously assault any of us with a gun or knife. I was also concerned that Lonnie now had either a gun or knife in his hands and could inadvertantly injure himself with the weapon while he continued to struggle with officers.

I heard Officer Howe yell at Lonnie something to the effect of let go, making me further believe Lonnie now had a weapon in his hands.

Despite multiple officers being onscene Lonnie was still able to overcome the officer's attempts at controlling his arms/hands, and was actively accessing his waistband area. I knew that the waistband area is frequently where psersons carry firearms and other weapons. If Lonnie was able to access a firearm or other weapon it would have put myself, other officers, himself, and bystanders in immediate danger. Further, if Lonnie was allowed to access a firearm it would have dictated an increased level of force be utilized by officers, likely resulting in seroius injury or death to Lonnie. As such, I deemed it reasonable and necessary to immediately incapacitate Lonnie to prevent him from accessing a weapon, and that the quickest and most effective way to accomplish the incapacitation was the use of my issued taser.

RESISTANCE: Lonnie had just ran from police in a foot pursuit. He was actively resisting officers by rolling around and squirming, making it purposefully difficult for officers to conduct a thorough pat frisk for weapons on him. He made a conscious and determined effort to reach into his right waist band area where guns and knives are commonly concealed on a person while officers were trying to frisk him for weapons. Officers advised Lonnie that they were trying to frisk for weapons, so it was even more concerning that Lonnie knew that was the intent of officers at that time, and it was at that time that he made the conscious and determined decision to try and access whatever was in his waistband.

I removed my taser and yelled taser a few times to the other officers and to Lonnie as a verbal

warning. It appeared other officers still did not have control of Lonnie's hands at that time. I then applied my taser in probe mode to the lower left back area of Lonnie. I felt it necessary to use probe mode as it was imperative that Lonnie be completely incapacitated as quickly as possible. Probe mode of the taser usually has a complete incapacitation effect, where drive stun is based on pain complainance.

Due to Lonnie's determination to access whatever was in his waistband I feared the pain complianance effect of drive stun would not work on him and I did not want to jeopardize other officer's safety by trying drive stun, and if failing to get the necessary effect on Lonnie, take more time to again use probe mode.

When I deployed my taser it did not appear to have any significant effect on Lonnie at that time. I could hear the taser clacking as though the circuit was not complete. As it was still in its 5 second cycle, I tried to apply the taser (now with the cartridge deployed) to his lower left leg to complete the connection. It still did not appear to have a significant effect on Lonnie.

Officers were able to gain control of Lonnie's hands. They completed another pat frisk for weapons. No weapon was every located. Lonnie admitted later to officers that he was reaching for marijuana/weed he thought he had on him in his pocket. Radio advised Lonnie had an outstanding DOC escape from community custody warrant.

After Lonnie was frisked for weapons, I observed one of the taser probes was hanging loosely from the cartridge line. It never connected with Lonnie or his clothing. The other probe was stuck in Lonnie's puffy jacket. No probes had entered Lonnie's body.

Corporal Spiering arrived and took photographs of the above described probes. He removed the probe from Lonnie's jacket. Ofc Bode and Ofc Marquez took the taser cartridge and probes to place on Police Property as Evidence.

Medics arrived onscene but were not needed to remove the probes. Sgt Bartlett was onscene as well and notified of the above information.

Lonnie was transported to Jail and booked on his warrant and obstructing.

On 1/9/16 at 1824 hours, Officer E Bishop and I (two man unit) were enroute to an unrelated call when we heard Officer McMurtrey in foot pursuit so we responded to assist.

I knew from listening to radio traffic that officers were responding to a DV with a weapon where the , called and stated a male who lives with him at, #10 hit him in #1a complainant. the chest with an axe handle. The suspect was described as a black male, 7'00" tall, wearing dark pants and a black shirt and was still at the house on 4th. The complainant was waiting at Cenex Zip Trip (3rd and Altamont).

Officer McMurtrey advised he did not see the complainant at Zip Trip and would walk to the residence. Just minutes later Officer McMurtrey advised he had a male running southbound from 3rd at 1824 hours. At 1825 hours officer's advised one was detained and they were now at 2217 E 4th.

As we arrived on scene, Officer's Howe, Wilkinson, Spolski and McMurtrey were already on scene in the front yard of 2217 E 4th with a male who at that time was in handcuffs. He was a black male wearing a black top and tan pants. They were attempting to do a pat down of the male and had to continually tell him to stop reaching for things. He was in the prone position on his stomach but I could tell he was still squirming and moving around not complying with officers. His hands were behind his back in handcuffs but he kept pulling his hands from the officers grip.

I heard Officer E Bishop say "right there" in his waistband. It appeared he was grabbing or reaching for something in the back waistband of his pants. I attempted to help in gaining control of his hands to keep him from reaching for items on his person but he continued squirming. The male was wearing layers of clothing and had a puffy vest/jacket on making it very hard to check for any weapons on him. This put officers as well as the suspect in a very dangerous position. It was unknown what weapons may be concealed on the male and what the males intentions were. Officer Bishop advised she was going to deploy her taser on the male and did so. She deployed her taser to the back area of the male. See her additional for more information. We continued to thoroughly search the male for any weapons. Officer Bishop advised radio of the males name which then came back showing he had a felony warrant.

Officer Spiering arrived on scene for photos and the male who was now identified as, Lonnie D Lacy

On 1-9-16 at around 1845 hours, Officer Bode and I responded to the 2200 block of East 4th Ave, to provide assistance to Officer C. McMurtrey, who was involved in a foot pursuit with a wanted suspect, named Lonnie Lacy.

On scene we arrived to support the investigation. I met with Officer E. Bishop, who asked me to take custody of a spent Taser Cartridge (S/N-C4104091R) and place it into property.

After securing the cartridge, I interviewed the listed witness, Chris Bellus, who resides at 2217 East 4th Ave. Bellus stated on this date at around 1830 hours he heard yelling coming from the front yard of his residence. Bellus stated when he looked outside his front door he observed 2 SPD Officers struggling with a male on the ground near the side walk. Bellus stated as he was stepping off his front porch, a SPD Officer asked him to stay inside the residence until the suspect was under control. Bellus stated he complied with the Officer's request and went back inside.

Bellus stated he has lived at the listed address for 8 years and didn't know the suspect or why he ran into his yard.

With the interview complete and the scene secured, Officer Bode and I drove to the Property Control Center to place the Taser cartridge into evidence.

On 010916, I responded to DV at **11** Radio advised that the complainant, **11 11** was calling from the Cenex at Altamont/3rd and reported his roommate, David Everett, hit him in the chest two times with an axe handle. He was described as a black male, approx 7-0, wearing a black shirt and black pants.

While enroute I heard Ofc. Mcmurtrey advise that he could not locate the complainant at the Cenex and would be walking to #1a . I responded to the 4th address and saw Ofc. Mcmurtrey and Ofc. Wilkinson at the corner of Stone/4th.

As I got out of my car I saw Ofc. Mcmurtrey and Ofc. Wilkinson take off and run northbound on Stone and then westbound through the alley just north of 4th. I heard Ofc. Mcmurtrey advise they were in foot pursuit and were westbound in the alley.

I got back in to my patrol vehicle and started westbound on 4th. I heard Ofc. Mcmurtrey advised the suspect was southbound at the third house. I stopped my patrol car in front of the home and saw a black male, wearing a black coat and pants. The male matched the suspect description of the suspect from the DV that hit his roommate with an axe handle.

The suspect climbed over the front backyard fence on the east side of the home. Because of the following factors:

Crime-He was a suspect in a DV where an axe handle was used in an assault of his roommate.

Threat-He had not been searched and the knowledge at the time was that he could still be armed with at least the axe as well as the possibility of being armed with knives and a gun.

Resisting-He was actively attempting to elude uniformed police officers by running away from them.

Because of these factors I drew my duty pistol and pointed it at the ground in front of him and ordered him to get on to the ground.

The suspect ignored my commands and continued to walk in a southwest direction towards the front gate of the property. I ordered him several more times to get on the ground. The suspect refused to cooperate and stated he did not do anything.

I was concerned that the suspect was not afraid that I was holding a loaded pistol. It did not appear he was in a mental state where he was making rational decisions.

I was relieved when I saw Ofc. Mcmurtrey come from behind him and guide him to the ground preventing me from shooting him.

Ofc. Mcmurtrey was laying on the suspect's upper body. I re-holstered my duty pistol and grabbed the suspect's legs, crossed them and held them down in an effort to limit the suspect's movement.

The suspect was not cooperating and yelling that he could not breath and to let him up. It was clear that he could breathe by the way he was yelling. He was told numerous times to stop resisting.

The suspect attempted several times to reach into his pockets and waist band. At the time I did not know if the suspect had a gun, knife or another weapon he was reaching for. He continued to attempt to resist us by pulling his arms away from Officers, rolling around and attempting to kick his legs free.

The suspect was eventually detained in handcuffs but he continued to roll around and was attempting to kick his legs free. The suspect continued to attempt to reach in to his pockets and waist band.

I quickly frisked the suspect for weapons in his waist band and pockets. Do to his erratic movements I did not feel I was able to get a complete check for weapons on him making him a continued danger as he continued to attempt to reach in to his waist band and pockets. He was still trying to break free from us by rolling around.

We continued to tell the suspect numerous times to stop fighting and to stop resisting and to calm down. Ofc. Bishop arrived and I heard her yell that the suspect was reaching for something and she could see the object.

Knowing that I had been unable to conduct a complete and thorough search for weapons on the suspect due to his actions I was still concerned the suspect could be armed and reaching for a weapon. For the following reason's I felt it was necessary for Ofc. Bishop to utilize her Taser on the suspect:

Crime-He was still a suspect in a DV assault where an axe was used.

Threat-I was unable to conduct a complete and thorough frisk for weapons on the suspect because he was actively rolling around and trying to get away. He continued to reach in to his pockets and waist band.

Resisting-He was actively resisting even in handcuffs by trying to kick his feet away, rolling around and trying to reach for an unknown object on his person.

Ofc. Bishop utilized her Taser on the suspect but I did not see the probes penetrate and make a connection. I could hear a clear audible clacking sound consistent with the Taser not completing the circuit. The suspect continued to yell and roll around.

I searched the male again but did not find any weapons on him. The suspect eventually calmed down and was placed in to a patrol vehicle.

After placing the suspect in to the car I assisted other officers at the house, see their report.

On Saturday January 9, 2016 at 1811 hours I responded to the report of Domestic Violence at Ave. The report stated that a Black Male assaulted the victim with an Axe Handle. As I approached the residence I observed a Black Male walking away from the area of the house. He looked over his shoulder and saw myself and OFC McMurtrey. He then started running North bound away from our location.

OFC McMurtrey and myself began chasing the suspect, later identified as Lonnie Lacy, on foot. Lonnie turned west through an alley, then jumped the back fence of 2217 E. 4th Ave. He had to jump a second fence of the same yard before reaching the front yard. Other officers were able to cut off Lonnie before he was able to make it back on to the roadway. When I came around the corner of the house I observed the other officer's attempting to detain Lonnie in handcuffs. I observed Lonnie continue to struggle against the officer and attempt to reach into his pockets. It was obvious to me that Lonnie was trying to access something either in his waist band or pockets. OFC McMurtrey and OFC Howe were able to secure Lonnie in handcuffs. Lonnie, however, continued to resist. He kept rolling from side to side, reaching around his waist. He kept pulling his hands away from the officers trying to hold him to the ground. At one point during the struggle I saw him reach inside the back of his pants. I then used my foot to hold his right hand to the ground. While Lonnie was on the ground pulling his arms away from the Officers, reaching for his waist band and pockets, and attempting to tuck his hands under his torso I advised him several times to stop resisting, relax his arms, and stop reaching for his waist and pockets.

- At this point in my investigation I was aware that the suspect, Lonnie Lacy, had committed the crime of Obstructing a Law Enforcement Officer, and was suspected of committing Assault with a deadly weapon. He also committed the act of Burglary when jumped the fence at 2217 E. 4th Ave, by entering the yard with the intent of committing the crime of obstructing.
- 2. I believed that Lonnie Lacy posed a threat to myself and the other officers on scene because he was actively resisting uniformed police officers while reaching for his waist band and pockets. I knew that his waist band and pockets had not been PAT Frisked for weapons. I observed him take great measures to avoid being detained by running one and a half blocks and jumping two fences. I was convinced that he was willing to do anything in his power to avoid being detained by police up to and including assaulting anyone of the officers on scene with a weapon. He was so determined to reach in his waist band or pockets that after being detained in handcuffs he continued to fight against law enforcement and reach into his waist band.
- 3. Lonnie was actively resisting Law enforcement by running away from the police of foot and continued to run after being advised to stop. After be taken to the ground by police he continued to resist police by pulling his

arms away from the police and tuck them under his body. After being handcuffed, Lonnie continued to resist Law enforcement officers by pulling his hands and arms away from the police while reaching into his waist band and pockets.

After Lonnie made several attempts to reach into his waist band and pockets after being advised to stop resisting and lay still OFC Bishop attempted to use an Electronic Control Device (Tazer) in probe mode. The Tazer had no visible effect on Lonnie's behavior. After quickly developing a plan to separate Lonnie's hands from his Torso and allow us to safely conduct a PAT Frisk, two officers lifted Lonnie's arms away from his body while another officer conducted a Prone PAT Frisk.

Lonnie then was escorted to a Patrol vehicle where he was evaluated by medics for the Tazer application. He was then escorted to the Spokane County Jail where he was booked for Obstructing and his DOC Warrant.

NARRATIVE:

On Saturday January 9, 2016 at about 1829 hours I was involved in a use of force with a taser application with Lonnie Lacy. I wrote my initial report that night and re-read it again today. I felt it important to make some clarifications to my initial report.

When I arrived onscene, Ofc McMurtrey, Ofc Howe and Ofc Spolski were already there with Lonnie. They were knelt down around him. Ofc Howe was on Lonnie's right side up by his shoulders/head, Ofc McMurtrey was on Lonnie's right side down by his legs and Ofc Spolski was on the left side area of Lonnie's body. Ofc Wilkinson arrived about the same time I did and was standing by Lonnie as well.

As Ofc Kester and I were pulling up to the house, Ofc McMurtrey advised they were detaining one. This radio traffic was put out just as I was exiting the patrol vehicle. As I approached Lonnie and the other officers, I thought the other officers were still in the process of placing Lonnie in handcuffs because he was still squirming around and appeared to be resisting their attempts to control him.

When I approached Lonnie, I shined my flashlight on his face and was focused solely on his face. I had recognized him as either Ronnie or Lonnie Lacy. I asked him who he was and he verbally identified himself as Lonnie Lacy. I stepped back away from Lonnie and asked Radio to run Lonnie Lacy for any outstanding warrants.

I then stepped around Ofc McMurtrey to the left side of him down near Lonnie's legs. Lonnie had been told numerous times to stop reaching for things and he was purposefully squirming around so officers could not get a thorough pat frisk for weapons done on him.

I knew Ofc McMurtrey had just been involved in a foot pursuit. Foot pursuits are exhausting and can take all the energy out of any officer. As I stepped around to the left side of Ofc McMurtrey, my body and body

camera were pointed at Lonnie's back. However, at that moment I had placed my right hand on Ofc McMurtrey's left shoulder and looked down at him so that he knew I was there. Right as I looked back at Lonnie's back, I observed his hands reaching for the right side of his waistband under his belt. This is the moment I yelled to other officers that Lonnie was reaching in his waistband. Although Lonnie's hands were behind his back, both of his hands were now off to the right side of his body out of my sight.

At this point, I removed my taser and gave the verbal warnings that I had my taser out and then deployed it (see my initial report).

Prior to my taser deployment, I did not think Lonnie was in handcuffs. I thought officers were in the process of trying to place him in handcuffs and frisk him for weapons when I observed Lonnie reach his hands into his waistband. All I saw at that moment was Lonnie's hands reaching into his waistband, I did not see the handcuffs on him.

Immediately after my taser deployment when officers regained control of Lonnie's hands, I observed the handcuffs on Lonnie and knew then that he had been in handcuffs when I deployed my taser.

After the incident I reviewed my body camera. At the moment when I reached over to Ofc McMurtrey with my hand while looking at him, my body camera is pointed at Lonnie's body. I observed this portion of my video and saw then that Lonnie was in handcuffs when he had reached into his waistband.

I wrote my initial report using the verbiage that I had observed Lonnie reach into his waistband with his handcuffed hands. This is because I knew at the time that I wrote my report that Lonnie's hands had been in handcuffs because I observed my body camera video and had obviously discovered that after my taser deployment. However, I did not think Lonnie was handcuffed at the time that I deployed my taser on him. I thought officers were still attempting to place him in handcuffs and he had then reached for a weapon in his waistband during that time when they were attempting to get him into handcuffs and frisk him for weapons.

I wrote in my initial report that Lonnie is skinny and flexible and is able to reach around the front of his body even when his hands are in handcuffs. This was an observation that was obviously made as a result of this incident after I recognized Lonnie had been in handcuffs when he reached for what I thought was a weapon in his waistband and was able to

resist officers attempts to gain control of his hands immediately after my observation.

I also wrote that Lonnie is flexible enough that if he accessed a weapon, he would still be able to utilize the weapon while in handcuffs. This again was another observation that was obviously made as a result of this incident after I recognized Lonnie had been in handcuffs when he reached into his waistband.


