<u>Incident Summary:</u> Officers responded to the call of a father following his suicidal and disorderly adult son. The suspect became assaultive towards his father and officers. He was subdued with a TASER application by each of the two officers on scene. (See officer reports for more specifics)

Officer Interview Summary: I spoke with officers Fiskvik and Fisher. They described the suspect's erratic behavior that suddenly escalated to an unexpected assault on his father, who was sitting nearby. Officers went to take the suspect into custody. The suspect became assaultive towards them in the process. (See officer reports for more specifics) Both officers deployed their TASERs in dart mode to subdue the suspect. Officer Fisher sustained abrasions to his right index finger and right forearm during the arrest.

<u>Subject Interview Summary:</u> I was able observe the suspect and his demeanor when I arrived on scene. He cooperated for officers and medics. SFD medics removed TASER probes. Medics advised the suspect had an elevated heart rate, so he was transported to Deaconess via AMR.

I contacted the suspect in hopes of interviewing him. He was cooperative and engaged me in conversation. He admitted to his disorderly behavior prior to SPD arriving. He also took responsibility for his behavior towards officers. Sgt Hartman's body camera footage (the video is 4:31 in length with markers added) shows this interview.

Witness Interview Summary: I interviewed the suspect's father, at the scene. He was the victim of the DV assault and is listed on the police report face sheet. His interview is captured on Sgt. Hartman's body camera video (the 30 minute long video) and the most pertinent portion is marked for easy access. described aggressive behavior by his son towards officers. He had no issue with officers' actions during and after the arrest.

Witness Officer Interview Summary BWC Y/N: No witness officers besides the two officers involved in the UOF.

Any Relevant Clarifying Information and Observations: When I arrived on scene I checked on the status of officers and the suspect who was in police custody. Medical aid was rendered for the suspect and we gave special attention to potential medical, developmental disability, and mental health issues the suspect might be dealing with after the suspect's father gave us this information. Prior to the booking process I telephoned the on duty Jail Booking Supervisor. I notified him of the suspect's suicidal statements, along with his potential mental health and developmental disability issues. I did this to allow corrections staff to appropriately classify the suspect and provide him adequate supervision. I requested that mental health professionals assess the suspect prior to his release from jail.

At the scene I looked for any onlookers that might have witnessed police/suspect interactions. I saw none. I asked Officer Voeller to do a canvas of the immediate area, including knocking on nearby doors, in hopes of locating any witnesses or possible surveillance camera systems. Voeller's canvas yielded no witnesses (See his additional).

TASER information and issues

This supervisor experienced significant issues with downloading the two TASERs involved. Several other patrol supervisors and I tried to download the TASERs, but were denied access in the SYNC software. Three days after the incident Sgt. Gately, who has administrative rights, was able to access and print out the TASER logs and graphs. As of 8/16/16 I am still locked out of accessing information from officers' TASERs.

Officers used a total of two TASER cartridges on this call. The cartridges, probes, and wires were collected and placed on property. The two cartridge serial numbers were: C4013DAEY and C41040HYR. The dart hits by both officers were very close in proximity. Coupled with the chaos of the arrest and subsequent medical response, I was unable to determine for sure which darts came from which TASER cartridge. However the four probes removed by medics is consistent with the description of events provided by officers. I do not have access to a database that allows me to identify the officers who were issued the above listed cartridges.

Downloading Officer Fiskvik's TASER we discovered it was mistakenly assigned to Sgt.Carpenter. This issue was corrected.

Downloading Officer Fisher's TASER we discovered several problems. Even though the TASER seemed to function properly during the incident, the cover sheet of the device log showed a "Major Error" flag under the Health column. I also discovered major deviations in dates and times on the log. The dates jumped around, including dates in 2001 and 2020. No TASER use was recorded on the date of the incident. The most recent usage graph was a single five second graph from "July 27, 2016 07:43:44". Officer Fisher did work that day according to Telestaff and CAD, but this time is outside of his normal shift hours. CAD doesn't show him logged on at this time. I included the graph from the date above, but it remains unclear if it is associated with the 8/14/16 incident. I directed Officer Fisher to contact Sgt. Boothe at the academy and to request a replacement TASER.

Sergeant Findings:

After investigating this incident I believe that Officers Fisher and Fiskvik acted appropriately and within the scope of department policy and training. They employed VDI tactics, prior to the suspect erupting. I believe their use of force was reasonable and necessary to secure and control a violent suspect.

for the basketball courts.

I then went to speak with Darren who was still sitting down on the front porch attached to the house. I was unaware of what Darren had talked to Officer Fiskvik about prior to me speaking with him. (Please see Officer Fiskvik's Additional for further). I asked Darren why he was acting out today. Darren stated it was over a girl. Darren stated the female did not want anything to do with him anymore and it was hard for him to move on. I asked Darren if he was throwing rocks and tearing down signs because of this female. Darren stated he was. I asked Darren what he was throwing rocks at. Darren stated he was throwing rocks at cars and that "thankfully he missed." I asked Darren why he was throwing rocks at car windows. Darren stated he wanted to break them.

I began asking Darren if he was willing to go get some help with his problems by going up to Sacred Heart to talk with someone that wasn't a Police Officer. Darren stated he was not willing to do so. I asked Darren if he just wanted to get away from everything and would be willing to get help. Darren stated he did not and that he was mad at himself and mad at the female in question. I asked Darren if he was willing to help his dad out by going to get help. Darren stated he was not. Darren then looked over at who was sitting about 8-10 feet away and yelled in anger, "no because he treats me like a fucking child." Darren was apparently upset with and his (Darren's) living situation.

Darren then stated that he was "really pissed off at the aspergers testing people." Darren was visibly and verbally upset talking about his Aspergers testing process etc.

I then asked Darren what we needed to do to help him out so we could fix the situation and not have to come back to his house and arrest him for doing something such as breaking a window or hurting himself. Darren began to talk about the Bible story of Moses when Moses hit the rock because he was irritated with everyone else and related his frustration in the same way.

Darren then asked me, "If I attacked you would she (referring to Officer Fiskvik) kill me." Darren then began making statements about police brutality happening around the country. I asked Darren if he was feeling suicidal and wanted to hurt himself today. Darren stated, "Death by cop." I asked Darren to say what he said again. Darren stated slowly and loudly, "Death by Cop." I asked Darren if that was what he was felling like today. Darren stated, "yes". I asked Darren what his plan to act upon that today was. Darren just stood there silent and straight faced and did not answer my question. Darren began to take off his watch as if he was preparing to rid himself of anything on him for a fight. Darren took the watch off of his wrist and instantly threw it at his father face.

From what I could see the watch hit in the face as he flinched from the impact of the watch. I immediately signaled to Officer Fiskvik a hand signal that we were going to take Darren into custody. Officer Fiskvik and myself moved in on Darren and grabbed both of his wrists to attempt to take him into custody. Darren began by immediately resisting being taken into custody tensing up his body and fighting with Officer Fiskvik and myself to get free. Darren began swinging his arms and kicking

Crime:

Malicious Mischief, Disorderly Conduct, Assault IV and Assault III (On Law Enforcement)

Threats:

Darren had been showing signs of suicidal ideations by not caring what others did to him and placing himself in harms way. Darren was throwing rocks at vehicles and his father attempting to cause damage to property and person(s). Darren was also throwing apples at houses attempting to cause damage to property. Darren was placing him self in danger by walking in front of vehicles not caring about the outcome. Darren was also harassing and threatening innocent and uninvolved bystanders trying to lure them into a fight prior to Law Enforcement arriving.

Darren's behavior while talking with him began to escalate in to frustration about his father Rules and his Aspergers testing process. Darren was raising his voice and shouting in anger towards me while talking about the issues. Darren began to have a blank stare on his face not looking at me and was non responsive to my questions. Darren appeared to be thinking about what his next move was going to be and how he was going to do it. Darren began to take off his watch in a manner that appeared he was preparing for a fight trying to rid himself of any object that might get in the way restricting him. Darren had assaulted his Father with a watch he took off of his wrist and intentionally threw at head with much force.

I observed that Darren was of a larger statute and I estimated him to be approximately 6'2" and approximately 250 lbs which is bigger than me. I had not searched Darren and was unaware of any weapons Darren may be carrying on his person at the time. Darren was also on the front patio of his residence and I was unware of what weapons may be inside of the residence accessible to Darren. It was unknown who else may be inside of the residence that Darren would have access to.

Darren's father was within 10 feet of Darren and it was apparent Darren had no regard for safety after throwing a watch at face. While moving in towards Darren to take him into custody I observed Darrens fist ball up in a manner that appeared he was getting ready to assault me. Darren appeared to tense up his body as I moved in towards him. It was unknown what other intent Darren had in mind besides the known fact he just informed me he wanted to die from suicide by cop.

Resistance:

Darren had tensed up his arms and balled up his fists to attempt to escape the controlled hold

Officer Fiskvik and myself were trying to place on him. Darren began swinging his arms and kicking his legs towards Officer Fiskvik and myself to get free from being placed in custody. I was kicked in the chest by Darrens foot while he was on the front porch. Darren would not listen to commands to stop resisting and was yelling/grunting in anger while fighting with Officer Fiskvik and myself to be taken into custody. Darren then lunged forward towards Officer Fiskvik. It appeared to me as if Darren was attempting to tackle Officer Fiskvik and potentially assault her. At the point Darren had gotten free from my grasp it appeared Darren had reached his hands out and attempted to grab the gun side of Officer Fiskvik's duty belt. I believed Darren was attempting to grab a weapon from Officer Fiskvik's duty belt to aid in helping him die from suicide by cop. At this point I grabbed Darrens shirt as it was the only thing I could grasp on him at the time and pulled him away from Officer Fiskvik hoping to create space for her to get distance from him.

Due to the above factors

After Officer Fiskvik had deployed the first Taser application I observed Darren begin to fight his way back towards Officer Fiskvik's direction and lunge towards her from the ground. It appeared to me that Officer Fiskvik's Taser had stopped working or that one of the probes may have lost contact with Darren making her Taser useless.

At this point I drew my Taser and applied a probe application to Darren's body at approximately 8-10 feet away from him. It appeared the application was working as Darren had stopped moving towards Officer Fiskvik.

At this point I began shouting commands to Darren to roll onto his stomach and put his arms out. Darren complied by rolling onto his stomach. Officer Fiskvik and myself were able to place Darren into double locked handcuffs. Darren was sat up and placed back onto the front porch of the residence to be out of the sun and in a more comfortable position while waiting for medics. Darren was advised he was under arrest and I read him his Miranda Warnings from my custodial interrogations card. Darren advised he understood his rights and was willing to talk with me. Darren did not speak with me about the incident any further until he was released from the hospital.

Darren was transported to Deaconess Hospital where he was treated for the Taser applications and elevated heart rate per Spokane Fire Department on scene.

While walking to my vehicle with Darren after he had been medically cleared I asked Darren about the assault. I said to Darren, "at one point you attempted to grab after my partner's duty belt is that right." Darren replied, "yeah." I then asked Darren what he was going after. Darren replied "The Gun."

Once medically cleared Darren was transported to the Spokane County Adult Detention facility where he was booked in for Assault IV DV and two counts of Assault III.

Upon arrival Officer Fisher and I approached the house. Both and Darren were sitting outside on the front porch. Officer Fisher contacted while I contacted Darren. Darren admitted he was upset. He said he had been talking to a female from church that he liked. He went on to explain that she currently has a boyfriend and all of a sudden she "put up a wall" and began distancing herself from him. This obviously upset Darren because he had feelings for this female. Darren began to calm down once he was able to vent and talk to someone about his built up frustration.

Darren said he wanted to go for a walk to cool down and he said he typically does that when he's upset. When I asked him why he was walking in and out of traffic he said he wasn't trying to and that there were no sidewalks forcing him to walk in the middle of the street. He said every time a car came close to him they would just drive around him. He admitted to pulling off signs in people's yard as he walked down the street because he was angry.

I asked Darren if there was any possibility he was walking in and out of traffic to harm himself or even kill himself. He told me he did not want to hurt himself and that he was just going for a walk. Darren went on to explain that he takes anti-depressant medications and has Asperger Syndrome although he has not been truly diagnosed with it. While I was talking with Darren he would avoid eye contact and would randomly zone out of the conversation. Darren also said while he was walking down the street he yelled to the whole neighborhood, "Gods coming soon and you better get right with him or die." I asked why he would say that and he said because it's true. Darren would not elaborate any further about the topic.

Officer Fisher then came over and contacted Darren as well. Officer Fisher offered for Darren to go up to the hospital to be able to talk to someone and get away from the current situation. Darren advised he did not

want to go anywhere. Darren then became very upset and turned to his dad and screamed, "he treats me like a fucking child at times, with the goddamn video games." Darren was obviously upset with his father although he would not admit it. He then went on to yell that he was "really pissed off at the Asperger people" because they were taking too long to get his results back.

Darren continued to rant on about several different things that made him more and more angry. At that moment in time we did not have enough things to meet the criteria for doing an involuntary transport to the hospital. Officer Fisher asked what other options there were to fix the issue since he did not want to go to the hospital. Darren replied by saying "just shoot me." He then asked Officer Fisher, "If I attacked you would she kill me?" Officer Fisher advised that we were not going to go through what if scenarios. Darren then began discussing police brutality around the world.

Darren then said "death by cop" under his breath. Officer Fisher asked him to repeat himself one more time and that's when Darren yelled "death... by... cop..." to get his point across. That's when Officer Fisher asked what he meant by that and what his plan was for that today. Darren did not say anything back and just sat there. Everything was silent for several seconds and Darren still refused to answer the question. That's when Fisher asked him if we were all done talking. Darren once again just sat there on the front porch without saying anything. He then began to take his Velcro and metal watch off his right wrist. He took it off and turned in his father's direction. He then threw his watch extremely hard at his father who was also sitting on the front porch approximately 10 feet away from him. The watch hit his father on the right side of his head and continued flying several more feet and landing in the dirt flower bed in front of the house. At that point we had a criminal charge of assault fourth degree (DV). Officer Fisher gave me our hand signal which meant we were going to move in on Darren to gain arm control so we could place him into handcuffs since he was now going to be under arrest for city assault dv.

Officer Fisher and I moved in at the same time to grab arm control. I grabbed ahold of Darren's left arm while Officer Fisher went to gain control of Darren's right arm. When we went hands on Darren immediately stood up from the edge of the front porch and pulled his arms back towards the center of his body so we would lose control of his arms. As he was pulling his arms away he then pushed me away with both of his hands in attempt to get away. Officer Fisher continued to gain control of Darren. Darren then ended up on his back on the porch. He then began kicking his legs at Officer Fisher and striking Officer Fisher at least one time in the chest. As he was on the ground kicking he was grunting very loudly. He then continued to fight and shifted his body towards the edge of the porch towards the front yard. Darren continued to wrestle with Officer Fisher.

I advanced back towards Darren to assist Officer Fisher who was still trying to gain control of Darren. Darren was able to advance on me so quickly that he was able to lunge forward and place his hand on my duty belt. He placed his hand on the holster of my service weapon. I was able to hear the top part of my gun holster move as he placed his hands on my duty belt. I feared he was going to gain access to my gun because of the

comments he made earlier that he wanted "death by cop".

I stepped back to gain distance between Darren and myself. I then told Officer Fisher I was going to use my Taser. Officer Fisher pushed off of Daren to gain distance so I could deploy the probes on my Taser. I was aiming for the lower torso on Darren.

At this moment I chose to deploy my Taser for the following reasons:

Crimes:

Darren had already thrown rocks at vehicles out of anger along with tearing down signs in citizen's yards which is the crime of malicious mischief.

- Darren was threatening citizens in the neighborhood.
- Darren assaulted his father (Fourth degree assault DV), which is a violent crime against another person.
- Darren assaulted Officer Fisher and myself (third degree assault) which is a felony.
- Immediate threats that Darren posed to the safety of Officer Fisher, his father and myself:
 - Darren is larger than both Officer Fisher and myself. At the time of the incident Darren advised he was approximately 6'2" and approximately 240 pounds. I am a female who is 5'7" and about 100 pounds lighter than he is.
 - Darren had not been frisked for weapons prior to going hands on with him. He had large jean pockets that could have easily concealed a weapon.
 - His demeanor was inconsistent and the moment we went hands on he was extremely angry.
 - Darren's father was approximately 10 feet away and I was unsure if his father was going to step in and help his son since they are family which would have made it two people against two people. His father is also a larger male who was about Darren's size or even possibly heavier.
 - The yard we were standing on was extremely bumpy and there were several areas that had concrete including the sidewalk and front steps. I was in fear that I could have been pushed over and could have hit my head on one of those surfaces.
 - Darren advised he wanted "death by cop" and that made me believe he wanted us to

end his life and would have done anything to make that happen.

- Darren was actively resisting:
 - When I went to grab left arm control of Darren he instantly pulled his arm away with the intent to get away.
 - He then continued to resist by punching me away.
 - He then kicked Officer Fisher in attempt to get away once again, still refusing to listen to commands.

After deploying the probes of my Taser for a five second interval Darren got up to his hands and knees and began advancing towards Officer Fisher and I. I was giving Darren several commands to get onto his stomach. He refused to do so. When I initially deployed the Taser I was approximately 7 to 8 feet away. Darren was still not listening to our commands and still trying to advance on us. I pulled the trigger on my Taser to send another 5 second shock interval with the same probes I had initially deployed from my Taser.

I applied a second Taser interval for the reasons listed above. Once I applied the second 5 second interval shock Darren implied that he was giving up and was going to stop resisting. He flipped over onto his stomach and listened to commands to put his hands behind his back. We were able to peacefully get Darren into handcuffs (DL). I advised to police radio that we had deployed our Tasers and needed AMR to respond along with the Fire Department to assess Darren and remove the Taser probes. Darren became cooperative once we had deployed our Taser's and even stated it had calmed him down.

The fire department arrived on scene and removed the probes. Darren was then transported to Sacred Heart Medical Center to be fully assessed prior to going to jail.

I developed probable cause to arrest Darren for Fourth Degree assault DV because Darren threw the watch at his father's head right in front of us. I also had probable cause to arrest Darren for two counts of Third Degree assault. Darren assaulted Officer Fisher by kicking him at least one time in the chest. I was also assaulted by Darren when he used both hands to push me away from me.

Officer Fisher followed behind AMR to Sacred Heart Medical Center and waited for the doctors to clear Darren. Once Darren was medically cleared he was transported to Spokane County Jail and was booked for Assault Fourth degree DV, and two counts of third degree assault.

Corporal Spiering arrived on scene and took photographs of the scene, probes inside Darren and several other important pieces of the scene. See photographs for further information.

The undersigned, a law enforcement officer, competent to testify, states as follows: That he/she believes a crime was committed by the above named defendant/defendants in the City and County of Spokane, State of Washington, because:

can attest to the following:

- He is the father of the defendant. On 08/14/16 at approximately 1502 hours ha called 911 because his son, the defendant was walking in and out of traffic and he felt his son was trying to get hit by a car intentionally and kill himself.
- He advised his son was also throwing rocks at him, at vehicles in the neighborhood and trying to start fights with citizens in the neighborhood.
- He advised his son would not be cooperative and has Asperger syndrome.
- He was able to get the defendant back to their house at Spokane, WA.
- He observed his son become upset with him and officers that were questioning him.
- He was hit in the head with a watch his son threw at him while on the porch of

Officer Fisher will attest to the following:

- He is a fully commissioned police officer for the Spokane Police Department and was acting in that capacity on 08/14/16 at approximately 1502 hours.

- He responded to 1403 W Grace Ave Spokane, WA for a disorderly male who was possibly suicidal.
- He arrived on scene and contacted and interviewed
- He witnessed the defendant throw his watch at his father.
- He went to grab arm control and the defendant who began to resist. The defendant ended up on his back and was kicking at him attempting to get away. The defendant struck him in the chest at least one time with his foot.
- He then gained distance and deployed his Taser. He was eventually able to get the defendant into handcuffs (DL).
- He observed the defendant push Officer Fiskvik and attempt to grab Officer Fiskvik's gun on her duty belt.
- He transported the defendant to Sacred Heart Medical Center where the defendant was medically cleared. He then transported the defendant to Spokane County Jail and booked him into jail for the charges listed above.

Officer Fiskvik will attest to the following:

- She is a fully commissioned police officer for the Spokane Police Department and was acting in that capacity on 08/14/16 at approximately 1502 hours.
- She responded to 1403 W Grace Ave Spokane, WA for a disorderly male who was possibly suicidal.
- She contacted and interviewed the defendant.
- The defendant advised he was not suicidal and that he was just upset because the girl he likes from church is distancing herself from him and he wanted to go for a walk to cool down.
- The defendant advised he was not walking in and out of traffic and that he
 was only walking in the middle of the street because there were no sidewalks.
 He advised he was not suicidal and that his intentions were not to get hit by a
 car.
- The defendant also advised he did indeed remove some signs from neighbor's properties because he was angry.
- The defendant also admitted he threw rocks at cars because he was angry but none of them hit the vehicles.
- Officer Fisher and she were speaking with the defendant who became very upset at his father for treating him like a child and because the doctors were taking too long with his Asperger syndrome diagnosis.
- The defendant became very angry and began talking about police brutality and how he wants "death by cop".
- The defendant then stopped answering Officer Fisher's questions and sat on the front porch of the house without saying anything. The defendant removed his Velcro and metal watch off his right wrist and turned towards his father who was also sitting on the front porch approximately 10 feet away from him.
- The defendant then threw the watch at his father striking him on the right side of the head. The watch continued sailing through the area due to the hard throw and landed in the flower bed in front of the house several feet further.

- Officer Fisher and she made a hand signal that they were going to gain control of the defendant's arms to place him into custody for assault fourth degree DV.
- She went to grab ahold of the defendants left arm while Officer Fisher grabbed ahold of the defendant's right arm.
- She attempted to gain control of the defendants arm but he pulled his arms away and then shoved her backwards.
- She stumbled backwards while Officer Fisher attempted to gain control of the defendant. She observed the defendant kicking Officer Fisher as he laid on his back on the front porch.
- She went back up to assist Officer Fisher in attempts to gain control of the defendant. The defendant then reached for her duty weapon and placed his hand on the top portion of her gun holster.
- She was able to gain distance and deploy the probes on her Taser. The deployment was affective. Once the five second cycle was over the defendant refused to listen to the commands to get onto his stomach. The defendant then began to get off the ground and try to move towards the officers. She pulled the trigger on the Taser for another 5 second cycle on the original Taser probes. The defendant then complied to the verbal commands and got onto his stomach.
- Officer Fisher and she were able to peacefully place the defendant into handcuffs (DL).
- She developed probable cause to arrest the defendant for fourth degree assault DV because the defendant threw his watch at his father's head.
- She also developed probable cause for two counts of assault third degree because the defendant kicked Officer Fisher in the chest and pushed her also in the chest.
- The defendant was eventually transported and booked into Spokane County Jail for the charges listed above.






