She also wrote a coding to assist in identifying bias's through our contacts with the public at the request of the Chief. She was able to accomplish this in one day, a skill that not many have and can write so quickly.

Shawna was able to identify many issues with the current body camera contract, items that were not being used, but were being paid for. SPD had currently been paying for CAD integration. This integration is for the labeling of body cameras automatically by use of our current CAD system and Evidence.com. The cost involved was almost \$100,000. She was able to code to fit the algorithm for AXONs need and get them to reallocate the spent money to the current AB3 Officers Safety Plan we are currently using. This new plan and saved money allowed the purchase of new Taser 7's. It is this type of thinking that has allowed this department to not only save some big money, but put our officers in today's world with today's smart weapon technology.

Shawna cares about our police officers and all she interacts with. She works tirelessly and almost effortlessly to assist SPD in every aspect and unit in the department.
