It must be superior in nature and further the department's mission and overall effectiveness. When the special awards committee reviewed this nomination, it was clear that members of the Defensive Tactics Cadre were most deserving of this award.

For many years our Defensive Tactics program has been limited in personnel and resources. In 2013, the Chief's Office advised a restructuring of the program was needed. The SPD Defensive Tactics Cadre began taking shape in the summer of 2013 under the direction of Sgt. Shawn Kendall. The number of Cadre members went from five to fifteen.

The Cadre has since become well organized and goal driven. Understanding the obvious connections between Defensive Tactics, Firearms, Patrol Procedure, Use of Force Options and Communication/De-Escalation skills, the DT Cadre began developing its instruction staff with other disciplines.

- Established a larger contingent of Instructor/Actor Personnel
- Members have become instructor certified in Verbal Defense and Influence
- Members have begun their Instructor certification journey through the Washington State Criminal Justice Training Commission Level 1 Control Tactics Instructors
- Members have become instructor certified in Excited Delirium and Chaotic Events
- Members have become Re-Certified in the field of Defensive Tactics Master Instructor
- Members have become TASER instructors for TASER International
- Members have become instructor certified in the Lateral vascular Neck Restraint through the National Law Enforcement Training Center
- Members have become instructor certified in Firearms through CJTC





In less than a year the SPD DT Cadre has conducted numerous training sessions in various fields:

- TASER Certifications for Spokane Police officers 21 separate 3-4 hour classes
- Continued instruction for portions of our week long Crisis Intervention Training approximately 5 classes in the past year
- Re-Certification and issuing of the new Expandable Baton systems for the entire Department - approximately 14 classes in the past year
- Several Sessions of Enhancing the Survival Mindset classes to civilian men and women in our community approximately 24 sessions in the past year, including full-scale and smaller satellite classes
- Continued Pre-FTO training sessions for our new hires approximately 12 sessions to include Baton, LNR and DT
- Routine DT Training for our Reserve, CO-OP and Explorer programs
- Huge contributions to the 2014 Spring In-Service, including actor and lead instructor positions for VDI, Off Duty Cary, and Active Shooter sites

Sgt. Kendall and the Defensive Tactics Cadre also re-wrote a very dated Defensive Tactics manual. This was started from scratch. The result is a workable manual designed for future modifications to best fit case law and best practice concepts.

Additionally, the DT Cadre implemented a Field In-service Training program for Defensive Tactics, which the Training Center has used as a model to present a variety of training topics. Now, instead of getting long blocks of DT training every few years, officers are getting DT training every couple of months.

When I look at what has been accomplished in just a short time it speaks volumes on the quality of the personnel that currently occupy the DT Cadre Staff. I strongly feel that the continued development of our instructors will take this Department straight to the top in knowledge and application in the world of Use of Force.

If not for the dedication and work ethic demonstrated by each member of this team, the DT Cadre would not have been able to accomplish the important goals outlined above and further the department's mission and goals.

I am very proud to present members of the Defensive Tactics Cadre with the Chief's Citation Award. The DT Cadre will receive a plaque and members of the unit will be recognized at our annual Employee Awards Ceremony. A copy of this document will be placed in your department personnel file.
