Recently, Sergeant Kurt Reese nominated you for Employee of the 4th Quarter, 2015. Employee of the Quarter nominations are based on either a specific act of unusual meritorious service; a specific project of significance to the community, city, or department, or sustained superior performance of assigned duties. When the Special Awards Committee reviewed the nominations, it was clear that you are most deserving of this recognition. Some highlights from Sergeant Reese's nomination:

"Officer Prim has been assigned to the downtown precinct as an NCO for two years. In that time frame, Officer Prim has excelled at knowing and recognizing the people of downtown. He can immediately recognize and relate with dozens of people downtown that we frequently have contact with. Prosecutor Adam Papini sent an email regarding Officer Prim to let Lt. Stevens know about the excellent work that Officer Prim was doing. On this date, Officer Prim went to the House of Charity motivating people to show up for community court, so that they would not get warrants. Mr. Papini noted that he really appreciated Officer Prim going out of his way to try and help people get to community court. Mr. Papini said that Officer Prim really made a difference.

There are many more examples where Officer Prim has gone above and beyond his daily duties to make the citizens of Spokane safer. Officer Prim has never asked for recognition, nor does he seek recognition. Officer Prim is an excellent candidate for employee of the quarter based on the above incidents and his continued superior performance."
