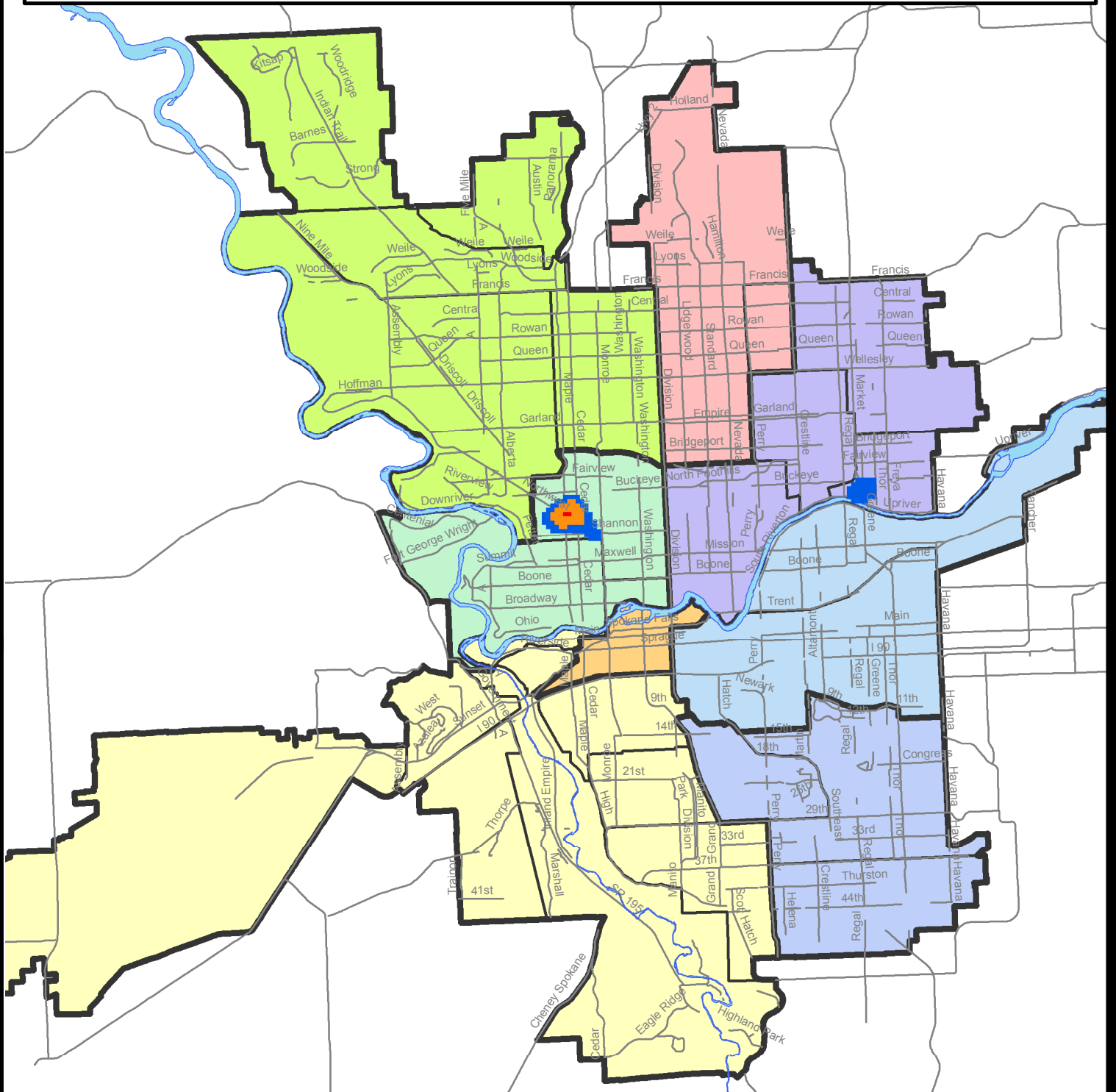

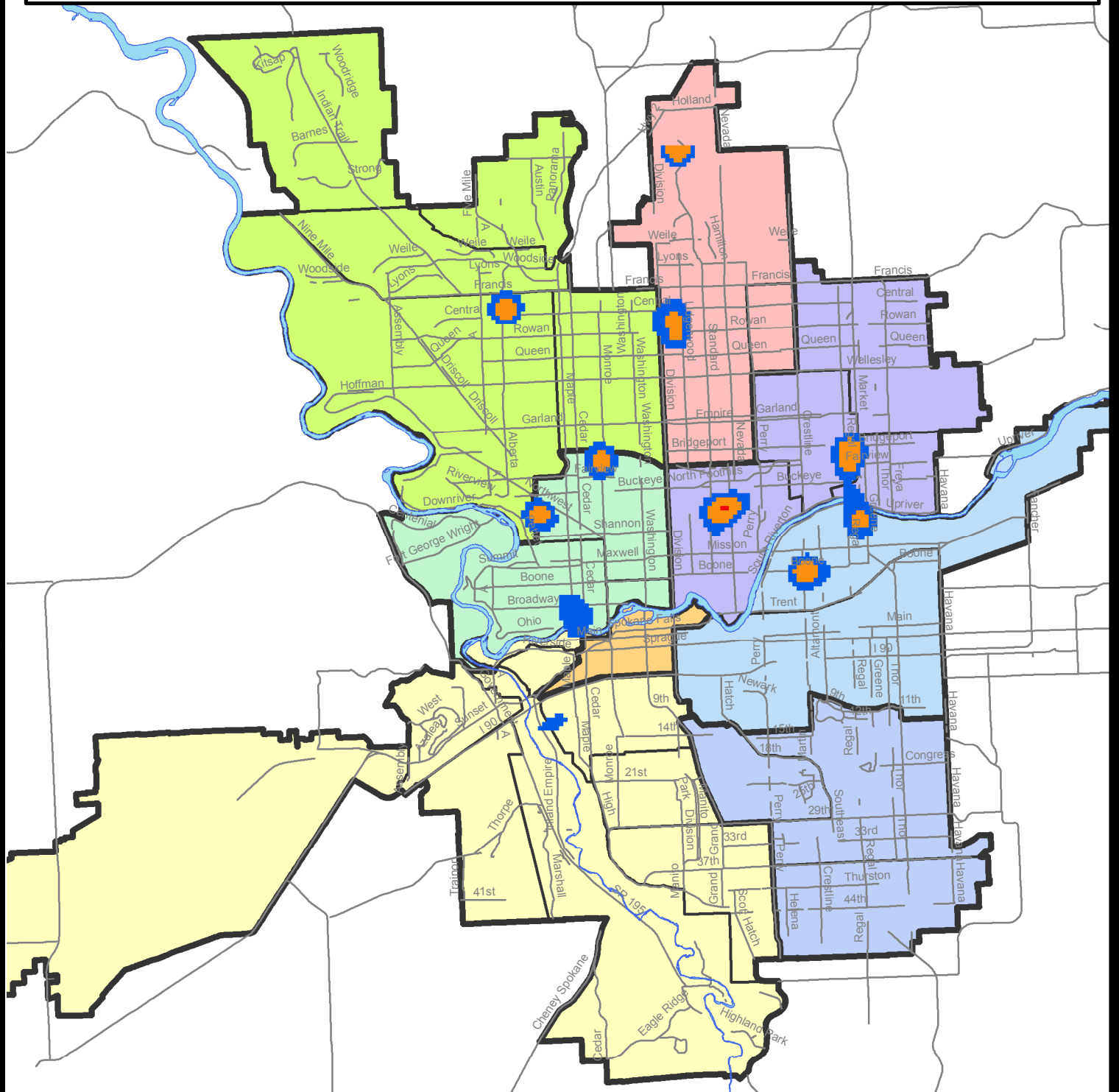

Further, the % change columns on the preliminary incident count differ from the percentage change on the UCR crime report, sometimes significantly.

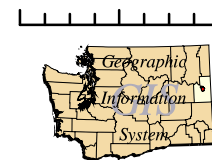
