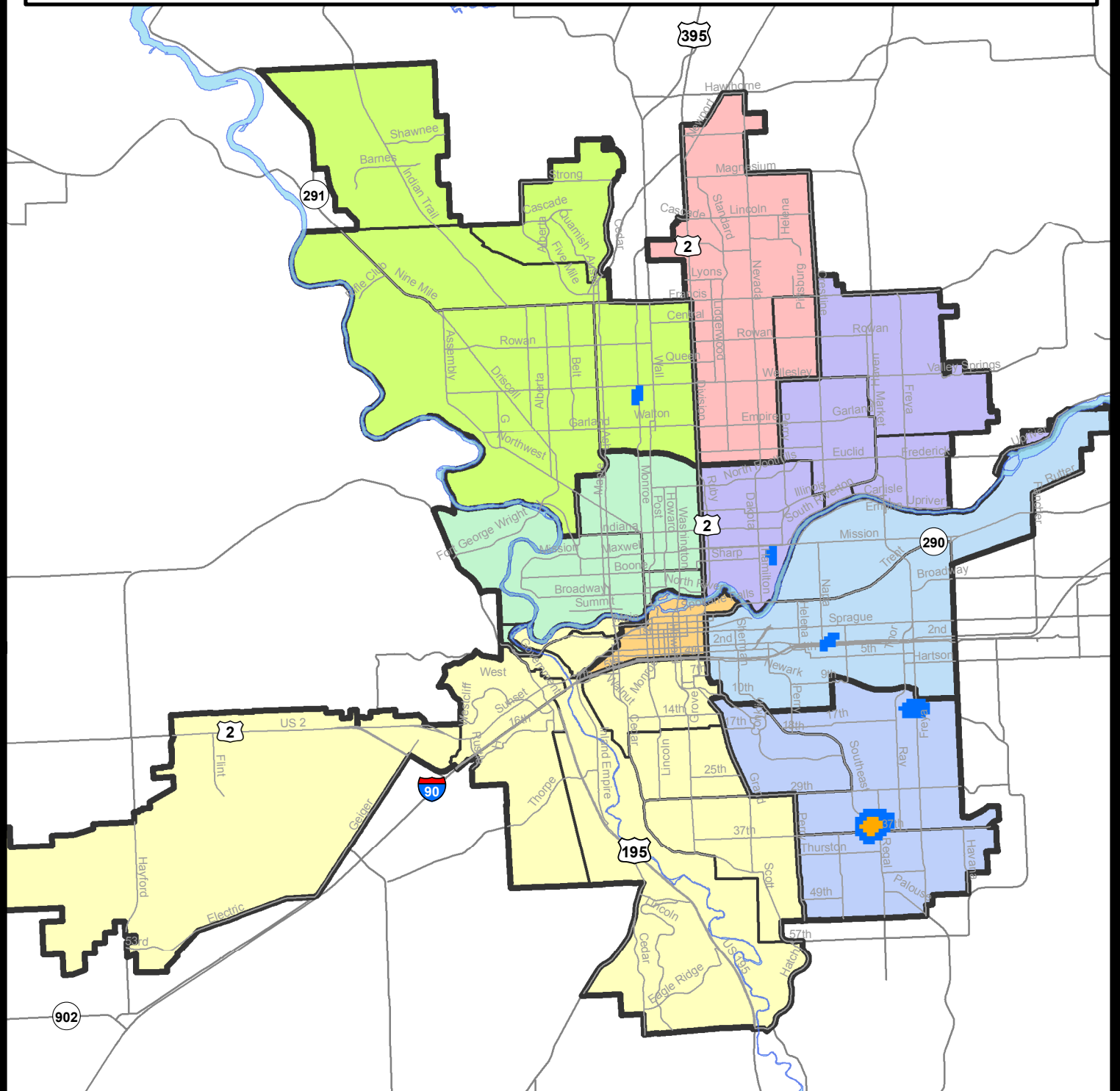

RESIDENTIAL BURGLARY HOT SPOT(S)



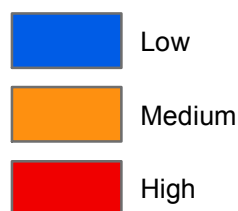

VEHICLE RECOVERY HOT SPOT(S)



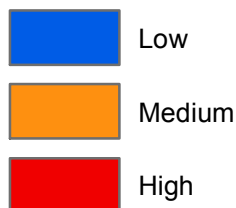

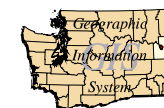
