Description of proposal: The application proposes to subdivide 34.93 acres of land into a 199-lot Planned Unit Development (PUD) for development for single-family homes. The application also includes a Wetland Modification Conditional Use Permit (CUP). The application is requesting modification to the maximum FAR, lot coverage, driveway coverage limits, and front living space and rear yard setbacks under the PUD application process.

The City of Spokane has determined that this proposal will not have a probable significant adverse impact on the environment, if mitigated as stipulated below. This decision was made after review of a completed environmental checklist and other information on file with the lead agency. Pursuant to WAC 197-11-350(3), the proposal has been clarified, changed, and conditioned to include necessary mitigation measures to avoid, minimize or compensate for probable significant impacts. An environmental impact statement (EIS) is not required under RCW 43.21C.030(2)(c). The necessary mitigation measures are listed below, and the Environmental Checklist is attached.

MITIGATING MEASURES:

1. Vehicular traffic from this project is expected to add 5 AM trips and 3 PM trips to the NB US 195 to EB I-90 ramp. WSDOT has commented that no additional peak hour trips may be added to the ramp due to safety concerns. The Beard Addition development is required to complete an improvement to the US 195 corridor that will reduce the impact of its traffic on NB US 195 to EB I-90 ramp ("Mitigation Project"). Studies of the US 195 corridor have identified the removal of the left and thru

movements from Eastbound 16th Ave at US 195 as the appropriate mitigation project. This mitigation project was recently confirmed in a December 2021 US 195/I-90 Study led by the Spokane Regional Transportation Council in collaboration with WSDOT, the City of Spokane, and other partnering agencies. The Beard Addition development may not finalize any portions of the project until a financial commitment is in place (secured by a letter of credit or bond), which has been approved by the City, providing for the design and construction for the Mitigation Project, which shall be under contract for construction within one year from the date of project approval. The details of the above mitigation project will be agreed upon by the developers, City and WSDOT.

2. Construct sidewalk on the south side of Grandview Avenue from Garden Springs Road to 21st Avenue.

7. Proposed timing or schedule (including phasing, if applicable):

Construction to begin Fall 2023 or one to three months after Planned Unit Development (PUD) approval. At the present time, there is no specific phasing plan other than seasonal; however, due to the nature of the proposal, a 199-lot PUD, this construction may be phased due to market conditions. If phased, phasing may include early grading, utility installation, portioning of the onsite/offsite infrastructure and platting in two or more phases.

At this time, there are no other planned additions, expansion or further activity related to or connected with this proposal.

- <u>Yes, the property owners also own or have options on parcel numbers 25263.2701, 25263.2702, 25263.2703, 25263.2704, 25263.2705, 25263.2801, 25263.2802, 25263.2803, 25263.2804, 25263.2805, 25263.2806, 25263.2807, 25263.2808, 25263.2901, 25263.2902, 25263.2903, 25263.2905, 25263.2906, 25263.3003 and 25263.2809 for a total of approximately 3.86 acres.</u>

 - The following environmental information has been or will be prepared related to this proposal: SEPA checklist, trip generation and distribution letter, concept drainage report, geotechnical evaluation, cultural resource survey, wetland delineation and mitigation report and a critical areas checklist (wetland). A conditional use permit/wetland permit will also be required for this project, which was included with the preliminary plat/PUD submittal.
- 10. Do you know whether applications are pending for governmental approvals of other proposals directly affecting the property covered by your proposal? If yes, explain:

 Yes, there is a plat alteration for the lots along 21st Avenue, Cumberland Lane, and Beard Drive that are under the same ownership. As part of that plat alteration, the five lots along Westridge Lane (25263.3001, 25263.3002, 25263.3101, 25263.3102 and 25263.3103) will be combined into two lots that will be subdivided as part of this plat, and both Westridge and Cumberland Lanes will be dedicated as public Right-of-Way. At the time of public hearing, the lots along Westridge Lane will be two residential lots. As part of the PUD/preliminary plat, a CUP and wetland permit will be required. Street plans for 21st Avenue have been approved.

 This project will require approval or permit of the following: preliminary plat and PUD, final plat and PUD,

 SEPA, conditional use permit, wetland permit, blasting permits, building permits, water plans, sewer plans,

 storm drainage plans, street plans, UIC registration, street permit, utility permit, demolition permit, possible

 asbestos removal permit, street tree plan, and clean air permit. Other permits may be required that are

This project proposes to subdivide nine parcels into 199 lots in the RSF zone. The project was originally a part of the approved Westridge Addition PUD; however, that preliminary plat with a PUD overlay has since expired prior to development of all phases. This project will construct or extend two north-south roads and three east-west roads. This project will be served by public water and public sewer. As part of this project, three wetlands were delineated, one of which will be re-established and rehabilitated within an updated wetland boundary at appropriate replacement values (2:1). Stormwater treatment will be provided in the large tract located largely within parcel number 25263.2907 and in some instances within the wetland buffers.

<u>A PUD overlay is included with this proposal. This proposal seeks to alter Spokane Municipal Code (SMC)</u> Section 17C.110.200 Development Standard Table 17C.110-3.

The items that will be modified are the following:

- <u>Maximum building coverage:</u>
 - \circ Lots 5,000 sf or larger: 2,250 sf + 35% for portion of lot over 5,000 sf.
 - \circ Lots 3,000-4,999 sf: 1,500 sf + 37.5% for portion of lot over 3,000 sf.
- Floor Area Ratio (FAR): 0.5
- Front Setback: 15 ft.
- Rear Setback: 25 ft.

Additionally, the proposal seeks to modify SMC 17C.230.145(C)(4)(a):

• Front yard hard surface coverage (vehicle parking): 40%

Our proposal requests to modify the above items to the following:

- *Maximum building coverage:* 60%
- Floor Area Ratio (FAR): No maximum
- Front setback: 10 feet house, 20 feet garage or car port.
- Rear setback: 20 ft.
- Front yard hard surface coverage (vehicle parking): 45%.

- 15. The following questions supplement Part A.
 - a. Critical Aquifer Recharge Area (CARA) / Aquifer Sensitive Area (ASA)
 - (1) Describe any systems, other than those designed for the disposal of sanitary waste installed for the purpose of discharging fluids below the ground surface (includes systems such as those for the disposal of stormwater or drainage from floor drains). Describe the type of system, the amount of material to be disposed of through the system and the types of material likely to be disposed of (including materials which may enter the system inadvertently through spills or as a result of firefighting activities).

This proposal, laying in the moderate susceptibility area, will use stormwater disposal methods consistent with Spokane Regional Stormwater Manual (SRSM), which may include grassed percolation areas, evaporation ponds, L.I.D. Ponds, detention and/or retention ponds and gravel galleries depending upon soil types at the locations of the proposed facilities. The anticipated disposal rate will be appropriate for the design option chosen. Currently the runoff volume of a 100-year storm event is anticipated to be 3.299 ac/ft. A storage area of 13.76 ac/ft is proposed to contain the potential 100-year storm event. A preliminary or concept storm analysis is included as a part of this application.

- (2) Will any chemicals (especially organic solvents or petroleum fuels) be stored in aboveground or underground storage tanks? If so, what types and quantities of material will be stored?

 After the development of the project, it would be expected that household volumes of these types of chemicals will be stored above ground in appropriately sized containers of less than 5 gallons.

 During construction, no large volume of chemicals will be stored on site.
- (3) What protective measures will be taken to ensure that leaks or spills of any chemicals stored or used on site will not be allowed to percolate to groundwater. This includes measures to keep chemicals out of disposal systems.

 Applicable BMP's will be used during construction to contain any leaks or spills if they occur from vehicle refueling and oiling operations. After development, small household leaks or spills may occur and are anticipated to be handled prior to leaving impervious surfaces.
- (4) Will any chemicals be stored, handled or used on the site in a location where a spill or leak will drain to surface or groundwater or to a stormwater disposal system discharging to surface or groundwater?

 No large volumes of chemicals are anticipated to be stored onsite within the residential development, therefore there is no direct spill or leak risk to groundwater.

b. Stormwater

- (1) What are the depths on the site to groundwater and to bedrock (if known)?

 Based on well logs in the area, depth to groundwater varies from approximately 100 to 200+ feet below grade.
- (2) Will stormwater be discharged into the ground? If so, describe any potential impacts.

 Yes, stormwater may be discharged into the ground as allowed per the SRSM, which requires treatment prior to discharge. No potential impacts are anticipated at this time.

 No, there are no surface indications or history of unstable soils in the immediate vicinity.
- e. Describe the purpose, type, total area, and approximate quantities and total affected area of any filling, excavation, and grading proposed. Indicate source of fill.

Proposed grading will be for the utilities, streets, lots, building pads and storm ponds. The grading would involve removal of organics, preparation of street subgrade and preparation of building pads. This will occur over the entire site. Although quantities are unknown at this time, we would anticipate the movement of approximately 50,000cyd to 100,000cyd of material onsite. No export or import is anticipated other than for road building materials such as crushed rock, pavement, etc...; however, if any import or export of materials is required it shall be from/to a preapproved source/destination and coordinated with the City of Spokane Development Services Center. Please take note that a separate grading application may be made at a later date as a phase of the noted project and should be considered a part of a consolidated permit process.

- f. Could erosion occur as a result of clearing, construction, or use? If so, generally describe.

 Some minor localized erosion from wind and rain may occur during construction but would be mitigated using appropriate BMPs. No erosion would be expected from the use of the site as surfaces will be stabilized by paving, concrete, buildings, and landscaping.
- g. About what percent of the site will be covered with impervious surfaces after project construction (for example, asphalt, or buildings)?

 The development of the site will have about 40 to 50% impervious coverage which includes roads, sidewalks, driveways and home construction. Lot Floor Area Ratios may be higher than typical FAR at 0.6 to 0.9.
- h. Proposed measures to reduce or control erosion or other impacts to the earth, if any:

 <u>Erosion will be reduced and controlled using appropriate BMPs during construction and stabilization of disturbed soils by paving, concrete, buildings, and landscaping following construction.</u>

2. Air

- a. What type of emissions to the air would result from the proposal during construction, operation, and maintenance when the project is completed? If any, generally describe and give approximate quantities if known.
 - During construction, some fugitive dust could be expected, although the intent of the permits would be to control this instance through watering, hydroseeding, or other BMPs. Additionally, there will be exhaust fumes from construction equipment, etc. At the completion of construction air emissions may be from home appliances such as dryers and gas furnaces, exhaust from yard maintenance equipment, homeowner vehicles and personal entertainment activities such as barbecuing.
- b. Are there any off-site sources of emissions or odor that may affect your proposal? If so, generally describe.
 - There are no known off-site sources of emissions or odor that may affect this proposal.
- c. Proposed measures to reduce or control emissions or other impacts to air, if any:

 <u>All site development shall comply with Spokane Regional Clean Air Agency (SRCAA), construction</u>

 <u>related requirements. Future landowners may require additional review through SRCAA depending on</u>

 future construction on land disturbing actions.

3. Water

a. SURFACE WATER:

 - The WDFW PHS map indicates the presence of a freshwater emergent wetland on and adjacent to the site. A wetland delineation and mitigation report is provided with the preliminary plat/PUD application, please see the delineation for more specific information.
- (2) Will the project require any work over, in, or adjacent to (within 200 feet) the described waters? If yes, please describe and attach available plans.

 Yes, this project will require work within 200 feet of the wetlands, which may all be removed, reestablished, and rehabilitated during project development.
- (3) Estimate the amount of fill and dredge material that would be placed in or removed from the surface water or wetlands and indicate the area of the site that would be affected. Indicate the source of fill material.
 - At this time a complete design and planting plan for revegetating the wetland has been completed. We would expect that 1,000 to 2,000 cy worth of grading within the tract will occur.
- (4) Will the proposal require surface water withdrawals or diversions? If yes, give general description, purpose, and approximate quantities if known.
 No surface water withdrawals or diversions are anticipated with this project.
- (5) Does the proposal lie within a 100-year floodplain? If so, note location on the site plan. *This proposal does not lie within a 100-year floodplain.*
- (6) Does the proposal involve any discharge of waste materials to surface waters? If so, describe the type of waste and anticipated volume of discharge.
 - No waste materials will be discharged to surface waters as the site will be connected to public sewer.

b. GROUNDWATER:

 - No groundwater will be withdrawn from this site. All potable water used will be provided by the local purveyor (the City of Spokane) per their existing water right. The project's cleaned stormwater will be discharged to the underlying soils and groundwater as allowed per the Spokane Regional Stormwater Manual (SRSM). A project specific storm drainage report will be provided when the project site is in the design process. However, a concept storm, preliminary storm evaluation will be provided for the preliminary plat/PUD process.
- (2) Describe waste material that will be discharged into the ground from septic tanks or other sources, if any (for example: Domestic sewage; industrial, containing the following chemicals...; agricultural; etc.). Describe the general size of the system, the number of such systems, the number of houses to be served (if applicable), or the number of animals or humans the system(s) are expected to serve.

 No water will be discharged via septic or other onsite systems. The subject site will be served by the City of Spokane public sewer. The site is expected to serve approximately 538 (199*2.7) people.

c. WATER RUNOFF (INCLUDING STORMWATER):

(1) Describe the source of runoff (including stormwater) and method of collection and disposal if any (include quantities, if known). Where will this water flow? Will this water flow into other waters? If so, describe.

The source of runoff from this site after completion of the subdivision will be from the constructed elements of the subdivision including but not limited to homes, streets, sidewalks, driveways, lawns, open spaces, etc. The intent is to convey stormwater to large tract ponds to treat and discharge the treated stormwater as required by the SRSM to the underlying soils via retention ponds and discharge via infiltration and evaporation. It should be noted that some minor basin modifications to this site that will positively affect the downstream properties will occur as street and home construction intercept upslope water due to rainfall on roadways and be carried to stormwater facilities, it should be expected that while generally stormwater will be intercepted, the project does retain the right to discharge the rate and volume of stormwater as calculated in the pre-developed condition and as contemplated in previous easement to the Westwood Hills 2nd Addition PUD via recorded easements, only if required.

- (2) Could waste materials enter ground or surface waters? If so, generally describe.

 No, stormwater treatment is required pursuant to the SRSM. All future runoff will be treated in the catchment area before discharge. Waste generated on site will be discharged via public sewer.
- (3) Does the proposal alter or otherwise affect drainage patterns in the vicinity of the site? If so, describe.

 No, while the drainage patterns within the site will be altered to send all stormwater to catchment

 areas, drainage patterns within the vicinity of the site are not anticipated to change, as all

 stormwater is expected to remain in evaporation ponds. As noted earlier, offsite flow may be required to one existing easement to discharge water offsite.
- d. PROPOSED MEASURES to reduce or control surface, ground, and runoff water, and drainage pattern impacts, if any.

As noted previously, the project will be developed following the requirements for stormwater as outlined in the SRSM. Additional measures, if any, will be added if required during the design and approval process with the City of Spokane and any other affected agencies. Please see the concept storm report for more information.

Please note that approximately ¾ of the City of Spokane is located within habitat for one or more of the following state sensitive vesper bats: big brown bat, Townsend's big-eared bat, and Yuma myotis.

(3) Proposed measure to reduce or control noise impacts, if any:

Construction and blasting will be restricted to hours allowed by code.

The project site is currently vacant land. Adjacent properties include vacant land to the northeast; single-family residences to the east, south, and northwest; and vacant land to the west and north. There is a City of Spokane-owned vacant parcel to the southwest.

 The City of Spokane GIS identifies no critical areas within two hundred feet of the project site. The preliminary plat/PUD and LIDAR identified slopes exceeding 30%.
- i. Approximately how many people would reside or work in the completed project? The site is expected to serve approximately 538 (199*2.7) residents.
- j. Approximately how many people would the completed project displace?
 No people are anticipated to be displaced with the completed project.
- k. Proposed measures to avoid or reduce displacement impacts, if any:
 There are no measures proposed to avoid or reduce displacement impacts, as none are anticipated.
- 1. Proposed measures to ensure the proposal is compatible with existing and projected land uses and plans, if any:
 - The project will be approved and developed in accordance with the applicable City codes and standards for residential development, streets, and utilities and the subsequent conditions of approval.

 - There are no proposed measures to ensure the proposal is compatible with nearby agricultural and forest lands of long-term commercial significance.

 - Approximately 199 additional middle-to-high-income housing units are proposed to be provided with this project.

There are no measures proposed to reduce or control housing impacts, as none are anticipated.

 Maximum height as allowed by code, 35'. - b. What views in the immediate vicinity would be altered or obstructed?
 Localized street level views of the site from adjacent residences would be altered with development.

 Street trees and market-based home construction as to facade look, color, and texture.

 The development will be illuminated at night consistent with City of Spokane zoning codes and standards.

 It should be expected that several streetlights will be added as well as additional porch and driveway lights, all to residential scale and levels.

 <u>Light or glare generated on the project site is not anticipated to be a safety hazard or interfere with views.</u>

 There are no offsite sources of light or glare that would affect the project.

 None, as no lighting impacts are anticipated from the proposed residential neighborhood.

 - GIS data from WISAARD was used to assess the potential impacts to cultural and historic resources on or near the project site. In anticipation of the DAHP comment that the project site is within the base layer, a Cultural Resource Study has been requested at the time of this writing. An inadvertent discovery plan will be prepared noting that during construction, if any artifact or human remains are discovered the project will stop in that area, and the city and owner will be notified.

There are no proposed measures to avoid, minimize, or compensate for loss, changes to, and disturbance of resources beyond following local, state, and federal laws, which may include an inadvertent discovery plan.

 - This site is served by Cumberland Street, Westridge Street, the 21st Avenue Right-of-Way and the 25th Avenue ROW. The project proposes to access the public street system via 21st Avenue and 25th Avenue.
- b. Is site or affected geographic area currently served by public transit? If so, generally describe. If not, what is the approximate distance to the nearest transit stop.
 - No, the site is approximately 0.50 miles from the nearest transit stop, Sunset @ Rustle on busses 60 and 61. Please note that, the bridge on Garden Springs Road does not support pedestrian traffic.
- c. How many additional parking spaces would the completed project or non-project proposal have? How many would the project or proposal eliminate?
 - Each residence will have at minimum two garage and two driveway spaces for a total of 796 (199*4) designated parking spaces in addition to street parking. No formal spaces will be eliminated.
- d. Will the proposal require any new or improvements to existing roads, streets, pedestrian, bicycle or state transportation facilities, not including driveways? If so, generally describe (indicate whether public or private).
 - *This project will create three east-west roads and extend two north-south roads to serve the development.*
- e. Will the project or proposal use (or occur in the immediate vicinity of) water, rail or air transportation? If so, generally describe.
 - No, this project will not use water, rail, or air transport.

f. How many vehicular trips per day would be generated by the completed project or proposal? This project is anticipated to generate approximately 140 AM peak hour trips, 190 PM peak hour trips, and 1,901 ADT.

This project is not anticipated to interfere with, affect or be affected by the movement of agricultural or forest products on roads or streets in the area.

No measures are proposed as no impacts are anticipated at this time, aside from the payment of proportionate impact fees.

The demand for services is not expected to increase beyond an acceptable level as anticipated by the Comprehensive Plan. Based upon preliminary calculations, the project anticipates to generate an average daily demand for water of 129,847.50 GPD, with a max day demand of 337,603.50 GPD and peak hour demand of 573,926 GPD. Likewise, the project expects to generate a sewer capita flow (without peaking factor) of 49,750 GPD and will generate a peak flow of 149,250 GPD.

b. Proposed measures to reduce or control direct impacts on public services, if any:
