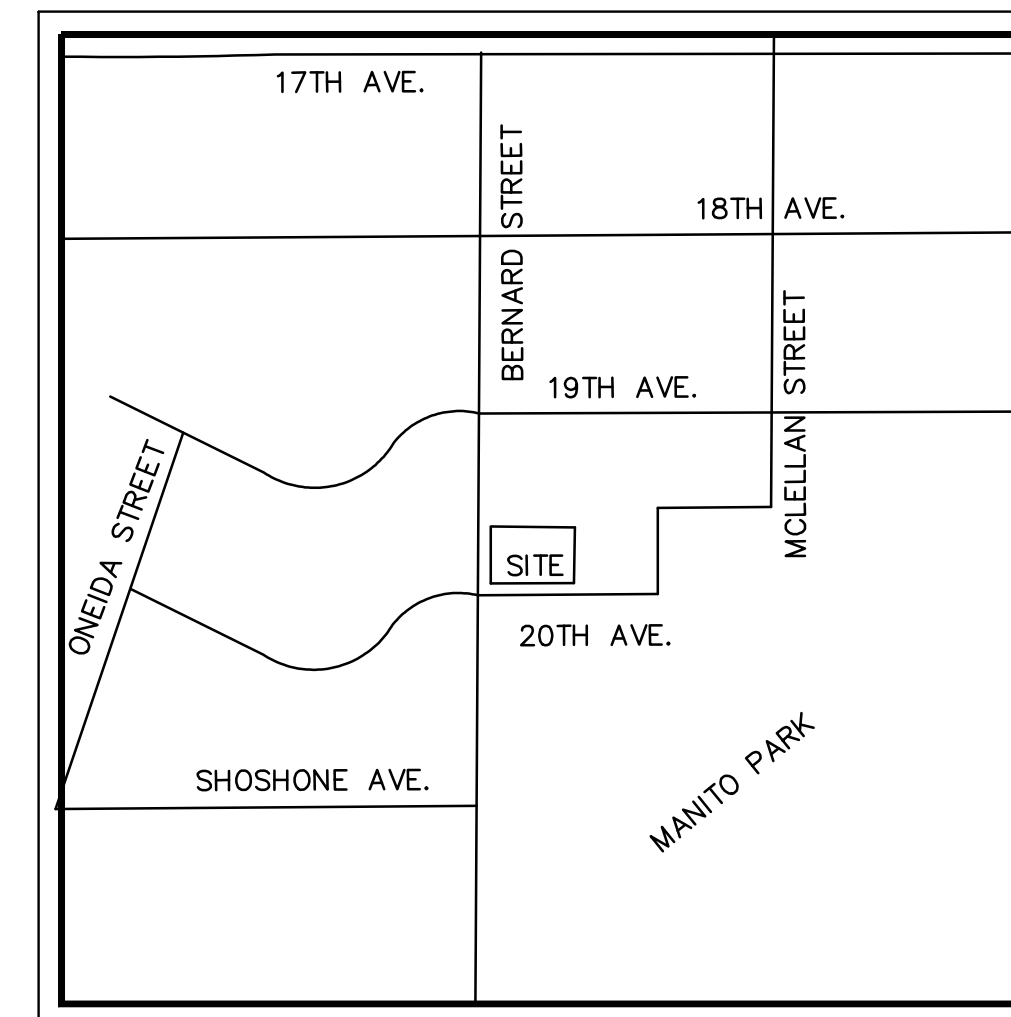
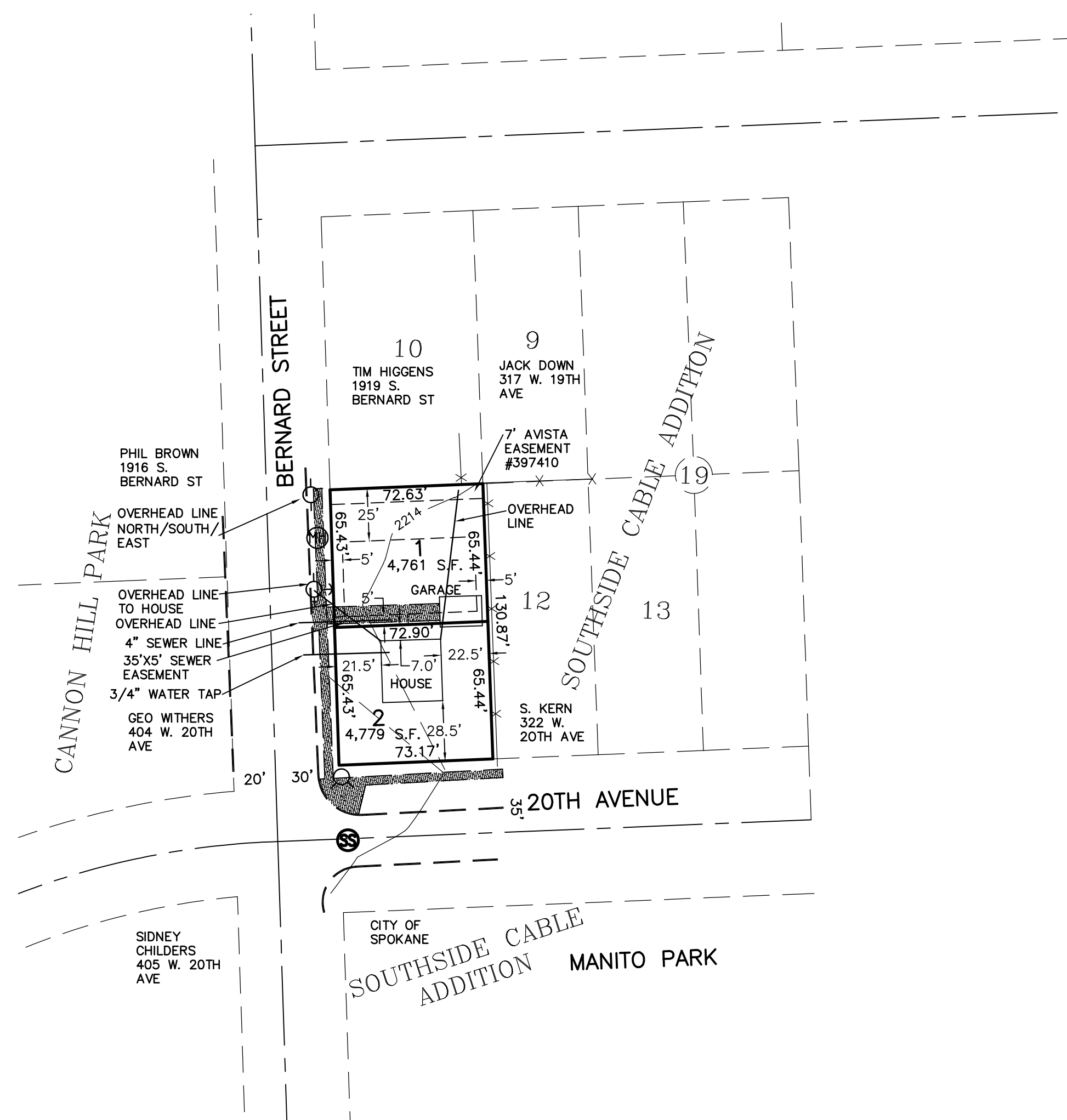

VICINITY MAP

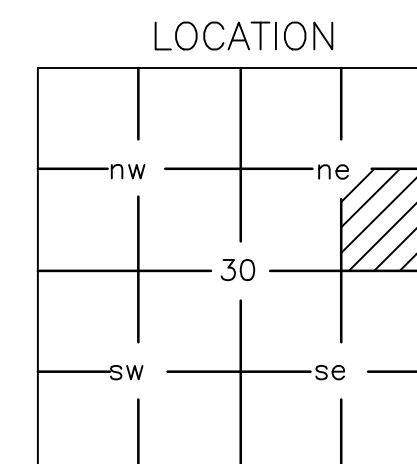
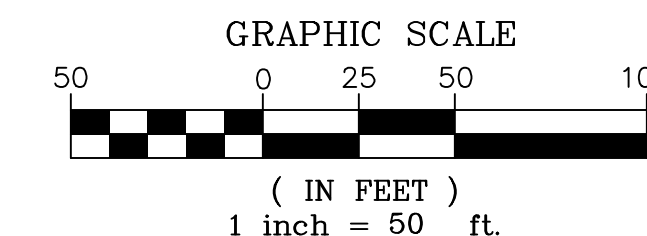
