The first Chief Garry Park Neighborhood Action Plan workshop occurred on Wednesday, February 24, 2016 at Steven's Elementary. The workshop was well attended with a total of 40 participants including residents (24), city officials (2), city staff (2), STA staff (2), project consultants (2) and visitors (8).



The neighborhood Chair, Colleen Gardner welcomed the attendees and introduced staff and consultants. Colleen described the importance of the planning effort and the general schedule for the planning process. The consultants presented a brief slide
