



2. On July 26, 2021, Mr. John Manix filed an appeal of the Decision on behalf of appellants listed above and identified by Appeal Number Z21-127APPL.
3. Also on July 26, 2021, Mr. John Hoye filed an appeal of the Decision on behalf of the Southgate Neighborhood Council, identified by Appeal Number Z21-128APPL.
4. The hearing on this matter was scheduled with Mr. David Hubert, City of Spokane Hearing Examiner Pro Tem for 9 a.m. on Wednesday, August 25, 2021.
5. On August 12, 2021, Mr. Taud Hume, notified the Hearing Examiner's office that he'd been retained by the Applicant and that he had a scheduling conflict on August 25, 2021, having already been scheduled to attend a hearing in Spokane County on another matter.
6. On August 16 and 17, 2021, the Hearing Examiner's office obtained agreement from the parties to continue the matter. In addition, Mr. Hoye requested that the date not be set in September due to out of country travel.
7. On August 17, 2021, Mr. John Manix (appellant under Z21-127APPL) requested an evening hearing to accommodate the various work schedule of the majority of the appellants.

## II. ORDER OF CONTINUANCE

The Hearing Examiner finds there is good cause to defer the matter and hereby grants the request for continuance to accommodate the Applicant's representative's schedule, Mr. Hoye's schedule, and allow for an evening hearing requested by Mr. Manix. Therefore, the hearing is hereby rescheduled for Wednesday, October 20, 2021, at 6 p.m. at Spokane City Hall, City Council Chambers (lower level), 808 W. Spokane Falls Boulevard, Spokane, WA 99201. Enter at the sliding doors on the east side of the building. Note that masks and 6-foot distancing may be required for all participants per the prevailing Covid-19 guidance in effect at the time of the hearing.


