Location of proposal: The project is located at 2 locations: Site A – 930 W Spokane Falls Blvd. (Parcel no.35183.1513) Site B – 1308 W Main Ave. (Parcel no. 35183.2101)

Description of proposal: The applicant is proposing to construct a recreational zipline in downtown Spokane. Site A is the zipline start and will be located at the existing Place of Truth's Plaza north platform, and Site B is the zipline end platform located on the east side of Red Band Park. Site B is located within the Shoreline Jurisdiction and Shoreline Buffer. This application is reviewing the portion of the extensions that are within the shoreline jurisdiction and shoreline buffer. This is a Type III application and there will be a Public Hearing in front of the City Hearing Examiner.
