

The purpose of the proposed Preliminary Short Plat is to divide Lot 4, Block 112, Lincoln Heights Addition Vol. "L" of Plats, Page 36, into two (2) lots. The current zoning of the proposed Preliminary Short Plat is R1. All lots created will have right of way access. All lots within the proposed Preliminary Short Plat will connect to City of Spokane sewer services for sewage disposal, City of Spokane Irrigation for domestic water services, and Avista for power services. This proposed Preliminary Short Plat meets the standards found in Spokane Municipal Codes 17C.110, 17D.010, and 17G.080 and in keeping with the infill density of the surrounding lots.
