

**NOTICE OF APPLICATION AND VIRTUAL PUBLIC HEARING  
FOR SHORELINE CONDITIONAL USE PERMIT  
“NSC River Crossings” File No. Z20-009SCUP**

Notice is hereby given that the Washington State Department of Transportation applied for a Shoreline Conditional Use Permit on January 9, 2020. This application was determined to be technically complete on March 6, 2020. The City of Spokane is hereby holding a virtual public hearing before the Hearing Examiner, which was previously scheduled for May 7, 2020 and moved to **Thursday, May 21, 2020**. The City deferred the in-person public hearing in an effort to slow the spread of the coronavirus (COVID-19) and to protect those most vulnerable. Due to the restrictions on public gatherings arising from the COVID-19 outbreak, this hearing will be conducted remotely using web and telephone conference tools, as described below. However, if the Governor’s restrictions for group gatherings are lifted prior to the scheduled hearing date, the hearing will be held in person at the designated time in the Council Chambers, Lower Level of City Hall, 808 W. Spokane Falls Boulevard, Spokane, WA. Any person may submit written comments on the proposal and/or participate in the public hearing.

**Overview:** The City requests that all non-essential visits to City Hall be observed. The City of Spokane along with the Hearing Examiner office is doing its part to slow the spread of COVID-19 and is hosting a virtual Public Hearing in response. In order to maintain compliance with WAC 365-196-845, the City is continuing to hold a virtual hearing to comply with due process on pending applications. Spokane City Council recently passed Ordinance C35905 which authorizes temporary procedural interpretations and also authorizes hearings that can be conducted consistent with the Governor’s proclamations and within the spirit and intent of hearing requirements.

**WebEx Details:** We encourage all interested persons and the public to utilize the WebEx meeting feature. Please download the application in advance of the hearing. The optimal equipment for audio/video participation is a computer, smart phone, or tablet equipped with a camera and a headset with microphone similar to what you use with your phones for hands-free use. The WebEx application is free to download and use to observe or participate in the hearing. If this technology is unavailable to you, you can participate by phone using the toll number, service charges may apply. Your experience by phone will be similar to a teleconference. The Public Hearing will open with the collection of participant information and an overview of how the hearing will progress, prior to the official opening of the hearing. The public is encouraged to submit written comments prior to the hearing by sending to the City Planner, Tami Palmquist [tpalmquist@spokanecity.org](mailto:tpalmquist@spokanecity.org); comments via email will need to be submitted by no later than 5:00 PM on May 20, 2020 in order for them to be received and prepared for submission into the record; comments received will be entered into the record at the time of the public participation portion of the Public Hearing. Comments received through US Mail will be included if they are received prior to the hearing.

**Public Comment Period:** Additional written comments may be submitted on this application by **May 20, 2020**. Written comments should be sent via mail or email to the Planning and Development address listed at the end of this document.

**SEPA:** This proposal was reviewed under the State Environmental Policy Act (SEPA). The lead agency was WSDOT and the North Spokane Freeway Final Environmental Impact Statement for this project was adopted on January 13, 1998. Environmental documents were added by addendum on September 17, 2019.

**Description of Proposal:** The North Spokane Corridor (NSC) is a 10.5 mile limited access highway that begins at Interstate 90 and ends at the Wandermere vicinity to the North. This application is for the new NSC bridges crossing the Spokane River located to the east of the exiting City owned Greene Street Bridge, the proposed pedestrian Spokane River crossing and S. Riverton realignment.

**Location Description:** The Spokane River at Greene Street (see attached map).

**Legal Description:** The entire legal description can be obtained with the Planning and Development Department.

**Current Zoning:** RMF (Residential Multi-Family), RSF (Residential Single Family) and LI (Light Industrial)

**Decision Making Process** Once the applicant submits an application to the City of Spokane for the review of the Shoreline Conditional Use Permit and the application is determined technically complete, a Notice of Application and Public Hearing will be posted on the property and mailed to all **property owners** and **taxpayers** of record, as shown by the most recent Spokane County Assessor's record, and **occupants** of addresses of property located within a four hundred foot radius of any portion of the boundary of the subject property, including any property that is contiguous and under the same or common ownership and control. This Notice of Application and Public Hearing will initiate an additional 14-day public comment period in which interested persons may submit written comments to the address of the City Staff. A Public Hearing will be held in front of the City of Spokane Hearing Examiner. Written comments and oral testimony at the public hearing for this proposed action will be made part of the public record. **Only the applicant, persons submitting written comments, and persons testifying at a hearing may appeal the decision of the Hearing Examiner.**
