<u>SEPA:</u> Separate SEPA Determinations of Non-Significance were issued on August 27, 2019 under WAC 197-11-970; the lead agency will not act on this proposal for at least 14 days. Comments regarding these DNSs must be submitted no later than 5 pm on September 10, 2019 if they are intended to alter or appeal the DNS.

Description of Proposals:

Z18-958COMP: This proposal would amend the Comprehensive Plan to include one new land use policy, Policy LU 4.6 Transit-Supported Development, to encourage and support transit-supported development. This proposal is intended to amend the City's land use policies in advance of the construction of the Central City Line and to give sufficient time for developers and neighbors to understand the impacts of the Central City Line and the new development options along the route. This proposal would have effects city-wide, as high-performance transit routes are established and implemented.

Z19-002COMP: This proposal is to amend Policy LU 1.8, General Commercial Uses, of Chapter 3 of the City's Comprehensive Plan, to update and clarify the existing policy, which gives guidance to the Plan Commission and staff when there is interest in pursuing a land use plan map change to General Commercial. The existing locations of General Commercial land use designation and other areas in the city of Spokane may be viewed online at the MapSpokane site, under the "Planning" and "Landuse Plan" layers: <u>maps.spokanecity.org</u>.

<u>Process Notes:</u> The two text amendments were prepared separately following request by the Spokane City Council. Following completion of the project materials, the City issued a notice of application and request for public comment to the newspaper, the Official Gazette, and the main branch of the library. Likewise, staff sent the notice to all neighborhood council contacts. Once the

public comment period ended, the Director of Planning issued a threshold determination for the project and obtained a public hearing date from the Plan Commission. Following the hearing before the Plan Commission a hearing date with the City Council will be requested. The date, time, an location of this hearing will be posted similarly to this notice. Written comments and oral testimony at all hearings will be made a part of the record. **Only the applicant, persons submitting written comments and persons testifying at a hearing may appeal the decision of the Plan Commission and City Council.**
