<u>Public Comment Process:</u> Notice of Application will be posted on the property and mailed to property owners and residents within four hundred feet of the subject property. This <u>Notice of Application</u> will initiate a <u>15-day</u> public comment period in which interested persons may submit written comments to the address of the City Staff, which appears at the beginning of this document. Once the public comment period has ended, staff will issue a decision within 10 days.

Notice of Right to Appeal: Appeals or requests for reconsideration of decisions by the Planning Director are governed by Spokane Municipal Code 17G.060.210 - Appeals. Decisions of the Planning Director regarding Type I or II applications are final unless appealed to the City of Spokane Hearing Examiner.
