**Location of proposal:** The proposal is located on the Spokane River, adjacent to 700 N Division St. – Parcel No. 35175.0031.

**Description of proposal:** The applicant is proposing a new 2,200 square foot public recreational dock to be used for non-motorized watercraft, sightseeing, and other recreational activities, along the Spokane River. This is proposed within the Shoreline Buffer and the 200' Jurisdiction.
