<u>Description of Proposal</u>: The applicant is proposing to subdivide 2 parcels and 1 partial parcel into fifty (50) new single family residential lots. This proposal includes infrastructure to accommodate the new development.

This notice will contain the date, time, and location of the public hearing. Once the public comment period has ended, staff will issue a Staff Report to the Hearing Examiner. Finally, a Public Hearing will be held in front of the City of Spokane Hearing Examiner. Written comments and oral testimony at the public hearing for this proposed action will be made part of the public record. **Only the applicant, persons submitting written comments, and persons testifying at a hearing may appeal the decision of the Hearing Examiner.**
