## Notice of Intent to Adopt Amendments to the Spokane Municipal Code

Notice is hereby given that City of Spokane Planning Services intends to propose amendments to the Spokane Municipal Code (SMC) for recommendation by the Plan Commission and adoption by the City Council as required by RCW 90.58.080(4) Shoreline Master Program Periodic Review. Two virtual technical team and open houses are scheduled for December 1, 2020; 10:00-11:00 AM and 2:00 - 3:00 PM. These will be joint meetings with the Dept of Ecology and City of Spokane to outline the scope of the Periodic Review, agency roles, proposal highlights, and time for questions.

A Plan Commission workshop is anticipated January 13, 2021. Plan Commission hearings are anticipated in late February and City Council in late March to April, affording additional opportunities for public comment. **PROPOSAL**: The Proposal for the Shoreline Master Program Periodic Review is a requirement to ensure compliance with several years of legislative changes to RCW 90.58 and solely constitutes the Scope of this proposal. The Periodic Review is <u>not</u> an update to the Shoreline Master Program or the City Comprehensive Plan - that is a future undertaking based on the State schedule for updates to both documents. The City of Spokane has reviewed the Periodic Review Checklist provided by Washington State Dept of Ecology and identified those sections of the Spokane Municipal Code (SMC) requiring amendment for compliance and those sections of SMC that are in compliance, documenting findings of adequacy. The City is also able to identify optional additional SMC sections to update in conjunction with this Review. Public participation and approval processes will be joint and coordinated with Dept of Ecology under the provisions of WAC 173-26-104. The joint review process consolidates the local and state public comment periods, shortening the approval process.

**SEPA**: The proposed amendments are subject to SEPA review and Dept of Ecology review, which is pending document drafting and public comment.

Only persons submitting written comments and persons testifying at a hearing are likely to have standing to appeal the ultimate decision of the City Council.
