Location Description: The subject proposal will be located behind the existing shopping center in the southwest corner of the property at 9001 North Indian Trail Road.

Description of Proposal: The applicant is proposing to erect a 70-foot monopole wireless communication tower and accessory ground support equipment within a fenced and landscaped area.

Legal Description: Parcel # 26225.0153. A full legal description of the subject property is available in Planning and Development, located on the 3<sup>rd</sup> Floor of City Hall, 808 West Spokane Falls Blvd., Spokane, WA 99201-3329.

SEPA: The City of Spokane is the lead agency for this proposal. Louis Meuler, Interim Planning Director, is the responsible official. A Determination of Non-Significance (DNS) is anticipated for this project.

Current Zoning: CC2-NC (Center and Corridor 2 – Neighborhood Center)

<u>Public Comment Period</u>: Written comments may be submitted on this application and any environmental issues related to it by <u>June 23, 2015</u>. Written comments should be sent to the Planning and Development address listed above or at the end of this document.

Public Hearing Process Once a Community Meeting has been completed, the applicant is authorized to make application to the City of Spokane for the review of the Conditional Use Permit. A combined Notice of Application and Public Hearing will be posted on the property and mailed to all property owners and taxpayers of record, as shown by the most recent Spokane County Assessor's record, and occupants of addresses of property located within a 600 hundred foot radius of any portion of the boundary of the subject property, including any property that is contiguous and under the same or common ownership and control. This combined Notice of Application and Public Hearing will initiate a 15-day public comment period in which interested person may submit written comments to the address of the City Staff. This notice will contain the date, time, and location of the public hearing. Once the public comment period has ended, staff will issue a Staff Report to the Hearing Examiner. Finally, a Public Hearing will be held in front of the City of Spokane Hearing Examiner. Written comments and oral testimony at the public hearing for this proposed action will be made part of the public record. Only the applicant, persons submitting written comments, and persons testifying at a hearing may appeal the decision of the Hearing Examiner.
