Property Owner Frequently Asked Questions (FAQ)



Site Reuse and Revitalization Program: Community Wide Assessment

Is the land you own or are interested in purchasing vacant or less productive than it ought to be? Do you have concerns that the historic use of the property or environmental contamination may be part of the issue?

Funding from the U.S. Environmental Protection Agency (EPA) Brownfield Community-wide Assessment Grant is now available through the City of Spokane to help reduce uncertainty and increase the marketability of properties within "The Yard."

How will assessment benefit me as a property owner?

- Potential for increased developer appeal;
- Reduced uncertainty regarding past uses and existing conditions;
- Tax incentives;
- Reduced liability; and Commercial property transactions generally require Phase I & II Environmental Site Assessments (ESAs).

Will I have control over the work done through this program?

You will have the right to stop participation in the program at various phases of the assessment process. You will be asked to authorize site access to the City's environmental consultant, who will perform all work at the direction of the City. You will receive final reports following site assessment.

What's the catch? There is no catch - for eligible, priority sites, ESAs, hazardous materials surveys and a wide variety of cleanup/reuse planning activities can be conducted at no cost to you. Phase I Environmental Site Assessments

Research study intended to gather information to assess the environmental condition of the property and identify potential areas where substances may have been released.

Estimated Value: \$5,000 (now grant funded)
Estimated Time to Complete: 1-2 Months

Phase II Environmental Site Assessments

Intrusive study in which actual physical environmental samples are collected and analyzed to characterize the type, distribution and extent of substances in buildings or the environment (if present).

Estimated Value: \$20,000 (now grant funded)

Typical Process: 2-3 Months
