These measurements are subject to singular and possibly cumulative errors. These errors result from limitations inherent in the measuring devices and from the introduction of a measuring device in to the physical flow stream. Also, error in velocity and depth measurements may be and typically are introduced by the physical conditions of each site. The flow numbers presented in this table are estimates only.
